Rives Mansion owner claims tenant stalled work, gutted interior

• Carmen Rivera claims tenant Ralph Verdugo completed renovations without proper permits, and then destroyed the interior when evicted.

DOWNEY – Owners of the Rives Mansion are refuting allegations made by a former tenant last week that they were irresponsible landlords.

While owner Carmen Rivera confirmed the historic Downey landmark is facing foreclosure, she also said she and her husband Oscar evicted tenant Ralph Verdugo after the Downey businessman failed to pull the proper permits and get renovations approved by her.

"I am the victim here. I haven't done any abuses," she said. "[Verdugo] delayed and delayed so the property would fall into We're working with the bank now to modify our payments."

signed a seven-year lease to convert the Rives Mansion, located at the intersection of Paramount Boulevard and Third Street, into an upscale steakhouse and wine garden. Last week, Verdugo announced he pulled

out of an agreement with the Riveras five months ago after finding out the couple was nearly 60 months behind in mortgage payments.

"It's sad and depressing," said Verdugo, who claimed he spent \$400,000 to restore the home's floors, walls, and windows. "I called the owners and they said it was a misunderstanding, but then they stopped returning my calls."

If the Riveras lose the property, Verdugo has the first right of refusal to purchase the home.

Rivera said she lost trust in Verdugo after he failed to seek her approval on renovation plans.

"I was supposed to get a timeline of what he was doing, but he never gave me one," Rivera said. "I didn't know what he was doing."

Verdugo, however, provided the Patriot copies of plans dated Sept. 11, 2013 that were submitted to the city of Downey Building and Safety Division with both his and Rivera's signature on them.

"She knew what we were doing," foreclosure and he could buy it. he said. "Black and white proves everything."

Nonetheless, Rivera said she In July 2013, Verdugo and Rivera expected the renovation of the house to wrap up in eight months and promised Verdugo only six months of free rent. According to the lease, Verdugo would be required to make monthly payments, but only after a certificate of occupancy was issued.

"I was not the [Rivera's] listing broker. I had no obligation to her or Ralph...I was impartial," Cartozian said. "But Ralph's account is 100 be a long-term tenant...he was incentivized to open as soon as possible. I don't know how Carmen was concerned about rent when she hadn't paid the mortgage in five

"He maliciously destroyed it percent accurate. He wanted to so we'd lose it and he could buy it," said Rivera, who asked investigators to assess the damage. "He put us in jeopardy - we expect up to \$350,000 in damages."



No-cost stroke seminar series returns Jan. 28

DOWNEY – The most successful Primary Stroke Prevention Seminar series in our nation's history resumes later this month featuring free carotid artery screenings that can cost upwards of \$500 at a doctor's

These lifesaving screenings will be provided at the first Primary Stroke Prevention Seminar of 2014, which will be held Wednesday, Jan. 28 from 9:30 to 11:30 a.m. at the Rio Hondo Event Center. In addition to the carotid artery screenings, free blood pressure screenings will also be offered at the seminar.

The stroke prevention event is sponsored by the RTH Stroke Foundation, Keck Medicine of USC, PIH Health, Rio Hondo Event Center and The Downey Patriot.

The carotid artery screening process is simple - a medical technician uses an ultrasound device to determine if individuals have plaque buildup in the carotid arteries that could mean the person is at-risk

for a life-threatening stroke. Adults professional societies including assessing a person's risk for stroke.

The seminar will also feature a presentation about life before and after a stroke, stroke risk factors, warning signs and prevention from Dr. Richard A. Rison. Dr. Rison has served as the Stroke since 2005. He is a board certified neurologist with additional subspecialty board certification in vascular neurology, neurocritical care, and electrodiagnostic and neuromuscular medicine.

He also serves at the University of Southern California's Keck School of Medicine where he holds the title of Clinical Assistant Professor of Neurology. > "Stroke has become the leading and the fourth leading cause of death in our nation," said RTH Stroke Foundation President Deborah Massaglia. And yet, among adults age 50 and over, a recent study showed that 97% could not identify a single stroke symptom, and only 1% could name stroke as a leading cause of death. Here are some key facts about stroke:

- On average, one American dies from stroke every four minutes
- Nearly 800,000 stroke cases are reported each year in the United
- · Women are two times more likely to die from stroke than breast

• Of all stroke survivors, 90%

"The good news is that stroke is one of the most preventable of all life-threatening diseases, with more than 80% percent of all strokes being preventable," Deborah said. "That's why we're offering this free seminar to help prevent strokes throughout the Downey community."

Last year more than 1,000 individuals from the local area attended Downey-area stroke prevention seminars, and more than 100 individuals were found to have blocked carotid arteries, abdominal aortic aneurysms, and/or extremely high blood pressure.

The carotid arteries are two large blood vessels that supply oxygenated blood to the large, front part of the brain. This is where thinking, speech, personality, and sensory and motor functions reside. You can feel your pulse in the carotid arteries on each side of your neck, right below the angle of the jaw line.

If you have carotid artery disease, the arteries become narrow, usually because of atherosclerosis. This is the buildup of cholesterol and other material in an artery. If a blood clot sticks in the narrowed arteries, blood can't reach your brain.

Busby was employed by the Space Frontier Foundation as director of its international lunar conferences for two years. In April 2006, he joined XCOR Aerospace in Mojave in media relations.

Phone Scams targeting Tax Payers

An aggressive and sophisticated phone scam targeting taxpayers, including recent immigrants, has been making the rounds throughout the country. Callers claim to be employees of the IRS, but are not. These con artists can sound convincing when they call. They use fake names and bogus IRS identification badge numbers. They may know a lot about their targets, and they usually alter the caller ID to make it look like

Victims are told they owe money to the IRS and it must be paid promptly through a pre-loaded debit card or wire transfer. If the victim refuses to cooperate, they are then threatened with arrest, deportation or suspension of a business or driver's license. In many cases, the caller becomes hostile and insulting.

Or, victims may be told they have a refund due to try to trick them into sharing private information.

If the phone isn't answered, the scammers often leave an "urgent" callback request.

Note that the IRS will never:

1) call to demand immediate payment, nor will the agency call about taxes owed without first having mailed you a bill; 2) demand that you pay taxes without giving you the opportunity to question or appeal the amount they say you owe;

3) require you to use a specific payment method for your taxes, such as a prepaid debit card;

4) ask for credit or debit card numbers over the phone; or

5) threaten to bring in local police or other law-enforcement groups to have you arrested for not paying.

He, 64-year-old vocalist, pianist and songwriter Steve Goldrich, and 66-year-old vocalist and bass player Paul Reisch did just that this year. Every 40 Years is their first album in, well, 40 years.

- Michael Harrison, the 66-year-old publisher of two leading radio industry trade publications, Talkers and RadioInfo.

Harrison had been a 22-year-old DJ at WNEW-FM "The New Groove," New York City's trend-setting rock station, back when Gunhill Road was trying to hit the big time.

"Back then, we chose the music we played - we weren't restricted to playing just certain songs or artists," Harrison says. "I heard Gunhill Road and I loved their sound, the poetry of their lyrics. I played the heck out of them.'

Leopold and Goldrich offer these tips for boomers who want their "encore" to be a revival of a youthful pursuit:

Keep your expectations realistic.

"Reuniting to record together was more about having fun and seeing what we could do than trying to hit the top 40, although we would like to do

that, too!" Leopold says. "We're not going to be superstars -- no one's even thinking about that. We enjoy being with each other and we hope there's a fan base who will enjoy the music. This project has kept us in touch, and that's been a great thing."

Goldrich says, "It is art for the sake of art and that is a wonderful concept." Adds Harrison: "This is an absolutely superb band."

Realize times have changed and you may have to, too.

The old paths to success in the music industry have virtually disappeared.

"It's all different," Leopold says. "Music is given away free. You need to get a song on TV or in a movie; play live; and sell a ton of merchandise."

Harrison is helping them find new ways of getting exposure.

"There's a website of course - they wouldn't have had that 40 years ago!" In yet another reunion, they also got a well-positioned industry advocate he says. "And getting a song played on mainstream radio isn't the same as it was back in the '70s, but there are still plenty of alternative stations and talk radio is showing great interest in their story. You just have to be creative."

Rubio seeks answers on Cuban sanctions

U.S. Senators Marco Rubio (R-FL) and Dan Coats (R-IN) on Wednesday asked Secretary of the Treasury Jacob Lew to detail how the Department of the Treasury plans to lawfully implement President Obama's announcement to unilaterally normalize relations with Cuba.

The full text of the letter is below:

Dear Secretary Lew:

We are deeply concerned that several aspects of the President Obama's new approach to Cuba, especially those related to unilaterally easing U.S. sanctions, violate the letter and spirit of several U.S. laws, and increase the moral and financial risk to the American taxpayer and financial system of doing business through Cuba's government-controlled financial system. We ask that you explain in detail how the Treasury Department plans to implement the President's announcement under current law.

On December 17, the President announced that "U.S. institutions will be permitted to open correspondent accounts at Cuban financial institutions to facilitate the processing of authorized transactions."

As you know, Section 7207 of the Trade Sanctions Reform and Export Enhancement Act (TSREEA) explicitly prohibits U.S. assistance and financing to Cuba. Moreover, it contains no Presidential waiver. Also, Section 103 of the LIBERTAD Act prohibits any financing of transactions involving confiscated property belonging to U.S. nationals.

Given these stark differences between the letter of the law and the Administration's announcement, we ask that you provide clear answers to the

What legal authority does the Administration have to allow establishment of correspondent accounts in Cuba, and the use of U.S. credit and debit cards by travelers to Cuba?

How would the opening of correspondent accounts and the use of U.S.backed credit cards expose U.S. financial institutions and affect legal action from Americans who have outstanding judgments rendered against the Cuban government by U.S. courts?

How would these regulatory changes impact U.S. obligations to protect U.S. trademark holders, namely those who had their intellectual property confiscated?

Less than three years ago, Cuba blocked access to the Cuba-based correspondent bank accounts of its European trading partners and confiscated their cash. Can the Administration ensure that this will not happen to U.S.

The President also announced that "Telecommunications providers will be allowed to establish the necessary mechanisms, including infrastructure, in Cuba to provide commercial telecommunications and internet services."

While Congress has authorized certain transactions to improve telecommunications services between the United States and Cuba, U.S. law prohibits U.S. investments in Cuba's domestic telecom infrastructure.

Specifically, the Cuban Democracy Act of 1992 (22 USC 6004) includes a direct prohibition on "investment in domestic telecommunications services." Moreover, it states that an "investment" in the domestic telecommunications network within Cuba "includes the contribution (including by donation) of funds or anything of value to or for, and the making of loans to or for, such network." The LIBERTAD Act subsequently reinforced this "no investment" in telecom prohibition (22 USC 6032(g)).

What legal authority does the Administration have to allow U.S. investments in Cuba's telecommunications infrastructure?

How would such investments affect legal action from Americans who have outstanding judgments rendered against the Cuban government by U.S.

Also, as part of the President's announcement, general licenses will be issued for all 12 categories of authorized travel in the existing categories. However, TSREEA codified the ban on tourist activities, which are defined as any activity not expressly authorized in the 12 categories of travel set forth in the regulations. It further specified, "as such regulations were in effect on June 1, 2000." At the time of codification, non-academic educational travel ("people-to-people") was only permitted via specific license.

Under what authority will the President license travel beyond the June 1, 2000 levels?

Under the travel codification, trips related to activities that are primarily tourist-oriented -- including self-directed educational activities intended only for personal enrichment -- are illegal.

How will Treasury enforce violations of travel for self-directed educational activities and by groups that sponsor people-to-people trips, which seek to engage primarily in tourist activities?

How do certain travel activities, including staying at confiscated properties by U.S. travelers, not violate the ban on trafficking, and "indirect financing," of confiscated property in LIBERTAD?

The fact that the Administration has been unable to answer these and many other questions almost a month after the President's announcement, raises serious concerns about the process which preceded it. We thus would like to know whether the Treasury Department was even consulted regarding these significant policy changes regarding Cuba, and if so, on what date.
