



Downey sells property to Habitat for Humanity

• City Council Roundup: Habitat for Humanity building seven townhomes for low-income buyers.

DOWNEY – Habitat for Humanity plans to build seven new townhomes in Downey exclusively low-income, first-time homebuvers.

Partnership Housing Inc., an affiliate of Habitat for Humanity, is purchasing .42 acres of city-owned land located at 9303-09 Elm Vista Drive, where the townhomes will be

The City Council on Tuesday approved the \$750,000 transaction. Downey acquired the land for \$1.05 city. million in June of 2007 with the intent of creating low-income housing.

Each of the townhomes will be three bedrooms, two-baths, with 1,215 square feet of living space. A two-car garage will be attached to each unit.

The complex will have four total parking spaces for guests. Habitat for Humanity of Greater Los Angeles will act as the general contractor.

The \$3.1 million project will be financed by a \$750,000 commission land loan, \$1.145 million from Downey's federal HOME funds, \$1 million from the developer, \$105,000 from the federal home loan bank and WISH program, and \$84,000 from in-kind gifts and private sponsorships.

According to a city staff report, dealership selling new and used Giant RV plans to utilize the entire 9.7-acre property located at 11111 its conditional use permit approved Florence Ave., which was formerly a Gemco department store, Sam's Club and World of Decor.

> The dealership's showroom will measure 87,674 sq. ft. Another 8,881 sq. ft. will be dedicated to office space, and 8,799 sq. ft. is set aside for the service area.

> There is also space for a sales area, parts storage, and electrical.

> The service area will only be used for light mechanical work, such as



satellite dish installations and minor oil changes, according to the report. The dealership plans to operate

seven days a week, 8:30 a.m. to 7 p.m. According to the report, the area between the building and Florence Avenue will be used for customer service parking, service center

parking, and RV displays. The parking lot area on the east side of the building will accommodate RV inventory, and the RV service parking will occur along the north side of the building.

Employees will park on the west side of the property.

As part of the permit approval, city planners included some conditions, including that all mechanical work be done in fully enclosed areas, and that air compressor exhaust stacks contain muffling devices.

Giant RV currently operates four locations in Indio, Colton, Montclair and Murrieta.





Expert to discuss how she overcame deadly risks of sleep apnea



Tamera Godfrey-Pixton has lost 175 pounds since 2011 and has improved her health immeasurably.

DOWNEY - Are you among the 18 million adult Americans who have sleep apnea? Most don't know they have the sleep disorder, let alone that it can lead to having a stroke. or many other lifethreatening health challenges.

On Wednesday, July 29 from 9:30 to 11 a.m. at Rio Hondo Event Center, noted sleep therapist Tamera Godfrey-Pixton, RPSGT, RST will provide lifesaving information about sleep apnea and what to do if you're diagnosed with the condition. At a free primary stroke prevention seminar.

She will also discuss the amazing and inspiring story of how she overcame a serious case of sleep apnea by changing her lifestyle choices and losing 175 pounds.

The seminar is sponsored by RTH Stroke Foundation, Rio Hondo Event Center and The Downey Patriot. Free cholestorol/glucose and blood pressure screenings will be offered. Cholesterol/glucose uvula) screenings are limited, so it's important to register early.

Tamera manages Neurodiagnostic and Sleep Disorder Services at Long Beach Memorial Medical Center, where she has worked since 2003. She was born and raised in Oklahoma City, where she worked clinically in sleep medicine, research in Narcolepsy treatment, and development of new sleep aid drugs prior to moving to California. She is an expert on sleep apnea who has battled the disorder both personally and professionally.

Formally known as "obstructive sleep apnea," sleep apnea is a serious disorder that occurs when a person's breathing is interrupted during sleep. People with untreated sleep apnea stop breathing repeatedly during their sleep, sometimes hundreds of times. This means the brain -- and the rest of the body -may not get enough oxygen.

"Sleep apnea causes a disruption in the sleep cycle – resulting in sleep deprivation," Tamera said. "This may lead to hypertension, heart disease, increased risk of stroke, mood and memory problems, impotence, and increased risk of linked to sleep apnea and drowsy automobile crashes."

National sleep apnea statistics are disturbing: nearly one in five sleep apnea? adults has the disorder. Sleep apnea occurs in all age groups and both sexes. However there are certain factors that increase the risk of sleep gasping for air? apnea, which include:

- having a small upper airway (or enlarged tongue, tonsils or legs while in bed?
- having a recessed chin, small
- a large neck size (larger than 17 inches in a man, or 16 inches in headaches?

- smoking and alcohol use
- being 40 or older
- · having relatives with the
- having Type 2 diabetes (more

"Many people with sleep apnea daytime sleepiness, or snoring which disturbs their bed partner, unaware they have sleep apnea," Tamera said. Typical symptoms of sleep apnea include:

- Snoring
- Waking up with a dry mouth
- Morning Headaches • Being excessively tired during the day
 - Weight gain
 - Sleeplessness • Difficulty concentrating
- Depression Irritability
- Sexual dysfunction
- Learning and memory
- · Falling asleep while at work, on the phone, or driving

"Left untreated, symptoms of sleep apnea can include disturbed sleep, excessive sleepiness during the day, high blood pressure, heart attack, congestive heart failure, cardiac arrhythmia, stroke, depression and early death," Tamera said. "And let's not forget that an increase in automobile accidents is

So how do you know if you have

- Do you snore?
- Have you ever awakened
- Has anyone told you that you stop breathing while you sleep?
- Do you kick or twitch your
- Do you have difficulty staying asleep?
- Do you feel sleepy or fatigued during the day?
- Do you get morning
- Are you more than 20 pounds

overweight?

If you answered "yes" to more than two of these questions, you may wish to visit a sleep specialist to determine if you have sleep apnea.

"Sleep apnea is common in people with silent stroke," she said. "Studies have shown that as many as 50 percent of silent stroke patients had sleep apnea."

"Having more than five sleep apnea episodes per night was associated with silent strokes," Tamera said. "Of course, early treatment of sleep apnea may help reduce risk of silent strokes."

She added that people with sleep apnea may also suffer sudden death from cardiac-related causes during the sleeping hours. Celebrities who suffered sleep apnea-related deaths included pro football hall of famer Reggie White and actor John Candy at age 43 and the Grateful Dead's Jerry Garcia at age 53.

Obesity is a major factor in sleep apnea. According to the Centers for Disease Control and Prevention, the number of obese American adults (those with a Body Mass Index of 30 or more) has more than doubled since 1980, rising from 15% to 35%, But there is so much more to sleep apnea than just obesity.

"That's why it's important to get information about sleep apnea from someone who understands all aspects of the disorder," Guy said. "Wherever she has spoken, Tamera has helped people understand the issues and answers surrounding

"By telling the story of how she turned her life around and answering questions from attendees about their own lives," Guy said, "Tamera will help those who attend the seminar understand how to make changes to improve their health that will positively impact their lives forever."


More improvements coming to Apollo Park

Jeannette Savage, a longtime resident of Downey, was called home to heaven on Monday, July 6th, 2015. Jeannette was born September 20, 1923 in Lafayette, Louisiana. She was the second daughter of Homer and Laura Perry. She grew up in the Lafayette area and graduated Bunkie High School in 1940. She attended college at Southern Louisiana Institute and graduated with a BS degree in Education (Math and Physical Education) in June, 1944. She began her teaching career as a coach and at different times also taught math. She married Hartsell in August of 1947 and began a family in Bastrop, Louisiana. Jeannette and her family moved from Louisiana to Southern California in 1962 and eventually settled in Downey. She stopped coaching and began teaching math at East Jr. High until 1977 when she transferred to Downey Sr. High. She retired from Downey High in June of 1990 after a 46-year teaching career. During this time she received the honor of Teacher of the Year in the early 70s and twice again in the mid and late '80s. Jeannette was also the recipient of the Jaime Escalante Award for Outstanding Teaching in Math in 1989. After retirement, she remained active in her church as well as the Daughters of the American Revolution in which she held several leadership positions. Jeannette and her husband, Hartsell, enjoyed their retirement years making various trips both domestic & international as well as spending time with their ever growing family. During her career, Jeannette touched the lives of thousands of students as well as their families. She will be fondly remembered by them for her southern "drawl" as well as her challenge to make them "think". She will be remembered by her family for her love of God and family. 

Much to my daughter's and my disappointment, the trees were tagged for removal on Monday morning. This was very upsetting and concerning to us.

My daughters immediately created a petition letter to inform the neighbors, asking them to sign it if they agreed with our concerns. They received several signatures, in the short amount of time they had, from neighbors who were home.

Monday morning at 6:30 a.m., I called the Public Works Department and spoke to Elizabeth to express my concerns. She was very understanding and said she would refer the information to a supervisor.

Elizabeth, knowing the time sensitivity of the matter, suggested that I also call Public Works administration at City Hall, which I did but they were Downey not open yet.

At around 7:30 a.m., with the trucks lining the street ready to cut down the six trees, I approached them and spoke to the site supervisor. He gave me the business card of Grissell Chavez, Superintendent of Maintenance and Facilities, who I called and spoke with expressing my concerns. She said she would immediately look into the project. At 7:55 a.m., the work had begun.

I called Grissell again to inform her of the progress. Within minutes I received a call from Ed Norris, Deputy Director of Public Works, informing me that Grissell redirected the crew to work on another project until further review of this project was completed. By 8:15 a.m., the trucks were gone.

I will be meeting with the city's Engineering Department to discuss, hopefully, an alternate way to complete their project without cutting down the six trees.

I want to express my sincere thanks first of all to my daughters, Kelly and Candace, for having enough care and concern for their community in creating the petition and making their neighbors aware of the situation; Elizabeth from Public Works; the site crew supervisor; Grissell Chavez; Ed Norris; and the city Engineering Department for taking a second look at the project.

On July 9, the California State Legislature passed Senate Bill 432 and it is on its way to the Assembly.

The purpose of this bill is what some have called modernizing outdated laws by removing the term "alien" from the California Labor Code and passed in the Senate without a simple "no" vote. This bill was introduced by our fellow State Senator Tony Mendoza because he and many feel that the term "alien" has become a derogatory in its modern day usage.

Now I don't object that the term could be considered derogatory, but my only issue is instead of worrying about the semantics of language, if they are really concerned with how immigrants feel then maybe they should approve legislation that would make their everyday lives better.

Has anyone ever driven around Los Angeles County and seen our streets filled with potholes? How about some of our high schools that have extremely high dropout rates, or local taxes that are killing the middle class and forcing them to relocate? The problem was how could rules and decisions given by courts in one state, have the same level of meaning and power in another? If you were sued in New York for example, could that lawsuit be irrelevant if you moved to Connecticut and never returned? This is why language is important because after federalism it becomes recognized nationally. Taking words out because they could be seen as offensive by a few does have its consequences. I wonder what Madison would think of that?

Like I mentioned earlier, I do understand how it could be seen offensive to some, but be careful about trying to change or omit the language. This could open up and bag of worms to others that might be offended by other statutory terms and could be problematic in the context of the courts, legislation, and business decisions.

My resolution is to try to expedite people in who are called "aliens" or have a problem with the term, to gain permanent status or citizenship Dear Editor: while explaining that it is not offensive but that it is just statutory. That it is applied to all people regardless where they are from and is not specific, but temporary. NORWALK - Norwalk city officials and law enforcement are scrambling to put an end to a recent rash of violent crimes that has plagued the city over the last week.

On Friday, the body of a man was found in a residence on the 12000 block of Nava Street. CBS-LA reported that the man, later identified as 23 year-old Paul Joseph Rivera, was pronounced dead at the scene after being found in a home after authorities responded to a call about gunfire.

The discovery is investigated as a homicide.

The very next day, one man was killed and another injured during a shooting at Gerdes Park in the 14700 block of Gridley Road.

This is getting ridiculous...people are coming into Norwalk and just taking rampage," said Rodriguez. "We gotta keep praying, and ask God to put an armor around this whole city and take control of what's going on. We can't have any more as father and son, however that people dying. This is what? Through the creation and adoption of the Bicycle Master Plan, the city intends to achieve the goal of increasing the number of non-motorized trips, resulting in a decrease in vehicle trips as well as greenhouse gas emissions, as well as to meet sustainability goals, improve the health and wellness of the community, to increase local economic development and civic involvement, to maximize connectivity by bicycle between the various assets within the city and to provide a safe, efficient and connected network of bicycle facilities that residents and stakeholders can enjoy for a variety of purposes.

As part of the Bicycle Master Plan, the city evaluated various means in order to encourage cycling as an alternate travel mode and looked at key origin and destination points throughout the city for feasibility of bicycle travel, the placement of bicycle amenities at key destinations such as bike racks, the installation of bicycle directional and wayfinding signage along established bicycle routes within the city and the creation of bike maps to facilitate bicycle travel. In addition, the plan included a public outreach component whereby the needs of cyclists from all age groups were gauged cyclists from all age groups were gauged through a needs assessment survey.

The existing street system was reviewed for feasibility in terms of the establishment of bicycle routes for connectivity within the city as well as between the city and origins and destinations external to the city. Said city as well as between the city and origins and destinations external to the city. Said proposed routes include several miles of Class II and Class III bikeways. The Class II bikeways will require the restriping of some streets in order to physically accommodate the bike lanes, resulting in the reduction in the number of travel lanes from two to one in either direction, where deemed feasible, based on the results of a supplemental traffic analysis. In addition, the Bicycle Master Plan conforms to regional goals and strategies, explored design changes which can expand bicycle ridership, identified various bicycle-related projects and provided cost estimates for their implementation. In accordance with Section 21080.20 of the California Public Resources Code, the Bicycle Master Plan is statutorily exempt from the provisions of the California Environmental Quality Act (CEQA).

SHARED STORIES: THE TIES THAT BIND

Escape from Indonesia after WWII

When she was six years old, Maria Indonesia during World War II. Her father had been a Dutch harbor pilot. Maria was nine when the war ended and her family of ten people had miraculously survived, but conditions remained dangerous. When World War II ended, my mother and my siblings and I were reunited with my dad. He was in Bandung in a camp. They let us live in a big house right next to his camp. Many of the men stayed in the camp because there was nowhere for them to go. I was six years old when the war started for us, and now I was nine. My parents had eight children, and we all survived.

It was the Japanese who invaded Indonesia and put the Europeans in prisoner of war camps, but after the war, many of the young Indonesians were also against us. Captain Sone and the Japanese soldiers had, from the beginning been telling the Indonesians to hate the Dutch people and to fight for independence and create an Indonesian republic. There were now some Indonesians who formed groups to attack Europeans.

Nobody had money or anything else. There were also many children with no one to take care of them. On the other side of our house were Churkha's (soldiers from India) who protected us. It was so dangerous that some of the men who wandered out of the camp got shot by groups of young Indonesians.

My father somehow got all of us on a military plane that flew us to Batavia (Djakarta). That was also very dangerous. We sat on the floor holding on to a rope that was tied in the front and back. The plane flew so low that we could see the tops of the trees and sometimes we thought we would run into the mountain tops.


