At approximately 3:00 a.m., Downey Police Officers responded to a traffic accident in the area of Firestone and Old River. The suspect had been driving westbound Firestone and lost control of his vehicle. He struck a light pole located on the northwest corner of Old River School Rd and Firestone. Officers determined during their investigation the suspect had been driving while under the influence and placed him under arrest for DUI.

Downey man arrested for threatening video

DOWNEY – A Downey man was arrested this week in connection with a video posted on Instagram that appeared to threaten an LAPD officer. Alex Izquierdo, 35, allegedly posted the 15-second video last week. The video appears to show an armed man sitting in a car behind an LAPD officer.

LAPD officials said the video was intended to be a publicity stunt as part words from Downey Unified's of a comeback by 1990s rap group Brownside.

"We don't see a specific threat against any police officer," LAPD Chief Charlie Beck said. "We believe, based on interviews, that the video was made not as a precursor to an attack on a police officer, but in a manner to support

the credibility of the person in the video for a rap career." Bail for Izquierdo was set at \$200,000.

School board candidates announce endorsements

DOWNEY - Downey school board member Donald LaPlante, who is up for re-election next month, announced an endorsement this week from Assemblymember Cristina Garcia.

Not to be outdone, his opponent, Linda Saldana, snagged an endorsement from a local teachers union.

LaPlante and Saldana, along with Maria Avalos, are candidates for the Downey school board in trustee area 4.

"Donald LaPlante has a significant long-term record of accomplishment on the Downey School Board and I endorse him for re-election in November," Garcia said in a statement. "When I was elected to the Assembly, he was one of the first to reach out to build bridges between me and the school community. He has been a leader and deserves another term on the Downey Unified Board of Education."

Saldana received the endorsement of the California School Employee Association, CSEA Downey 248.

Pamela Martinez, president of the Downey chapter of the CSEA, said Saldana "will bring new energy to our District and has the students' best interests in mind."

CSEA Downey 248 has more than 650 members that are employed with the Downey Unified School District.

Candidates forum Oct. 21

DOWNEY - The Downey Patriot will host a forum for Downey Unified School District board of education candidates Wednesday, Oct. 21, at 6:30 p.m. at the Columbia Memorial Space Center.

The forum will be an opportunity for residents to listen to school board candidates as they explain their vision for Downey schools and answer questions in a moderated discussion.

Eight candidates are seeking four open seats on the Downey school board, including incumbent Willie Gutierrez and Claudia Medina in Trustee category. Area 3; incumbent Donald LaPlante, Maria Avalos and Linda Saldana in Trustee Area 4; and incumbent D. Mark Morris and Vanessa Rodriguez in Trustee Area (6).

Incumbent Tod Corrin is running unchallenged in Trustee Area 2.

The candidates forum is free and open to the public. Christian Brown, a staff writer for the *Downey Patriot*, will serve as moderator.

'State of the Schools' offers look at STEAM curriculum

Superintendent Dr. John Garcia hosted the school district's third annual State of the Schools breakfast last Friday, where 350 guests were provided updates on the district's current achievements and vision for the future.

The event was hosted at the L.A. County Office of Education in Downey and attracted several community leaders, including Assemblymember Cristina Garcia, Downey Mayor Pro Tem Alex Saab, members of the Cerritos College Board of Trustees, Cerritos College President Dr. Jose Fierro and representatives of local service organizations and businesses.

The event opened with students from Gallatin Elementary School's Character Council leading the audience in the Pledge of Allegiance and the Character Counts Pledge. An address was then given by Tod M. Corrin, president of the Downey Board of Education, followed by Teacher of the Year, Grant Warhurst.

In addition to hearing Garcia present the district's strategic vision, guests received an update on the major initiatives being implemented throughout the district.

Those in attendance also viewed Downey Unified's promotional video that focused on the rebranding process of the district. This video explained the direct correlation between Downey Unified's vision and mission, and the strategic direction that will be followed for the next three years.

This video, titled "Downey, will become more Unified" widespread as the branding initiative continues to rollout.

Former Warren High baseball manager named to Hall of Fame

DOWNEY – Former Warren High baseball coach Tom Bergeron will be inducted into the CIF Southern Section Hall of Fame this month, the CIF has announced.

Bergeron will be one of 15 coaches and educators inducted Oct. 14 during ceremonies at The Grand in Long Beach.

Bergeron began his career as a baseball coach with Warren High in 1969. He left after three years, beginning a 32-year tenure as manager of Gahr High School's baseball program.

Bergeron collected more than 600 career wins, two CIF Southern Section Finals appearances, and 21 league championships.

He has coached nine MLB players, two of which were members of the U.S. Olympic baseball teams in 1984 (Shane Mack) and 1988 (Bret Barberie).

The baseball field at Gahr is named in Bergeron's honor.

Transient gets 6 years for killing

DOWNEY – A homeless man who admitted to killing a man and burying his body along the 105 Freeway was sentenced to six years in prison Monday.

Bryan Petty, 25, pleaded no contest to voluntary manslaughter and was immediately sentenced at Norwalk Superior Court.

Petty was originally charged with murder after he killed 35-year-old David Vallejo on April 1, 2013.

But the only witness in the case said Petty acted in self-defense when he struck Vallejo with a piece of pipe.

Petty said he buried Vallejo's body because he feared gang retribution.

"It was a difficult case," Deputy District Attorney Steven Schreiner told

City News Service. "It's hard to know exactly what went on there."

"When I started working, I got a sense of independence. I have two daughters and I like the fact that now I don't have to ask others for anything. In fact, now my mom asks me to help her out instead of me asking her. That makes me happy. I remember when I got my own car and I did everything on my own. I can buy whatever my daughters want.

"When I was 6 months pregnant with my first daughter, I was away from my family and my sister passed away. My family kept it from me because I was pregnant. They didn't want me to get depressed. I was really close to her.

"That had a profound effect on me. It changed my way of thinking about life. It changed how I viewed my family. Instead of bringing us together, it drove us apart. It was the first time I had lost somebody. I didn't know how to cope with it, I didn't know how to grieve. I felt a lot of hatred and I didn't believe in God at that time. So, I started to go to church a little bit.

"The death of my sister changed me. I named my first daughter [Faith] after her. Now I cherish every moment I have with her - I didn't expect to lose her so early. Now I look at it this way, if something big happens in your life, you have to keep moving forward. I have three tattoos because of my sister. One says, 'keep moving on.' Another one says, 'time will heal' and the third says, 'Faith.'"

A pilgrimage for love, justice and dignity

One hundred women walked 100 miles to welcome Pope Francis to Washington. Their goal? To bring attention to the U.S. immigration crisis and to touch the hearts of our nation's leaders.

They started their pilgrimage outside the immigration detention facility in York, Pennsylvania. They walked for eight days, sharing their stories of struggle, discrimination, deportation, and family separation. They pushed through pain and blisters to reclaim their humanity and inspire love and compassion for migrants everywhere.

I caught up with them on day five in Baltimore and again at the closing vigil in Washington, DC. I expected to see tired faces and dragging feet, but instead I was greeted with cheers, singing, tears of joy, and an overwhelming sense of hope and determination. "Are you all tired?" they chanted. "What's that?"

These courageous women are unstoppable.

They weren't acting alone. Also on a mission to put a human face on the immigration conversation was 5-year-old Sophie Cruz, who came all the way from Los Angeles.

This determined little girl in a beautiful Mexican indigenous dress caught the pope's attention. Francis embraced her as she gave him a t-shirt and a letter.

"I want to tell you that my heart is sad," she wrote. Reflecting on her worries about her undocumented parents, she told the pontiff, "every day I am scared that one day [the authorities] will take them away from me."

Sophie represents the 4.5 million citizen children who experience this fear and uncertainty every day, something that no kid should ever have to endure. She asked Francis not to forget about children caught in the middle of our broken immigration system, and begged him to urge President Barack Obama and Congress to pass immigration reform.

As I watched Francis address Congress, I smiled and thought of Sophie, the 100 women, and our nation's immigrant families. We all rejoiced upon hearing the pope's words of compassion toward immigrants. He called on our lawmakers to "view them as persons" while "seeing their faces and listening to

The pontiff's words couldn't have come at a better time.

Anti-immigrant rhetoric is growing. Politicians are competing with one another to see who can say the most outrageous, hateful, and racist words about immigrants. Their comments have even inspired violence — such as when two men brutally assaulted a Latino man in Boston, telling police, "Donald Trump was right, all these illegals need to be deported."

Pope Francis implored Congress to remember that this country was founded by immigrants, and urged them to follow the Golden Rule.

The pope continued his U.S. visit with stops in New York City and Philadelphia, where he continued spreading messages of love and respect for

In one of his last public events in Philadelphia, he spoke with great affection to a crowd filled with recent immigrants at Independence Hall, a place known to many as America's birthplace.

"Do not be discouraged by whatever challenges and hardships you face," he advised them. He asked them "not to forget that, like those who came here before you, you bring many gifts to your new nation.

What's next for the 100 women?

They'll walk on the 11th day of every month in prayer, love, and unity with this nation's more than 11 million undocumented immigrants. How many more miles will it take until Congress starts treating immigrants with the respect they it.

Grass cutting vs. lawn care

Dear Editor:

There is often a big difference between cutting grass and taking care of $\,Mass\,shootings\,$

Most gardeners are still cutting the grass way too short for these hot drought conditions. It is simple common sense that if you can see the dirt/ soil through the grass blades that the hot sun is going dry out the dirt very quickly. If you want it to recover, It will now take more water to do this than before it was cut.

If the grass tips turn white shortly after cutting, it is a sure sign of it being stressed (from cutting it too short) as well as being cut in the heat of the day, and therefore, now needing more water than it did, just before it was cut. Yes, cutting the grass in the heat of the day rather than in the cool of the evening is simply punishing to the grass, and defies common sense.

Cutting the grass blades by more than 1/3 of its height will guarantee stress on the grass, which now requires more water to keep it green and/or healthy. Stressed, cut grass turns white and also shrinks a bit from moisture being drawn out of the blades – which makes it even shorter. Once you notice this, you will see that it easily takes about 4-6 days to overcome it. But in this drought, with less water usage, along with 90-100 degree temps, it might not

In the last 5-10 years, how many people have bothered to aerate the soil so that water can truly penetrate down instead of running off – or just staying on the top and evaporating. Most of us would be very sadly surprised at how hard and compacted the dirt is at 2-5 inches below the surface! In this regards, even a small hand drill (with about a 5/8 drill bit) can do some mighty wonders! All the places that are turning brown first, are probably the spots with the heaviest compaction. It is also 'probably' where the sprinklers are leaving the least amount of water. Just try and stick a moisture meter or a screw driver into the gound of these brown spots and see how incredibly hard it goes into the ground. A few holes and very slow soaking will quickly revive these spots - sometimes in just 1-2 hours! Once again, it is simple

How many of us are giving the grass any fertilizer at all? Better yet, how about using smaller amounts of fertilizer but perhaps more frequently during these stressful times. Use just enough to keep it green, but not so much that it needs to be cut every 4-7 days. Most lawns could easily get by for two weeks

If 'gardeners' are going to give their customers honest service, this is what you can do (to help all of us save water in the drought). Many people simply do not understand the basics of lawn care, and you 'gardeners' could greatly assist us, as well as advise all of us who aren't so knowledgeable about these

It would be common sense to keep their grass as long as possible to shield the ground from this excessive heat of these prolonged 90+ degree days. 3.5 inches (for fine-bladed fescue grass) ought to surely be the minimum height during these prolonged intense summer months of heat when conserving water is so important. St. Augustine or marathon grass can be shorter as it is

For all of us, just go outside and casually look at all the lawns that are still the greenest. In every case the grass will be longer than the ones that have turned brown – and usually it is cut by the homeowner. This is not 'automatically' a sign of using more water. In contrast, all the brown spots are so short you can see the dirt beneath it. Long grass is a common sense way of actually conserving water. Also, using a moisture meter while watering will certainly aid in minimizing water usage. You won't have to error in overdoing

Where the grass grows next to sidewalks and curbs, a one inch depth of dirt should be dug out so that water can drain down into the roots instead of running off and into the streets. You could also drill some holes in this little trench and/or just mix in some organic fertilizer to easily facilitate more water and nutrients getting down to the grass roots on these edges that

I don't claim this short article to be the whole 'gospel' of lawn care. But I do think 90% of us can see the common sense wisdom and practicality of what is said. It is NOT by water alone, that grass will live without constantly struggling to stay alive. We can greatly assist it, and still cut back a whole lot

Yes, there is often a huge difference between cutting grass and taking care of a lawn!

Climate change

As the Pope visits the United States, climate change should be in everyone's mind. As Pope Francis said, we humans need to change. We need to take actions now on a personal and political level to stop or slow climate

There was a very cavalier attitude in the Republican debate last week about climate change. They don't get it. Marco Rubio said that it would be too expensive to act or that there is nothing that we can do about it. Chris Christie said his state has already met their energy goals. That was all - in a 3-hour debate. That is a shame.

Jake Tapper, the moderator of the debate, brought up George P. Shultz, (President Reagan's Secretary of State) who said that we need to act now (on climate change) as President Reagan did when faced with the ozone layer shrinking. There were some skeptics that didn't believe we could turn it around. But Reagan got people working on a solution as an insurance policy. It turned out that he made the right decision. Scientists were able to reformulate aerosol sprays and refrigerants to stop the ozone layer from disappearing. George Shultz says that we must do now what Reagan would have done. As an insurance policy against disastrous climate change we need to work together to find solutions.

For a start we need to drastically cut our use of fossil fuels. On the Federal level we could pass a revenue-neutral carbon fee and dividend program with border tariffs on merchandise produced by countries that don't participate. Put a fee or tax on carbon at the source - petroleum and gas at the wellhead and coal at the mine. Citizens Climate Lobby has suggested a fee of \$15 per ton, increasing by \$10 every year. The money raised would go back to each of us as a monthly rebate check. This money could be used by each person to reduce their use of fossil fuels - taking actions such as insulating their homes, putting solar panels and cool roofs on their houses, planting a shade tree, buying a more efficient hybrid or electric car or a bicycle. This would be a fair and efficient way to quickly get us off fossil fuels.

George Shultz said, "We all know there are those who have doubts about the problems presented by climate change. But if these doubters are wrong, the evidence is clear that the consequences, while varied, will be mostly bad, some catastrophic. So why don't we follow Reagan's example and take out an insurance policy? First, let's have significant and sustained support for energy research and development.... Second, let's level the playing field for competing sources of energy so that costs imposed on the community are born by the sources of energy that create them, most particularly carbon dioxide. A carbon tax, starting small and escalating to a significant level... would do the trick. These two policies could be put in place along with eliminating burdensome existing laws and regulations and using the marketplace rather than edicts by the government. Put a price out there and let the marketplace adapt."

This is not a Democrat or a Republican concern, it is everyone's concern. After Pope Francis' visit, why don't we all work together as an insurance policy to find the best solutions to slowing climate change before it is too late? Anita Rivero



reading this column has eaten a peanut butter and jelly sandwich. These days, peanut butter gets a bad rap because it and a high-sugar jelly. brings with it a considerable number of

calories. However, along with its fat content comes a load of nutrients, and I think very highly of the value of peanuts and peanut butter.

Although a Canadian patented peanut butter in 1884, Michigan's Dr. John Harvey Kellogg patented the "Process of Producing Alimentary Products" in 1898. As part of his focus on nutrition, enemas, and exercise, Kellogg Flakes, of course) to the patients at his Battle Creek Sanitarium.

During the depression, the peanut butter and jelly sandwich became an especially popular sandwich due to the cheap, quick, high-calorie food. Much has changed in the last 70 years, including food availability and Childhood obesity has become an epidemic. Is it time to rethink our favorite lunchtime go-to food?

A sandwich of bread, jelly, and peanut butter can contain about 530 calories (180 calories from fat, 296 calories from carbs, and 54 calories from protein), as well as 460 milligrams of sodium, 74 grams of carbs, 35 grams of sugar, and 20 grams of fat. Two tablespoons of peanut butter alone contain 188 calories and 16 grams of fat.

I was shocked when I compared it to a McDonald's cheeseburger. The PB&J is higher in every one of these categories except sodium. Note, however, that the fat in a cheeseburger is the dreaded trans fat (which raises our LDL "bad" cholesterol, and lowers our HDL "good" cholesterol).

I encourage you to experiment by combining peanut butter with sliced apples, bananas, celery, whole-grain crackers, and wholegrain bread, and by incorporating almond butter as well. Peanut butter is satisfying, nutritionally dense, and offers many health benefits. I highly recommend it as part of a healthful diet.



Local government belongs to us, but we need to do our part

The end of summer means the anticipated arrival of a new season. Of course I am referring to campaign season for local elections. All over our country local election campaigns are in full sprint.

As with autumn leaves, an assortment of campaign mailers and flyers will begin to drop into your mailbox promoting candidate ideals, successes and, in some cases, bashing opponents.

Some are better than others, most are meant to be informative, and all of them follow the same rule: pose with flag, children/family or other elected officials and if possible fire or police representatives. I was once told by one of my political advisors during one of my campaigns that I needed to have a picture with a dog since it "polled really well" (our family dog had just passed away and I was not going to make one up for a photo op).

There's nothing wrong with imagery if it is not fake. It's a way to establish recognition. But candidates need to present more than awkward unnatural poses to voters - they need real dialogue and transparency.

Connecting with voters means being heard and having conversations.

This is where we as voters must meet the candidates half way. This is especially true if you wince at the amount of money spent on local elections. Unfortunately money stills dominates the ability to get your message out as a candidate but that does not necessarily make that person the better candidate or elected official. We have seen this time and time again here in California.

When candidates canvass or walk districts, be prepared with questions about your city, their vision and their background when they knock on your door. Find out who supports them

anyone else on the city council, school board or whatever institutional seat they are running for. We are known interest groups. for the company we keep, good and bad. Some run as outsiders, new ideas or anti status quo, and some as experienced insiders. We as voters should know why.

Knowing how a candidate thinks on their feet, their views on specific local issues or whether they sound scripted, can benefit your decision in the long run. Ask them about what their plans are and why. Look into the length and service to their community. Did they just move into the school district or city to run for office? Are they involved or participated in community events in the past?

Also, collect the mailers and spend a few minutes reviewing each along with their website. Find out whether four more weeks of campaign season or not they will be participating in a candidate forum or debate and learn when and where it is to take place and plan on attending.

Be informed! Learning about a candidate is very important. For one, you now have an educated assessment of which candidate shares your values and vision, concerns and priorities. Secondly, having a connection with someone who will represent you on a school board or city council makes it easier to voice your opinion directly to them on matters of importance in said: " In any moment of decision, the future. That does not mean you will agree on everything but at least you will have an idea of their vision on issues most important to you.

In California local elections by law are non-partisan. That means that regardless of party or ideology each person stands on their own personal involvement and education about the candidates crucial.

Sadly, some of us see this as time consuming and futile. Without taking the time to vet candidates the system of

(and why) and if they are close to government and elections breaks down completely and in favor of candidates with the most money and special

> Unless we believe that our vote doesn't count or all politicians are corrupt, so why vote? The answer is simple. So many have fought and died to protect our ability to choose our representatives and it's up to us to make informed decisions in their



DOWNEY – Football is returning to St. Pius X- St. Matthias Academy.

The Pirates defeated Long Beach Wilson at Paramount 34-7 in their first game, were defeated by Los Alamitos at Veterans Stadium 49-12 in their second game and defeated Long Beach Jordan at Paramount 38-15 in their third game. The Pirates defeated Carson at Carson 21-6 in their fourth game and were defeated by Narbonne at Paramount 54-6 two weeks ago.

The Bears have been led on offense by standout senior quarterback Jordan Yancy. Yancy has completed 32/67 pass attempts for 638 yards and 11 touchdowns. Jordan has also carried the ball 21 times for 183 yards and five touchdowns. If the Bears are going to win tonight, Jordan Yancy needs to play well.

Warren lost last year's S.G.V.L. finale to Paramount 42-34. If Warren had won that game, the Bears would have made the playoffs. Coach Lara, his staff and players are looking forward to the start of S.G.V.L. play and making a run into the C.I.F. Southeast Division playoffs.

The Downey High School football team will travel to Dominguez tonight in their S.G.V.L. opener. The Vikings had a bye last week to rest up and get injured players healthy for the start of league play. Downey finished their preseason schedule 2-3.

Downey won their season opener against San Pedro 13-2 at home, lost their second game to Hart at Hart 38-14 and lost their third game to Alemany at home 42-6. The Vikings won their fourth game
