### Health providers face few consequences for violating privacy laws

When CVS Health customers complained to the company about privacy violations, some of the calls and letters made their way to Joseph Fenity. One patient's medication was delivered to his neighbor, revealing he had cancer. Another was upset because a pharmacist had yelled personal information across the counter.

Fenity worked on a small team that dealt with complaints directed to the company president's office, assuring customers their situations were rare. "I sincerely apologize on behalf of CVS Health," Fenity says he'd respond. "This is not how we handle things. The breach of your protected health information was an isolated incident and we'll do better."

In fact, Fenity learned — partly from battling CVS over the privacy of his own medical information that was "a lie."

CVS is among hundreds of health providers nationwide that repeatedly violated the federal patient privacy law known as HIPAA between 2011 and 2014, a ProPublica analysis of federal data shows. Other wellknown repeat offenders include the U.S. Department of Veterans Affairs, Walgreens, Kaiser Permanente and Walmart.

And yet, the agency tasked with enforcing the Health Insurance Portability and Accountability Act took no punitive action against these providers, ProPublica found.

In more than 200 instances over those four years, that agency, the Office for Civil Rights within the U.S. Department of Health and Human Services, reminded CVS of its obligations under the law or accepted its pledges to improve privacy protections. (CVS did pay a \$2.25 million penalty in 2009 for dumping prescription bottles in unsecured dumpsters.)

To be sure, the organizations with the most HIPAA violations are all large health care providers with many locations that serve millions

## Downey students host robotics competition

#### **HUMANS OF DOWNEY: KELLEY ROBERTS**



"I am the Construction Chairman for the Downey Rose Float Association and have been for over 25 years. I started decorating floats 36 years ago. My neighbor and his sister were going to come down and decorate a Rose Parade float. I wanted to go. My parents said, 'No. You're on restriction.' So I faked a pout, stormed to my room, closed the door, jumped out the window, then over the fence, met my neighbor on the next block and went to decorate a float. They were a little upset when I got back but they said I could have been doing something worse.

"Back in 2000, I designed and built a roller coaster on our Rose Parade float and then I rode in it at the Rose Parade. We plan for every little part of the parade. Except for one thing that year. Where we were positioned in the parade was in the back. So when you're moving forward on Orange Grove, you move forward, you stop, you move forward then you stop. Well, the float weighed 40 to 45 thousand pounds. By starting - stopping, starting stopping, it put a little more load on the transmission that we hadn't planned on.

"Now, as we're coming up to that famous turn onto Colorado Blvd. The one with all the grandstands and the TV cameras, I'm riding the roller coaster around and my brother is screaming at me, 'The transmission is boiling over.' I could only talk to him for a brief 2 seconds every time I came around to his spot. So I told him, 'I don't care... whatever you got...get me past camera.' So, I heard him yell through the float, 'Give me all the water. If I don't get the water, I'm going to pee on this transmission.' But once we got past that famous turn, it's mostly down hill with a few spots of up hill. After the turn it's a constant flow. It's not start - stop - start - stop. So, it was less stress on the transmission. Of course, I had to get rid of that transmission when we got done."

## PRIVACY: VA hospitals caught violating **HIPAA laws**

of patients each year. In statements, they said they take privacy seriously. (Walmart declined to comment.)

"CVS Health is strongly committed to protecting the privacy of our patients' health information," CVS spokesman Mike DeAngelis wrote. "We have established rigorous privacy policies and procedures throughout the Company to safeguard patient information."

Over the course of this year, ProPublica has reported on loopholes in HIPAA and the federal government's lax enforcement of the law. A story earlier in December detailed how the Office for Civil Rights only rarely imposed sanctions for small-scale privacy breaches that caused lasting harm.

The data analyzed for this story shows the problem goes beyond isolated incidents, carrying few consequences even for those who violate the law the most.

"The patterns you've identified makes a person wonder how far a company has to go before HHS recognizes a pattern of noncompliance," said Joy Pritts, a health information privacy and security consultant who served as chief privacy officer for HHS' Office of the National Coordinator for Healthcare Information Technology until last year.

Pritts said the government is supposed to take into account a health provider's prior track record of following the law when deciding whether to pursue fines for privacy violations. "You have to ask whether that's happening," she said.

The VA was the most persistent HIPAA violator in the data. Time and again, records show, VA employees snooped on one another and on patients they weren't treating. One employee accessed her ex-husband's medical record more than 260 times. Another employee peeked at the records of a patient 61 times and posted details on Facebook. A third improperly shared a vet's health information with his parole officer.

All told, VA hospitals, clinics and pharmacies violated the law 220 times from 2011 to 2014. For this story. ProPublica counted as violations those complaints that resulted in either corrective-action plans submitted by a health provider or "technical assistance" provided by the Office for Civil Rights on how to comply with the law.

The VA has never been called out publicly by the Office for Civil Rights or sanctioned for its string of violations.

The VA would not make an official available for an interview, but said in a written statement that it "takes veteran privacy and the privacy of medical or health records very seriously."

"The challenges VA is facing are similar to those experienced across public and private sectors, and we are continuously striving to better protect veteran data," its statement said, adding that it provides training to staff, investigates complaints and conducts audits of who accesses health records.

Some privacy problems whether inadvertent or the deliberate acts of rogue employees—are to be expected. But repeated complaints may signal organizational failures,

"I don't think it's a defense to just say, 'We do a billion prescriptions a year," said Mark Rothstein, chair of law and medicine and the founding director of the Institute for Bioethics, Health Policy and Law at the University of Louisville School of Medicine. "They need to be more

assertive to try to figure out what's wrong. It may be true that you can't get down to zero, but you need to make a really good faith effort to follow up on the complaints that were filed."

OCR has broad latitude in deciding how to handle complaints. It can resolve them privately and informally, as it has chosen to do in the vast majority of instances. It also has the authority to impose fines of up to \$50,000 per violation, with an annual maximum of \$1.5 million. In the most egregious cases, the agency can file criminal charges against violators. It is free to post complaints online, if it protects patients' identities.

Deven McGraw, deputy director for health information privacy at the Office for Civil Rights, said the agency's top priority has been investigating breaches that affect at least 500 people, which providers are required by law to report promptly. "Often, when we take a look into those breaches, what we find is that they were not accidents," she said. "What contributed to the breach of thousands, if not tens of thousands of records, was systemic noncompliance ... over a period oftentimes of years."

Still, McGraw acknowledged, more can be done about health providers with multiple HIPAA

"I don't like the idea of repeat for that behavior and I would like to see us doing more in this regard," she said, adding that the office's case management system in the past was an impediment but is now being fixed to proactively flag them.

Although the Office for Civil Rights receives thousands of complaints a year — nearly 18,000 in 2014 — it issues only a handful of financial penalties. The agency posts details online about the fines violators have agreed to pay (fewer than 30 since 2009), as well as a listing of large breaches. But that represents a tiny share of the incidents investigated by the office; the rest has been hidden from the

wrote in an email: "Entities who not necessarily guilty of a crime or a civil wrong. Our office makes public details of cases that result in action agreements or civil monetary penalties on our website."

Despite the VA's status as the top serial HIPAA violator in ProPublica's analysis, McGraw said, "that doesn't mean that we treat them any differently in terms of our overall enforcement philosophy."

Using data provided by OCR under the Freedom of Information Act, ProPublica is launching a new tool, HIPAA Helper, which allows users to look up reports of privacy violations by provider for the first time. OCR's material often referred to the same entities by multiple names. CVS was listed as "CVS," "Pharmacy, CVS," "Caremark, CVS," "CVS Caremark" and more. Kaiser Permanente was identified as "Kaiser Foundation Hospital," "Kaiser Hospital," "Kiaser Permanente," and even "KP." We have standardized organizations' names to make searching easier.

The database also includes the large breaches self-reported by health providers to the Office for Civil Rights, privacy incidents logged separately by the VA and violations cited by the California Department of Public Health, which can impose its own fines against hospitals for failing to protect

patient privacy.

Two reports issued this fall by the HHS inspector general faulted the Office for Civil Rights' casetracking system for its inability to track repeat offenders.

The Office for Civil Rights said it is taking steps to fix those problems.

To gain a better understanding of the nature of the complaints received by OCR, ProPublica requested dozens of letters sent by the office to health providers detailing the allegations and how they were resolved.

In the case of CVS, common complaints included giving drugs to the wrong patients, speaking too loudly when discussing health information in front of customers, and faxing medical information to the wrong places (including to random strangers).

Many of the letters culminate with the admonition: "Should OCR receive a similar allegation of noncompliance against CVS in the future, OCR may initiate a formal investigation of that matter."

But that doesn't seem to have happened.

DeAngelis, the CVS spokesman, said the company's 200,000 employees who work in pharmacies, medical clinics and call centers are required to complete privacy training when they are hired and every year afterward. That's in offenders not being called to task addition to regular on-the-jobtraining on privacy practices, he

> Nicolas Terry, a professor and executive director of the Hall Center for Law and Health at Indiana University's law school, said the Office for Civil Rights has moved more aggressively in recent years to impose fines against health providers that have had largescale breaches or have done "dumb things," such as a cardiology group that used a publicly accessible online scheduling system. Still, he said, the agency could do more.

"If you see the same offender continuing along the same line of conduct, then at some point, you've got to ramp up and say, 'You are not taking the hint that we are dropping, Terry said.

For patients whose medical information is exposed, the effects can be far-reaching.

The breach involving Fenity occurred in September 2014, when he couldn't refill a prescription for a controlled substance — a medication to treat Attention Deficit Hyperactivity Disorder — at a CVS pharmacy and called the company's helpline (as required) for permission to get the drug elsewhere.

All CVS employee calls were routed to the center in San Antonio where Fenity worked, and he soon discovered that a co-worker who assisted with the call hadn't kept his inquiry confidential. Walking down a hall a couple of days later, Fenity heard the co-worker mention his name and the medical lingo used to describe controlled substance overrides.

Deeply shaken, he told a supervisor and, after investigating, the company fired the co-worker and counseled two others who were told the information. Fenity remained so anxious and embarrassed by the incident that he took a leave of absence. (He was terminated this August for not returning.)

"It was incredibly difficult for me to reassure members that we would appropriately handle their [personal health information] or Walgreens ranked third for take accountability by working to avoid any additional HIPAA

> After trying to resolve the issue within the company, he filed a privacy complaint against CVS with the Office for Civil Rights. He said he believes the company's systems for protecting his health data were —and still are — inadequate. It is pending.

> CVS's DeAngelis said the investigated Fenity's company complaint promptly and fired the employee to blame.

> DeAngelis also noted that employees can request that their calls be routed to a employee who "would be the only representative authorized to access their prescription account. In fact, following Mr. Fenity's incident, this option was offered to him and he accepted."

> Fenity can still recall the chill of realizing the information about his medication was out.

"It's like feeling your clothes have been ripped off in the middle of work," he said. "That's what it feels like. You feel so exposed."

"Start brainstorming, or, if you already have an idea, you can submit your ideas and proposals for a new state law on my website," Garcia said.


"Entries can touch on a wide range of issues that can be addressed by legislation and will improve the quality of life in our neighborhoods and throughout the state of California.

### College's food drive brings in more than 1,400 donations

WHITTIER - Rio Hondo College students shattered all previous records for their annual canned-food drive, collecting more than 1,400 cans by the campaign's official end at noon Wednesday, Nov. 25.

The drive, led by the Associated Students of Rio Hondo College (ASRHC), had been expected to collect a record-setting around 800 cans – about 200 more than in 2014. But donations surged in the last several days, more than doubling the 599 cans donated last year.

In 2014, the students also doubled collection totals, making this year's achievement a boost of at least 365 percent over two years.

"We're going to need to set some higher goals," ASRHS President William Ashby said Wednesday. "Our old ones just won't do any more."

Ashby's team helped inspire the surge by offering a \$150 prize to the student club that donated the most cans. The funds can be used to support club activities or events. The competition was so fierce, Ashby said members of two student groups continued to bring in cans until even past the official deadline.

The food was donated to the Whittier Interfaith Food Center, which distributes food to the area's neediest residents.

"It is quite moving to see the giving nature of our students, faculty and staff demonstrated in the student canned food drive," said Superintendent/President Teresa Dreyfuss. "It's a great indicator of the compassion at Rio Hondo College for our surrounding communities."

The student government hasn't concluded its holiday giving, either. On Monday, as the food drive was winding down, Ashby's team launched its annual toy drive. The drive aims to collect 150 toys – 50 more than 2014 – to donate to the Interfaith Food Center.

"Efforts like the canned-food drive and toy drive showcase the 'community' in community college," said Board of Trustees President Madeline Shapiro. "They make me proud to be a part of Rio Hondo College."

## \$22 million settlement reached to clean up hazardous site in South Gate

Environmental Protection Agency and U.S. Department of Justice on Tuesday announced that a group of 40 parties have agreed to conduct the cleanup of the Cooper Drum site in South Gate, 10 miles southeast of downtown Los Angeles.

The settlement requires an estimated \$15 million to construct the additional groundwater treatment system needed, including wells, piping and treatment costs, plus \$7 million to reimburse EPA for its past cleanup actions at the Superfund site.

"Today's settlement is a binding commitment to pursue the final cleanup of this former industrial site," said Jared Blumenfeld, EPA's Regional Administrator for the Pacific Southwest. "Our goal is to protect the residents of South Gate from the toxic chemicals that have contaminated their local groundwater."

Cooper Drum is a 3.8 acre site located in a commercial, industrial and residential area of South Gate. From 1974 until its closure in 1992, the Cooper Drum Company reconditioned used steel drums from industrial customers, such as chemical manufacturers, chemical packagers and oil companies.

The 55 gallon steel drums, which contained residual oils and drums, primarily volatile organic compounds such as trichloroethylene (TCE), spilled and leaked on the site,

contaminating soils and groundwater.

Cooper Drum was placed on Superfund's National Priorities List in

Over the last 14 years, EPA has overseen the design, construction and operation of soil and groundwater treatment systems aimed at cleaning up TCE, lead, PCBs and petroleum hydrocarbons, authorities said.

The site's soil vapor extraction system, which has been operating since 2011, has removed over 742 pounds of chemicals from affected soils. The groundwater extraction system has treated more than 17 million gallons of contaminated groundwater since 2012.

## Republicans know nothing about Syria

For the most part, there were no surprises: Donald Trump railed against Muslims, Chris Christie lamented that the NSA can't intercept Americans' phone calls and emails as easily as it used to, Ben Carson remained confused about foreign policy, and Carly Fiorina yelled loudly that nobody was paying any attention to her.

That's great entertainment. But one ongoing theme bothered me — a lot. It seemed to me that none of the Republicans running for president had even the vaguest understanding of what's happening in Syria.

I learned during my nearly 15 years of working on the Middle East at the CIA — and after earning my college degree in Middle Eastern Studies — that nothing in that region is easily accomplished. Almost no issues are black and white. Alliances shift constantly, and sometimes politics makes for strange bedfellows.

Syria is no exception.

The debate theme was basically this: The Islamic State is bad, Syrian President Bashar al-Assad is bad, and "moderate" Syrian rebels are good. In a perfect world, that would indeed be the case. But it's not a perfect world, and that's not the reality of Syria today.

Certainly, we can all agree that the Islamic State is a dangerous and desperate terrorist group that must be stopped. But at what cost? Why is it up to the United States to send troops to fight a foreign civil war?

We've been at war for the past 14 years in that part of the world. Isn't it time to stop fighting over there?

And what of Assad? He's a ruthless dictator, to be sure. And the civil war he helped set in motion has claimed the lives of more than 200,000 of his own countrymen — and forced nearly 12 million more to flee their homes as refugees or internally displaced people within Syria.

But he's also the only one protecting religious minorities like Alawites,

Druze, and Christians in Syria — the latter of whom make up about 10 Like many political animals, I was glued to the latest Republican percent of the population, including notable minorities in both the Syrian parliament and cabinet. Unlike many people elsewhere in the region, Syrians of all traditions were generally free to practice their faith before the war began. This also used to be the case in Iraq under Saddam Hussein, despite

his own ruthlessness. By now most Iraqi Christians have fled the country. Church leaders have been kidnapped and murdered. And you're more likely to meet an Iraqi Christian in Detroit than in Baghdad. And those "moderate" rebels? Maybe a few are freedom-loving

secularists. But many more are hardcore Islamists like the al-Qaeda-affiliated Nusra Front. They aren't any more interested in democracy than Assad or the Islamic State itself. There is, however, a solution. And it doesn't involve killing more people,

stumbling into other countries' civil wars, or "carpet bombing" the Middle East, as Ted Cruz proposed. It's called diplomacy. The United States has national security interests in Syria: We want to stop the Islamic State. The Russians and Iranians have interests, too: They

want to support and protect their friend Assad. The Turks have an interest in protecting their border. The Jordanians have an interest in resettling Syrian refugees back in Syria. Doesn't it make sense, then, to call for peace talks that would include

Moscow, Damascus, Amman, and other regional capitals? Doesn't it make sense for the international community to work together to bring peace and stability back to the region? Assad is no choir boy. But we should be talking to him, too. There's no

dealing with the Islamic State while this war is still underway.

## Broadband rents are too damn high

As the digital revolution hurtles ahead, low-income communities across the United States aren't reaping many of its benefits.

The less you make, the less likely it is that you're hooked up at home. This is especially true if you lack a high school diploma. And the already steep cost of Internet access is continuing to climb.

A recent Brookings Institution report explores these inequities, identifying critical gaps in broadband adoption. The study breaks down broadband adoption data by metropolitan areas, revealing not just national trends but also local ones.

The average adoption rate for America's 100 largest metropolitan areas is a little higher than the national average of 75 percent. But even among these larger populations, major disparities exist. San Jose and Seattle may have more than 80 percent of their metro populations online, but Lakeland, Florida and Greensboro, North Carolina hover around 64 percent. There's no cohesive national broadband picture.

The researchers found significant correlations between income, education levels, and adoption rates. Nearly 90 percent of households earning \$50,000 or more have broadband, while less than 47 percent of households making under \$20,000 do. Many other studies have had similar findings.

When you control for other factors, income and education appear to be two of the most significant factors driving broadband adoption.

Meanwhile, adoption rates continue to grow unevenly across the country. While 58 of the 100 biggest metro areas saw significant gains from 2013 to 2014, the other 42 areas didn't. At this rate, the invisible hand of the market

won't push us towards universal access.

If the digital divide won't solve itself, how can we fix it?

Brookings recommends a multi-pronged approach that includes targeted income assistance for those who can't afford exorbitant broadband prices, as well as digital skills training.

Many Internet service providers would like to focus exclusively on digital literacy. Instead of admitting that their near-monopoly status has allowed them to set astronomical prices, they'd rather accuse struggling families of not being digitally savvy enough to even want broadband access.

Digital skills are important, but they can't undo the economics. When so many households can't afford access to what Brookings calls the "defining infrastructure of the 21st century," we need to start asking hard questions about why that is. The Brookings report builds off the growing body of evidence telling

us what our wallets already know: Broadband prices are too damn high. In fact, U.S. Internet users pay far more for broadband than consumers in many European and Asian countries — often for much slower connections. Here's the deal: Monopolistic cable companies have every incentive to

squeeze their customers. Families struggling to pay for school supplies can't afford these luxury prices. To ensure universal high-speed Internet access, our policymakers must address this fundamental problem.



#### Suspects charged in car chase that ended in Downey

DOWNEY - A driver and his two passengers were arraigned last week on charges of identity theft and recklessly evading pursuing officers in a highspeed chase that concluded in Downey.

Richardson, 22, all of Anaheim, are each charged with one felony count of identity theft by retaining information on 10 or more victims with the intent

A witness contacted the Orange County Sherriff's Department (OCSD), northbound Interstate 5 and attempted to stop the vehicle.

Brown is also charged with one felony count of evading while driving recklessly and sentencing enhancement allegations for prior prison convictions for the unlawful taking of a vehicle on two separate instances in 1993, possession of a controlled substance in 1994, second degree burglary in 1995, attempted grand theft, unlawful taking of a vehicle and evading while driving recklessly in 1996, receiving stolen property and possession of a controlled substance in 2000, second degree burglary and receiving stolen property in 2001, receiving a stolen vehicle and receiving stolen property in 2003, possession of a controlled substance in 2005, buying or receiving a stolen vehicle in 2006, second degree burglary in 2008, possession of a controlled substance and receiving stolen property in 2008, all in Orange County.

If convicted, Brown faces a maximum sentence of 12 years and eight months in prison.

#### Basketball player accused of taking someone else's car from valet

HOLLYWOOD - A professional basketball player pleaded not guilty Wednesday on a charge that he took someone's luxury sports car from a hotel valet earlier this month, the Los Angeles County District Attorney's Office

#### Man gets prison for attempted rape

ALHAMBRA - A 34-year-old man was sentenced Tuesday to six years in state prison for assaulting a woman in March.

At his court appearance, defendant Rudy Anthony Gallegos of Los Angeles pleaded no contest to a felony count of assault with intent to commit a sex

In addition to the prison sentence, Los Angeles County Superior Court Judge Jared Moses also ordered Gallegos to register as a lifetime sex offender.

Deputy District Attorney Presciliano Duran, who prosecuted the case, said in the early afternoon of March 3, Gallegos abruptly assaulted a woman as she was walking in Alhambra.

According to the prosecutor, the defendant struggled with the victim, pulled her to the ground and began to take off her clothes.

The woman screamed and three passersby heard her cries, the prosecutor said. They ran to the victim, pulled Gallegos off of her and subdued the defendant until police arrived, the prosecutor added.

#### Father charged with kidnapping daughter

PALM SPRINGS - The father of a two-year-old daughter who went missing on Christmas Eve during a supervised visit was arraigned this week on kidnapping and child stealing charges.

Jack Perry, 31, was arraigned Wednesday at the Foltz Criminal Justice Center, Department 30. Prosecutors asked that his bail be set at \$1 million.

Perry was arrested Monday in Palm Springs after he allegedly took his daughter, Lucia, from a shopping mall during a supervised visit. He is charged with one felony count each of kidnapping and child stealing.

According to the criminal complaint, the defendant robbed employees at more than a dozen locations between July 7, 2014 and Dec. 20. The locations included various fast food restaurants and gas stations, the prosecutor said.

During a Dec. 13 robbery, Holman allegedly forced a store clerk back inside the business so he could rob him, the prosecutor added.

#### Driver convicted of DUI crash that killed elderly woman

LANCASTER - A 26-year-old man was found guilty last week of crashing into a Lancaster home, killing a 71-year-old woman who was in her bedroom.

Deputy District Attorney Sun Chung said a jury found Aaron Daniel David Bryan Brown, 45, Jessica Smith Roten, 55, and Corey Dillon Benson of Lancaster guilty of one count each of murder, gross vehicular manslaughter while intoxicated, driving under the influence of alcohol causing injury within 10 years of another DUI offense and driving with a .08 percent blood alcohol content causing injury within 10 years of another DUI offense.

Benson faces 15 years to life in state prison at a hearing scheduled on Feb. 2 who began investigating this case. OCSD deputies located the vehicle on the in Department A20 of the Los Angeles County Superior Court, Antelope Valley

> Benson was driving with a blood alcohol level that was more than twice the legal limit on West Avenue J-12 when he crashed into Patricia Ann Holmes' bedroom on March 29, according to court testimony. Holmes, who was lying in her bed at the time, died as a result of the injuries, the prosecutor said.

> Benson had previously been convicted for driving under the influence in

The jury deliberated for a day before returning with the guilty verdicts.

#### Gang members accused of fatally stabbing gang rival

PLACENTIA - A Placentia criminal street gang member who was arrested in central California was brought back to Orange County to be arraigned on charges for the attempted murder of a gang rival.

The Orange County District Attorney's Office (OCDA) is seeking to enjoin Erick Adonis Ferman, 19, Placentia, and Matthew Luis Zavala, 20, Fullerton, in a gang injunction. Ferman and Zavala are each charged with one felony count of attempted murder, and one felony count of street terrorism with a sentencing enhancement for criminal street gang activity.

Zavala also faces sentencing enhancement allegations for two prior strike convictions for vandalism with damage of \$400 or more with a sentencing enhancement for criminal street gang activity in 2014, both in Orange County.

Zavala is currently being held on \$500,000 bail. If convicted, he faces a maximum sentence of 51 years to life in state prison.

Ferman faces a maximum sentence of 19 years in state prison. He was apprehended on an arrest warrant by officers from the Fullerton Police Department (FPD) and members of the U.S. Marshals Service in central California on Dec. 27.

Three additional co-defendants have been charged in this case: Cynthia On Dec. 7, a guest left his vehicle with a hotel valet and when he returned Barron-Juarez, 20, of Garden Grove; Lexus Marie Cobos, 19, of Anaheim; and Vincent Matthew Duran, 19, of Placentia.

> On Dec. 6, at approximately 1 a.m., Zavala, Ferman, and Duran are accused of entering a convenience store in Fullerton, where they spotted a member of a rival street gang. The three allegedly started a verbal argument with the victim and then assaulted him outside the store.

> During the altercation, Zavala, Ferman and Duran allegedly stabbed the victim. Zavala and Duran fled in a stolen vehicle, authorities said.

#### Man accused of torturing, killing children's mother on Christmas

POMONA - A Pomona man was charged Tuesday with the torture and murder of the mother of his children during a domestic dispute on Christmas

Clarence Durell Dear, 51, was scheduled to be arraigned at the Pomona Branch of the Los Angeles County Superior Court. Prosecutors asked that he be held without bail.

Deputy District Attorney Joy Roberts with the Arson Unit is prosecuting the case.

Dear is charged with dousing the 41-year-old victim, Dawn H., with a flammable liquid and setting her on fire. The incident occurred shortly before 2 p.m. Friday in the 1500 block of Cordova Street. The victim later died at a

Dear is charged with one count of murder with the special circumstance of torture. He also is charged with one count of cruelty to a child, the couple's 12-year-old son.

The special circumstance makes Dear eligible for the death penalty. Prosecutors will decide later whether to seek death.

#### Drivers plead no contest after illegal street race kills two spectators

CHATSWORTH - The driver of a vehicle that crashed during an illegal street race, killing two spectators, entered no contest pleas last week for causing

Karen Gary Balyan, 44, pleaded no contest to two felony counts of vehicular manslaughter with gross negligence and admitted to fleeing the scene during the commission of the crime, and no contest to one misdemeanor count of assault with a deadly weapon.

Co-defendant Israel Valenzuela, 39, also entered a no contest plea to two

On Feb. 26, Balyan drove Gevorgyan's vehicle while racing Valenzuela during an illegal street contest near Plummer Street and Canoga Avenue in Chatsworth, according to court testimony. Within seconds of the beginning of the race, Balyan lost control of the vehicle that slammed into a curb and struck three

in jail and five years formal probation.

#### Father, son convicted of embezzling \$300K from employees

SANTA ANA - A father and son were convicted Tuesday of embezzling over \$300,000 from employee wages on public works jobs.

Daniel Jacob Siapin, 60, and his son Gabriel Daniel Siapin, 37, both of La Habra Heights, pleaded guilty to a court offer of 28 felony counts of taking and receiving a portion of worker's wage on public works, and 32 felony counts of recording a false and forged instrument with a sentencing enhancement for property loss over \$200,000.

Daniel Siapin's California state contractor's license was revoked by the court. Daniel Siapin and Gabriel Siapin are each expected to be sentenced to 90 days in jail, three years formal probation, ordered to pay over \$227,000 in restitution, and are prohibited from working on any other public works contracts at their sentencing on April 11.

At the time of the crime, Daniel Siapin owned Siapin Horticulture, a landscaping, irrigation, and maintenance company, which he ran with his son Gabriel Siapin.

The defendants violated the law on a public works job, which requires a minimum "prevailing wage" be paid to workers. Prevailing wage consists of a base salary and "fringe benefits," or benefits in addition to base pay such as vacation pay and pension money. Fringe benefits must be paid directly to the worker or may be put into a fund for later withdrawal by the worker if they do not work a full 40 hours a week. The California Labor Commissioner's office and the Orange County

District Attorney (OCDA) received a complaint alleging underpayments of prevailing wages to workers on the Lakeside Middle School alterations project located in Lakeside, California. In a collaborative effort, the California Labor Commissioner provided Orange County with evidence to support allegations of underpayments of fringe benefits to workers on three different projects, including Lakeside.

In February 2010, the City of Los Angeles Compliance Department and Center for Contract Compliance assessed penalties and wage fines against the defendants' company for not paying their employees the prevailing wage on a public works job. A civil assessment was levied against the defendants.

In June 2010, both Daniel and Gabriel Siapin met with employees and offered to contract with a third party administrator to hold the employees' fringe benefits in a savings account.

Between 2011 and February 2013, Siapin and Siapin failed to deposit over \$300,000 in employee fringe benefits into the savings account from work performed in Orange County and other Southern California counties. The defendants instead embezzled the money meant for employee fringe benefits.

The State Labor Commissioner's office levied civil wage and penalty assessments for past wages following a 17-month in-depth investigation.

"Prevailing wage laws ensure that workers on public works projects are paid a just day's pay for a hard day's work, and those who violate those laws engage in wage theft," said Labor Commissioner Julie A. Su. "Wage theft is a crime and my office is working with District Attorneys across the State to investigate and prosecute these cases. I am proud of and grateful for our collaboration with the Orange County District Attorney to bring scofflaw employers to justice."

The OCDA and the Labor Commissioner work together on joint investigations to ensure that all labor laws are enforced on public works jobs, including payment to workers of the wages they've earned. The Labor Commissioner's office, also known as DIR's Division of Labor Standards Enforcement, adjudicates wage claims, investigates discrimination and public works complaints and enforces state labor law.

Every bag was decorated with personal messages, and the bags were distributed along with blankets.



## In Bellflower, special education students get prepared for college and careers

plan is to one day work in the retail market - a passion that has led him to three internships over the last year and which is influencing his plans to attend Cerritos Community College.

Bellflower High School senior Pedro Rodriguez isn't as certain about the future, but he's doing what he can to prepare for college and to develop the skills he will need to build a career.

"I know someday I'm going to be on my own," Rodriguez said. "I have with customers and other coworkers. to be ready for that."

Neale and Rodriguez are part of the Bellflower Unified School District special education program, which provides customized educational guidance for nearly 1,650 preK-12 and adult transition students who grapple with a variety of challenges, ranging autism, specific learning disabilities, or other conditions that lead them to learn differently, to severe physical and mental disabilities. About 500 special education students attend District high schools.

"Our students – special education as well as general education - deserve every opportunity to prepare for college and careers," Bellflower Unified Superintendent Dr. Brian that happens."

As a result, the District offers two programs funded by state grants designed to teach special education students employment skills and to transition to college courses that lead to self-supporting careers -Partnership Program. Bellflower Unified is in the process of applying for new grants for the programs and is expanding its staffing.

WorkAbility prepares students for job interviews, to craft resumes,

BELLFLOWER - Mayfair High to dress for work and to conduct School senior Jacob Neale's career themselves in a professional manner. The program starts middle school students on career exploration and provides training and a limited number of internship opportunities for students age 16 and older.

> Neale has interned for about a month each with community partners Dollar Tree and Hot Topic during the 2014-15 school year and for CVS over


> "I learned how to communicate I learned how to take direction and to be on time, to dress up nicely," he said. "I want to do retail or customer service, maybe working for TJ MAXX or Forever 21, somewhere like that."

> Rodriguez interned with the YMCA over the summer. He guided children on the playground and helped with food preparation - tasks with which he is familiar thanks to the time he has spent watching over his 10 nieces and nephews.

The two students also participate in the Transition Partnership Program, an effort that provides training to prepare juniors and seniors for careers after they graduate from Bellflower Unified. The program works with colleges, apprenticeships and adult Jacobs said. "These programs ensure schools. The program, which takes in a limited number of students each year, currently has openings.

Cerritos College partners through the program with Bellflower Unified, helping students determine which classes to take to prepare for careers and how to access services to ensure WorkAbility and the Transition their success. BUSD Special Education Coordinator Irene Ramirez and her team help students fill out admissions paperwork and bring 50 students to the college for its Senior Preview Days each spring.

Neale said one of the strengths of

the program is the passion shown by Ramirez and her team.

They helped prepare me," he said. "They are very helpful with the interview process and the daily workday and how we should act, plus any applications we need to fill out. It really is very helpful."

Both students said a key lesson they learned was to look interviewers in the eye and communicate clearly their ideas and goals.

Ramirez, a 20-year BUSD employee, has coordinated WorkAbility and the Transitions Partnership Program since 2013. She said the District has hired a full-time transition specialist to ensure students have resources at Bellflower and Mayfair high schools, and is seeking a part-time team member.

"It's a richly rewarding effort to see these students gain the skills and move toward independence," Ramirez said. "We teach them they need to learn to earn and gain the skills to pay

The lady was dressed to the hilt, with high heels and a lovely dress. Here was in my tennis shoes and sweat pants. What a contrast.


A few months later, we rented a cabin in Big Bear. After our two-week stay, we packed up and were ready to leave.
