CRIME REPORT

THURSDAY, APRIL 21

At 11:30 a.m., an explosion occurred inside the laundry mat located at 10303 1/2 Lakewood. Downey Police and Downey Fire responded and nearby businesses were temporarily evacuated as a precaution. DFD extinguished a small fire. A couple patrons received minor injuries, but nobody was seriously injured. Foul play is not suspected, but the incident is still under investigation by Downey Fire.

At 4:30 p.m., a male and female broke into a parked car at the Stonewood Shopping Center. When the owner interrupted the burglary, the suspects fled into the nearby neighborhood, both were eventually caught by police. Both suspects were arrested for vehicle burglary.

FRIDAY, APRIL 22

At 10:00 a.m., a residential burglary occurred in the 8600 block of Springer, but an alert neighbor obtained a license plate of the suspects' car before they left the scene. A couple hours later, detectives located the car in the area of Florence & Eastern and stopped it. Evidence tying the occupants to the earlier burglary was discovered in the car. Ultimately, two adults and one juvenile were arrested for the burglary. The juvenile was also wanted in the City of Bell for robbery.

At 7:30 p.m., a man entered Daniel's Jewelers inside Stonewood Shopping Center and asked to see a ring and necklace. When the clerk removed the items from the display case, the suspect grabbed them from the clerk and ran out of the store. The suspect was last seen running through the parking lot but eluded capture. Detectives are investigating.

Elderly resident killed in hit-and-run

DOWNEY – A 74-year-old Downey resident was killed Wednesday night in a hit-and-run crash near Brookshire Avenue and Gallatin Road.

NBC-4 reports that the victim was not in a crosswalk when the collision occurred at about 8:11 p.m.

The resident was reportedly struck by a white Honda driven by 64-yearold Quddus Kahn. Police say Kahn fled the scene but returned an hour later.

Kahn was arrested and charged with felony hit-and-run.

The identity of the victim has not been publicly released.

The break-in occurred sometime between Monday evening and the early morning hours on Tuesday. The instruments stolen varied from District owned, Booster purchased, and personally owned.

Downey Unified School District declined to release too much specific information in order to preserve the integrity of the ongoing investigation, and in an effort to not further disrupt the individuals involved, has also opted not to host on-site interviews of students or staff for media.

A turning point in my life was when we moved from Los Angeles to Bellflower when I was 7 years old.

In Los Angeles we walked a couple of blocks to Exposition Park and the Coliseum, the museums, the rose gardens, picnic areas, and play areas. We spent a lot of time in the park, especially in the museums and the kiddies' pool.

We lived in the bottom half of a large house which was on Figueroa Street which was very busy. We kids would cross the street and walk a block or so to the local movie theater where we would spend the greater part of Saturday afternoons.

We walked three or four blocks to the Catholic school and church. We took a bus or trolley to go on further excursions with our mother. She was a reader, and we became readers by frequent visits to the Los Angeles main Fortunately, our mother wanted us to stay with our own age group.

Our backyard was adjacent to the parking lot of the medical building next door. We had abundant room to bike, skate, play ball, etc., after business hours and on weekends. We were allowed to ride our bikes around the block, but no further. Nicky climbed the giant avocado tree and made a

Harjo, born in Tulsa, Oklahoma, is a Myskoke poet and musician. The early nineteenth century Romantic impulse to get back to Nature as the nurturing and healing source, features strongly in the Native American Renaissance of the late 20th century. Harjo is rooted simultaneously in the natural world, in earth, and in the spirit world, as was Samuel Taylor Coleridge, who chose to make the exotic believable, in everyday language. We rode in the car to Griffith Park on many weekends for picnics with friends and on our own. We kids were given free reign and explored the hills and the zoo on our own.

When we moved to Bellflower, we moved from an urban to a rural area. We were far from most things, although we had dairy farms, a pig farm, a horse in a field, a frog pond, a dry river bed with lizards, and horned toads

We didn't know too many neighbors in L.A. - mostly just the people above us, as we were in a business area. In Bellflower, we got to know most of the people around us as everyone was new to this new tract of homes, which was located in an agricultural area. We even knew the names of our neighbor's pets.

We rode a school bus to the public school, and later, when we were older, and wanted to, we'd ride our bikes to school. Because they were purchasing a new home, my parents could not afford to send us to a parochial school.

When our mother took us to get registered, the school wanted to promote us all one grade ahead because of our parochial education.

On my first day of public school in the third grade, the teacher wanted to make me feel welcome, so she asked me to name the vowels. I had no idea what a vowel was. So much for parochial education, and thank goodness that our mother kept us in our age group.

In L.A., we played mostly in our backyard and the adjoining parking lot. In Bellflower, we had the full reign of the tract of homes, and we rode all of the streets. Most of the families had but one car and it was used to take the fathers to work. The cars were parked in garages, so the streets were open and empty and there was not much traffic, so we could play ball there.

We rode our bikes beyond the boundary of the homes and explored the orange groves, the dairies, the frog pond, the river, and the pig farm. We visited the horse in the field and the little café on the corner of Woodruff and Rosecrans. We played baseball and kickball in the side street, and it seemed like most the kids flew kites on the front street.

We'd play hide-and-go-seek. It was easy to hide as there were no street lights at that time, and you could just lie down on a lawn and never be discovered. We had some major dirt clod fights along the perimeter of the orange groves, and the riverbed, which was not yet cemented and was dirt, became a good place to play.

The closest store was across the river. Rosecrans ended in a dirt road by the pig farm, and there was no bridge over the river. Helms Bakery trucks, the Good Humor man, the milkman, and a store bus would bring us treats and needed staples.

The Fuller Brush came by frequently and we were visited by encyclopedia salesmen, aluminum siding salespeople, accordion sales people, and various other people trying to sell these new homeowners something to improve their homes or lives.

We kids had much more freedom in Bellflower than we did in L.A. Unfortunately, most of our friends lived closer to the city center, and we couldn't bike to their houses for a year or two.

Nicky and Barbara joined the Scouts, and I, along with friends my age, created a bike club and enjoyed our outings without any adult supervision, dues, uniforms or rules. We were driven into Bellflower to see a movie, and picked up afterwards.

Rancho hospital celebrates as final beam put into place

DOWNEY - Several Rancho Los Amigos National Rehabilitation Center Administration and staff gathered along with Los Angeles County Supervisor Don Knabe on Friday to commemorate the "topping out" of the future Outpatient Building.

During Friday's small ceremony, multiple Rancho Los Amigos leaders were invited to sign the final steel beam of the developing structure.

Supervisor Knabe also signed the all of our patients in one building, into place.

The new Outpatient Building is a part of the five year, two phase, \$418 million Rancho Rising 2020 campus renovation and beautification project, which is currently on schedule and expected to conclude in the year 2020.

Rancho COO Benjamin Ovando described Friday as a "big milestone" in the process of the campus's construction.

"In this building we'll actually be able to provide outpatient services to

beam before it was raised and set whereas right now we're kinda spread out among five buildings that were built anywhere from the early 1900's to about the 1960's," said Ovando. "So it's going to be a lot easier for our patients because they won't have to go from building to building for their appointments. Now they'll be able to go to just one building and get all of their outpatient services."

> Along with the added convenience of the single outpatient building, Ovando also cited getting into seismic compliance as one of the major parameters in going forward

with the construction.

Supervisor Knabe, who has been one of the driving forces and biggest supporters of the Rancho Rising project, described Friday as a "great day for Rancho."

"I think the importance of Rancho is not only locally and to the county and to the region, but to our state and our nation. It's one of the top rehab hospitals in America, and the only public facility that always makes that ranking," said Knabe. "What we do here is extremely important...it's just a great day."



optimal success. Although in some situations a leader may not be appointed or immediately emerge from within a group, its members will notice actions which provide leadership to others, and will naturally begin to follow that person's leadership examples. This is one way of leading by example. It is my intent to illustrate different forms of leading by example in order to substantiate its use as a valid form of leadership. I strongly believe that leaders

are not simply those who command others to perform different actions. A leader is someone who will perform an action and lead others to get things done, by doing them together. A leader does not label himself as a captain, boss, or leader. A leader is humble and inspires others to achieve success through his or her actions. The followers of such a leader-like individual realize the powerful influence of a positive attitude and willingness to work with others to achieve goals, which is the foundation of the work ethic they seek to maintain in their life.

Encountering situations where there is a group which needs to accomplish something, in the absence of a designated person to lead the group, can be very difficult. The want for an individual to lead the group can be daunting, but someone must step up to the Downey President Fred Donnelly. plate and lead. A few years ago, I competed in a 5K obstacle mud run for writing one of the best groups of race called "Run for your Lives," where participants had to get through the entire course without having their three flags removed by role-playing "zombies."

During that race, a group of thirty people including myself approached a long, narrow straightaway filled with zombies attempting to remove our flags from us. We all knew that we needed to strategize overcome obstacles: by combining before attempting this obstacle

allowing team members to accept individually, each of us would be responsibility for failures as well vulnerable to losing at least one flag. Although our entire group was comprised of strangers, one man spoke up and called out to us, "We need to all go at once. If we action. go one at a time, it's pretty much guaranteed they're going to get our flags. If we all go at once, there is a higher percentage that most of us will make it out with our flags not taken! Let's go guys, we can do

> Our group of thirty people listened to this stranger, a man none of us knew, and we agreed to follow his advice because it made good sense. More pot will mean more use among youth

Probably one of the hottest topics around dinner tables and in workplaces as we approach election season in California is the legalization of marijuana -- will California follow Colorado and Washington's lead and legalize it for recreational use? Wherever you fall on this issue personally, one fact remains that cannot be ignored: legalization would most likely increase youth use of

Research has demonstrated time and again that the more accessible a substance is, the more youth use it. According to a nationwide survey of young adults ages 18 to 25, children of parents who smoke marijuana are more than three times more likely to use it themselves. Among those whose parents had used marijuana, 72% had used it also. Conversely, only 20% of those whose parents had never used marijuana reported having used marijuana themselves.

Alcohol and tobacco provide the best case studies, of course. Decades of research on these two legal substances shows that youth usage rates are considerably higher in places where there is easier access for adults (in the form of more stores selling the products, for example), despite the age restrictions that are supposedly in place.

Most people say 'yes' to legalization without thinking about the consequences of a powerful and financially-motivated marijuana industry.

What about the inevitable proliferation of marijuana dispensaries throughout our communities? What about the potential of marijuana advertising in print, on billboards, and online? What about public use? Of course, there will be efforts to regulate all of it, but there is no denying that once the vast mechanism of a 'Big Marijuana' industry is in place, our communities will be much more saturated.

We cannot underestimate the impact this will have on the teens and youth around us. What is viewed as 'socially normative' deeply influences young people. If teens are inundated with marijuana messages and imagery, or, if they're regularly seeing the adults in their lives smoking pot, they're more likely to do the same – three times more likely, according to the research.

All of this matters, of course, because marijuana use hurts youth more so than it does adults. Research shows that marijuana has significant detrimental cognitive effects on the developing brain. Youth can't regularly use marijuana without long-term consequences.

For these reasons, I am very concerned about the impact legalization of marijuana would have on (community's) youth. I believe strongly that it is our duty as adults to protect our kids from harm. I hope you feel the same.

If we don't protect our children, who will?

Cultural divide in farming communities squelches conversation about hot-button issues like pesticides

A friend of mine is a farmer out in Montana. She's also eight months pregnant with her first child.

Recently she looked out her window and saw a worker spraying pesticides on her neighbor's farm. Concerned for the health of her baby, she called the neighbor about the spraying. "Oh," the neighbor asked, "do you want him to spray your land too?'

She remained polite on the phone but was internally panicked. What had he sprayed, and how would it affect her child?

In the day that followed, she faced dilemmas like whether to take the dog in the car and walk him somewhere else, or even not to walk him at all.

Was the land around her poisoned? Could she walk anywhere without endangering her child? She became a virtual prisoner in her home.

She's not the only one I know who lives in the country and faces issues like this.

Another friend deals with her neighbor's cow manure, which runs off into her stream. The neighbor in this case is a nice guy, she says, but there's a cultural divide between her and the farmers who surround her. She doesn't see a way to approach them about issues like these to achieve any kind of good results.

Thanks to this divide, what could be a matter of common courtesy neighbors having a reasonable conversation to keep from imposing on one another — feels impossible.

The question of "organic vs. pesticides" or "local food vs. industrial food" (or however else you want to frame it) hasn't been a rational debate for a long time. It's ideological. To the farmers in the two anecdotes above, it's likely an Broken and What We Can Do to Fix It. identity issue.

That is, in farming communities, one's stance on pesticides or so-called factory farms becomes a part of one's identity. Anyone who disagrees with you isn't just engaging in a reasonable disagreement — they're attacking your very identity.

How do we shift the discourse? How can neighbors learn to have reasonable — and honest — discussions about hot-button food issues?

It can be done. I've done it.

I've also not done it.

That is, with some people, I've been able to have a frank conversation in which each of us is honest. We spoke as human beings, despite some fundamental disagreements.

But in other cases, we couldn't get past talking points and slogans. Some people, for example, claimed that anyone who takes issue with pesticides or any other agricultural practice is "anti-farmer." When that's the case, talking to one another is a pure waste of time.

Right now, we stand at a point in history when most Americans are separated from the production of their food, but also when more and more of us are concerned about where it comes from.

that's not a reason to dismiss anyone. It's a reason for dialogue. Each side has something to learn and something to contribute. We can go in two directions. Either each side can become more polarized

Sometimes that enthusiasm gets ahead of our knowledge of farming, but

and more entrenched in their positions, or each side can open up to discussion. Let's take the high road.

American elites don't have to go offshore to hide their money

The first thing you notice on the cab ride from the airport to downtown Panama City is the skyscrapers. They're architecturally beautiful, but jumbled together as if there was no plan or consideration for how they might look next to one another.


What you might not notice is that they're nearly all empty.

Panama, a small Central American country with just 4 million people, has dominated the news in recent weeks.

For that you can thank the Panama Papers — a massive leak of private documents from the Panamanian law firm Mossack Fonseca, which serves well-heeled companies and individuals all over the world. The leaks exposed a vast global system of shady offshore tax shelters and the global elites that benefit from them.

A few months before Panama landed on the front pages of nearly every newspaper in the world, I visited the country and got a look at those empty buildings firsthand.

Unlike many travelers, I wasn't in Panama City to launder my illgotten cash or to hide my profits from meddling tax collectors (not least because I have neither). I was in search of beautiful beaches and perfect waves, both of which the country is well known for.



It was striking, however, that the most attractive resource the country advertises to the global elite is a hands-off business and tax climate seemingly designed for exploitation.

According to my cab driver (and Reuters), drug cartels are responsible for much of the building boom in Panama City.

For cash-laden criminals unable to drop their funds in a checking LETTERS TO THE EDITOR account, investing in a Panamanian commercial building makes a lot of sense. They carry excess cash into the country by hand and convert it into an appreciating asset that can remain empty for years. Never mind that many Panamanians live in rickety shacks and dire poverty.

Many who take advantage of Panama's lax business climate never Dear Editor: have to step foot in the country. Named in the Panama Papers were 12 current or former world leaders, 128 other public officials and politicians, and hundreds of other elites — from well known celebrities to enigmatic businessmen — from over 200 countries.

They each in some way used Mossack Fonseca to create hard-to-trace shell companies to hide their assets. Those companies helped their owners evade taxes, public scrutiny, legal action, or all three.

Iceland's prime minister, Sigmundur Gunnlaugsson, was forced to step down in the face of massive public protests after he was named in the leak. British Prime Minister David Cameron, Russian leader Vladimir Putin, and famous soccer player Lionel Messi have faced significant public scrutiny as well.

Notably, few American names have been listed to date. That could change in revelations to come, but it also might not. States like Delaware offer very similar hands-off approaches to regulation that individuals and companies can exploit to hide their business dealings without going


One single address in Wilmington, for example — 1209 North Orange Street — is listed as the headquarters for 285,000 separate businesses exploiting Delaware's lax laws. Indeed, both Hillary Clinton and Donald Trump have firms registered in that two-story office building.

In fact, the Tax Justice Network ranks the United States third in the world for financial secrecy, behind only Switzerland and Hong Kong. Downey and Firestone, and more touches at City Hall. Panama is No.13.

As the saying goes, behind every great fortune is a great crime. And the Panama Papers provide the tools to begin prosecuting some of the more egregious crimes of tax evasion and corporate irresponsibility. Many countries have already begun to take action on this front, the United States included.

Perhaps more importantly, the leak provides an impetus for muchneeded public pressure to fix our rules so they work for everyone — not just the tax-dodging elites and their shady shell corporations.

Congresswoman seeks answers from mobile app

Representative Linda Sánchez (CA-38), chairwoman of the Congressional Hispanic Caucus and a member of the Congressional Anti-Bullying Caucus, sent a letter to Nuistars Inc., the developer of Ogle, a social media app which allows high school students to post photos, videos and text anonymously on campus specific forums.

Ogle has been used to post threats to schools across the country, including a recent threat to Cerritos High School which turned out to be a hoax.

In the letter to Nuistars, Sánchez raised concerns about the lack of accountability for those posting inappropriate or offensive comments, pictures and videos to Ogle. The letter also asked Nuistars to address three specific questions on Ogle's operations regarding threats and bullying:

What mechanisms is Ogle using to report and review inappropriate content?

How does Ogle cooperate with law enforcement?

What recourse do individuals, many of whom are minors, have when lewd photos of them are posted without their consent?

Below is the full text of the letter

Dear Mr. Jiang,

Recently, a student anonymously posted a serious threat on the page of a high school in my district on Ogle. Since then, students, teachers and parents have raised alarm that Ogle users have also been posting inappropriate images, and pejorative comments about other students. While I understand the intent of this app is to "connect to your campus in a fun, creative way," I, like many in my community, have concerns about the way this app is being

Ogle allows students, many of whom are minors, to operate behind a wall of anonymity. As such, I am increasingly concerned by the amount of bullying and harassment on the app, and the lack of accountability for those posting. While school teachers and administrators have the ability and flexibility to address this kind of conduct on school grounds, they are not able to intervene in comments transmitted over the internet (cyberbullying). The anonymous posting of these comments makes it impossible to hold individuals accountable for derogatory, inappropriate and mean-spirited remarks that have major implications for the children they are targeting. More than one in four children in America will be bullied either at school

or online. Bullying has serious consequences for youth. It contributes to high dropout rates, increased absenteeism, and significant underachievement, can lead to physical and psychological issues and in some tragic cases, suicide.

Given the recent events in my district, I would appreciate a response to the questions below about Ogle's policies and welcome any additional information about what Ogle is doing to combat cyber bullying.

What mechanisms is Ogle using to report and review inappropriate

How does Ogle cooperate with law enforcement?

What recourse do individuals, many of whom are minors, have when lewd photos of them are posted without their consent?

Lakewood/Apollo intersection

Went in to note what I had just encountered at the intersection of Lakewood and Apollo (entrance to The Promenade), where the southbound traffic on Lakewood was held by a red, while the northbound traffic had a green for what seemed like a full minute, and then the light sequenced to allow Apollo traffic to enter Lakewood.

I thought that there should be an adjustment to the sequencing as there is no sound reason why both sides of Lakewood shouldn't have simultaneous "greens" for through traffic. His response was that they "were aware of the problem and they and their consultant were studying it."

It seems to me that that is bureaucratize for "nothing will be done until Armageddon occurs, or the guy in charge retires." Noted that I had been through that intersection before during the afternoon "rush" and had found southbound traffic backed up to north of Alameda getting close to the signal controlled entrance to the Landing, and that Downey was on the verge of succumbing to the same problem that is found on major east-west corridors in Norwalk: Too many traffic signals stacked too closely together causing major gridlock.

Lakewood used to be such a nice flowing corridor. It seems to me that all it takes is minor reprogramming so that whenever northbound traffic has a "green", the same color signal is displayed for southbound through-traffic. Perhaps the City Manager needs to be asked about this, and when he

thinks it will be resolved.

Perhaps if Downey was spending less money on "branding" they might

not need that sales tax increase that they're pushing? Oh, who am I kidding, they've boxed themselves over the years into the same severe financial corner that Vallejo, Stockton, and San Bernardino

found themselves in: Too much reliance on the magic numbers provided by CalPERS and the desire to buy some ephemeral "labor peace" with the "found wealth" that CalPERS was selling, but now the chickens are looking for that roost, and it is as it always is, the wallet of the taxpayer that will be clutched.

If they don't wish to be in bankruptcy court, they need to start taking (not looking at, but taking) some meaningful reductions in overhead starting with the City Manager's compensation package, and all of the department heads, then working down.

And, what are they going to do about the crime-center that Rio San Gabriel Park has become?



NORWALK- Best friends since their freshman year at Norwalk High School, seniors Celeste Larios and Kethzia Higuera will be two of only 1,000 high school students across the nation who will have the entire cost of their undergraduate studies covered through the coveted Gates Millennium

Larios and Higuera have pushed each other academically, earning a 4.99 and 4.6 grade point average respectively. Larios will attend Stanford to study environmental engineering and Higuera, co-valedictorian for Norwalk's Class of '16, will attend UC Irvine and study nursing. The pair can also request funding as Gates Millennium Scholars if they continue to a graduate degree program.

"We push each other. When one of us is struggling, the other will be there to offer words of encouragement," said Larios, who admitted that when they are together, it can be a bit awkward for others. "We do finish each other's sentences. Also, we tend to say the same things at the same time."

Larios and Higuera first met the summer before freshman year at tennis camp. When they arrived at Norwalk High for their first day of school, they were seated next to each other in the same first period class and formed a fast friendship. They quickly became best friends, bonded by their desire for a safer environment and their dedication to academic excellence.

The two became heavily involved with Norwalk High's Millennium Club, which focuses on promoting eco-friendliness. Though the Millennium Club is not affiliated with the Gates Millennium Scholarship, it acted as a springboard for their ambitions in higher education.

In addition to a full schedule of Advanced Placement classes, the pair assisted with the Norwalk High Friday recycling program, participated in beach clean-up days, supported the American Cancer Society's Relay for Life with their Key Club peers, baked treats for the Ronald McDonald House and volunteered in the Compton Initiative, a non-profit committed to beautifying and restoring Compton.

"This is a wonderful story of two determined students who share a love for humanity," Norwalk La-Mirada Unified Superintendent Dr. Hasmik Danielian said. "They have touched the hearts of teachers and fellow

In Memory of Donald Russell

May 14, 1919 - April 12, 2016



Downey resident for 95 years, one more from the Greatest Generation, Don Russell, passed just one month shy of turning 97 on April 12 at his home in Downey within 4 weeks of a diagnosis of bone cancer.

Born on May 14, 1919 on Coeur d' Alene Lake in St. Mary's, Idaho near where his mother's family

worked the sawmills in Harrison since 1891 having left Missouri via train and covered wagon. Many of the family relocated to Long Beach, California in the late 1910's where Uncle Henry Scheuer was subdividing downtown Long Beach with friends, the Bixby's. In 1921 at the age of 2 in his father's Maxwell, Don with his sister Katherine (Kitty), half-brother and -sister Robert and Jeanette Briggs, and parents, Allison and Pearle (Diehl) Russell moved to Downey to begin a chicken ranch with their roadside stand that was maintained by his mother during the Great Depression after the loss of his father when Don was 8 years old who is buried in the Downey cemetery. Don attended Downey Elementary school, and was the first class to attend the new junior high school on the Downey High School campus (the buildings remain on Brookshire Avenue). Don graduated from Downey High in 1938. Don's memories of the 20's are of vaudeville shows before the featured silent movie, all for a dime, at the Meralta and Avenue Theaters. Don would reminisce about the days driving through the orange groves with his brother and their friends, the Tweedy's, without getting caught.

During WWII, Don was stationed at Fort McArthur where he drove a Willy up and down the west coast as part of the communication motor pool; then, was shipped overseas to support the Battle of the Bulge. It was during his 5 year tour of duty that he would daily swing through Downey to get his personal car to drive to the South Gate roller

the young girl, Janice Lucken, that would soon become his wife of 69 years before her passing four years ago. After their marriage January 1943, she moved to and worked on the base with Don until he was shipped overseas. After the War, he designed and built their home in Downey where they raised their five children. They were partners in business throughout their married life, she attending to the bookkeeping of his milkman, Helms bread-man, street sweeping, and broom winding businesses, and he continued to run their apartment business until his passing.

For over 30 years Don and Jan worked tirelessly searching through microfiche to research their family genealogy and discovered Don's ancestry traced back to the American Revolution, were the first white settlers of Ohio and Michigan where Johnny Appleseed was a regular visitor, were family friends of George and Martha Washington, and that Don is related to Princess Diana/Prince William by their grandfather, the Third Earl of Sunderland.

In the 1950's, Don and Jan enjoyed taking their family on vacations in their travel trailer to all parts of the western United States and beyond. The two of them began traveling the world extensively in 1966 reaching all continents and hundreds of countries, some multiple times including 6 trips to China and to Alaska, and have traveled several times across the continental United States by various means, including in their motor home reaching every state including Alaska, and had been on 54 cruises together. All of these trips were joined with the couple's dozens of friends. Don continued to travel after Jan's passing including taking his children, great and grandchildren on 12 more cruises.

Don is survived by his children, Gayla Rudolph-Emerson, Patty Russell-Rohrer and Kevin Russell, and 7 grandchildren: April Wolf, wife of Brian Wolf; Amy Wolf; Markie Rudolph; Rebecca Marrs-ElGharib and husband Bas ElGharib; Matthew Marrs and wife Rachel; Kimberly Fleck; Kelly Russell; Allison Rohrer; and 2 great grandchildren: McKenzie Wolf and Logan Wolf. Don was predeceased by his wife Jan, their daughters Cheryl Marrs and Debbie Russell, and grandson Downey Fire Department Battalion Chief Brian Russell Wolf.

A memorial service celebrating his life will be held at St. Mark's Church in Downey on Saturday, May 7th at 10:30 a.m.





Bellflower High School praised for emphasizing civics lessons

BELLFLOWER – Bellflower Middle/High School has earned recognition as a California Democracy School from the Los Angeles County Office of Education (LACOE) for creating and institutionalizing a highly effective civic-learning program.

Bellflower Middle/High's program teaches students to frame an inquiry into a public problem or issue, research the issue, engage in dialogue about perspectives on the issue, communicate their conclusions and take direct civic action on those

As part of their studies, students have provided homeless residents with toiletry care bags, urged Bellflower to install better lighting on crosswalks to shield pedestrians at night, studied efforts to adopt a district-based voting system and cleaned up a community park.

Bellflower Unified created the program as part of the three-year California Democracy School Civic Learning Initiative led by LACOE and funded by a grant from the S.D. Bechtel, Jr. Foundation. Eleven other high schools in Los Angeles and Orange counties also were selected for the program.

"Bellflower has accomplished something rarely seen in American schools," said Initiative Director Michelle M. Herczog, Ed.D. "They have fully integrated civic learning across every grade level in all social science classrooms. By doing so, civic learning is not seen as an 'addon' or burden on the curriculum but a way to enhance the teaching of social science to be rigorous, relevant and engaging for students."

The Initiative sought not only to seed civic-learning programs at each




