Police arrest 2 in Buffalo Wild Wings brawl

DOWNEY - Two people have been arrested for their roles in a wild brawl outside Buffalo Wild Wings last September, a fight that was captured on video and went viral on

Gabriel Fuerte, a 43-year-old resident of South Gate, and Josue Garcia, a 42-year-old Bell resident, surrendered to Downey Superior Court on March 8, Downey Police officials said Tuesday.

Their next court appearance was Thursday.

Police say that Fuerte and Garcia were involved in a brawl outside the Buffalo Wild Wings restaurant at Stonewood Center on Sept. 20. A bystander recorded portions of the fight and posted the clip on Facebook.

Downey Police said they identified Fuerte and Garcia after "an intensive investigation."

DOWNEY – Walmart, the newest addition to the still developing Downey Promenade, hosted a successful ribbon cutting and grand opening Wednesday morning, much to the dismay of many of Downey's

The morning's ceremony kicked off at around 7:30 am, and was attended by notable Downey

residents, including Mayor Alex Saab, former Mayor Mario Guerra, a few of Downey's royal court, and a section of the Warren Band led by Band Director David Niemeyer.

As a part of the opening to the ceremony, Guerra dedicated the store with a blessing.

"...We pouted. We cried. We were heartbroken because this location right here is special in the history of mankind...that was on May 10th. Mayor Saab also made a few comments and presented the store with a certificate of recognition on behalf of the residents of Downey.

Downey Chamber of Commerce President Cindy Kovach also spoke, adding "We are thrilled that [Walmart] are planning to be a partner with the Chamber and we look forward to a great association with Walmart."

The public outcry has been prevalent since then Mayor Pro Tem Saab announced Walmart's arrival late last year. The public's opinion was never more present when Downey Patriot Editor Eric Pierce published an article entitled "I Will Shop at Walmart (and you Probably will too)" earlier this week.

The outspoken response to Pierce's article seemed primarily negative, with many saying that they would take their business elsewhere; some even claiming to boycott the Promenade all together. Very few supported the store's opening, or instead decided to be optimistic.

Originally, a higher end store was planned to be the cornerstone of Downey's latest dining, shopping, entertainment enterprise. However, the final result of Walmart was claimed to be out of the city's hands by Saab in an article published in last year's Year in Review magazine.

Despite any negative feelings towards Walmart, however, Wednesday's ribbon cutting stayed peaceful and quiet without any known incidents.



DOWNEY - The Downey High School boys' swim team claimed their fifth straight S.G.V.L. championship by defeating cross-town rival Warren 172.5 to 140.5 last Thursday afternoon at the Downey Aquatics Center.

Paramount finished third with 68 points and Gahr finished fourth with 65 points, respectively.

The swim meet was close but the Vikings were able to pull away late after sweeping the 100 breaststroke. Marcus Powell won the 200 IM in a time of 2:04.66 and set a new S.G.V.L. record. Powell also won the 100 breaststroke in a time of 1:05.15.

I will shop at Walmart (and you probably will too)

DOWNEY - To be honest, this column started as an angry rant against Walmart, railing against the mega-retailer for its regrettable decision to open a store at the Downey Promenade, the new shining jewel of the Downey

It was an easy story to write, and a completed version sat on my computer desktop for several weeks.

But for some reason, I couldn't hit "publish." Something nagged at my conscience. Something about the article felt wrong - hypocritical even - but I couldn't put my finger on it.

And then it hit me: I am a Walmart shopper.

Last weekend, I made two separate visits to Walmart stores, including their new supercenter location on South Street in north Long Beach. The experience was pleasant ("pleasant" being a relative term).

American flags hung from the rafters and the aisles were brightly lit. Don't get me wrong, this Walmart store would never be mistaken for a Target, but things were orderly and clean. The workers were actually working.

Maybe it was a fluke experience, or maybe I wandered in before the shine wore off the new store, but this particular Walmart gave me hope for the

It's easy to dislike Walmart. First and foremost, it undervalues the worth of its employees and retaliates against workers who exercise their rights to protest for higher wages.

Its dependency on overseas manufacturing costs the U.S. hundreds of thousands of jobs. Its corporate owner is obscenely rich, to the detriment of our country and communities.

And then there are the tangible reasons to dislike Walmart, such as their fondness of installing 30 checkout counters but with only two lanes open at any given time. Their aisles generally are a mess. Their carts are wobbly. Those smiling, cheerful associates in Walmart TV commercials don't exist

But despite all those faults, I still shop at Walmart, out of necessity more than choice. If I can't find it on Amazon, or I absolutely need something right away and want to stretch my dollar, Walmart is the place to go.

I have a feeling Walmart's arrival in Downey would have been more welcoming had the store been located in another part of town, perhaps on the former All-American Home Center site. When Downey Studios closed several years ago, the Downey community was promised an upscale shopping and entertainment village, with high-end retailers. Those plans changed, obviously, and that was never communicated to residents.

Quite literally we were promised a Nordstrom's and got handed a Walmart. So in that sense, Walmart is the victim of circumstance.

The best we can do now is urge Walmart to be a good community partner. They're off to a promising start, sponsoring last week's State of the City address and donating thousands of dollars to Downey charities. I would like to see these gestures continue far into the future; there are many service clubs and non-profits in Downey that could greatly benefit from Walmart's

Let's give Walmart a chance.

"There's a lot to see on the east coast like Civil War battlefields," he said. "But the wall at the Vietnam Memorial is what I'd most like to

Unzicker served in Vietnam for 13 months starting in 1969 and has never had the financial means to see the national memorial dedicated to

his fallen comrades.

"I wanted to get a reverse mortgage to pay for the trip, but I had some mold and water damage in the house that needed to be

Last month, workers at Twin Home Experts overheard him mention his dream of visiting the memorial as they fixed his home. Dave Schuelke, who co-owns the business with his twin brother Jim, said it was only fitting to cover the costs of Unzicker's travel and accommodations.

"I heard the desperation in his voice when he called us for help to fix his home - and when he told us why, we wanted to do this for him to make a big difference in his life," Dave Schuelke said. "This guy has got such a huge, huge heart and he was just so grateful for everything

And the Schuelkes' went big with their surprise, lining Unzicker's street with a dozen Twin Home Experts vehicles and smiling employees with U.S. flags in hand.

"They think I'm deserving of this and I'm not going to argue with them," Unzicker said with a laugh. "I won't turn down their generous offer - it means so much to me."

Unzicker, who retired as a Teamsters truck driver in 2002, said he hopes to make his pilgrimage to Washington D.C. with his dog, Zoey, in spring 2017.



Those who know Congress best are shaking their heads

I had the good fortune last week to spend some time in Washington, D.C. with about a dozen former members of Congress. As you'd expect, we got to talking about the current Congress. Very quickly it turned out that the same reform efforts to make the institution work better — and were struck that question was troubling all of us: Why is it held in such low public esteem?

We represented both parties and a variety of eras, and had a range of experience under our belts. But we all found ourselves chagrined by what we've been witnessing. You have to understand that most former members of Congress believe deeply in the value of the institution for American representative government. We might take opposite sides of particular policy debates, but on one point we all agree: we want the institution itself to succeed and thrive. These days, it's doing neither.

For starters, we were hard-pressed to come up with any real accomplishments for this Congress. It did pass a revision to No Child Left Behind, and a controversial expansion of cyber-surveillance capabilities which it slipped into a must-pass budget bill. It also took the entirely uncontroversial step of broadening sanctions on North Korea. But that's

In the country at large, people are fretting about control of our borders, stagnant wages, college expenses, the cost of health care, the opioid addiction crisis, the spread of ISIS, the strengthening effects of climate change. The administration is trying to keep the Zika virus from gaining a foothold in this country, and congressional inaction has already caused Puerto Rico to default on one set of obligations, with a much bigger default looming - and doomed airline passengers to longer and longer waits as the TSA struggles. Yet on Capitol Hill, no one seems particularly concerned. Instead, its members left

This may be unfair, but I can't help but think about my first year in Congress. We enacted 810 bills, including the passage of Medicare and Lee Hamilton is a Senior Advisor for the Indiana University Center on Medicaid, the Voting Rights Act of 1965, the Elementary and Secondary Education Act, the Water Quality Act, and setting up the Departments of like that, but the contrast is inescapable. Among the group of people I was for 34 years. with last week — people who watch Congress closely — there was unanimity:

this will go out as one of the least productive years in congressional history.

Worse, members show little interest in making Congress more productive. Our little group all remembered times when we or our colleagues pushed current members aren't doing so. Most Americans belong to some group or another that's trying to accomplish change for the better and improve itself at the same time. Why would Congress be an outlier? But it is.

Some of the observations we shared last week are old hat. Congress is excessively partisan, with too many of its members highly distrustful of the other party and inclined to blame it for Capitol Hill's ailments. As an institution, it seems incapable of ridding itself of the bad habits it's gotten into: the reliance on omnibus bills and continuing resolutions; timidity in the face of presidential power; a marked reluctance to use the levers of congressional authority — especially control of the federal budget — to prod or check executive action.

Yet none of us believe this is irreversible. We are all convinced that strong leadership in Congress could make an immense difference. In the past, effective legislators on both sides of the aisle — as committee chairs and as caucus leaders — have left behind them a legacy of great accomplishment. Democrat Emanuel Celler of New York and Republican William McCullough of Ohio joined forces to craft the Civil Rights Act of 1964; Democrat Wilbur Mills of Arkansas and Republican John Byrnes of Wisconsin together helped shape Medicare.

I won't waste your time with a list of consummate legislators who were able to get things done. The point is simple: it may be a different time and legislative environment from 50 years ago, but strong leadership can make Congress work. On that, my former colleagues and I, Republicans and Democrats, found ourselves in full agreement.

Let's take decisive action on opiod abuse

Right now, people need our help.

Right now, thousands in Wisconsin and across America are struggling with opioid abuse. And that's why stopping this epidemic is a top priority in the House of Representatives.

The scope of the epidemic has expanded dramatically. Between 2004 and 2012, the proportion of deaths related to opioids increased by approximately 38%. About 4.3% of Wisconsin adults reported using heroin or other opioids in 2013, which was a marked increase from a decade earlier. In fact, every 25 minutes, a baby is born in America with drug withdrawal symptoms.

Prescription painkillers and heroin are the primary driving forces behind this epidemic. According to the federal Centers for Disease Control and Prevention, in 2014, 45% of people who used heroin reported that they were also addicted to prescription pain killers.

They've passed legislation to help combat opioid addiction and abuse. But now it's time for action on the national level.

This week, the House will pass a package of bills to curb opioid abuse, addiction, and deaths. One important piece of legislation is the Comprehensive Opioid Abuse Reduction Act, introduced by my friend, colleague, and fellow Wisconsinite, U.S. Rep. Jim Sensenbrenner (R-Menonomee Falls). His bill creates a comprehensive opioid abuse reduction program at the Department of Justice. This program will direct federal resources to the opioid abuse problem, and gives states the flexibility to attack opioid abuse issues in their

Other bills the House is considering this week will help local officials on the front lines of this fight. They will ensure federal dollars are going to programs with positive, evidence-based outcomes. They will also care for expecting mothers and their children, review how pain medication is prescribed, and help qualified veterans become emergency medical technicians to fight this crisis on the ground.

The Senate has passed bipartisan legislation by a vote to 94 to 1, and now Many states, including Wisconsin, have stepped up to the challenge. the House is following suit. We can win this fight. Now let's get the job done. Rep. Paul Ryan is Speaker of the House of Representatives.

A two-pronged assault on women

We heard a lot about the "war on women" during the 2012 election cycle mostly over Republican attacks on abortion rights and birth control.

While the phrase has faded in this election year go-round, the war on women has not. The only change is that now we're fighting on two fronts reproductive rights and economic survival.

To a man, the three Republicans still in the nomination race oppose abortion rights.

No surprise there. But Ted Cruz has upped the ante and come out against exceptions for rape and incest. John Kasich would allow the exceptions, but says there's no point in talking to him about choice.

The formerly pro-choice Trump is now not only against abortion, but blurted out recently what others undoubtedly believe but are too dishonest to say out loud — that the government should punish the women who have abortions. And probably the girls, too.

While reproductive rights are fundamental to women's well-being and autonomy, the right to fair pay and benefits is no less so.

After all, adult women are by far the majority of those working for the federal minimum wage. It's parked at \$7.25 per hour because the feds haven't

The legal base pay for tipped workers lags even further behind — it's been a measly \$2.13 since 1991.

Women make up 70 percent of tipped servers, and most of them don't work in those high-dollar, white-tablecloth restaurants. They're working in

low-level hash houses and places like Denny's and Red Lobster.

A Census report last year showed that the poverty risk for women spikes once they enter the workforce. For women with kids, the poverty rate is almost double that of men in the 25-34 age range — prime working years.

Some experts say the growing gap may be partly due to continuing high unemployment rates among single mothers. Could be — but I'm betting a bigger factor is the poverty-level minimum wage, which disproportionally affects women of color.

Every presidential candidate has weighed in on the minimum wage. While Hillary Clinton and Bernie Sanders argue over how much is enough — \$12 for her, \$15 for him — Cruz says \$0 is the right number. He'd do away with the federal minimum altogether, having deemed it a "bad policy."

In typical Trump fashion, the GOP front-runner has said America needs "good paying jobs," while declaring a preference for leaving the minimum at \$7.25. Not to be outdone on the contradiction front, Kasich says it's "very important that we don't raise the minimum wage willy-nilly," but then adds that Uncle Sam ought to let the 50 states set 50 different minimums if that's

All this adds up to a multi-pronged attack on low-wage working women, who are the least able to fight back. They're trapped by the ironclad partisanship on Capitol Hill, where Republicans have promised not to raise wages as long as they control Congress. And pushing back on those abortion restrictions states have been rolling out? Forget it.

Between Congress and the nut-case wing of the GOP calling the shots in the presidential race, the war on women promises to be a long one indeed. Martha Burk is the director of the Corporate Accountability Project for the National Council of Women's Organizations.







Paging Dr. Frischer...

My father taught me to drive when sirens, etc. I was 15. He showed me the rules of the road and how to be a safe and smart

driver. He was my role model for so many things, and it was because of his patient teaching that I gained my freedom with the keys to the family car. How tough it is, to face this issue



For most of us, there comes a time when it is appropriate for our aging parent to give up their car keys. The decision is likely to be a wrenching one. When is the right time to encourage, or even force them off the road? What might help to make the decision more clear? To make it even harder, this time often comes when they are already facing losses - health, loved ones, mobility, and now independence. For practical and emotional reasons, giving up driving is a transition that everyone involved wants to put off for as long as possible. It is no wonder that many adult children say that taking away the car keys was among the hardest things they ever had to do.

According to the AAA Foundation for Traffic Safety, the rate of accidents per mile of driving increases steadily after age 65. Still, age alone is not a predictor for poor driving skills. Older drivers actually cause fewer motorist and pedestrian deaths than drivers of any other age group. They are the most likely to wear seat belts, and less likely to drink and drive. They drive far fewer miles. Urging a family member to stop driving should only be motivated when you are convinced that they pose a danger behind the wheel.

Watch for changes in health, especially:

·Vision impairment – As eyes age, less light reaches the retina, and there is increased susceptibility to cataracts, glaucoma, macular degeneration, etc.

·Hearing difficulties - This can occur so gradually that it may take a while to even notice. It affects the ability to hear horns, screeching tires,

·Flexibility - Aging may diminish the ease of movement in the neck, shoulders, arms, and feet.

·Prescription drug use - New prescriptions can compromise driving ability and cause drowsiness, blurred vision, tremors, or other side effects.

·Alcohol and/or drug abuse -When combined with aging, the consequences can be even more serious. Alcohol, for example, stays in the body longer and tolerance declines. Many drugs, including prescription medications, interact badly with alcohol.

Be on the lookout for clues, including:

- •Traffic tickets, accidents, or a drastic change in auto insurance rates
- \cdot Damage that appears on the car Discrete reports from friends of poor driving

·Displays of tension or exhaustion during or after driving

- ·Complaints about getting lost ·Difficulty concentrating ·Reluctance to drive at night ·Difficulty seeing traffic lights Driving below (or above) the
- ·Slow reaction times ·Getting honked at

posted speed limit

A driving discussion with a parent should never be confrontational. It might begin with: "Mom/Dad, if or when you can no longer drive, how will you stay mobile?" If you have observed impaired driving, they have likely noticed it as well. Have a discussion about that traffic ticket or accident. Let your parent discuss their concerns, and then be there to help them with

Honor their feelings and let them take the lead in their own life - with your input and support. This will make a difference in their ability and willingness to give up their car, and make it a far less lonely and frightening prospect. If you live nearby, make a regular routine of stopping by to see them, and include them in your life. Offer to drive them to the activities they enjoy, to the market, etc. Include them in family outings. Encourage

them to take a bus, taxi, Uber, or to walk if possible. Help them develop new hobbies or routines and interests gardening, walking or swimming.

If there's resistance, it might be time to enlist professional help. My family once hired a private driving instructor who evaluated an aging parent "off the record." She not only gave an objective professional opinion about their skills, but also included driving tips and advice. When the time comes, your loved one's doctor or member of the clergy may have powers of persuasion. When I'm consulted, I weigh the risks and benefits for continued driving. I follow with an open and tactful discussion with the patient and their family, addressing options, and finally a negotiation for a workable plan. In the event where there is clear evidence of substantial driving impairment and a real threat to patient and public safety, I have an ethical duty to notify the DMV of any medical conditions that would impair driving. Ultimately, the DMV makes the final determination.

Through the years, I have found that a loving, cooperative approach between family and patient leads to the best outcome. Don't be afraid to tackle this difficult issue early, so that there is time to create a workable plan together.

Study: NFL players not at increased risk of suicide

Retired National Football League (NFL) players are at no greater risk of suicide when compared with the general U.S. population, according to a new study by the Centers for Disease Control and Prevention (CDC).

The findings from CDC's National Institute for Occupational Safety and Health (NIOSH) appear in the that don't require driving, such as May issue of the American Journal of Sports Medicine.

> The NIOSH researchers calculated the suicide death rate for 3,439 retired NFL players who played at least five seasons between 1959 and 1988 and compared it with the suicide death rate for gender-, race-, and agematched people from the general U.S. population.

> They found that from 1979 to 2013, the rate of suicide among these former professional football players was less than half of what would be expected compared with the general U.S. population.

> The NFL group experienced 12 suicide deaths compared with 25 that would be expected in a comparable gender/race/age sector of the U.S. population.

> "The issue of football players being at higher risk of suicide than the general population has been raised in the popular and scientific literature," said Douglas Trout, MD, Deputy Director of the Division of Surveillance, Hazard Evaluations and Field Studies at NIOSH. "In studying this particular cohort of professional football players, our researchers did not find this to be the case; more studies are needed before further conclusions can be reached."

> Based on previous information suggesting different risks for different positions, the researchers divided the players into two categories: speed positions such as quarterback, fullback, running back, and wide receiver; and non-speed positions, which include all defensive and offensive linemen positions. Punters and kickers were excluded from the analysis because their positions generally did not involve contact that resulted in head

> Fifty-eight percent of the suicide deaths were white players and 42 percent were black players, virtually equal to their representation in the entire group (59 percent white, 41 percent African American). The rate of suicide, or "intentional self-harm," was significantly lower in former NFL speed-position players compared with the general U.S. population. The suicide rate for non-speed-position players was lower than that of the general population, but the difference was not mathematically significant. There were also significantly fewer overall deaths from cancer, heart disease, and assaults/homicides among the former NFL players than in the

> CDC conducted the study to learn more about whether football players, who are at a higher risk of concussions when compared with the general U.S. population, might also have a higher risk of suicide.

> Although the study found no increase in risk of suicide, it does have several limitations. Records available to the researchers did not include information like environmental or genetic factors related to suicide risk or specific information about concussions among the players in the group studied.

> NIOSH first began to study the deaths of retired NFL players in 1994 after a request from the NFL Players Association. NIOSH has published two other studies for this group about death from cardiovascular disease and from neurodegenerative disease. This latest study adds to the current discussion about the relationship between playing football and suicide risk, but does not resolve the issue of whether suicide is more common among former football players.

> A Sefer Torah is a handwritten copy of the Torah on a scroll made from kosher animal parchment. It is written entirely in Hebrew by a trained sofer, or scribe. The scroll is mainly used in the ritual of Torah reading during Jewish services.

At other times, it is stored in the holiest spot within a synagogue, the Aron Kodesh (Holy Ark). This is usually an ornate, curtained-off cabinet or section of the synagogue built along the wall that most closely faces Jerusalem, the direction in which Jews face when they pray.

When my great-grandfather returned home, he was invited by several My great-grandfather, Reverend Edward Martin ("E.M."), was a minister churches in the area, and in other parts of the country, to show films and lecture about his trip. > After my great-grandfather and grandfather passed away, the lecture material was left in my Mom's care. In 1992, she donated the Torah to Temple Ner Tamid, a local synagogue in Downey, California.

> My parents met with Rabbi Ettelson and had an interesting discussion concerning its scribing. Mom was given a pointer and asked not to touch the printing. The Rabbi then showed them a silver pointer he used which was about six inches long and had a small hand at one end in a pointing position.

> Upon my parents' departure, the Rabbi gave them a copy of the Pentateuch. He also invited all of us to Simchat Torah scheduled for the forthcoming Sunday, during which their newly-acquired Torah would be dedicated.

> On May 20, 2011, I attended my friend Dora Silvers' Bat Mitzvah at Temple Ner Tamid. At that time, I talked with the cantor and the organist about the donated Torah that was among other Torahs being presented in a ritual fashion to the congregation. That was certainly a very moving, very memorable sight for me to witness.

> While looking through some family albums recently, I ran across the 1992 transmittal document I typed for Mom that explained the history of the gifted Torah. I then called the synagogue and asked if they would be interested in receiving a copy of Mom's document.

> My thinking was perhaps there were new leaders of the synagogue unfamiliar with the story behind the gifting. I immediately received a call back from Temple Ner Tamid President David Saltzman. He was very interested, and we agreed to meet before a Sisterhood dinner scheduled for November 13, 2015, at the synagogue.

> Upon meeting David, he escorted me to the Holy Ark where five Torahs are kept for safekeeping. The ornately-decorated cloths, or mantles, that cover the Torahs are breathtaking. David gently removed my great-grandfather's Sefer Torah from the Holy Ark and placed it on the podium for viewing. The excellent condition of the Torah and the reverent care in which David handled it brought tears to my eyes.

> After a very interesting and educational discussion, David carefully returned the Torah to and secured the Holy Ark. He then accompanied me back to the nicely-appointed dining area where I enjoyed a wonderful feast with my friend Dora and fellow members of Temple Ner Tamid.

CSULB graduation ceremonies are next week

LONG BEACH - California State University, Long Beach (CSULB) expects to confer a school-record of more than 10,000 bachelor's, master's and doctoral degrees for the 2015-16 academic year, with many of those earning degrees expected to walk across the stage at Commencement 2016.

The four-day celebration will highlight a collection of 10 graduation ceremonies at the Long Beach campus scheduled for Tuesday-Friday, May

The record-number of graduates comes as the university's graduation rates have reached all-time highs - 66.7 percent in 2014-15 with an additional increase expected this year. 

"Her enthusiasm is that of a first-year teacher," Reyes wrote in Slager's nomination form. "She has never lost the substantial sense of joy and excitement for teaching children to read and write. This enthusiasm is

Slager's students see themselves as scholars because she sees them in that light, Reyes wrote.

In an interview, Reyes recalled how Slager connected with a fourthgrader who had been a challenge for teachers to motivate.

"She racked her brain for ways to get him to engage. Then, she found





Project Location: The project site is located at 9553 Firestone Boulevard and surrounding properties bound by Firestone Boulevard to the south, Newville and Pangborn Avenues on the east and west espectively, and the southerly boundaries of residential properties that line the south side of Ardine Street in the City of Downey.

Project Description: The proposed project involves a GPA request to change the General Plan Land Use designation of the southerly half of the planning area from General Commercial (GC) to Medium-Density Residential (MDR). The MDR land use category is designed to accommodate multi-family developments ranging in density from 18 to 24 units per acre. The requested MDR land use designation matches the General Plan land use designation of the northerly portion of the planning area, which the City changed in 2005 as part of the General Plan Update.

The only exception to the requested MDR land use designation is the planning area's southeastern corner (9601 Firestone Boulevard). For this property, the proposed GPA entails changing the General Plan land use category from GC to Neighborhood Commercial (NC). The requested NC land use designation better reflects the size of the lot and its existing improvements, which includes a recently renovated three-tenant commercial building.

Zone Change: The planning area currently maintains two zoning designations: Neighborhood Commercial (C-1) and Parking Buffer (P-B). Incidentally, the Downey Zoning Code (Article IX, Land Use, of the Downey Municipal Code) no longer references the P-B zone. All mention of it was removed from the Zoning Code in 2008 when it was updated. The Downey City Council removed the P-B zone because it was considered redundant since the development standards of the City's residential and non-residential zones provide the same safeguards as the former P-B zone. The only trace of the P-B zone is the City's Zoning Map and properties on the map that still maintain that classification.

The Zone Change application is a request to change the zoning in the planning area from P-B and C-1 to Multiple Family Residential (R-3). Among the City's zoning classifications, the R-3 zone is the classification that best corresponds with the requested MDR General Plan designation. The purpose of the R-3 zone is to provide for the development of multiple-family residential projects.

Home prices continue to climb, but affordable markets still exist

Home prices are climbing due to a limited number of homes for sale in many markets. In the first quarter, home prices surged 6.3 percent year-over-year, reaching a median of \$217,600, the National Association of Realtors reports.

But home buyers in Cumberland, Md., for example, can still snag some deals. Homes there cost a median of \$67,400 in the first quarter, the lowest in the nation. That stands in stark contrast to San Jose, Calif., where the median existing single-family home price was \$970,000 in the first quarter, the highest in the nation.
