

According to its website, ALDI offers a "no-frills grocery shopping experience [that] focuses on customers first - delivering high quality food they're proud to serve their family, responsive customer service, everyday low prices and a quick-and-easy shopping experience with only four to five aisles and all the essentials.

"We carry the most commonly purchased items and display them in their designed shipping boxes to help save time and resources to restock

Access to the ALDI store will be via Lakewood Boulevard and Nash Avenue.

Hahn, Napolitano lay out plans for Fourth District at candidates forum

DOWNEY - The two top candidates vying to replace Don Knabe on the Los Angeles County Board of Supervisors agreed the county must do a better job of supporting the region's most vulnerable communities during a Tuesday night forum in Long Beach.

"L.A. County is a safety net - and it's our job to make sure people don't pollution. fall through the cracks," said Rep. Janice Hahn, (D-San Pedro).

The congresswoman – and former L.A. city council member – is running against Steve Napolitano, a former mayor of Manhattan Beach and Knabe's

'You deserve a voice and I want to be that voice," Napolitano said before a sanctuary of 400 people at First Congregational Church of Long Beach.

During the candidates' forum, hosted by the Coalition for a Just L.A., nearly a dozen community organizations and advocacy groups presented Hahn and Napolitano with a broad range of chronic issues facing the Fourth

Responding to questions, the two candidates differed less in ideology

and most in style. While Hahn framed herself as a heartfelt visionary with national experience, Napolitano portrayed himself as a knowledgeable problem solver with local experience.

Both agreed in the need for expanded affordable housing and increased revenue to pay for such projects. Last October, the county moved to create a new affordable housing fund intended to set aside \$100 million by 2021.

"We need to put that money in a lock box like we do in Congress so we don't even talk about using it for anything else," Hahn said.

Napolitano, however, said the county can't rely on just money alone, but must incentivize housing developers to incorporate low-income and senior housing into new developments.

Each candidate committed to safeguarding benefits for undocumented immigrants by increasing access to health care and protecting residents from deportations that separate families.

Hahn also promised to use her experience in Washington D.C. to jumpstart the county's early childhood education program by acquiring available federal funding.

She affirmed support for the county's efforts to seek a special tax on people earning more than \$1 million per year. The funds would go towards homeless services, namely transitional housing.

Napolitano does not oppose the tax, but maintained it isn't enough to tackle the problem comprehensively.

"The 'Millionaires' Tax' only brings in \$250 million and we need \$500 million," he said.

Taxing things like marijuana sales could help raise more money for this housing, Napolitano added.

Both candidates advocated for new environmental policies to address air

"We don't have to choose between clear air and jobs – we can have them both," said Hahn, who suggested third-party oversight of emission levels at the ports of Long Beach and L.A.

Conversely, Napolitano added the need for a broader policy that looks First elected in 1996, Knabe is being termed out of his Fourth District into clean truck lanes on freeways that would encourage eco-friendly trucks.

> If no candidate receives more than 50 percent of the vote, the two top finishers will face-off in November. The winner will represent nearly two million people in the county's Fourth District, which stretches from the South Bay, down to Long Beach, and up through the Gateway cities to Diamond Bar.



The importance of open access to Downey's space center

DOWNEY - A few weeks ago, the Downey City Council approved a measure to allow all students going to school in or residing in Downey to visit the Columbia Memorial Space Center for free.

I am very thankful to the Mayor and the City Council for their vision and support of this initiative. My mom worked at a local school. Free access to the Museum offered our family a frequent day out, transforming the Museum into a valuable resource for both bonding as a family and learning.

Being able to visit the with its exhibits, I fell in love with the wonder and beauty of science, explored new ideas and exercised my creativity, gaining an appreciation for science as an expression of who we are as humans and how we see the world. Easy access to the Museum enabled this learning and affected my life.

Opening the Space Center for free to the students of Downey is deeply meaningful to me. I know the power places like the Space Center can have on young people and I am so thankful, proud and excited to be in a place that is offering all members of the next generation great learning experiences and the ability to make their own memories. 



The case for limited government

It has been 35 years since Ronald Reagan's first inaugural speech as President — the one in which he said, "In this present crisis, government is not the solution to our problem; government is the problem." Over that time, hostility toward government seems only to have grown, led by politicians and embraced by millions of Americans. In this most recent presidential campaign, Republican candidates outdid one another in calling to abolish the agencies they were running to lead, including the IRS, the Department of Education, the Environmental Protection Agency, and the Department of

I find all this troubling. Not because I think those agencies — or the government as a whole - are faultless, but because I don't see how a democratic society and market economy can function without an effective government. Capitalism and a representative democracy may need to function separately for this nation to be strong, prosperous, and free, but they also need to work together.

In fact, I'd argue that limited government is more often part of the solution than it is a problem. It funds core functions — infrastructure, basic research, the court system, education, anti-crime efforts, national security — that allow private markets and the private sector as a whole to flourish. It sustains national parks, interstate highways, libraries, medical research, the air traffic control system and other services that make this a vibrant society.

It strives to protect Americans from hazardous food and drugs, unsafe workplaces, discriminatory employers, and toxic polluters. It has played a key role in asserting fairness for minorities, women and the most vulnerable people in our society.

This is not to say that government does not overreach, or that it always performs as it should. On occasion, its leaders make poor and misguided decisions; its legislators, however well intentioned, create wasteful and unneeded programs. And every time something like this happens, there are many of us waiting to bash government.

When it performs as it should, on the other hand, few people notice and even fewer of us stand up to defend it.

But let's get real here. What's the alternative? We're not going to do away with government, give unfettered free rein to the market, and hope that someone decides to try to make a go of delivering core services. Nor are we going to go all out and establish government ownership of the means of production. Instead, we have to make the sometimes comfortable, sometimes uneasy co-existence of the market and the government work.

So it's crucial for our political leaders to hit a pragmatic note and strive constantly to find the right balance between the two. To debate and then establish in clear terms where government should and should not be active. To test what works and what does not and then pursue the former and shut down the latter. To work hard to wring duplication out of the bureaucracy and rigorously pursue efficient, effective, and accountable government. To make sure that enforcement of the law is both tough and fair. And to recognize that their focus on policy needs to be balanced by a focus on effective management and implementation of programs.

The fact is, government has not changed much in size over the decades. For the last 50 years, federal net outlays have fluctuated between about 16 and 20 percent of GDP, with the occasional dip below or spike above. The total federal workforce stood at 5 million in 1964 and 4.2 million 50 years later. Whether it's a Republican or a Democrat in office, government doesn't seem

Nor, really, do most people seem to want it to. As a politician, you can always get applause for quoting the old Thoreau line (which he in turn paraphrased), "That government is best which governs least." But start listing what government does that affects people's everyday lives, and you'll see members of that same audience nod their heads in agreement. It's the balance Patty Jackson between limited government and the private sector that it's our job constantly to assess, debate, and get right.

Big banks can be beaten

When the 2008 financial crash slammed the New York City construction industry, Maribel Touré's husband lost his job as an architect. On top of that, Maribel suffered a serious accident.

But what really plunged the family into financial trouble was sending their daughter to college.

As a child growing up in Mexico, Maribel's father had repeatedly told her that la educación es la clave — "education is the key." So she worked hard to obtain a college degree in Mexico and then moved to the United States, where she became a radiology technician.

Maribel wanted the same opportunity for her daughter to obtain "the key." But high tuition bills strained the family budget and pushed them to the brink of foreclosure.

"The government was helping the banks, but they refused to help me," Maribel said recently. "I never stopped working and I never stopped paying my taxes — the same taxes the government was giving to the banks."

Maribel is just one of many Americans who were hurt by the financial crisis and want more done to crack down on the Wall Street greed and recklessness that caused it. That's why she's added her support to a new Take on Wall Street campaign that aims to channel widespread public anger over our broken financial system into concrete, bold change.

The campaign's priority reforms would help ensure that Wall Street pays its fair share of taxes. The additional revenue could be used for urgent needs, such as making college more affordable for families like the Tourés.

A small tax of just a fraction of a percent on each stock and derivative

trade, for example, could generate massive revenue while also curbing short-term speculation. For ordinary investors, such a tax would be hardly noticeable. The real targets would be the high-speed traders who now dominate our financial markets while adding no real value to the economy.

Closing tax loopholes that now encourage excessive executive pay could also generate much-needed funds for social programs or public investment to fix our crumbling national roads and bridges.

One of these loopholes lets private equity and hedge fund managers pay a 20 percent capital gains rate on the bulk of their income — just half of the nearly 40 percent top rate the wealthiest Americans normally owe. As a result, billionaire financiers pay a lower tax rate than millions of our country's teachers, firefighters, and nurses.

Maribel Touré ended her story on a hopeful note. She said that after feeling guilty and ashamed about her financial problems for a long time, she decided to fight back.

She joined New York Communities for Change, a coalition of working families in low- and moderate-income communities that fights for social and economic justice. They worked with local officials to put pressure on her bank, so she was able to modify her mortgage loan in time to save her house.

Her story, she said, shows that if we join together, we can win against

Trump's 'realty check' on climate

Newsflash: Donald Trump isn't as retrograde on climate change as we thought. It turns out he's well aware of the dangers of global warming — at least to his golf courses.

The Republican presidential hopeful is so concerned, in fact, that he's petitioned the Irish government to let him build a seawall to secure his luxury golf course and hotel on the County Clare seaside.

According to an application filed by one of Trump's companies, to "do nothing" as the ocean continues to eat away at the waterfront greens would pose a "real and immediate risk" to Trump's beachfront property. And it explicitly cites rising global temperatures as the root of those threats.

As any good neighbor would, the real estate magnate also sounded the alarm to local residents. A brochure circulated by his company to surrounding towns makes the case for coastal protection, pointing out that more frequent storms brought on by global warming will increase the rate at which beaches disappear in the coming decades.

Climate change, Trump seems to be saying, is an existential threat to his Irish golf course. But what does he say about it here in the United States? It's a Chinese-orchestrated "hoax." It's "BS." It's "pseudo-science."

It doesn't stop there. Trump's also picked a pro-oil and coal climate denier as a top energy adviser. And he's promised to trash domestic rules and

international agreements that cut carbon pollution.

Apparently the billionaire-turned-politician is happy to appeal for government support to protect his overseas assets. But he's not on board with public policies meant to keep his fellow Americans and their homes safe.

And the threat to his fellow Americans is very real.

A recent study by the humanitarian group Christian Aid calculated that 34 million people in the United States — that's 10 percent of us — will be living in towns and cities exposed to coastal flooding by 2030. The eastern

Miami ranks eighth for world cities whose residents face being washed out. It's forecast to shoulder the highest financial costs from rising oceans of anywhere on earth, with \$3.5 trillion in exposed assets over the next 50 years alone. New York City, Trump's hometown, comes in a close third at \$2.1 trillion in expected losses.

But when the storms come, it won't be people like Trump who pay the

Horse racing's shame and ours

One horse was already dead as Pramedya saddled up for the fourth undercard race of the 2016 Preakness Stakes, an annual Triple Crown race held in Baltimore. Unlike Homeboykris, who died of apparent heart failure after winning the first contest of the day, she wouldn't even reach the finish line.

A spectator's hand-held video is all that remains of the racehorse's fatal run — the bulk of the Internet since scrubbed by the guardians of this so-called "sport." In the clip, Pramedya stumbles awkwardly along the infield fence, her fractured leg dangling grotesquely in front of her.

The footage ends prior to her being euthanized on the track.

The demise of these two innocent animals is pretty much par for the course for a day of racing in America. As noted in a 2012 New York Times report, an average of 24 horses die each week for our entertainment. The overall number is likely higher, given the reluctance of industry officials to report casualties, nearly all of which occur at lower tier tracks and during training.

Greed, corruption, performance-enhancing and pain-masking drugs, and breeding practices that make horses prone to injury all contribute to these premature deaths. None of these transgressions, however, would be possible without our tacit approval.

To the detriment of those around us (and probably to ourselves), we humans have mastered the art of denial, compartmentalization, and rationalization. In a country whose masses routinely profess their love for animals, how else to explain the delirium of the record-setting Preakness crowd at Pimlico, even as jockey after jockey flogged their respective horses down the home stretch?

This capacity to distance ourselves from our actions — and their consequences — is part and parcel of our conflicted relationship with

We invite some into our homes to be our companions, while sending billions of others to slaughterhouses. We voice outrage when a captive gorilla is shot, yet we hunt and fish countless other animals to death.

Treatises have been written about how we've managed to get to this point. And while there's no definitive answer to that question, I do believe it's possible to return to a place where our hearts and words live in harmony with our actions toward animals.

Recall how it felt to be lost in the moment watching an animal, any animal, simply being himself or herself. If you're having difficulty remembering such a time, make a point of studying a child having that experience. It won't be long before you recognize the wonder in their

Create similar opportunities for yourself. Along the way, you'll notice that each animal you observe displays characteristics that are unique, as well as universal — reflective of both their individuality and our shared kinship.







Congresswoman writes letter to mobile app creator

month to Nuistars Inc., the developer of Ogle, a social media app which allows high school students to post photos, videos and text anonymously on campus specific forums.

Ogle has been used to post threats to schools across the country, including a recent threat to Cerritos High School which turned out to be

In the letter to Nuistars, Sánchez raised concerns about the lack of accountability for those posting inappropriate or offensive comments, pictures and videos to Ogle.

The letter also asked Nuistars to address three specific questions on Ogle's operations regarding threats and bullying.

The full text of the letter is below:

Dear Mr. Jiang,

Recently, a student anonymously posted a serious threat on the page of a high school in my district on Ogle. Since then, students, teachers and parents have raised alarm that Ogle users have also been posting inappropriate images, and pejorative comments about other students. While I understand the intent of this app is to "connect to your campus in a fun, creative way," I, like many in my community, have concerns about Newcombers Club fashion show the way this app is being used.

Ogle allows students, many of whom are minors, to operate behind a wall of anonymity. As such, I am increasingly concerned by the amount of bullying and harassment on the app, and the lack of accountability for those posting. While school teachers and administrators have the ability and flexibility to address this kind of conduct on school grounds,

The anonymous posting of these comments makes it impossible to hold individuals accountable for derogatory, inappropriate and mean-spirited remarks that have major implications for the children they are targeting.

What recourse do individuals, many of whom are minors, have when lewd photos of them are posted without their consent?

I was born in Hong Kong, the eldest of eight children. My parents met on Po Tai Island, which is part of Hong Kong. My father only went to school for six years, and he became a farmer and a fisherman on Po Tai Island. There he met and married my mother.

Many years later, my family moved to an urban area in Hong Kong, and my father started to work as an owner of a family knitting factory. My parents put their energy into the knitting factory, and my grandparents took care of the family. There were twelve family members altogether.

When I was a senior in my high school, I met Ringo, my future husband, during my summer job. I worked at my father's knitting factory, and it was the first job in my life. I went with two other friends to work in the quality control department.

On the first working day, three of us were waiting in front of the factory's front desk to fill out employment forms. Ringo worked there as an office assistant. Ringo greeted us and handed us our time cards to clock in.

Working in a knitting factory was very boring, even though I had friends who worked and talked with me. Most of our co-workers were older women. I noticed Ringo always walked around us; he sang songs when he approached me. When I went to lunch with my friends, I saw him wearing sunglasses and singing with a low voice at the factory's entrance.

One day, both of my friends didn't go to work. Ringo asked me to go to lunch with him. We just ate at a nearby restaurant. He told me that he was a returning summer job worker and he was a senior high school student too.

After the first lunch, Ringo always appeared in front of me with a smile on his face. I was happy to see him rather than checking numerous knitting items for flaws.

Two months after my summer job was over, Ringo waited for me at the bus stop. He told me that he wanted to visit his aunt. She was living in my neighborhood. We had a great conversation on the way home.

When I got off the bus, we walked for a short distance and he bought two red bean popsicles at a roadside snack bar for us to eat. Then he asked me for my phone number. After that, he always called me to go study at nearby libraries.

My parents and my grandparents knew that someone was attracted to me. They put pressure on me because they didn't want me to have a boyfriend when I was a student. I didn't know how to resolve this conflict with my family.

Eventually, they stopped giving me money for my studies. I needed to pay all of my tuition and daily expenditures when I was in college. My college life was difficult. I became a tutor after school, and Ringo and I worked on weekends. Ringo studied electronic engineering.

My college school time, part time jobs, and dating occupied all my time. As the oldest girl, I was expected to bear most of the responsibility of caring for my seven younger siblings while my parents worked. Many years after I knew Ringo, my family still opposed Ringo.

After I finished college, my first job was being a scriptwriter for a television broadcasting company. Ringo worked at Jockey Club as a technician. Even though Ringo tried to have a good relationship with my family, my family still didn't like him.

Ringo saved his salary to buy an apartment that was being built. When the apartment was completed, we got married in 1984. It was nine years after Ringo and I first met.

I was committed to marrying Ringo, but I also wanted to please my both of our parents. We followed their instructions to have our wedding party at their favorite expensive restaurant. We invited all of their friends and relatives to come. We had almost three hundred guests attending our wedding. Eighty percent were my family's guests. After the wedding, for a long period of time we had to balance our budgets and pay off our debts.

My grandparents eventually accepted my husband, and many years later, my parents did as well. My parents lived with us for about ten years, and Ringo helped to take good care of them. Ringo and I moved to the United States in 2000 and we now have 2 children.

I have known Ringo for over forty years. I consider him as an intimate friend rather than a husband. He totally understands me; sometime he can read my mind. I am very grateful to Ringo for his kindness to each member of my family. I think no one can replace him.

In Memory of Raymond Glenn Richart, Sr.

June 21, 1920 - May 14, 2016



Raymond Glenn Richart, Sr. returned to live with his Heavenly Father on May 14, 2016. He was born June 21, 1920 in Eagle Rock, CA to Fabin and Pearl (Sullivan) Richart. He was the youngest of three children. After graduating from Eagle Rock High School he attended Glendale Junior College and Pasadena City College. While attending GJC, he participated in the newly organized, government funded program called the Civilian Pilot Training Program. To help the war effort, Raymond joined the United States Army Air Force, now the U.S. Air Force. He flew the C-46 aircraft over the infamous and treacherous "Hump". The Hump was the name given by Allied

pilots of WWII to the eastern end of the Himalayan Mountains over which they flew military transport aircraft from India to China to resupply the Chinese war effort and the units of the United States Army Air Forces based in China. For its efforts and sacrifices, the India-China Wing of the Air Transport Command was awarded the Presidential Unit Citation on January 29, 1944 at the personal direction of President Franklin D. Roosevelt, the first such award made to a non-combat organization. The pilots were expected to fly 35 missions during their tours; Raymond flew a total of 110 missions over the Hump. He and other Hump pilots are honored at a monument at the Air Force Academy in Colorado Springs, Colorado. He retired from active duty in November of 1946 as a Major, and was a member of the Inactive Duty Armed Forces until June of 1980.

After WWII Raymond was a flight instructor, then joined the Los Angeles County Sheriff's Department. During his years as a deputy, he was written up in the newspaper for singlehandedly thwarting two armed robbers in the process of attempting to rob a bank. Raymond returned to educational endeavors, obtaining his Bachelor's Degree from the University of Southern California. He later received his Bachelor of Laws degree from Southwestern University School of Law, after which he worked for the Bureau of Investigations of the Los Angeles County District Attorney's Office, retiring as an Investigator IV, overseeing five offices, in 1980. Raymond retired with 31 years of service in Los Angeles County. Assemblywoman Cristina Garcia has posthumously awarded a resolution to honor Raymond Glenn Richart, Sr. for his distinguished service.

Raymond is survived by his beautiful wife of nearly 57 years, Teddie Lee Halley Richart; his sons, R. Glenn Richart, Jr., Paul K. Richart and daughter, Cynthia M. Richart Marroquin. He is also survived by his nine wonderful grandchildren: Kelly, Kristen, Kevin K., Steven, P. Kevin, Amanda Rae, Eric, Nicholas Ray and Erinn; and three step-grandchildren: Jeff, Julie and Valerie. Granddaughter, Karley Knox, predeceased him in 1996.

Raymond lived an amazing life during his almost 96 years, and if you asked him, his proudest accomplishments would be his family, who looked up to and honored him for the wonderful man that he was.

Services were held to honor his life on May 21, 2016 at the LDS Church in Santa Fe Springs. He was interred at Forest Lawn Cemetery in Cypress with full military honors.

on Dec. 16, 1936. She was preceded in death by her parents, Medardo and Mariana Jimenez, and her husband, Miguel Angel Ortiz.








