Ricky Galvez murder suspects participated in crime spree before his killing, prosecutors say

DOWNEY – The three suspects accused of killing Downey police officer Ricky Galvez in a botched robbery are responsible for shootings and another robbery that occurred the same night Galvez was killed, prosecutors said this

Galvez, 29, was killed in the police station parking lot while sitting in his personal vehicle at around 11 p.m. on Nov. 18.

Jeremy Alvarez, 21, of Montebello; Steven Knott, 18, of Montebello; and Abel Diaz, 17, of Bellflower, have been charged with his murder.

On Tuesday, prosecutors filed new charges against the trio, alleging Alvarez and Knott conducted a takeover robbery at a Bellflower cell phone store at 5 p.m. on Nov. 18.

About five hours later, the trio conducted another robbery in Paramount,

Knott is also accused of firing a gun at an occupied building in South Gate in September 2015.

Prosecutors also filed attempted murder charges against a fourth suspect: 28-year-old Rebecca Ann Ustrell of Montebello. Ustrell, along with Alvarez and Knott, were tied to an Oct. 18, 2015 shooting at a Montebello

All three male suspects remain incarcerated without bail. Ustrell is being held on \$1 million bail.

All suspects have pleaded not guilty. Their next court appearance is set for Sept. 28.

Downey Police release use-of-force statistics

■ **POLICE:** Public filed three excessive force complaints since 2011; all found to be unsubstantiated.

DOWNEY - Only three use-offorce complaints were lodged against the Downey Police Department in the last five years, according to data released by the department last week.

The data shows that the vast majority of calls to which Downey PD responded between 2011 and 2015 resulted in peaceful resolutions.

Single complaints alleging excessive force were filed in 2012, 2013 and 2015. Of those three complaints, none were substantiated.

Police officers used force 372 times over the five-year span. There were four officer-involved shootings: two in 2011 and two in 2014.

"Of the 682,067 calls for service over the past five years, less than onehalf of one percent resulted in force being used against a person. And of the 372 uses of force by Downey officers over than span, only three resulted in a citizen complaint," said Police Chief Carl Charles.

"Incidents involving force are not a common occurrence at our department which can be attributed to the amount of training our officers receive and the professionalism they display on a daily basis," the statement said. "While every attempt is always made to bring situations to a peaceful resolution without using force, there are circumstances where a level of force is required to protect the public, the officer(s), and the subjects they are interacting with."

Mayor Alex Saab said the data "clearly reaffirms the true professionalism of our Downey police officers and the great job they do to protect and serve all that live and work within our community."

In New Jersey, student loan agencies don't tell borrowers about help until they ask

■ INVESTIGATION: It's yet another obstacle for borrowers from the country's largest state-based college loan program.

NEW JERSEY – Some restaurants have secret menus, special items that you can only get if you know to ask. New Jersey's student loan program has secret options, too — borrowers may be able to get help from the agency, but only if they know to ask.

New Jersey has the largest statebased student loan program in the country, with particularly stringent terms that can lead to financial ruin, as ProPublica and the New York Times recently detailed. The agency overseeing the program says it has a policy to help some families if the children who were supposed to benefit from the loans die.

"Families of deceased borrowers (or surviving cosigners) must inquire past four years, they have helped if HESAA has a policy on loan 35 of 50 cosigners or co-borrowers forgiveness," a supervising staffer wrote in an email to employees in May 2016. "We should not be volunteering this information."

Similar instructions were sent out three years earlier. "Only advise the cosigner/coborrower about loan forgiveness when asked," wrote the same staffer in a 2013 email about what to do when borrowers die. A senior supervisor was cc'ed on both

The agency said that the instructions were not agency policy.

Director Gabrielle Charette said at the board meeting in January 2013.

But that wasn't what happened. Instead, the agency only erased late payment reports if a borrower requested it.

"All reportings from Nov 2012 can be removed when disputed," a program officer instructed staff in an August 2013 email related to Hurricane Sandy credit reporting

Following the storm, the agency did put a note on its website telling borrowers to contact them if they were struggling and says it sent written notice about the delinquency policy to borrowers.

When asked about credit reporting after the storm, initially Karrow stood by the statements of the executive director. "Regarding Hurricane Sandy, no delinquencies were reported to any credit agency during the month of November, 2012," she said in an emailed statement to ProPublica.

But when ProPublica showed

reported late in November 2012, the agency changed its response to say officials had discovered that credit reporting had not been suspended, "as had been directed by the Executive in the early days following the storm."

The instructions to staff illustrate just one side of the agency's hardnosed approach in dealing with struggling student borrowers.

As we have detailed, repayment of New Jersey's loans cannot be based on income and borrowers who struggle to find a job or face financial hardship are given few breaks.



Officials with the Greater Los Angeles Vector Control District also confirmed West Nile virus in samples taken from Pico Rivera, Glendale and Lincoln Heights.

Year to date, West Nile virus has been found in 98 mosquito samples and 31 dead birds within the Vector Control District's service area.

"Whether you're concerned The blog is operated by Pam about West Nile virus or Zika, the solution is the same," said LEvy Sun, the district's public information officer. "Residents must get rid of standing water around their home, and wear insect repellent to avoid mosquito bites."

> West Nile virus is primarily found in birds, and is transmitted between birds and to people and horses by mosquito bites.

According to the CDC, "most people infected with WNV will have no symptoms. About 1 in 5 people who are infected will develop a fever with other symptoms. Less than 1% of infected people develop a serious, sometimes fatal, neurologic illness."







Incarcerated parents

Dear Editor:

Incarcerated parents are not getting their needs met due to multiple barriers, especially when it comes to receiving visitations from their children.

For instance, WIC 361.5 does not specify which entity (child welfare agencies, prison facilities, or caregivers) has the responsibility of transporting children to visit their incarcerated parents. It only states that children should be provided with "transportation services, where appropriate." Therefore, child welfare workers and caregivers could disagree as to where this responsibility lies, yielding low visitation rates.

Child welfare workers are further discouraged to provide transportation given that over 60% of state prison inmates are incarcerated at an average of over 100 miles from their last residence (Mumola, 2000). This lack of agency accountability is evident when comparing visitation rates between incarcerated parents and their non-incarcerated counterparts. In their study, D'Andrade and Valdez (2012) found that approximately 40% of incarcerated parents complied with their visitation orders, whereas 70% of non-incarcerated mothers, and 60% of non-incarcerated fathers complied.

Incarcerated parents also lack consistent access to court-mandated services required to successfully achieve reunification. D'Andrade and Valdez (2012) found in their study sample that only 12.5% of incarcerated mothers and 0% of incarcerated fathers received domestic violence services; 32.1% of incarcerated mothers and 17.6% of incarcerated fathers received substance abuse services; 43.5% of incarcerated mothers and 36.4% of incarcerated fathers received mental health services; and 41.4% of incarcerated mothers and 33.3% of incarcerated fathers received parenting classes.

As a result, only 25.8% of incarcerated mothers successfully reunified with their children, half as likely as their non-incarcerated counterparts. Incarcerated fathers did not fare any better as only 13.5% reunified, one third as likely as their non-incarcerated counterparts.

It is therefore crucial to increase the availability of court-mandated services for incarcerated parents, but who will fund these services?

Access to welfare programs

Dear Editor:

There seems to be a vexatious disconnect between the beliefs of the Republican Party and the needs of marginalized and disenfranchised communities. Specifically, their views on state welfare programs.

In 1996, the Republican Congress enacted The Welfare Reform Act. The objective was to eliminate as many individuals as possible off the welfare rolls and transition them into the workforce.

The policy introduced which outlined the process is TANF (Temporary Assistance for Needy Families). TANF is a designated welfare to work program. In order to qualify for aid, applicants must meet the following requirements: must be a U.S citizen and child(ren) must be a citizen or have eligible alien status, must be seeking employment, child(ren) must be 18 or under with the exception of those individuals who are enrolled in school full-time with an expected graduation date before the age of 20, applicant must have a child under the age of 18 living in the home, and if the applicant is pregnant it must be within one month before due date.

Under this program, families are eligible to receive aid up to five consecutive years. In addition, a family must meet a certain annual income, including assets, in order to qualify for aid.

However, state requirements create barriers for many families that would otherwise qualify. For example, a family may have a combined income that is over the federal poverty line but may struggle with basic necessities. This family may have to make a choice between paying for shelter and going without food.

This family could benefit from the SNAP program, however, income criteria may disqualify this family from receiving aid. In addition, families' whose assets exceed program income guidelines may be deemed ineligible. For example, a family may not have many assets, but possess a car worth \$9,600 and that would be over the vehicle asset limit requirement, hence creating a barrier to eligibility.

Although the Republican platform pushes against this type of assistance, welfare programs are needed to improve the lives of those in need. Welfare programs can be of great benefit for those who are in need, but the requirements for eligibility must be realistic and make the aid accessible, and not create unintended barriers.







The life story of my late sister Phyllis, nicknamed Foddy, I believe, is the ultimate in forbearance and fortitude, and any other adjective in Webster's Dictionary that describes picking yourself up, dusting yourself off, and finding the courage to carry on.

I won't even go into the disastrous first marriage to the father of her three sons. She husband of several years, and was


> And, guess what - even the daughter-in-law apologized and asked forgiveness for her past treatment of this lady who just wanted to love and be a part of her grandchildren's lives.

Without a doubt, Phyllis would be joking and making you laugh with her cute ways and comical antics, like saying at the end of the workday: "let's get the hell out of Dodge."

My sister got on with the business of life as best she could, and like a circus clown, wore a smile on her face for others around her even though there lay profound sadness in her heart.




























Good Samaritans praised for stepping into action

County District Attorney Jackie Lacey on Wednesday honored four women and two men who aided victims and helped capture and prosecute violent criminals in Long Beach and Willowbrook.

"What our honorees did was not easy," Lacey said during the Courageous Citizen Award ceremony in Long Beach. "These brave people chose to act. They saved lives and helped stop criminals. By honoring them today, we repay their courage in a small way."

Lacey recognized two Long Beach women for saving a neighbor who was bludgeoned by a bat-wielding man; two women and a man for aiding an elderly victim and then helping police catch the assailant in the violent attack in Long Beach; and a Metro employee who risked his own personal safety to thwart an assault on a woman at a Green Line station in Willowbrook.

The luncheon ceremony was held as part of the Rotary Club of Queen Mary.

The honorees were:

Debbie Carr, 66, of Lakewood; and Noelle van Deursen, 45, of **Long Beach:** Ms. Carr and Ms. van Deursen rushed to the aid of a Long Beach woman after she was beaten in her home on Oct. 11, 2013, by a man wielding a baseball bat. The woman was the target of a murder-

for-hire plot by her daughter and

her daughter's boyfriend.

Ms. Carr and Ms. van Deursen heard the woman's cries for help and found her severely beaten. They assisted the victim while she told them about the attack. Their quick action helped save the woman's life, and their statements helped police arrest the daughter, her boyfriend and the man hired to kill the victim.

A jury convicted the daughter and her boyfriend of conspiracy to commit murder, attempted murder and robbery. In spring 2015, each was sentenced to 31 years to life in state prison. The man who beat the victim was convicted of first-

LONG BEACH - Los Angeles Long Beach meeting aboard the degree robbery and sentenced to 10 years in prison.

> Laura Astrin, 37, of Seal Beach; Amber Goebel, 38, of Long Beach; and Luis Enrique Vieyra, 39, of Long Beach: Ms. Astrin, Ms. Goebel and Mr. Vieyra came to the aid of a 74-year-old man who was struck in the head and knocked down by a 24-year-old man for no apparent reason. The senior, who was blind in one eye and using a walker, was walking on a Long Beach train platform on May 7, 2015, when he was attacked.

> Ms. Goebel and Mr. Vieyra witnessed the incident and told Ms. Astrin, who called 911 and followed the defendant. Ms. Goebel and Mr. Vieyra stayed with the victim until paramedics arrived. Officers apprehended the assailant based on information Ms. Astrin provided. Ms. Astrin, Ms. Goebel and Mr. Vieyra were crucial in securing a conviction in the case.

On Feb. 22, 2016, the defendant pleaded no contest to battery with serious bodily injury and was sentenced to four years in prison.

Lawrence Sears, 57, of Los Angeles: Mr. Sears was working as a custodian at a Green Line Metro station on June 4, 2015, when he saw a man struggling with a woman over her purse. As the man began to punch the woman in the face, Mr. Sears intervened, placing himself between the woman and her assailant.

The defendant continued his assault, trying to fight off Mr. Sears while also attempting to grab the victim's purse. The man then focused on attacking Mr. Sears, who used a trash-picker to protect himself. Ultimately, Mr. Sears tackled the defendant and held onto him until a sheriff's deputy arrived at the scene.

On Aug. 4, 2015, the defendant pleaded no contest to two counts of assault by means of force likely to produce great bodily injury and one count of assault and battery. Three months later, he was sentenced to two years in state prison.



Norwalk still split on how to fill Rodarte's seat

NORWALK - The Norwalk City Council still remains split concerning former Councilmember Marcel Rodarte's vacated seat, and as such was not able to come to a decision on how to fill the empty seat at Tuesday's council meeting.

Former Councilmember Rodarte resigned from his position earlier this year in order to accept a job as executive director of California Contract Cities Association.

City Council currently has two options to fill the now empty seat.

City Council may, within 60 days of the vacancy, make an appointment to fill the vacancy. Because the vacancy occurred within the first half of Rodarte's term, the person appointed to fill the vacancy would hold office until the next general municipal election, which is March 7, 2017.

At that time, the appointed person, should they desire to continue in office, would have to run for office to retain the seat through the remainder of the term, which will end March 19, 2019.

The City Council may choose to call for a special election to fill the office for a term to expire March 19, 2019. The special election must be held at the next regularly established election date not less than 114 days from the call of the special election, which would now be March 7, 2017.

This is also the city's next regular members of the City Council. If this option is selected, the ballot would list three City Council seats; two full fouryear terms and one two-year term.

Councilmember Leonard Shryock reminded both his fellow elected officials and those in attendance at Tuesday's meeting that despite the issue's importance and need for resolution, the council has proven that they can work together despite the current vacancy, already passing several items since Rodarte's departure.

"We've voted on some 60 plus items...," said Shryock. "...We've already proven we can work together. The city issues are too important to be deadlocked..."

However, almost ironically, discussion of the issue had quickly become heated even before Shyrock's comments, especially between Councilmember Luigi Vernola, who favors option one, and Vice Mayor Cheri Kelley who is calling for option

Specifically, Kelley believes that the public should be allowed to vote for Rodarte's replacement. However, Vernola fired back with the possibility of deadlocked issues in the coming

"I see this as an opportunity to continue the good work that we're doing," said Vernola. "There are going to be issues - important issues


