Many factors are linked to breast cancer risk. Some factors affect risk a great deal and others by only a small amount. Some risk factors you can't change.

For example, the two most common risk factors for breast cancer, being a woman and getting older, are not things you can change. Other factors you may be able to control. For example, leading a healthy lifestyle may help lower your chances of getting breast cancer.

Understanding which factors may affect your risk can help you work with your health care provider to address any concerns you may have and develop a breast cancer screening plan that is right for you.

Age: Age is an established risk factor for breast cancer in both women and men. The older a person is, the more likely she/he is to get breast cancer.

Age at First Period: Starting menstrual periods at a young age is linked to a small increase in breast cancer risk. For example, women who began their periods before age 12 have about a 20 percent higher breast cancer risk compared to those who began their periods after age 14.

Alcohol: Many studies show that drinking alcohol increases the risk of breast cancer. For example, findings show that women who have two to three alcoholic drinks per day have a 20 percent higher risk of breast cancer than non-drinkers.

Birth Control: Current or recent use of birth control pills (oral contraceptives) slightly increases the risk of breast cancer. Studies show that while women are taking birth control pills (and shortly thereafter), they have a 20 to 30 percent higher risk of breast cancer than women who have never used

Breastfeeding: Breastfeeding lowers the risk of breast cancer, especially in premenopausal (before menopause) women.

Fruits & Vegetables: Studies show that eating vegetables may slightly lower the risk of some breast cancers. Eating fruits may also help lower breast cancer risk.


Height: Many studies have that shown taller women have an increased risk of breast cancer.

Weight: Gaining weight in adulthood appears to increase the risk of breast cancer (both before and after menopause).

Race & Ethnicity: Rates of breast cancer in the U.S. vary by race and ethnicity. White women have the highest incidence (rate of new breast cancer cases) overall, while Asian-American and Pacific Islander women have the lowest.

For Lars Clutterham, music is life

DOWNEY – Lars Clutterham's motor is always running. It's not just the inaudible thrum of energy you detect under his skin, it's the polyrhythms of contained impulses competing for expression as he leans forward and his hands and shoulders and upper body move to shape his thoughts and feelings. It's no surprise therefore to learn that at 68, he's been a lifelong musician. Music is visibly alive in him.

It's no surprise either to feel an even higher level of enthusiasm as he contemplates the upcoming October 22 Downey Symphony world premiere of his most ambitious composition, Suite for Orchestra, aka Downey Celebration Suite, which will share the bill with Gustav Holst's epic The Planets.

Cutterham's peripatetic career, which has taken him from Illinois to Florida to Paris to San Diego, had kept him locked down in the Hollywood film industry work for years.

women who have two to three "I'd been living in Downey for a long time and wasn't doing any alcoholic drinks per day have a writing, "he says over lunch pecan pie a la mode at Carrows.

"My wife's family had season tickets to the Downey Symphony. I thought I'd write an encore piece for them, and sent it on to [Musical Director] Sharon Lavery at USC. It was a tonal scherzo piece, accessible and straightforward. 'I like it,' she said. I didn't hear any more about it until I thumbed through the program for this season and saw my name on the bill. Then she said, 'I need seven more minutes.' So I wrote them for her."

Clutterham's local emergence seems a long time coming. For a lengthy period during his 18-year Downey residency, which he began as music director at Downey United Methodist Church in 1992, he worked as a copyist and proofreader at the Twentieth

Century Fox Music Library in Culver City. Sometimes, improbably, he bicycled to work—an hour-and-a-half each way—his head filled with musical ideas. Most of his work involved the minutiae of music preparation for film scoring, which includes orchestration, conducting scoring sessions, and transcription. This last category is crucial. An accidental dot left in the wrong place can change the duration of a note and completely alter a musical score.

"I must've worked a thousand scores," he says. "One day I'm sitting with my feet propped up on a paper stack. 'What am I using as a footstool here?' I wondered. It was the score for 'E.T.' Another time I worked on a score I thought had the dumbest name. It was 'Forrest Gump.'"

Whether the stresses of film work caused a bout of Meniere's disease, which begins with dizziness and vertigo and proceeds to severe hearing loss—catastrophic for a musician—he decided to cut back. Major shifts in the directions of his life were no new thing; once his father earned his Ph. D. in computer science at the University of Illinois, he moved his family (Clutterham has three younger siblings) around the country before settling in Orlando, Florida. Fortunately, music was their constant companion; his mother and siblings all played. One sister became a ballet dancer.

"I went to four high schools in four years," Clutterham says. "One of them was in Chatsworth. I was comfortable with the changes. I don't remember ever meeting a new person or making a new friend. Music was my substitute for all that."

For a while Clutterham took his piano studies with the highest seriousness. At age 12 he did well enough in a piano competition to play a Beethoven piano concerto with the Florida Symphony ("That was good for my little ego"), but shortly afterwards adolescence hit ("sports, girls"). He lost the stomach for discipline and turned to pop music. He made a stab at it again at Cornell College in Iowa and, after graduating, a year's piano study in Paris under the nononsense tutelage of Blanche Bascourret De Gueraldo at the Ecole Normale de Musique.

But in the high-pressure, highly competitive world of the musical soloist, you can't miss a step along the way. It was a restless time. The whole western world, it seemed, was in ferment over the war in Vietnam (Clutterham possesses a strong social conscience). He taught for four years at a Quaker school in Pennsylvania, but couldn't shake the idea of writing film scores and worked his way into the industry after writing commercial music in San Diego and moonlighting as a club pianist.

Now he's back where he feels at home.

His description of the Serenade's opening movement seems to mirror his restless nature as various solo woodwind instruments skip across a full orchestral landscape.

"The second movement is slow, with two things going on, the progression of a sunrise and a lyric idea spelling out the name of Downey. The third has an urgent rhythmic passage in a minor key, with acknowledgment of the Latino community—the theme makes use of Latin percussion."

Asked about his musical influences, he mentioned the choral austerity of Poulenc and the harmonics of Debussy.

"Yeah, I can live with that."

His face brightened.

"This pecan pie is pretty good. I think I'll have another slice."

Everything seemed bright at the moment.

Planning Comission approves more housing for Downtown Downey

DOWNEY — An effort to create more housing downtown continued this week as the Planning Commission approved a six-unit housing development on 2nd Street.

Located at 8117 2nd St., across from the post office, the development includes six townhomes ranging in size from 1,770 square feet to 1,943 square feet.

Homes will be three stories tall with attached two-car garages. Five of the six units include 3 1/2 baths, with one home providing 2 1/2 baths.

The homes will be similar in design and floor plan, five of the six units

featuring a bedroom and bathroom adjacent to the garage. The second floor features a kitchen and dining room connected in an open concept configuration.

Each of the homes will come with balconies ranging in size from 38 square feet to 102 square feet.

Access to the homes will be via a single driveway on 2nd Street.

In a staff report, city officials said the development will be built in a modern architecture design.

"Decorative LED lighting will be provided throughout the development," the report reads. "Lighting along the driveway portion of the lot includes impact resistant LED wall luminaires along [the] east wall. LED wall sconces will also be provided in between the garages."

Last week, city officials held a groundbreaking ceremony for Village Walk, a new development of 28 townhomes at 3rd Street and La Reina Avenue.

Each of the homes will be three stories tall. The first model homes are expected to be completed by April, and the entire development could be finished by December 2017.

"Housing is integral to the development of Downtown Downey," said Mayor Alex Saab. "This is part of the puzzle we've been envisioning having downtown for many years."

Meanwhile, 117 three-story townhomes are being built on Paramount

Vacant for more than a decade, the 6.5-acre property at 10734 Paramount Blvd. includes three separate lots that lie in between 5th and 7th streets. The largest lot is 241,000 sq. ft. and once housed three medical buildings known as Gallatin Medical Center. The two smaller lots were previously used for surface parking.

Couple convicted of infant child's death

DOWNEY – Last week a judge found a Downey couple guilty of Enforcement Agency. inflicting child abuse on their 4-month-old child, which led to the infant's death.

Los Angeles County Superior Court Judge Raul A. Sahagun found Ashley Debra Jones, 26, guilty of second-degree murder and child abuse in a court trial.

Additionally, the judge found true that the defendant inflicted great bodily injury on the victim. Also, it was found true that Jones willfully caused and permitted the child to be injured and harmed and that injury and harm resulted in death.

Jones' co-defendant, Johnathan Lucero, 26, was found guilty of felony child abuse in the same case. The judge also found true that Lucero willfully caused and permitted the child to be injured and harmed and that injury and harm resulted in death.

Sentencing for Jones and Lucero is scheduled for Nov. 15 in Department D at the Los Angeles County Superior Court, Norwalk Branch. Jones is facing 15 years to life in state prison, while Lucero faces 10 years in state prison.

Deputy District Attorney Franco Baratta, who prosecuted the case, said Jones, Lucero and their 4-month-old daughter were living in an apartment they shared with Lucero's family.

On the morning of Dec. 31, 2015, Jones found the infant unresponsive and called a family member for help, the prosecutor said. The family member called 911 and when paramedics arrived they took the child to the hospital, who was soon pronounced dead, the prosecutor added.

A day after the child's death, Jones and Lucero were charged in connection with the incident.

According to court testimony, the 4-month-old baby was beaten. She was malnourished and had skull fractures, cerebral contusions, multiple rib fractures, a lacerated liver, bruised lungs and contusions to her diaphragm.

EMT student saves choking woman at BJ's

DOWNEY – A Rio Hondo College emergency medical technician student put his classroom training into practice this month when he stepped in to help a choking woman at an area BJ's Restaurant and Brewhouse.

Mark King Jr., 23, of Lynwood, was celebrating a friend's birthday at the restaurant in Downey on Sept. 16 when some of the guests told him a woman at the party was in distress, possibly having trouble breathing.

"They know I'm in school for EMT, that I'm CPR-certified and I know what to do," King said. "I rushed over and asked the woman if she was choking or if she just

couldn't breathe. She pointed at her throat and gave the universal sign that she was choking. She was gasping for air."

King sprang into action.

"I got into position to give the Heimlich maneuver, the procedure you do to help someone who is choking. I gave three to five abdominal thrusts, and the food that was lodged in her airway came out," he said.

The student's poise and presence of mind were praised by Rio Hondo College leaders.

"Mark embodies the essence of the community service mindset we try to foster at Rio Hondo College," Superintendent/President Teresa Dreyfuss said. "I'm proud that our training played a pivotal role in helping him save this woman. He is a true hero."

King who works at Disneyland, said he had been considering the EMT program for a while.

"I like helping people and I thought this would be a good field to go into. I have a couple of friends in the field and I have an older cousin who is an LVN," King said.

To join the EMT program, King first needed to take a basic fire tech course over the summer. Then, in August, he began the eightweek program, which meets from 8 a.m. to 2 p.m. four days a week. He picked Rio Hondo College because the program has a sterling reputation while remaining affordable.

King said his experience at the restaurant solidified his drive to Facebook. become an EMT.

"It reassured me that I'm able to act under pressure, to execute the procedures in a safe and effective manner, to help someone," he said. "It also made me feel great."

SPORTS BRIEFS: Football regular season begins Friday for Downey, Warren

DOWNEY – The Downey High School football team will host the Dominguez Dons tonight in the S.G.V.L. opener for both schools.

Downey finished preseason schedule with a record of 4-1 and Dominguez enters tonight's game with a record of 1-4. Downey is coming off their bye week where several key players have rested up and gotten healthy.

Downey defeated San Pedro at San Pedro 27-21 on 8/26, was defeated by Hart at Downey 30-20 on 9/2, defeated Burbank at Downey 7-6 on 9/9, defeated Millikan at Millikan 48-21 on 9/16 and defeated Chino Hills at Downey 42-22 on 9/23.

Thus far, Viking quarterback Trevor Hill has completed 69/130 pass attempts for 860 yards with seven touchdowns and two interceptions. Hill is averaging 172 yards passing a game.

Downey running backs have carried the ball 181 times and have accumulated 1,337 yards on the ground. The Vikings average 267.4 yards rushing per game and 7.4 yards per attempt. Emari Demercado has carried the ball 53 times for 454 yards, Baraq

Ross has carried the ball 49 times off their bye week where several for 395 yards and Asfunso Elam key players have rested up and has carried the ball 23 times for 197 yards.

Save the Rancho trees

Research links income inequality to the poor fitness of America's youth

The United States, anyone could reasonably argue, has the most accomplished elite athletes in the world. The best evidence? In Rio this past summer, young American men and women finished at a comfortable first place in the Olympic final

But what if we compared nations on the fitness of average young people, not elite athletes? How would the United States stack up then?

Not too well, concludes a global study just published in the British Journal of Sports Medicine. This new research — conducted by a team of academics from Canada, the United States, and Australia — looked at the fitness levels of 1.1 million young people aged 9 to 17, from 50 different nations.

In this competition, young people in the United States didn't finish first. They start charging parents hefty fees if their kids want to play school sports. finished an appalling 47th out of 50.

"If all the kids in the world were to line up for a race," report author Dr. Grant Tomkinson summed up, "the average American child would finish at the foot of

How could the United States, a nation that prides itself on nurturing Olympic champions, have an overall population of young people so unfit?

The new study doesn't answer that question directly. But it does make a fascinating connection. In nations with smaller gaps between rich and poor, young people show higher levels of fitness.

Income inequality, as the study puts it, appears to be a "strong structural determinant of health" in children and youth.

This linkage won't surprise anyone who's been following research on inequality. In recent years, investigators have detailed that people in societies with lower levels of inequality live longer than people in nations with high inequality, like the United

Residents of more equal nations also trust each other more, bully each other less, and enjoy better mental health.

But why should social indecency and ill health thrive in unequal places? And, more pointedly, what explains the link between inequality and youth fitness?

No one knows for sure, but analysts have some ideas. Some lean toward a fiscal explanation. In unequal nations, they point out, wealth and political power tend to concentrate in the hands of an awesomely affluent few. These privileged individuals typically don't use public services and often resent having to pay taxes to help fund them.

In deeply unequal nations, this combination of political power and resentment ends up generating government budgets that gut public services the rich seldom use — everything from public parks to public education.

Amid the resulting fiscal austerity, public parks start closing. Public schools

As a result, fewer kids get to play and exercise. A top-heavy distribution of

wealth translates, in effect, into less-active childhoods. Other analysts take a more physical approach and focus on the stress that inequality inevitably generates. This ongoing stress pounds relentlessly on our immune systems. And the things we take for relief from that pounding — drugs or

sugar-packed snacks, for instance — typically leave us less fit. Both these fiscal and physical explanations have merit. And both help us understand the importance of doing all that we can to reduce inequality.

If we want to see all kids have the chance to become champions in life, we'll need to start adopting, as the authors of the new global fitness study conclude, "policies aimed at reducing the gap between rich and poor."

Despite threats by the Saudi government to sell billions of dollars' worth of their assets and reexamine the bilateral relationship with the U.S., Congress snubbed the monarchy and passed the bill, then overturned a presidential veto to it almost unanimously.

This is just one of the most overt pieces of evidence that the historically cozy U.S.-Saudi relationship is on the decline.

A couple years ago, few questioned the decades-old political alliance between the U.S. and Saudi Arabia. But, amidst a heated election season in the U.S., the bloody Saudi-waged war on Yemen has led to a wave of protest by Capitol Hill lawmakers and human rights organizations who want to reexamine this relationship.

During the Obama administration, a whopping 42 weapons deals have been brokered between the U.S. and the Saudi government, worth over \$110 billion. However, the latest deal, amounting to \$1.15 billion, was met with unprecedented opposition over concerns of apparent Saudi war crimes in Yemen.

In a letter to the White House, 64 members of the House of Representatives Dear Editor: asked President Obama to withdraw the weapons deal, and 27 Senators voted in favor of a resolution opposing the deal.

Humanitarian and human rights organizations like Oxfam, Amnesty International, and Human Rights Watch got involved in the opposition movement too, pointing to the nearly 10,000 deaths and injuries caused by the Saudi war on Yemen using U.S.-made weapons.

Major media outlets like The New York Times penned editorials slamming the

This is a welcome and overdue change for many who believe that Saudi Arabia's war crimes in Yemen shouldn't go unpunished, but it's also an important moment to rethink the entirety of the U.S. alliance with Saudi Arabia and the U.S.' role in the Middle East.

The tension between the U.S. and the Saudi monarchy isn't just manifesting in the legislative branch of the government — the executive branch has also sent clear signals that the tides are turning.

In 2015, President Obama, along with Secretary of State John Kerry, orchestrated one of the most successful diplomatic wins of the administration: the Iran nuclear deal. The Saudi monarchy, nervous about the geopolitical and sectarian trends in the Middle East apparently aligning against them, felt threatened by the deal and lobbied in Washington against it.

This didn't stop the White House and State Department from pushing the deal through, much to the chagrin of the Saudi royal family.

While this eroding relationship is a much welcomed change after years of watching the U.S. government turn a blind eye to human rights abuses committed by Saudi Arabia and other regional allies, the path forward isn't clear.

Hillary Clinton and Donald Trump both have problematic visions for the United States' future relationship with the regime.

Trump, a notorious Islamophobe who called for an open ban on Muslims coming Congress recently passed the Justice Against Sponsors of Terrorism Act to the United States (and who's blamed Saudi Arabia for 9/11), hasn't proposed a

> On the other hand, a Clinton administration will likely opt to continue the business-as-usual blank check support to our traditional allies in the region, including Saudi Arabia.

> So while it seems like we're entering a new moment of opportunity to change U.S. policy regarding the regime, real change won't come in the next few weeks

> It'll take years of hard work to persuade the next administration how rethinking

our role abroad is in the best interest of America, nations in the Middle East, and the innocent victims of violence between the two.

In all honesty, the sign should read "Parking Scam, Beward of Fraud." Shame on you, this is Downey. We're better than that.



My neighbor on the corner is doing some remodeling. The contractors have built a large pile of dirt in the side yard, and they are hauling it away bit by bit at the end of each work day. Our back yard has some uneven places, some left where trees had been removed over the years, and others newly created by the excavations of our dog. Since we are having a party in a few weeks, I intend to fix some of those holes, and this looked like a good opportunity.

Toward the end of the day, I go over and ask the workmen if I could take some of the dirt. I bring my shovel, along with a trash can and a dolly. I think that the trash can would hold a few shovels-full, and with several trips I could fill a few of the holes.

The men are packing up for the day, and I see that they were storing some of their shovels in a corner of the back yard along with a pile of scrap wood. They have an old wheelbarrow leaning up against the fence.

"Mind if I borrow the wheelbarrow?" I ask. Maybe I can get a couple of quick trips before they leave.

"Sure," they say. "Put it in the corner and close the gate when you're done." I'm free to take my time. I uncover the wheelbarrow from under some discarded wood, bring it out to the pile, and proceed to fill it up.

In earlier times, I have done my share of shoveling dirt. But it has been a while since I loaded a wheelbarrow, took hold of the two handles, and walked the weight of it down a path. It takes me a moment to recover the feel of the load as it bounces along balanced on one wheel.

A wheelbarrow is not a cart. A cart will stay motionless until you push, and will stop when you stop. The wheelbarrow relies

I concentrate as I push the load of dirt out of my neighbor's other to keep the load balanced, while at the same time guiding it safely down the driveway as it bounces on its soft wheel — up onto the walk, over the bumps, and into my back yard.

I dump the dirt near the little gully that I am trying to fill, and retrace my steps around the corner to the neighbor's dirt pile for another load. As the empty wheelbarrow bounces on its tire, free of its burden, the frame rattles and twists.

The backbone of a wheelbarrow consists of two stout pieces of wood, spread apart at one end and shaped to form handles. At the other end, the pieces of wood are drawn almost together to support the axle for the wheel.

of the opening (the handles) connected by a metal brace. The bucket of the wheelbarrow rides on the middle of these two beams.

Laid down flat, it would look like a shallow "V," with the ends

a heavy lacing of bailing wire serves to hold the two pieces of the frame together. Now with the bucket empty, this flexible connection moves a little with each change of surface.

This brace has been cracked apart by repeated flexing, and

Dents and pockmarks cover the bottom and sides, the memory of shovels stabbing at wet cement, and chunks of concrete and stone thrown into the bucket on countless demolition jobs.

Where rivet heads hold the bucket bottom to the beam, the friction of stucco sand mixed by hand in the wheelbarrow has worn the steel so thin that fine holes are just beginning to break through the bottom. And the entire bucket is twisted a little bit, the result of some trauma that has left this wheelbarrow useful, but permanently disfigured.

But it's good enough for another load for me, and probably many more for the crew that will throw it up into the truck on top of everything else when they pack up for the last time.

It comes to me, the feeling of how much I love tools like this. So much of our doing, our building, our striving, pounded into the steel of this simple object, mute, but for me, more of a memorial than some of the grand constructions that we build.

County commission on drugs, alcohol formally opposes Prop. 64

County Board of Supervisors' Commission on Alcohol and Drugs voted unanimously last month to oppose Proposition 64, the ballot measure to legalize recreational marijuana.

The commission is an appointed body of alcohol and drug experts, who among them have experience in the substance abuse treatment field, city government, community advocacy, and law enforcement.

The commission advises the Board on alcohol and drug issues with the goal of reducing problems and the negative impact of substance use disorders on the quality of life for individuals and their families residing in Los Angeles County.

Following three-hour a moderated debate between and opponents proponents of Prop 64 and after multiple questions from community members, the Commissioners were unconvinced that legalizing recreational use would benefit our youth and communities. In an LA County Department of Public Health Auditorium, full with over 100 attendees, the commission unanimously voted
















Norwalk headlines list of cities opposing Measure M

NORWALK - The Gateway Cities and South Bay Cities Councils of Governments, representing nearly half of the 88 cities in Los Angeles County, oppose Measure M, the projected \$121 billion sales tax increase proposed by the Metropolitan Transportation Authority.

Measure M is intended to improve transportation throughout the county, but its priority list means that some communities won't get completed improvements for decades, city officials said.

"Measure M pushes back improvements to the I-5, I-605, and I-710 for 40 years. We don't think it's fair for working families to foot the bill today when they won't get significant traffic relief in their area for decades," said Michael Mendez, mayor of Norwalk.

Because Measure M puts many transportation projects in the region decades down the line, local elected officials have raised concerns about the expenditure of the projected \$121 billion in sales tax revenue.

"Who's to say there will be any money left when it comes time to do the work on projects like the I-405-I-110 interchange and the South Bay Curve," asked El Segundo Mayor Suzanne Fuentes.

As a sales tax increase, Measure M requires a two-thirds vote for passage. If passed, Measure M will double the transportation sales tax for injured workers. rate approved by voters in 2008 and have no end date.

Workers' compensation reform bill signed by Gov. Brown

ARTESIA – SB 1160 authored compound by state Sen. Tony Mendoza, chair of the Senate Labor & Industrial Relations Committee, was signed into law last Friday by Governor Jerry Brown.

The new law established by SB 1160 implements major reforms to California's Workers' Compensation system to fix persistent delays and denials of medical care for injured workers and address billions of dollars in workers compensation billing

The legislation received broad support from workers, organized labor, doctors, medical providers and attorneys.

"I thank Governor Brown signing SB 1160. This transforms the workers' compensation system so that injured workers are guaranteed to receive timely and appropriate medical treatment and benefits within the first 30 days of a work place injury," said Mendoza.

"SB 1160 also cracks down on the billions of dollars in fraudulent medical billing," said Mendoza. "Fraud hurts injured workers and drives up costs for California's businesses."

This year, a series of news and prosecutions highlighted billions of dollars in rampant workers' compensation insurance fraud perpetrated doctors and workers' compensation service providers in addition to the delay and denial of necessary medical care are stayed until the resolution of

Additionally, doctors and medical providers who had been criminally charged and prosecuted with workers' compensation insurance fraud were continuing to seek payment through the filing of liens.

"I am outraged by the pervasiveness of fraudulent medical billing in California's workers' compensation system," said Mendoza. "The degree and severity of the problem negatively impacts workers, businesses and California's economy."

"A worker who is legitimately injured on the job is entitled to immediate medical treatment. My bill ensures that injured workers will no longer be subject to delayed or denied medical treatment within the first thirtydays of a reported injury," said Mendoza.

"SB 1160 implements muchneeded reforms and creates safeguards against fraud. We must provide all the necessary tools so the state can crack down on and ultimately stop those who commit these despicable crimes," added Mendoza.

Specifically, SB 1160 will do the following:

- Require that, if a physician or provider is criminally charged with workers' compensation, Medi-Cal, or Medicare fraud, criminal charges.
- For liens filed on or after January 1, 2017, require the lien

and claimant to submit a declaration

- ■Curb workers' compensation fraud by codifying the Chorn (2016) decision on lien assignments and prohibiting lien assignments on or after January 1, 2016.
- Prohibit the use of financial incentives for a physician, based on a Utilization Review (UR) decision, and give the Division of Workers' Compensation (DWC) the authority to review UR compensation information.
- Increase the minimum penalty for failing to report workers' compensation data to the Workers' Compensation Information System (WCIS) from \$5,000 to \$10,000.
- Starting January 1, 2018, eliminate prospective Utilization Review (UR) in the first 30 days of an accepted claim if the medical treatment follows medical guidelines and is under the employer's control, as specified.
- Require that, on or before July 1, 2018, all Utilization Review (UR) processes must be accredited by an independent, nonprofit organization.
- Require that, on or before July 1, 2018, employers will need to submit Utilization Review (UR) plans to the DWC for approval of their UR process.
- Require that all Utilization the physician or provider's liens Review (UR) documentation be submitted to the DWC in an electronic format, allowing for the creation of a comprehensive Utilization Review (UR) database.

- Modernize the Utilization (UR) /Independent Medical Review (IMR) timelines to include the upcoming formulary (July 1, 2017) for medicine in the workers' compensation system.
- Update the existing Medical Treatment Utilization Schedule (MTUS) in the workers' compensation system and link the MTUS with the upcoming formulary by creating an alternative public hearing process for MTUS updates.

In 2012, SB 863 (De Leon) was signed into law in order to help reduce costs, improve medical delivery, and address fraud and abuse. Some strides have been made, however endemic medical and service provider billing fraud persists. Additionally, many workers' compensation stakeholders continue to report consistent problems related to the workers' compensation system, including medical dispute resolution, the quality of workers' compensation data, and the lack of peer-to-peer communication in the denial of medical treatment for injured workers.

During the past year, Senator Mendoza has taken the lead by holding a series of hearings on the state of the workers' compensation system around the state with key stakeholders including the Division of Workers' Compensation (DWC), organized labor, employers, doctors, medical providers and workers' compensation attorneys and injured workers. SB 1160 is the product of these hearings.

Counsel's Corner: Suing someone? Look before you leap

DOWNEY - Determining the best way to solve a conflict and whether to proceed with filing a lawsuit is a business decision that must be made with the big picture in mind. It is very important to evaluate your goals and assess any potential personal impacts as litigation is serious business.

In the midst of high emotions when you have been wronged, it is important to take a deep breath and carefully weigh what I believe are

You should first evaluate the merits of a case. This seems like an obvious first step, but it must be more than just letting your emotions surrounding facts.

Be sure to look at important documents and see if they support your position. Often, cases are decided based on a simple distinguishing fact or subtle exception to the law. In addition to helping you decide whether to pursue an action you should consult an experienced litigation lawyer. Doing so early on will allow you to frame your claim carefully and may avert any early challenges to your lawsuit.

Discuss with your lawyer how this can be done without compromising the case. Rather than sending angry emails or making threats, a simple phone call may get the parties talking. The matter may be able to be resolved informally through early mediation or another form of alternative dispute resolution.

> The decisions about how to resolve conflict and whether to pursue litigation cannot be done in a vacuum. You must consider certain factors and remember that far greater than the conflict at issue is the ultimate need for you to avoid the aggravation and expense of protracted litigation.

Fall is here and school is back in session but for many graduates, it's out for good. If you're a recent high school or college graduate, this might be the first time you're on your own. Living away from home and paying for your own housing, food and other necessities can be a tough adjustment. Make sure you have the right bank account for you. A lot may have changed since you opened your account, so consider changing your account to find the best one for your needs. If you are still sharing a bank account with your parents, consider opening your own. Opening an account can be simple and it's possible to do so online or over the phone – but you'll need a minimum deposit amount and documentation like your Social Security Number.

Always make the minimum payments on time, and if you're having trouble paying off your loans, don't ignore them.

Contact your lender, explain your situation and pay as much as you can immediately while prioritizing paying off the rest.

Check up on your healthcare. Under the Affordable Care Act, you can stay on your parents' plan until you're 26. If you aren't currently on your parents' plan or wish to leave their plan, you have several options to explore. Under federal law, if you're not covered by health insurance you must pay a fee on your next federal tax return. You can explore the different levels of coverage available and estimate how much a plan will cost you at Healthcare.gov, the federal healthcare website.

Get ready for retirement – yes, really. The younger you start saving, the more valuable your savings are. According to this Bankrate example, starting your savings at age 25 at \$2,000 a year will yield a retirement account of \$560,000 (assuming your earnings grow at Remember that this is a rule of thumb and you can adjust it to fit 8 percent every year). 



How much should you expect to pay in closing costs?

Closing costs are fees associated at the closing of a real estate transaction. The closing point is when the title of the property is clean. transferred from the seller to the buyer. Closing costs are incurred by either the buyer or seller.

If the costs come in high, you can walk away from the loan; there are plenty of lenders who might be willing to offer you lower fees at closing.


