City council hopefuls make their cases at debate



■ ELECTION: Nine candidates participate in debate hosted by The Downey Patriot.

DOWNEY - All nine City Council candidates stood front and center Friday at the Downey Civic Theatre for a debate presented by the Downey Patriot.

The event was free and sponsored by PIH Health, Downey Federal Credit Union, and Downey Brewing Company.

five districts – Districts 1, 3, and 5 – are up for reelection. Every district up for election is contested, as every candidate has at least one opponent.

Blanca Pacheco, Alma Marquez, Hector Lujan, Rick Rodriguez, Frine Medrano, Art Montoya, Louis Morales, Mayor Alex Saab, and Art Gonzales all came face to face with a crowd of 300-400 residents and supporters in the Downey Civic Theater, answering question compiled by the debate's moderator, former Downey Patriot staff writer and

This year, three of Downey's current Norwalk Patriot editor Christian Brown.

> Several questions were also received from community members through email and social media.

Mayor Saab stood as the sole candidate who was running for reelection, as evident by his opening statement.

"I want to thank the residents of Downey for affording me the opportunity to represent them the last four years, and I ask for another four years to represent them [and] continue the momentum that we pleaded for more funding to

city and the residents of Downey," said Saab.

Saab is running for District 5.

Running opposite of the sole reelection hopeful is Art Gonzales, who could be described as the freshest face to Downey out of the group. Gonzales is still relatively new to the city, having only moved to the city around five years ago.

The other two districts up for election are almost evenly split amongst the candidates: Pacheco, Marquez, and Lujan are running for District 1, while Rodriguez, Medrano, Montoya, and Morales are all vying for the District 3 spot.

Each candidate was allowed a 60-second opening statement, along with 60 seconds to respond to debate questions, and 30 seconds for rebuttal. Most questions were addressed by district.

The possible half-cent sales tax increase was a big topic at the debate, splitting the candidates three to six, with candidates Rodriguez, Montoya, Gonzales supporting.

"I was at that city council meeting where the fire department

have worked so hard on for the better staff their department, and I know that the fire stations as well - three of four of them are in need of upgrade. How can they do their jobs if they don't have the right equipment or the right funding to make sure that they can proceed in their daily operations...," said Montoya. "... No one is going to want to come to Downey to buy anything or do business if there's a fear of them getting hurt..."

> On the side of the opposed, Pacheco said that the sales tax increase might hinder the continued growth of the city.

"We are a city that is growing. We are continuously expanding. We have a Downtown Downey area, we now have a Promenade, and it's nice; this growth is nice," said Pacheco. "My concern is that this sales tax increase would hinder that growth, and I'm seriously concerned about that..."

Other topics discussed by the candidates included public safety, housing, and homelessness.

Luis Marquez, accused of having child out of wedlock, apologizes for 'mistake'

■ ALLEGATIONS: Downey council member is alleged to have had a child ouside his marriage.

DOWNEY Downey political figures Luis and Alma Marquez have found themselves surrounded in controversy concerning a child that the councilmember allegedly fathered with another woman.

According to an official who spoke to the Patriot on the condition of anonymity, a woman by the name of Maribel Zavala has brought an allegedly out-ofwedlock child of Marquez's to light after the council member supposedly denied that the child I am working through it with my is his.

According to this source, and family. Zavala wants Marquez to take responsibility for the child.

The anonymous official also spoke of a meeting between the three parties involved, where Zavala supposedly said she was intimidated by Luis and Alma to not bring the issue to the public.

In a prepared statement, Councilman Marquez acknowledged "making a mistake" but called allegations of a love child "completely false" and "a political attack."

"This is a personal and legal matter that is affecting my family, so on the advice of our attorney, I will not be commenting on this issue any further other than this statement," Marquez said. "I want to publicly apologize to my wife Alma, my children, my entire family and all the residents of Downey. I made a mistake and wife and family. My number one concern is protecting my children

Downey High SkillsUSA students put in day of service

leadership skills to the test on Saturday, Oct. 8, when they volunteered at the Dare 2B Digital exposition, which was hosted at the school.

The daylong event introduced almost 1,000 Downey Unified middle school students and parents to cutting edge digital technologies.

The DHS student volunteers are part of the school's SkillsUSA team. Through the day, they helped register participants, provided directions, assisted program presenters, and documented the event through photography and video.

"They were amazing," said Norma Kropelinicki of Dare 2B Digital. "I work with a lot of volunteers and I would take this group anytime."

At the end of the event, the students hunkered down in the shade for a group photo and a well-earned break. "I couldn't be more proud silent auctions to raise money for library programs. of your professionalism," teacher Frida J. Vadgama, Downey High's SkillsUSA lead advisor, told the group.

SkillsUSA is a national program that builds leadership skills and supports career and technical education, Vadgama said. Many of the students who worked Saturday will participate in SkillsUSA Leadership and Skills competitions at the regional level, with gold, silver and bronze medalists advancing to the state and possibly even national

Nicholas Acosta, co-president of Downey High's SkillsUSA team, was happy with the volunteer turnout and with the enthusiasm of his peers. "I like to see students involved not only in school but in the community," he said.

Dare 2B Digital event featured presentations by leaders in cuttingedge technologies such as virtual reality, space exploration and digital entertainment. NASA/Jet Propulsion Laboratory and Southern California Edison were among the presenters. The event also included appearances by celebrities Kevin McHale of "Glee," YouTube stars such as Leo Camacho, and others.

The event was made possible through a partnership between Downey Unified School District and Invent Your Future Enterprises, with grant funding from the California Career Pathways Trust. Promoting careers in science, technology, engineering, arts and math (STEAM), Dare 2B Digital aims to inspire young innovators through interactive, hands-on learning experiences.

Dutch students visit Downey on world tour

DOWNEY – STORM Wave, the electric motorcycle designed by STORM Eindhoven, a team of 24 Dutch students at Eindhoven University of Technology, rode into Downey this week as part of their 80-day world tour.

The goal of the journey is to show the potential of e-mobility worldwide. The team was in Los Angeles, where they visited various events, including a meeting with the Dutch Honorary Consul at the VTBS Architects Office, Downey High School's Engineering Department, and a group of local creatives at Stay Gallery.

The motorcycle runs on a battery pack designed by Eindhoven students. The pack consists of 24 cartridges that have 28.5 kWh of energy, which enables the motorcycle to travel 380 kilometers (236 miles) on a single charge.

Furthermore, it is possible to adapt the whole pack to enable a lighter motorcycle for a more sporting driving style.

STORM Eindhoven left the Netherlands to tour the world on Aug. **DOWNEY** - Seventy Downey High School students put their 14, and traveled through Europe, the Middle East, and China before coming to the US.

> The innovative motorcycle started touring the United States in Washington state. The bike will travel down the West Coast and through the South and Midwest before finishing its tour of America in New York on Oct. 26.



STORM will make stops in Sacramento, San Francisco, Phoenix, Dallas, Columbus, and Pittsburgh, among others.

During each stop, the STORM team will meet with universities and companies interested in smart urban planning and sustainability to demonstrate the potential of sustainable transportation and recharge the motorcycle.







Commentary: Candidates play it safe at City Council debate

■ ELECTION: Candidates for Downey City Council mostly fail to deliver past generic talking points.

DOWNEY – When three city council seats are up for grabs in a five-district municipality, you further continue the erosion of identity that's been nipping closer and closer to its core for the past little dogs in one of them. 15 years or more.

All of which made last Friday night's debate onstage at the Downey Civic Theater critical. Beyond lawn posters and slick mailers, it's the only chance we'll have had so far to ask, "Who are district director for State Senator these people?" and hope to gain some knowledge of what we may be in for.

You looked at the roster and wondered how, with a couple of exceptions, anyone's list of virtues and occupations could qualify them for elective office. A safety specialist? A neighborhood watch

But sometimes they surprised you. Gonzalez seemed refreshingly candid and free of dreary political rhetoric, and Rick Rodriguez gave a direct, surprisingly eloquent and even touching response to a question about conflict of interest with his security firm. And when the question of dealing with homelessness came up, he seemed to be (or to say so) the only one who understood it as mainly a mental health issue. There was a time, before the Reagan administration shut down mental clinics in the 1980s, when the sight of someone sleeping on a street was inexplicable and troubling. But if they knew, no one else had anything to say about it.

The terms "transparency," "accountability" and "integrity"

came up a few times, leaving us of touch with the priorities of banking to the price of cucumbers to wonder what they alluded to. Has the decision-making process of the city been opaque or hidden from us? If so, let's hear examples. Have there been incidents of ethical misconduct the candidates know about and we don't? As there was virtually no follow-up questioning, these interesting issues, to say the least, were left unaddressed.

Once everyone in the lineup understood that no one in their midst was going to erupt in a barrage of savage personal attacks, the candidates warily settled in to a round of questions that included positions on the proposed tax increase, crowded parking conditions, veterans affairs, park and public safety, legalization of marijuana dispensaries, and easing of term limits. As everyone seemed to agree most of the time with everyone else, the questions took on the velocity of lightning rounds and the evening sped by to a premature end.

The answers of what each candidate would do for the city were among the most disappointing. It wasn't enough for Marquez and Medrano to say they'd use their state connections to direct more money toward Downey when they didn't tell us 23 what they'd do with it. Pacheco's statement that a prime objective would be to help any kid who came to her wanting to become a lawyer, suggests that she's out

Do the debates help us choose wisely?

Surprisingly, the Democrats didn't take me up on my offer even though I drawing viewers in great numbers. The contest is close, and the chance to watch the two candidates spar with one another face-to-face makes for entertaining

> This is hardly a bad thing. Overall, presidential debates are a plus for the public dialogue. They get tremendous coverage throughout the media universe, both while they're taking place and in the days that follow. They let the voters see the candidates under pressure and gauge their performance. As scripted as they can sometimes seem, they still let us watch the candidates think on their feet. They're serious events, and are certainly more substantive than campaign speeches and television commercials.

> It's true that they don't usually change the trajectory of a race — although we won't know until Election Night whether this year's debates played a role in the outcome. They can reinforce enthusiasm, but it's rare that they create it from

> Yet I think our focus on debates — at least in the form they currently take is misplaced. It's not so much that they reward one-upmanship, a quick wit, and clever zingers — although they do. Rather, I think they don't actually help us make

> Over my years in Congress and afterward, I've sat in on a lot of meetings at the White House where foreign and domestic policy were discussed. For the most part, I came away impressed by the process by which presidents make tough decisions. They go around the room, asking each guest, "What do I do now?" They ask participants to define the issue, lay out the options, identify American interests at stake, and make recommendations. It's usually a sustained, unhurried process, with very little fancy oratory: instead, I've heard sharp debate and thorough discussion characterized by forceful, reasoned, fact-based, and responsible arguments. Presidents pay close attention and sometimes take notes. They want to hear different opinions, seek advice, and then go off and make a decision.

> You have to remember that the choices a president has to make are complicated and often very difficult — almost by definition, an issue doesn't get to that level unless it's a tough one. I've sat in on meetings with both Democratic

and Republican presidents, and one of the things that often impressed me is that We're in the middle of the presidential debates, and not surprisingly, they're ideology has played a smaller role than you'd imagine. The conversations are quite pragmatic.

> What all this means is that the real quality you're looking for in a President is judgment: the ability to consider issues from all angles, weigh options carefully, and then choose the wisest course — sometimes from among a tangle of unpalatable

That is what presidents do. But the qualities necessary to do this do not come through in the debates, which tell us very little about how candidates would do at exercising judgment in the fog of policy-making. A campaign event that calls for impassioned oratory, a quick wit, one-liners, and sharp digs is not especially helpful for helping us choose who is going to make the best decisions.

I think we can do better. Selecting a president is serious business. We want to put control of the process on the voters' side, and not let the candidates get away

How do we do this? We change the nature of the debates. To begin with, I believe there should be a series of them, each focused on a single issue education, say, or national security. Candidates should face a panel of questioners asking them to address the toughest questions on those matters — people who are sharp and incisive and are prepared to follow up and press candidates when they spout mush. Ideally, the candidates should face this panel one at a time, rotating who goes first, and with other rules to assure fairness.

The point is, we want voters to go to the polls not just with a good idea of where the candidates want to take us and how they're going to get there. We also want voters to have a clear sense of how sound the candidates' judgment is, because that's ultimately what will make or break their presidency.

Prison labor is slavery by another name

Right now there's a national movement mobilizing to raise the federal minimum wage to a living wage of \$15 an hour. But imagine if instead of earning even that much, you could only earn a few cents an hour.

If that sounds like something from the developing world, think again. The reality is our prisons are perpetuating slave labor.

Every day, incarcerated people work long hours for barely any money. Meanwhile, prisons charge inmates for everything from telephone calls, to extra food and convenience items, to occupying a bed.

In an official statement announcing the start of the historically largest nationwide prison strike, the IWW Incarcerated Workers Organizing Committee wrote: "In one voice, rising from the cells of long term solitary confinement, echoed in the dormitories and cell blocks from Virginia to Oregon, we prisoners across the United States vow to finally end slavery in 2016."

The prison system profits from mass incarceration. Prisons have numerous fellow inmates, according to the first National Former Prisoners Survey. incentives to fill beds — including the cheap labor prisoners provide — and very little incentive to treat prisoners like human beings.

Current minimum wage laws don't apply to people in prison, nor do labor rights regulations. So prisoners experiencing grueling hours or cruel treatment don't have any recourse to file complaints or seek restitution.

On the contrary, clear human rights violations – including chain gangs — go unchecked all the time.

And the prison system targets an already incredibly vulnerable population. All seven members of the Downey Unified School District Board of Most inmates aren't just low-income — they're the poorest of the poor. In 2014, Education are supporting Dr. Tammy Ashton for election to the Cerritos prior to their incarceration, inmates generally made over 40 percent less than their peers.

because of policies that criminalize race, poverty, and mental health.

Some are there because they couldn't afford to post bail after facing minimal charges. Others end up back in the system because of stigma and policies that make it difficult to find a job as an ex-convict.

Others still are locked up for being homeless and sleeping on the street, or

stealing food. Many with mental illnesses end up cycling between the emergency room and a jail cell.

But even those with steady work, once inside prison, can't continue to earn a decent living. On just a few pennies an hour, prisoners can't support themselves or their families, or earn enough to survive once they reenter society.

People who spend years or even decades behind bars lose years worth of wages and have few resources for food or rent post-incarceration. It's easy to see how prisons trap people in a cycle of poverty that helps ensure that even if released, they're likely to end up back in prison.

The majority of these prisoners are people of color who've been disproportionately targeted for imprisonment — from racial profiling to the failed war on drugs that targeted black communities starting in the 1980s.

And it's not just the wages that are reminiscent of slavery.

One in ten prisoners is subject to physical and sexual abuse by guards and

There's no real infrastructure to address the physical and mental consequences that come with this abuse. Meanwhile, prison wardens, correction officers, and prison administrators are rarely held accountable for their actions.

Some of these injustices have inspired the Department of Justice to end federal contracts with private prisons, but that's not enough.

The Eighth Amendment states that cruel and unusual punishment is illegal in this country. Yet, today people are slaving away in prison factories, under working conditions that first prompted the rise of the labor movement.

Prisoners are human beings who deserve the same human rights and dignity

We must end the practice of prison labor. It's slavery by another name, and Much of the prison population only wound up in the system in the first place we have a clear obligation to ensure that slavery is completely eradicated in the

The best and worst presidents on taxes

With all the debate over Donald Trump's tax-dodging, I've been wondering how taxes have played into presidential politics in the past.

For some answers, I turned to Bob McIntyre, head of the nonpartisan research and advocacy group Citizens for Tax Justice. For 40 years, McIntyre has been on the frontlines of efforts to make our tax code fairer.

When asked what American president he considers the worst on tax fairness, his initial response was "Yipes, there are so many."

After some consideration, he bestowed that honor on Ronald Reagan, whose

The top marginal tax rate dropped from 70 percent to 50 percent (before being cut even further to 28 percent in 1986). And, even more harmful, according to McIntyre, was the bill's vast expansion of corporate tax loopholes.

Ironically, though, when I asked what president has done the most to advance tax fairness, Reagan's name came up again — not as number 1, but as the runner-

While Reagan is a big hero of anti-tax Tea Partiers, later in his presidency, he agreed to raise taxes several times to address mounting budget deficits.

McIntyre was particularly involved in the fight over Reagan's 1986 reform, after cranking out reports for a decade that documented rampant tax-dodging among America's largest corporations and wealthiest individuals.

The loophole-closing 1986 reform was still not enough to solve the problem of insufficient revenue to pay for federal spending. But by creating a broader tax base, Reagan set the stage for President Bill Clinton's increases in the tax rates on the highest earners.

The top marginal rate rose to 39.6 percent in 1993, where it stands today.

The combination of the 1986 and 1993 reforms was essential to the balanced federal budgets that occurred in the late 1990s, according to McIntyre.

But of course, then President George W. Bush blasted a cruise missile-sized hole through all that fiscal responsibility with a new round of tax cuts and a spike in war spending

So who was the best president for the cause of tax fairness?

Again, the answer was surprising: Teddy Roosevelt, but not because he was a strong advocate of progressive taxes (which indeed he was). Instead, McIntyre says TR deserves the honor because of the unintended consequences of his pettiness.

To understand his argument requires a bit of a history refresher.



In 1912, Roosevelt, who'd held the nation's highest office from 1901 to 1909, decided to throw his hat back in the ring because he was dissatisfied with the presidential performance of his former protégé, William Taft.

When TR failed to beat Taft for the nomination, he founded his own party the progressive, so-called "Bull Moose" Party — and while he didn't win the election, he succeeded in splitting up the Republican Party.

This, McIntyre points out, led to Democratic takeovers of previously Republican state legislatures, which was critical to delivering the three-quarters of states necessary to ratify the 16th Amendment.

"Without Teddy's petulance," McIntyre told me, "the amendment authorizing a federal income tax would almost certainly have failed to be adopted."

So how does one stay motivated to keep fighting for fair taxation for 40 years? "Perhaps I have Sisyphus as my hero," McIntyre said.


Trying to stop big corporations and billionaires from rigging the system does indeed seem like pushing a rock up a hill over and over. But until we elect public servants willing to stand up to these powerful forces, we have no choice but to keep pushing.

You've heard the question I'm sure, "Why are we here?" Did you ever get a solid answer to that question? It's almost like asking the question, "Why do we write?"

I think most of us here today write because we have to. I wonder if that was why Ann Frank wrote and kept a diary. Because she had to. I'm so glad she did.

Memory of Ricky Galvez stays alive at GOOD golf tournament

■ **GOOD:** Golf tournament raises money for scholarships in late police officer's name.

DOWNEY – Nearly an entire year after his passing, Downey fallen police officer Ricky Galvez was honored at the annual Gangs out of Downey (G.O.O.D.) golf tournament fundraiser.

The event was held Friday afternoon through the evening at Rio Hondo Golf Club.

G.O.O.D. has annually held golf tournaments in years past, however this year's was established as the first "Officer Ricardo 'Ricky Galvez' Memorial Golf Tournament."

According to G.O.O.D. President Lt. Mark McDaniel, the tournament was established in order to keep the memory of Officer Galvez alive.

from us, I thought it was the right thing to do to keep his memory ongoing and keep his memory with us all," said McDaniel. "It was fitting to name the golf tournament in his honor."

Galvez was tragically murdered just outside of the Downey Police Station last year in what officials have called a botched robbery

Despite it being a busy day in the city of Downey with the annual Sate of School's address that morning and the highly anticipated City Council debate in the evening, many of the community's political figures and notable residents still came to play a few holes and honor the Zamora, was Galvez's roommate. city's fallen hero.

Former Mayor Mario Guerra described it as a "magnificent

"Ricky is so special to us, not only by what he represents, but by the kind of person he was," said Guerra. "So today we're here

"Shortly after Rickey was taken preserving his legacy and passing it on to another generation..."

> Current Mayor Alex Saab also gave his thoughts, emphasizing the work that G.O.O.D. does for the community.

> "G.O.O.D. does an invaluable service for our community," said Saab. "Not only does it collaborate with all the different organizations in the community, but it also motivates our young people [and] educates them why they shouldn't get involved in crime or gangs... it's a model organization."

> A handful of DPD officers also attended, many of which were close to Galvez.

One such officer, Whinkler

"He was a big brother towards me," said Zamora. "He never had a bad day, or at least that you could see. Always smiling, always cracking jokes, always looking for a great time even if it was in a dark setting. He was always thinking about others before himself. He wanted to see others succeed

before he did...he was a great friend."

Zamora had seen Galvez the night of his murder. Zamora said he was "in shock" when he learned of the tragedy.

"I had just seen him leave to work that same night...when I came home around 6 p.m. he was going to work," said Zamora. "I got a call like at one in the morning from my supervisor to come into work because he needed me. He didn't explain why. When I got to work I was told what happened.

"I don't think I had ever felt that way in my life. It was a new feeling for me. I felt like I had lost a family member – a close brother. It's a piece of me that will never be given back, but he affected all of us in a big way."

Zamora did however find comfort in the outpouring of support from the community, much like many of the other officers affected by the loss.

"It was very heartwarming," said Zamora. "It was something

that was unexpected because I still had people out in the world had never been like something like this before... so many people are out there that still love their law enforcement officials and they care a lot about their police officers, and they came out and showed us that. Son charged with murdering elderly mom

VAN NUYS – A man was charged Wednesday with murder after he is accused of throwing his elderly mother out a window and then beating her.

Woman admits killing mother-in-law

DIAMOND BAR – A San Dimas woman was sentenced Tuesday to nine years in state prison after pleading guilty to a charge in connection with the death of her mother-in-law last year.

Un Young Lee, 44, entered her plea to one count each of elder abuse causing death and arson of inhabited dwelling. She was immediately sentenced by Los Angeles County Superior Court Judge Salvatore Sirna.

On March 25, 2015, firefighters responded to a blaze at the victim's home in the 1200 block of North Diamond Bar Boulevard in Diamond Bar. No one was found inside.

Lee was found later that day driving her SUV in Orange County. The remains of her 77-year-old mother-in-law, Young Ja Lee, were found inside the vehicle.

Prosecutors believe the elder Lee died sometime between March 23 and March 25.

Man accused of trying to stab police

SANTA MONICA – A 31-year-old man was charged Wednesday with trying to stab two Los Angeles County sheriff's deputies at a Metro train station in Santa Monica.

Thomas Francis Napack (dob 4/5/85) of Los Angeles faces two counts each of attempted murder of a peace officer with a knife use allegation and assault upon a peace officer.

Napack is accused of charging at two deputies monitoring the transit station with a knife in each hand on Oct. 4, the prosecutor said. The defendant was shot by one of the deputies as they evaded the alleged stabbing attack, the prosecutor added.

Bail is expected at more than \$2 million. If convicted as charged, Napack faces a possible maximum sentence of life in state prison.

> Prosecutors said Becerra and Hartley allegedly trafficked a woman between November 2012 and August 2016.

> In that time, the defendants reportedly seized the woman's daughter, severely abused the child and ultimately killed the minor victim on or about Aug. 9, according to prosecutors.

> On Aug. 9, Becerra and Hartley attempted to cross the San Ysidro Port of Entry with the child's body in a duffle bag, but the defendants were stopped by authorities and taken into custody, prosecutors said.

> If convicted as charged, each defendant faces a maximum possible sentence of life in state prison.

Three found guilty of killing neighbor who complained about graffiti

ARLETA – Three gang members have been found guilty of the murder of an Arleta man who had complained about graffiti in front of his house.

first-degree murder and Javier Garcia aka Fects, 23, and Oscar Sanchez million. aka Crudo, 30, were both found guilty of second-degree murder.

Deputy District Attorney Robert Rabbani of the Hardcore Gang Division said sentencing is scheduled for Nov. 15.

At about 4 a.m. on December 21, 2014, Garcia, Adauta and Sanchez did donuts in their car in front of Edgar Barrientos's house in an effort to lure him out of his home, the prosecutor said. Once on a vehicular manslaughter charge for a New Year's Day crash in the victim came out of his house all three defendants beat him to the ground on two separate occasions, according to court testimony.

When two neighbors came to his aid, the three defendants turned their attention to them. Barrientos then came to the aid of his neighbors but was stabbed to death by defendant Adauta, the prosecutor added.

According to witness testimony, Garcia and Barrientos were neighbors. Barrientos complained days before his murder about graffiti in front of his house put there by one of Garcia's fellow gang members. The attack on Barrientos was in response to the complaint about the graffiti, the prosecutor said.

All three defendants also were found guilty of the willful, deliberate and premeditated attempted murder and the assault with of, at the direction of, or in association with a criminal street gang.

RANCHO PALOS VERDES - A Rancho Palos Verdes physician convicted of illegally prescribing drugs to undercover operatives was sentenced last week to three years in county jail followed by two years of mandatory supervision.

Dr. Richard Seongjun Kim, 44, was convicted on Sept. 20 of 17 felony counts of of unlawfully prescribing controlled substances without a legitimate medical need to undercover operatives working with the Drug Enforcement Administration.

Deputy District Attorney Emily Street of the Major Narcotics Division, who prosecuted the case, said Kim would ask the operatives to bring in prior medical charts and X-rays to justify the prescribing. On one occasion, an operative brought in a chest X-ray of a dog that was used to justify his prescriptions, prosecutors said.

Over the course of three months in 2014, the general practitioner wrote prescriptions for Norco, Xanax, Soma and Adderall without ever conducting a physical exam, taking any vital signs or completing any medical charts at his clinic on Western Avenue in Rancho Palos Verdes, prosecutors said.

Sex offender charged with rape

GLENDALE - A 48-year-old homeless man has been charged with raping a woman at a closed grocery store parking lot in Glendale.

Michael Zinzun (dob 5/28/68) faces one count each of forcible rape, forcible oral copulation, sexual penetration by foreign object, kidnapping to commit rape and resisting arrest.

Zinzun was convicted in Florida for a sexual assault in 1998 and burglary in 2005.

In the early hours of Sept. 29, Zinzun is accused of dragging a woman who was sleeping on a bench to a parking lot and sexually assaulting her, the prosecutor said. A witness called 911 and when police arrived the defendant fled but was arrested soon after, the prosecutor added.

If convicted as charged, Zinzun faces a possible maximum Christopher Adauta aka Piso, 21, was found guilty of one count of sentence of life in state prison. Bail has been set at more than \$3.3

Man ordered to stand trial in death of Lyft driver

TORRANCE - A 21-year-old man has been ordered to stand trial which a Lyft driver was killed.

Arturo Martinez Conchas (dob 10/23/94), of Hawthorne, pleaded not guilty last week to one felony count each of gross vehicular manslaughter while intoxicated, driving under the influence of an alcoholic beverage causing death and driving with a .08 percent blood alcohol content causing injury.

The charges include an additional misdemeanor count of possessing a controlled substance, MDMA.

Conchas was held to answer to the charges on Sept. 15 and is due back in court on Oct. 26 in Department W81 of the Los Angeles County Superior Court, Airport Branch.

On Jan. 1, victim Thor Anderson, 21, was making a U-Turn near a knife on the two neighbors that came to help Barrientos. The jury 182nd Street and Doty Avenue in Torrance when the defendant also found true that all of the crimes were committed for the benefit allegedly broadsided him, prosecutors said. Anderson died as a result of his injuries, prosecutors added.

Commentary: Transparency starts at the top, yes on Prop 54

One of the most straight forward yet impactful measures on this November's ballot is Proposition 54, the California Legislature Transparency Act.

It's been said that a basic tenet of a healthy democracy is open dialog and transparency. Allowing transparency in government is vital to the public trust. Secrecy breeds desperation and concern, that is why this proposition is so

If approved, Prop. 54 will stop an egregious and far too common practice from happening in the state Legislature. Without this law state legislators and special interest can continue to replace the entire contents of a proposed law with new language and then ram it through at the last minute (literally at times) for passage before most legislators or the public have a chance to even read a bill.

This happens regularly every year. They call it "gut and amend" bills.

This lack of transparency at our state capitol should stop. We, the

people, have every right to know what's in a bill before it's signed into law. And legislators should know what they're voting on before casting their votes. These last minute, back-door maneuvers far too often create policies that only serve a select few special interests at the expense of families, businesses, and communities.

This is not the way our state legislative process was designed to operate, and it's the voters who end up paying the price for the lack of accountability of their elected leaders. Fortunately, we will have a chance to solve this problem by voting on Proposition 54. The measure will create more transparency in the state Legislature by making three simple changes to be rushed through the Legislature California's Constitution:

- Require all proposed laws to be distributed to all legislators and posted online at least 72 hours before a final vote by either house.
- Require the legislature to post online within 24 hours a video recording of every legislative meeting that is supposed to be open to the public.
- and share their own recordings of addresses.

legislative proceedings without fear of criminal consequences.

I am constantly amazed that this is not currently the law. These are simple and effective ways to help the culture of openness and good government to work. If we want the legislature to operate fairly and open, I strongly encourage voters to read about Prop 54.

All legislative hearings will be available for viewing online (not just the ones the legislators wants you to see) and everyone would be able to follow a bill throughout the entire process. Nothing should be hidden from the citizens who vote to elect their representatives.

No longer will proposed laws without the ability for the public to know what is going on and weigh in on policy that impacts our livelihoods.

Secrecy is an enabling force to abuse of power and transparency is one of the answers in providing greater accountability. currency of true leadership is an open government and trust in the process of transparency and that ■ Allow all individuals to create is something that Proposition 54

The large bipartisan coalition of supporters includes the League of Women Voters of California, California Chamber of Commerce, National Federation of Independent Business of California, the Latin Business Association, Hispanic 100, California State Conference of the NAACP, the First Amendment Coalition, Orange County Business Council, and the Howard Jarvis Taxpayers Association, among many others.

The only opposition I can imagine would only be from special interest or legislators that like to keep their own special agendas private. Accountability and transparency is vital for our state. I will be demanding more transparency in our State Legislature because I will be voting Yes on Prop 54. There is more information on the web site YesProp54.org.



Realtors forecast strong home sales in 2017

According to forecasts just released from the National Association on the market, with some of the usual suspects at the top. of REALTORS® (NAR), the Mortgage Bankers' Association (MBA), and Freddie Mac and Fannie Mae, "We can expect a hot year for home sales in 2017," said Realtor Mag, the NAR's official magazine.

"NAR is predicting existing-home sales to reach 6 million in 2017, higher than its 5.8 million forecast for this year. But other entities are but a tight supply of homes for sale on the market that will likely lead even more bullish. MBA is predicting home sales to eclipse 6.5 million next year, while Fannie Mae and Freddie Mac are both predicting 6.2 million."

What's driving this trend? "A huge wave of Generation Yers," otherwise known as millennials, whose long-overdue march into homeownership may finally be happening. A strong showing from this group can prop up the real estate market not just next year, but for several years to come. "They are predicted to keep home sales and condo sales strong well in to 2020, according to economists,"

While the overall picture for home sales next year and into 2020 looks rosy, sales and price appreciation will, obviously, vary depending

"The top markets for price appreciation likely will be in Seattle, Wash.; Portland, Ore.; Denver, Colo.; and Boston, predicts Eric Fox, vice president of statistical and economic modeling at VeroForecast," they said. "These markets' robust economies have growing populations to some of the largest price increases across the country."

Gord Collins notes that, "The top forecast markets show price appreciation in the 10% to 11% range," with Seattle at 11.2%, "followed by Portland, Oregon at 11.1% and Denver, Colorado at 9.9%.

The California Association of Realtors' forecast shows "modest gains next year amid tight supplies and the lowest housing affordability in six years," said the San Jose Mercury News. "Sales of existing single-family homes -- which make up about 68 percent of the overall market -- are projected to rise 1.4 percent in 2017 to 413,000 transactions. Meanwhile, the median house price -- or price at the midpoint of all sales -- is projected to rise 4.3 percent to \$525,600. That's the smallest percentage gain in six years."


