An open letter to Downey's newest council members

As Downey's city council receives a fresh update, now is the time to discuss Downey's future

Dear Blanca Pacheco, Rick Rodriguez and Alex Saab:

Congratulations on your election—and in Alex Saab's case, reelection—to the Downey City Council. You've waged successful campaigns against an unusually large field of opponents, and all honors are due your having won the preference and confidence of your district voters. You carry their hopes, and the hopes of the entire city, into the future.

As a journalist and Downey resident, I've been a city-watcher for decades, and became more than casually impressed when I first saw the level of professionalism and competency with which city staff conducted a public hearing at the Downey Theater on the McMansionization issue; and at the colorful, varied, sometimes near-rowdy meetings of the Community Redevelopment Agency at the Downey Library, where people of almost every conceivable age, background, occupation and income level met to discuss the future of the city. This was democracy in action!

cancelled by the state). But the absence of any of those kinds of meetings is symptomatic of what's been happening to Downey ever since the local aerospace industry collapsed, and with it, the cultural and civic amenities that came with the residential life of a largely professional and management class—elements that produced a robust sense of community.

This is where you come in, to a job that's more difficult than ever. What's becoming clear over time is that prior councilmen, aside from performing perfunctory duties or using their office for personal and political gain, have been more or less kicking the can down the road when it comes to visionary leadership. To go to city council meetings now is to see a group dealing with everyday, largely utilitarian issues—road repair, underground gas pipes, signage--the more bureaucratized, the safer they feel. Audiences show up to hear their specific agendas hashed out; once the discussion is over, they get up and leave. Hardly anyone stays around to see how the democratic process of city government works on a scale

In a way, you can't blame them. The leadership has become a technocracy. The minutiae it has to deal with is both crucial—particularly with the threat of litigation looming behind every decision—and stupefyingly boring. No wonder they have no mental energy to deal with larger, more ambiguous issues, like those forms of heritage crucial to

identity; culture and the arts; and the use of space when it comes available. When they come up with an issue that requires thought and reflection rather than numbers and specs, they punt. When there's something specific and measurable, they turn it over to consultants and developers without asking what the self-interest of those people may be, or their track record in keeping promises. Or the unexpected results of their projects, as in the near-elimination of sidewalk space outside the KB townhouse development on 5th and Paramount.

I'm generalizing, but the trend is unmistakable. The developer who is still building The Promenade long after its proposed completion date never mentioned how sterile and dreary all that uniformly boxy architecture stretched over a vast dystopic terrain would be—even Benihana's lacks traditional character. And you know that promised four-star hotel will never materialize.

As for the Avenue Theater, in which the city has now officially lost a half-million dollars, more mid-level restaurants and food outlets, in a street already loaded with them, will not take the meaningful place over a cultural center proposed by local arts leader Lorine Parks, among others.

While on the subject, Downey's 2005 Master Plan for the future, mandated by the state, mentioned the Downey Symphony, The Civic Light Opera, the Downey Art Museum and the Downey Civic Theater itself as the city's prime cultural attractions. The DCLO is gone; the Symphony can barely cover a tenth of its operating cost; VenueTech, the management firm that runs the Downey Theater, is virtually fleecing the city while staging oneand-done events that contribute nothing to Downey's cultural identity; and the art museum, which preceded LACMA as L.A. County's first of its kind, has fallen to the blowhard vindictiveness of a former mayor who wouldn't heed state attorney, now state senator, Kamala Harris' appeal to reopen it (this while the arts are exploding twelve miles up the road, making L.A. an international arts capitol).

Clearly the city has been unable or unwilling to deal with these issues. I'd recommend forming an advisory arts council consisting of locals who have proven themselves vital to the community. They would include Frank Kearns, Lorene Parks, Andrew Wahlquist, Carolina del Toro, Pat Gil, Valentine Flores, Harold Tseklenis, Donald Marshall, Roy Shabla and Marsha Moode. Singly and as a group, they've all met with the city to try and figure out the next step, but like the rest of us, they need official leadership to find a new direction.

Another issue you'll have to deal with is the economy. Downey's unemployment rate is slightly higher than both the California and national levels, but more to the point, the city's average per capita income is \$23,216 and its household \$60,374. (The generally agreed on number for a representative middle class income is now \$125,000.) Over 11% of Downey's residents live below the federal poverty line. At the same time, the lowest price of new housing (including the townhouses going up on 3rd and La Reina) begins at \$400,000. This does not include mortgage interest, insurance, utilities, food, clothing and transportation. At the pre-election candidates' debate, someone mentioned the need for financial subsidies for increasingly unaffordable housing. But the city is not equipped to offer them, and in any case they wouldn't serve as a long-term solution to a place whose new jobs are mainly in the service sector and therefore low-paying. This is one of the most crucial and demanding issues you'll be dealing with. Downey has had a magnificent past, and its residential designs, schools, its muchheralded fire and police services, and the more intangible element of community spirit are legitimate sources of pride. But all this has been under duress over the past decades. It won't take much more to make Downey lose the quality that's made it Downey. Particularly with technology and globalization crowding the mid-foreground

What we need from you is critical thinking, an almost reflexive mode of saying to yourself and the rest of us, "Is this the only way? Is there a better alternative? What's at stake in the larger community?" For example, a number of studies, including the California Air Resources Board, have published the health results of prolonged noise and air pollution, which include stress, neurological disorders, asthma, heart disease, arteriosclerosis, low birth weight and premature birth. I recently asked a councilman if he'd ever considered these factors in approving residential development like KB on the heavily traveled Paramount Blvd.

His answer: "No. We've never thought of it. No one brought it to our attention."

I know you have an orientation process to familiarize yourself with city government, but I'm hoping you take to heart the work of the late Jane Jacobs, still America's premiere urbanist, who wrote, "When we deal with cities, we are dealing with life at its most intense and complex. Cities have the capability of providing something for everybody, only because, and only when, they are created by everybody."

To which a writer for The Atlantic added, "When cities succeed, they represent the purest manifestation of democratic ideals. When cities fail, they fail for the same reasons democracies fail: corruption, tyranny, homogenization, overspecialization, cultural drift and atrophy."

The above mentioned Master Plan sent out 40,000 inquiries to the citizens of Downey. One hundred and ninety-three responded. I also made an unofficial and loose tally of the percentage of people who voted in the council election. The number barely broke double digits. Alex Saab told me that when he went door-to-door on his first term campaign, he was shocked to hear how many people didn't know that a city council existed, let alone who represented them.

This isn't good enough. When VenueTech president John Lind came to town to size up the theater, he observed, "The city isn't responsive to the people, so the people feel they have no part in what goes on."

I'm hoping you'll change that. For starters, either you can add more content to the Discover Downey

newsletter, or resume publication of the Downey Communicator, in which city news on issues and developments, and invitations to comment, went to every household in the city.

I'm glad that you, Ms. Pacheco, are willing to address the neglected tensions of South Downey; that you, Mr. Rodriguez, are interested in making city government more transparent (as in Where did the \$650,000 go that was earmarked for parks and bike lanes three years ago?); and that you, Mr. Saab, can further articulate what exactly are those "values and priorities," as you put it, that truly make Downey unique.

I often play tennis afternoons at Furman Park, which is next to Rio Hondo Elementary School. Sometimes I pause to watch when the kids are released into recess, swooping over the large playing field like flocks of joyous songbirds. When your first terms are up, the fifth graders will be in high school. If you earn second terms, they'll be starting their lives as young adults. Who'll look out for them in their formative years, I wonder? Who'll enable them to develop the civic and social consciousness integral to living good lives?

Never underestimate your role, both in act and example, in shaping what they become.

Garcia continues push to repeal tampon tax



DOWNEY – Assemblymember Cristina Garcia (D-Bell Gardens) kicked off her first day of the 2016 legislative session Monday by introducing AB 9 and AB 10, two measures that would not only remove the tax on menstrual products, but make them free in schools and shelters.

Currently, due to Gov. Jerry Brown's veto of similar legislation last year, women in California still pay over \$20 million annually in taxes on tampons and sanitary napkins, paying on average \$7 a month for 40 years.

our lives, we are still being taxed for being born women," said Garcia. "Every month of our adult life we are taxed for our biology. Every month we are told our periods are a luxury, while also being told they are something to be ashamed of and we must hide."

"It's not enough to make these products more affordable, we have to make them free to the women and girls who struggle to get access to these products," she added.

Last year New York, Connecticut and Illinois passed legislation to make menstrual products exempt from the sales tax, bringing the total number of states exempting the products to eight. Meanwhile, in California the tax remains and there is now a case before the California Superior Court, on the Garcia feels that feminine basis that tampons and sanitary

The complaint states that "Every month, for 40 years of the current tax violates the 14th amendment's equal protection

> "We shouldn't have to wait for a court case to strike down this unlawful tax. I am committed to working with the Governor to end this unfair tax on women whether it's through legislation or the budget and also to find ways to make these products free where they are needed " Garcia said.

Currently, California exempts health items like walkers, medical identification tags, and prescription medication, including Viagra. Tampons and sanitary napkins are not exempt.

"If you look at other items that are tax exempt, I think it is only fair that these essential products for women be included," she said. "When I carried this legislation last year, I kept hearing stories of girls missing school because they didn't have access to these products. In New York City when they provided the products for free, they saw a 2.4% increase in attendance in their pilot school. I knew that as a state we couldn't just stop at getting rid of the tax. We have to make the products free in schools in and shelters.

"This is about gender equity and social justice."

5 Freeway construction in Downey slated to start next month

■ TRAFFIC: Construction on 5 Freeway in Downey anticipated to last through 2019.

DOWNEY – The I-5 intersection at Florence Avenue is scheduled to undergo long-term construction beginning as early as January of next

The Santa Ana Freeway Florence Avenue Interchange Project aims to bring several benefits to the highly traveled freeway corridor which extends through Downey and Santa Fe Springs to just north of the 605

Improvements include the addition of a high occupancy vehicle lane in both directions, interchange improvements, replacement pedestrian overcrossings.

Florence Avenue overcrossing will also be widened from four to six lanes.

Several closures have also taken place due to the project. Dollison Drive (between Quinn Street and the southbound I-5 on ramp) and the southbound 1-5 Dollison Drive have been permanently closed. The southbound I-5 Florence Avenue on ramp long-term closure will continue My5LA.com. through early 2018.

Project cost is \$215.4 million. The anticipated traffic opening is late



Why fake news is dangerous

Franklin Roosevelt once said, "Democracy cannot succeed unless those who express their choice are prepared to choose wisely." He was talking about why education matters in a representative democracy, but it's a safe bet that had he known about fake internet news, he'd have said the same thing — except maybe with more pointed words.

Our representative democracy depends on ordinary people making sound judgments about politicians and policy. This is hard to do at the best of times. Issues are complex. Being able to sort out what matters and what's a diversion takes knowledge and judgment. Being a full citizen in a representative democracy depends on accurate information — and the ability to discern what's reliable and what's not.

To fold into that mix deliberately false news makes the citizen's task much more difficult — maybe even impossible. Yet astoundingly, that's where we find ourselves now. Millions of people see patently false stories about undocumented workers pouring across the border or Hillary Clinton being involved in the assassination of JFK — and some number of them believe it. Meanwhile, people across the globe — teenagers in the Balkans, disinformation specialists in Russia, entrepreneurs in the U.S. — all seem to be cashing in.

I'm well aware that some critics argue that "fake news" is nothing new. They cite such well-known fabricators as Jayson Blair at The New York Times and Janet Cooke at The Washington Post. Fair enough. But when Blair, Cooke and others like them were caught, they were fired and drummed out of journalism.

These days, purveyors of fake news get paid to mislead the public. This is new. These are fantasies masquerading as "news" — misleading, disingenuous

and removed from context. They're outright lies generated without regard for the commitment to accuracy that real journalism strives for. This is very, very dangerous. Outside of criminal activities like bribery, it's hard for me to imagine a greater disservice to our country.

Americans care about being informed. When I'm in front of an audience, invariably someone asks me to recommend the most reliable source of information I know — because there are a lot of choices out there. People know that they have political decisions to make, that their votes matter, and that they shouldn't make them in a vacuum. False news makes the basic responsibilities of citizenship much harder.

On the positive side, responsible media outlets are increasingly aware of the problem and are seeking ways to counteract it — as well as to call out politicians who blatantly traffic in misrepresentation. There is no question that in the coming years, real journalists' ability to identify bogus stories, rebut ignorant claims that go viral, and stymie efforts at misinformation will be a vital part of their responsibilities. Similarly, the platforms that have given an outlet to fake news — Facebook and other social media — are recognizing their obligation to fight it without compromising users' access to the real stuff.

Which, of course, is what makes what to do about false news so devilishly difficult. As a nation, we thrive on a multitude of voices and news sources. We **Downey** don't want to discourage the sharing of information or opinions, nor do we want to restrict Americans' access to it.

When misinformation has spread in the past, we've always been able to depend on the truth catching up and eventually prevailing. Now, however, the circuits are being overloaded — not just by the proliferation of platforms and sources of information, but by people who are using the tools of democracy to undermine it. We must strive for an environment in which truth wins the day in the war over information.

I can't pretend to know how we will ultimately help Americans sort through what's truth and untruth, what's serious argument and what's propaganda, but I do know that this is one of the key battles of our time. Fake news is a threat to our system, a land mine that can cripple representative democracy by making a mockery of its most basic tenet: that the people will make the right decisions. This is a challenge we need to address head on and without delay — the future of our representative democracy is at stake.

Who voted for Wall Street?

During the campaign, Donald Trump said he wanted to fix our rigged economic system. And we can't do that, he said, by counting on the people who rigged it in the first place.

He talked a big game about Wall Street and the big banks. He repeatedly called out Goldman Sachs, the Wall Street behemoth, by name in ads and speeches, characterizing the firm as controlling his rivals Hillary Clinton and Ted

So it should come with some shock, at least to Trump voters, that now President-elect Trump has chosen a consummate Wall Street insider, Steve Mnuchin, for treasury secretary.

Mnuchin spent 17 years as an executive at Goldman Sachs before continuing his lucrative career as a banker and investor. Is this not the swampiest of characters that Trump vowed to drain away?

Trump's anti-Wall Street messaging resonated with millions of voters. A poll taken just before the election showed that nearly 70 percent of undecided voters in key swing states wanted to break up the big banks and cap their size to avoid another financial crisis.

The same proportion wanted to close the "carried-interest loophole," an insidious provision that enables hedge fund managers to pay lower taxes than

It's unclear whether Trump's anti-Wall Street messaging made the difference for these voters. But it's abundantly clear that he didn't mean a word of it.

In Washington, personnel is policy. And Mnuchin's appointment casts serious doubt that Trump will follow through with any of his bluster on Wall Street.

Mnuchin isn't just any Goldman Sachs alumnus: He oversaw one of the largest foreclosure operations in the country. Mnuchin bought mortgage lender IndyMac in 2009, renamed it OneWest, and continued on as its chair through ISIS $\nu s.$ the U.S.2015 — a period in which OneWest foreclosed on more than 36,000 families.

What exactly does Mnuchin want to do while in power?

In his first announcement, Mnuchin exclaimed his "number one priority is tax reform," promising to work with Congress to pass the "biggest tax cut since

Reagan." He claims the benefits of this tax cut will go to middle class families, rather than the upper class.

Fortunately, tax plans, unlike campaign promises, can be easily and quickly fact checked. Unfortunately, Mnuchin's statement comes back pants-on-fire

Over half of the cuts in Trump's proposed tax plan would exclusively benefit the top 1 percent, according to the non-partisan Center on Budget and Policy Priorities. The plan would increase their after-tax income by 14 percent, 10 times more than for middle-income earners.

Mnuchin won't be the only Wall Streeter in the Trump administration. Steve Bannon, the chief strategist for the president-elect and former head of the white supremacist news outlet Breitbart, is a fellow former Goldman Sachs employee.

The Wall Street swampiness of both Mnuchin and Bannon, however, pales in comparison to that of Wilbur Ross, the billionaire investor selected by Trump to lead the Commerce Department. The 79-year-old investor built a career on greed, exploitation, and apparent tone deafness. Ross infamously whined in 2014, "The 1 percent is being picked on for political reasons."

of the government and the overall economy.

It's been just eight years since Wall Street bankers had to come to Washington, hat in hand and utterly humbled, to ask for a taxpayer funded bailout. The reforms put in place to prevent a repeat of the 2008 crisis are tenuous at best — and now they're under serious threat from the same people they were designed to rein in.




Paging Dr. Frischer...

Many years ago during my medical residency training at UCLA, I spent time in the emergency room. You can imagine how interesting it could be to work a graveyard shift, and that seemed especially true if it happened to fall

on a night with a full moon.

Nurses warned me to be ready for anything on those nights. Even today, there are times when my receptionist



Could the phase of the moon alter our physical or mental state? Ancient Assyrian and Babylonian discuss this. Note that the word *lunatic* was derived from the Latin word *luna*, meaning moon.

The human body is made up of about 75% water. The moon (along with the sun) causes the tides. Could these gravitational tides affect our body? The effect of gravity diminishes with distance but never goes away; in theory everything is always tugging on everything else. Do note that the highest tides occur both on full and new moons - yet no one seems to connect strange behaviors or events psychological issues. to new moons!

have searched for any statistical connection between the moon and human biology or behavior. Reliable studies comparing the lunar phases to births, deaths, heart attacks, suicides, violence, psychiatric hospital admissions, emergency room visits, epileptic seizures, surgical outcomes, menstruation, and sleep habits (to list just a few) have simply found no

significant correlation. Many studies that claimed to find connections turned out to have used flawed methods, or have not been able to be reproduced.

A frequently quoted study was performed by an international group of scientists, who examined the sleep patterns of children and differences in their daily activities. The findings revealed that during full and new moons, the children in the study slept five fewer minutes. The change in sleep represented about a 1% decrease, with no noticeable change in daily activity.

One statistically significant study performed by the Colorado State University Veterinary Medicine Center involved almost 12,000 participants: dogs and cats. During a full moon, emergency room visits increased by 28% for dogs and increased by 23% for cats. How this single study would relate to human behavior is unclear.


Certainly there are creatures that shape their lives around the tides. The behavior of coastal wading birds and the breeding of the California Grunion (fish) are good examples of that.

So, why does this myth persist so stubbornly? Perhaps when I was a resident in that UCLA emergency room, knowing that it was a full moon, I interpreted traumas and crises as more extreme or bizarre. Perhaps when strange things happen during a full moon, we tend to make that connection, but when strange things happen over the rest of the month, we don't automatically connect them to astronomic events. Perhaps, before electricity, the light of the full moon kept people up at night, causing sleep deprivation and associated

40% of new cancer cases linked to tobacco



Forty percent of cancers diagnosed in the U.S. may have a link to tobacco use, according to this month's Vital Signs Report published by the Centers for Disease Control.

Tobacco use is the leading preventable cause of cancer and cancer deaths. It causes more than lung cancer — based on current evidence, it can cause cancers of the mouth and throat, voice box, esophagus, stomach, kidney, pancreas, liver, bladder, cervix, colon and rectum, and a type of leukemia (acute myeloid leukemia).

Each year between 2009 and 2013, about 660,000 people in the U.S. were diagnosed with, and about 343,000 people died from, a cancer related to tobacco use, according to a new report by CDC. Three in ten cancer deaths were due to cigarette smoking, but progress has been made. Since 1990, about 1.3 million tobaccorelated cancer deaths have been avoided.

"There are more than 36 million smokers in the U.S.," said CDC Director Tom Frieden, M.D., M.P.H. "Sadly, nearly half could die prematurely from tobacco-related illnesses, including 6 million from cancer, unless we implement the programs that will help smokers quit."

National Health Interview Survey (NHIS) data released today in a separate article in the same MMWR show that current cigarette smoking among U.S. adults declined from 20.9 percent (45.1 million) in 2005 to 15.1 percent (36.5 million) in 2015. During 2014-2015 alone, there was a 1.7 percentage point decline, resulting in the lowest prevalence of adult cigarette smoking since the CDC's NHIS began collecting such data in 1965.

"When states invest in comprehensive cancer control programs—including tobacco control—we see greater benefits for everyone and fewer deaths from tobacco-related cancers. We have made progress, but our work is not done," said Lisa C. Richardson, M.D., M.P.H., director of CDC's Division of Cancer Prevention and Control.

Comprehensive cancer control programs are focused on reducing cancer risk, detecting cancer early, improving cancer treatments, helping more people survive cancer, improving cancer survivors' quality of life, and better assisting communities disproportionately impacted by cancer. Comprehensive tobacco control programs coordinate efforts to implement proven strategies to prevent tobacco use initiation among youth and young adults, to promote tobacco users to quit, to eliminate secondhand smoke exposure, and to identify and eliminate tobacco-related disparities. However, not all states or all people have experienced the benefits of these efforts; tobacco prevention and control resources, along with access to medical care and cancer treatment, vary widely across the U.S. The Vital Signs report on tobacco-related cancers

Incidence and death rates were highest among African-Americans compared with other races or ethnicities, people who live in counties with a low proportion of college graduates, and people who live in counties with high poverty levels.

By region, incidence rates were highest in the Northeast (202 per 100,000 persons) and lowest in the West (170 per 100,000 persons).

Incidence rates for tobacco-related cancers are still higher among men (250 per 100,000 persons) than women (148 per 100,000 persons).

Preventing and reducing tobacco use and tobacco-related cancers take comprehensive approaches

Quitting smoking at any age has health benefits, including reducing the risk of getting or dying from cancer. Quitting smoking improves the prognosis of cancer patients and reduces the risk of getting a secondary cancer (a cancer that occurs in a different organ) in cancer patients and cancer survivors.



What is your favorite snack?


Definitely a Snickers bar. They're another guilty pleasure, but not during training camp.



He's worked with a diverse band of acclaimed artists, including Peter Cetera, Celine Dion, Kenny G, Patti LaBelle, and the late Michael Jackson. In fact, Anka cowrote Jackson's posthumous #1 worldwide hit, "This Is It."

verse he had written to a former babysitter. In an interview with NPR's Terry Gross in 2005, he stated that it was to a girl at his church whom he hardly knew.

Anka stardom as it rocketed to #1 on the Canadian and U.S. music charts. "Diana" remains one of the best selling singles ever by a Canadian recording artist.

Frustrated after more than ten years without a top 25 hit record, Anka switched labels again, which marked a turning point in his career. This time he signed with United Artists and in 1974 teamed

recorded his first single, "I up with Odia Coates to record Confess", when he was 14. In the #1 hit, "(You're) Having My 1957 he went to New York City Baby", exposing Anka to a new where he auditioned for Don generation of fans and proved his Costa at ABC, singing what was staying power among his original widely believed to be a lovestruck fan base that was now maturing.

SHARED STORIES: My love for synchronized swimming

For those who are familiar with Brooklyn and Queens, New York, Daniela Kanz offers a fascinating description of Jones Beach in the summertime and the all-day trek required to get there. My interest in the Summer Olympics mainly evolved from my enjoyment of synchronized swimming.

One of my all-time favorite movie stars as a child was Esther Williams in the aqua-musical Million Dollar Mermaid (the 1952 biographical movie about Australian swimmer Annette Kellerman).

This movie led to my love of swimming and eventually water ballet. I have borrowed the DVD from the library several times to enjoy watching it yet again.

Esther Williams was an advisor to the International Olympic Committee at the 1984 Summer Olympics in Los Angeles for the new sport of synchronized swimming. Not only was Esther Williams a film star, she was a businesswoman – being first to endorse a product – swimwear. She later was involved in selling swimming pools.

I became enchanted with water ballet before I knew about America's Mermaid, as Esther Williams was nicknamed. I have fond memories of the water ballet shows put on at Jones Beach out on Long Island, New York. Going to the beach from Jackson Heights without a car was quite a journey. My Dad and I would take a bus to the subway to the Long Island Railroad, and then another bus to the beach. It seemed like we would never get there to this ten-year old.

I fondly remember my Dad playing the Why Game with me to help pass the travel time. He would mention something, and I would respond "Why?" – And he would come up with another answer and I again would reply

It never ceased to amaze me how far and how long he could play this game without running out of things to tell me. My memory does not serve me well enough to tell you what some of these tales were, but I can still feel that amazement and wonder that this interaction with my Dad provided.

Once we arrived at Jones Beach, the first stop was to the umbrella rental stand. My Dad felt we needed that protection from the sun.

Then I would finally be allowed to get in the water with the admonishment – You must come out when your fingertips start to shrivel. He also went in the ocean water a few times and only did the breaststroke. He never did the crawl stroke the way I learned to swim.

Jones Beach has a boardwalk with many vendors. Every time I eat pizza, I think about the time my poor Dad burned his lips so badly with some melting cheese from a slice of pizza we had purchased on the boardwalk.

I also recall being amazed at his eating clams on the half shell with just a bit of lemon juice squeezed on them. I refused to try them when he offered some to me. I have since tried them and can tolerate this delicacy, but just as soon pass

One of the best things about Jones Beach was not only the ocean to swim in and that wonderful clean white sand to play in - there was also a swimming pool and the very odd thing was that the pool was filled with salty seawater rather than chlorinated water.

When evening came, the best was yet to come - the water ballet show in the bay. There was huge stadium seating in a horseshoe around the water and several feet across the water was a stage with a live band to accompany the water ballet

After the show, it was all I could do to get to the bus with my Dad. I slept on the bus – was awakened to get on the train – was awakened again to get on the subway – and awakened yet again to get on the last bus to our street. I struggled to the house from the last bus stop and was asleep before my head hit the pillow dreaming about being a water ballet artist one day.

Super Storm Sandy hit my beloved Jones Beach hard in October of 2012, but the needed repairs were complete by May of 2013. Maybe one day I shall return.

Lynwood becomes first city to regulate marijuana manufacturing in L.A. County

LYNWOOD – On a 3-1 vote, Lynwood's City Council this week approved on first reading an ordinance that would regulate businesses that grow and manufacture medical cannabis within city limits. The ordinance would allow up to 5 such businesses.

The ordinance will need to have at least one more reading before it passes which will take place on December 20, 2016.

Council members José-Luis Solache, Aide Castro and Maria Teresa Santillan-Beas voted in support of the resolution, while Salvador Alatorre was the dissenting vote and Edwin Hernandez was not present.

If passed, the Lynwood ordinance would allow the licensing of up to five

properties to grow or manufacture marijuana at any given time.

Those properties could not be within 600 feet of a school or day care center or within 50 feet of a residential zone.

Aaron Herzberg of CalCann Holdings, a marijuana real estate company, said Lynwood is actually the first city in Los Angeles County to explicitly license the growing, manufacture and extraction of cannabis.

By Herzberg's estimates this ordinance could generate as much as \$5 million in tax revenue for the city per year.







