**DOWNEY** – An off-duty Los Angeles Police Department officer was involved in a shooting incident early Monday morning when he confronted two burglary suspects at his residence.

According to a press release posted by the Downey Police Department, the incident occurred on the 7800 block of Borson Street at around 1:00 a.m.

The off-duty officer was assaulted and discharged his weapon during the encounter.

Both suspects sustained gunshot wounds and were taken to local hospitals for treatment. The officer involved was also treated for minor injuries at a local hospital.

# Analysis: Downey's new-look City Council shows signs of promise

**DOWNEY** - We've grown so accustomed to rancor and even loathing between parties and factions of the federal government that we're in danger of forgetting that the democratic process can't work without people of different minds getting together to hash out decisions in the name of fairness and the greater good.

It was a pleasant surprise therefore to see the city council in action last week, which worked hard to check off the items of a busy to-do list without the farcical exchanges and gasbag monologues that often characterized meetings prior to the newly elected lineup, as though those sessions were some kind of late night talk show with lame jokes.

There were clearly no hard feelings, for example, between Sean Ashton and the rest of the council, particularly Alex Saab, who had tried to ace Ashton out of his rightful place in the mayor pro tem cycle of appointment—an action that drew heated protest from the Downey community. Saab's implication was that Ashton wasn't up to the task, **DOWNEY** – Downey-Florence that something was wrong with him somehow. > Another pleasant surprise was how well Rick Rodriguez and Blanca Pacheco took to water as both political novices and newly elected council members. You'd think it would take months for them to grow into their roles within the complexities of city government, but a local orientation as well as a boot camp session in Sacramento and acknowledgement segment did the trick.

> The earliest part of council meetings routinely consists of each member giving the public a report on what they've been up to; that is, after everyone dutifully asserts how great a city Downey is, a seeming mandatory postscript to The Pledge of Allegiance. The next requirement is to take separate developments and groups and assert how great they are (boosterism is an essential part of council function; everyone does it). The new playground at Independence Park, and Downey's Girl Scout troops, earned Pacheco's nod. Her role with Gangs Out of Downey, and her report that there are no street gangs in the city, are to meet green building standards; genuinely noteworthy.

For his part, Rodriguez ("It was just awesome to see how great our city is") praised the Keep Downey Beautiful program, and announced the volunteer cleanup campaign that will muster at the Metro Rail station on February 18th.

preceded Saab everyone by praising the Downey Police Department (an excellent department by any measure but also campus of Rancho Los Amigos the object of required superlative); mentioning the Independence Park playground and the Downey Historical Society; asking for volunteers for that evening's homeless count (a county-wide action); extending an invitation to the January 28 Downey Symphony performance and art show at the Downey Theatre; and singling out Jim Rodriguez of the Planning Commission for acknowledgment.

recommendations for public safety; the projected new rail link (2029) between Artesia to South Downey; and among other announcements, the need for barriers around the iconic Bob's Big Boy to keep drunken drivers from crashing into it, as happened earlier in the month.

Not to be outdone, Mayor Fernando Vasquez hit the city/ police exacta ("The cohesiveness community is second to none; praising local fire and police effort that the Florence Avenue overpass construction is 37% complete; cited an excellence award for our city manager, Gilbert Livas; and mentioned Downey's inclusion as one of only a hundred cities in a nationwide Bloomberg initiative aimed at finding ways to make local governments more effective.

The awards, proclamations followed. Healthy Heart Award. New police hires. Planning Commission. Rose Float Association. Used oil recycled artwork awards to elementary schoolkids citywide. The auditorium was packed with cops, their friends and families, kids and their families, Rose Float people, photographers and selfie-takers with council members who drifted down from the dais and into the audience. By the time it got down to city business, the place had cleared out and was nearly deserted.

Now the work began, some of it involving minutiae, like the building code update on electrical, mechanical and plumbing designed and later, how to switch Downey's 2200 streetlights to LED lighting, which would save the city \$74,000, while many of the light poles are in bad shape and their owner, Southern California Edison is, as Ashton observed, "not cooperative."

Much of the evening was spent in earnest discussion of what to do

about the homeless problem, which is clearly vexing, both nationally and to temperate Los Angeles County, which counts over 46,000 indigents. Rick Rodriguez mentioned the 90 Downey churches, as well as service clubs and nonprofit organizations, which are trying to deal with homeless needs. Vasquez wondered aloud about how to get them jobs. Livas came closest to the core of the issue when he said, "Our biggest problem is getting them to accept

That's because it's basically somehow morphed into a social problem. No one seemed to recall that, before the Reagan administration shut down mental hospitals and clinics as a costcutting initiative during the 1980s, you didn't see so many people living in the streets and under freeway overpasses. Vagrancy laws were enforced. Clinical treatment, including medication and residency, was widely available. But somehow, with the closings and the question of civil rights, and especially cutbacks in social programs, people in need were abandoned (up until a few months ago, I saw a middleaged woman living in Furman Park, in her Lexus).

To watch the city council grapple with this intractable issue was to witness an exercise in humanity, which is no small thing. They worked hard into the night. And the discussion about committee meetings during the day, requiring council members have to leave their regular jobs, underscored Saab's earlier statement, "You have no idea how much personal sacrifice this

Late in the evening, Rodriguez announced that he was cancelling his security firm's contract with a mental health issue that has the city. No one asked him to. The subject never came up. But he decided on his own to avoid any conflict of interest issue (this has not been true of everyone in the council's history, then and now).

> It was then you saw what promising team this group is already turning out to be, and how important good chemistry is with people who make policy. There are larger concerns they may not be equipped to handle, but Rodriguez's good will seems contagious, an intangible that informs everyone in the room and may well take them farther than one would expect.





# Downey space center installs plaque to commemorate Apollo 1 tragedy

**DOWNEY** – Columbia Memorial Space Center paid respect to the Apollo 1 tragedy with a plaque installation last Saturday.

The CMSC's newest memorial installation came a day after the 50th anniversary of the Apollo 1 tragedy that claimed the lives of NASA Astronauts Virgil Grissom, Edward White and Roger Chaffee; it was also the 31st anniversary of the Challenger explosion, to the day.

The Columbia disaster anniversary followed shortly after on Wednesday, Feb. 1.

Saturday saw the museum play host to a handful of experts with ties to the space exploration and engineering programs, as well as NASA astronaut John Olivas.

The day's events began with a few words from CMSC Director Ben Dickow, before the unveiling of the Apollo 1 tribute plaque.

"Today we honor three crews lost in humanity's ongoing progress to explore and to learn more," said Dickow. "...Yesterday was the 50th anniversary of the Apollo 1 disaster. It was NASA's first real hiccup, and it has a particular poignancy to Downey. Actually, all of the disasters do..."

Columbia Memorial is located on the grounds formerly occupied by the NASA site where the Apollo shuttles were designed and built. Many of the astronauts also trained in the area.

"The engineers here in Downey had close relationships with the





# **New policy regarding Letters to the Editor**

Spirited political debate is one of the great freedoms enjoyed in the United States. Indeed, the right to support a political candidate, or to rag. Older readers claim we lean left. It's a no-win situation. endorse or oppose public policy, or march against injustices -- without fear of persecution -- is a tenet of democracy.

Unfortunately, healthy political discourse has devolved into childish name-calling that does little to move the national conversation forward.

Worse, citizens have gotten lazy, trading books and newspapers for talk radio and dubious internet websites that have financial incentive to whip the masses into a frenzy. Unfortunately, in the past couple of years, this page has devolved into exhaustive attacks between a small number of regular contributors.

Republican versus Democrat. Hillary versus Trump. Conservative

versus liberal.

Young readers accuse the Downey Patriot of being a conservative

It's all very exhausting, and while the passion invoked in these letters is admirable, they contribute virtually nothing of substance to the national discourse.

I take part of the blame. In an effort to remain fair and neutral, I was too timid in exercising editorial judgment.

Not anymore. Going forward, we're asking that letter writers be original in their contributions. Don't simply replay political talking points from cable television, but offer unique musings and commentary.

If you've already written your opinions on abortion, the presidency, animal rights, or any other myriad of topics, there's no need to repeat with. They're incredible people. And I want to thank Ben Carson, who's your thoughts.

We're also asking that letters be as short as possible. If you can't make your point using 300 words or less, reconsider your argument and find ways to be more succinct.

And lastly, be local. The greatest impact Downey residents can have is on a local level. Find a way to better your community, and in turn, you will better your country.

# A speech everyone should read

As a country, we make a habit of looking forward, not backward. But I'm going to ask you to turn your attention back a few weeks, to Barack Obama's January 10 farewell address to the American people.

I've been reading presidential farewell speeches for many years. Most of them give good advice. This speech, however, was exceptional. It can be read with benefit by Republicans and Democrats, conservatives and liberals — because it says a lot of things that we need to hear about our system and our country. I hope that for some time to come, this speech will be a topic of conversation in classrooms, at church socials, and around the table at local service clubs.

Why? To begin with, the speech is filled with confidence in ordinary people and respect for what workaday Americans can accomplish. This is a founding value of our country — both a promise and a call to civic arms. Our rights, the former President notes, "have never been self-executing." Instead, our system is built around the belief "that We, the People, through the instrument of our democracy, can form a more perfect union."

The responsibility for making this a better country, in other words, lies with each of us. "Show up, dive in, stay at it," he says. "And more often than not, your faith in America and in Americans will be confirmed."

At the same time, throughout the speech, Mr. Obama makes it clear that it's challenging to make representative democracy work. As a nation, he argues, we have enormous potential — but we cannot take our success for granted. If we don't "create opportunity for all people," he warns, "the disaffection and division that has stalled our progress will only sharpen in years to come."

Indeed, our democracy is being severely tested right now, in part by a disintegrating sense of common ground among Americans of different racial, ethnic, and class background, and in part by the growing ease with which people can retreat into "bubbles" — both geographic and ideological — in which we see only people we identify with and hear only information that already fits our preconceived notions.

This makes the underpinnings of a successful representative democracy - the search for common ground, the willingness to negotiate, the freedom to compromise — difficult if not impossible to pursue.

Yet what may be most striking about the farewell address is that it is filled with hope, and with a clear optimism that we can overcome division and temporary steps backward. Not that this will be easy, Mr. Obama notes. Restoring a sense of common purpose will require a change both in hearts and in beliefs. "We all have to start with the premise that each of our fellow citizens loves this country just as much as we do; that they value hard work and family just like we do; that their children are just as curious and hopeful and worthy of love as our own," he says.

Furthermore, he recognizes that while politics is a battle of ideas, "without some common baseline of facts, without a willingness to admit new information and concede that your opponent might be making a fair point, and that science and reason matter, then we're going to keep talking past each other." These are challenges, but they're hardly insurmountable especially if we learn to put ourselves in others' shoes.

As you read this speech, it's hard to avoid a sense of the basic strength of our country. There's a celebration of the peaceful transfer of power, a straightforward discussion of race and ways to surmount the burdens that racial discord have imposed on our society, a magnanimity toward ideological adversaries, an underlying sense of inclusiveness and decency. These are wise words from a mature politician who clearly has confidence in the nation's ability to forge ahead and meet its challenges.

I understand that a lot of people in this country don't agree with former President Obama on many things. But set aside the person who wrote it for a moment: this speech is instructive for all of us on what this country is all about and how we can make it better.

# Don't play into Trump's hands on the Muslim ban

I'm a Muslim woman and a social justice advocate.

I'm terrified, heartbroken, and outraged by Donald Trump's "Muslim ban." As I watched administrative chaos and rapidly organized protests unfold at airports all over America, I was overwhelmed with messages from friends fearing they'd never be able to see their loved ones again.

Though the executive order doesn't use these exact words, this is no doubt a Muslim ban.

It's not just that the countries Trump wants to prohibit immigration from — Libya, Yemen, Iraq, Iran, Syria, Sudan, and Somalia — are majority-Muslim. It's that religious minorities (i.e. anyone who isn't Muslim) from those countries will be prioritized for entry into the U.S.

Refugees, immigrants, and Muslims are human beings — regardless of their age, status, skills, or nation of origin. Many Americans realize this, which is why thousands have turned up at protests to speak out against

But while they mean well, non-Muslim opponents of the ban still have to be careful not to repeat dangerous stereotypes when pushing back against this extreme action.

For instance, you may have heard that Trump's order left off the Muslimmajority countries where President Trump has business deals — some of which, like Saudi Arabia and Egypt, happen to be where individuals who've carried out violent attacks hailed from.

All of that's true, of course, and there's value in pointing out Trump's unprecedented conflicts of interest.

But in reality, Muslims in these countries are the primary victims of extremist violence there. And suggesting that Trump should ban those countries too only encourages broadening the Muslim ban, not ending it.

Another common argument I've heard is that Muslim refugees and immigrants strengthen national security by acting as police informants and joining the military, and that this ban could break the bonds of trust that enable those partnerships.

It's true that Muslims are leading providers of tips to law enforcement agencies investigating "terrorism." But it's not like all Muslims are somehow connected to or aware of extremist plots. We're ordinary people, and we shouldn't have to be "useful" to law enforcement to deserve fundamental

The narrative link between Islam and violence is used to justify military intervention abroad, which in turn is used to justify suspicion of Muslims at home. Muslims are seen as potential "terrorists," to the point that the word is popularly linked with Islam — despite repeated horrific acts committed by white men in the U.S. in the name of Christianity or white nationalism.

This stereotyping feeds into increased hate crimes and harassment, as well as profiling and government surveillance of Muslims.

Sadly, Donald Trump isn't the first president to make things worse for Muslims.

The Obama administration's wars were often justified through the demonization and dehumanization of Muslims. So were its expansion of the drone program, unwarranted surveillance, militarization of our borders and policing, and record-breaking numbers of deportations.

Trump's latest action is reminiscent of past immigration bans, and the implications of where we could go from here are terrifying. Scary precedents include the ban on immigration from Asia and the great national shame of Japanese internment.

Only by acknowledging the history of these systems and policies systems that existed long before Trump took office — can we understand how to resist them today.

Trump's Muslim ban has already been widely applied, and we can't ignore the threat of it growing. I, and so many Muslims, recognize this undeniable possibility. We're not safe. We're targets here and abroad.

So I'd ask this of my friends and neighbors: Don't reinforce ideas that paint us as inherently violent and undermine our humanity. Reach out to us, support us, uplift our voices and humanity.

I've gotten a real glimpse—during the campaign, I'd go around with Ben to a lot of different places I wasn't so familiar gonna be heading up HUD. That's a big job. That's a job that's not only housing, but it's mind and spirit. Right, Ben? And you understand, nobody's gonna be better than Ben.

Last month, we celebrated the life of Reverend Martin Luther King, Jr., whose incredible example is unique in American history. You read all about Dr. Martin Luther King a week ago when somebody said I took the statue out of my office. It turned out that that was fake news. Fake news. The statue is cherished, it's one of the favorite things in the—and we have some good ones. We have Lincoln, and we have Jefferson, and we have Dr. Martin Luther King. But they said the statue, the bust of Martin Luther King, was taken out of the office. And it was never even touched. So I think it was a disgrace, but that's the way the press is. Very

I am very proud now that we have a museum on the National Mall where people can learn about Reverend King, so many other things. Frederick Douglass is an example of somebody who's done an amazing job and is being recognized more and more, I noticed. Harriet Tubman, Rosa Parks, and millions more black Americans who made America what it is today. Big impact.

I'm proud to honor this heritage and will be honoring it more and more. The folks at the table in almost all cases have been great friends and supporters. Darrell—I met Darrell when he was defending me on television. And the people that were on the other side of the argument didn't have a chance, right? And Paris has done an amazing job in a very hostile CNN community. He's all by himself. You'll have seven people, and Paris. And I'll take Paris over the seven. But I don't watch CNN, so I don't get to see you as much as I used to. I don't like watching fake news. But Fox has treated me very nice. Wherever Fox is, thank you.

We're gonna need better schools and we need them soon. We need more jobs, we need better wages, a lot better wages. We're gonna work very hard on the inner city. Ben is gonna be doing that, big league. That's one of the big things that you're gonna be looking at. We need safer communities and we're going to do that with law enforcement. We're gonna make it safe. We're gonna make it much better than it is right now. Right now it's terrible, and I saw you talking about it the other night, Paris, on something else that was really—you did a fantastic job the other night on a very unrelated show.

I'm ready to do my part, and I will say this: We're gonna work together. This is a great group, this is a group that's been so special to me. You really helped me a lot. If you remember I wasn't going to do well with the African-American community, and after they heard me speaking and talking about the inner city and lots of other things, we ended up getting—and I won't go into details—but we ended up getting substantially more than other candidates who had run in the past years. Civil Rights violations should take a back step when the security of the country is at stake.



# Things you didn't know about Downey: Meralta Theater

**DOWNEY** – Downey's Meralta Theater was named after two – "The Jazz Singer" – got its play at the Downey Meralta in 1928. women who performed in vaudeville together before they entered the theater business.

Meralta is a combination of the names of the original owners' old stage act – Laura Peralta and Pearl Merrill traveled all over the United States as a saxophone comedy act. Laura was 5 foot 3, weighed 100 pounds and Pearl was an enormous woman, nearly 6 feet tall and 300 pounds. They were billed as Ella Fant and Miss

Both women were getting homesick for California as Laura came from one of those big, tight-knit Catholic families with nine kids, and Pearl got tired of living out of a suitcase, so after two years on the road, they gave up the act and opened a movie house in Boyle Heights in 1917.

The Downey Champion newspaper dated Jan. 28, 1926 had an Pearl Merrill made arrangements with the Collegiate Comedy Company of Hollywood to film their next one-reel comedy in Downey. The unique part of this arrangement was that the cast was to be titled "Dapper Dan of Downey" and photographed by was to be comprised entirely of local people.

Pearl also stated that the Collegiate Comedies would make the interior scenes of this comedy on the stage of the Meralta – they would use Kleig lights, spots, cameras, etc. In other words, the Meralta stage would be transformed into an actual motion picture studio and the people in the audience would be given a rare treat of seeing an actual motion picture being made.

Before talking about a pet, I must confess why I am afraid of all animals, including dogs, cats, birds, or any creature.
