Downey's Liliana Hernandez honored as Woman of the Year

DOWNEY - Downey eighth grader Liliana Hernandez was Cristina Garcia for her efforts in steering girls towards opportunities in science, technology, engineering and math (STEM).

Liliana is a founding member of Girls in STEM, a club at Downey's Columbia Memorial Space Center. She has rallied

her fellow club members to take part in hands-on STEM explorations, field trips and service projects.

Outside of her work with Girls in STEM, Liliana is a longtime member of the Girl Scouts of America and serves as her class president.

In her spare time, Liliana builds robots and regularly competes in the Team America Rocketry Challenge, which is the world's largest student

rocket contest and is integral in the aerospace and defense industry's strategy to build a strong U.S. workforce in science, technology, engineering and math.

Liliana aspires to one day become a doctor.

Assemblymember Garcia honored one woman from each of the cities she represents, which includes Downey, Artesia, Bellflower, Bell Gardens, Cerritos, Commerce, Montebello, Norwalk and Pico Rivera.

Her district Woman of the Year, Dr. Veronica Obregon, was honored at a ceremony at the State Capitol.

Below are brief biographies on each of the winners.

Michele Diaz (Artesia): Michele Diaz has been a resident of Artesia for over 34 years and has been active member in her community since then.

Michele has served on the City of Artesia's Planning Commission for the past 18 years; she has also served as the Commission's Chairperson multiple times. In addition to her vast experience in city planning, Michele is entering her thirteenth term as President of the Friends of the Artesia Library.

The Friends of the Library is a self-supporting program that aims to increase awareness of the library and its importance in their communities. Michele has helped organize fundraisers from book sales to dinner events that attract over several hundred attendees.

In addition to serving on the city's planning commission, Michele has participated in and organized neighborhood cleanups, tree plantings, and vine trimmings. She has also assisted on the restoration of Artesia's Historical Fire Station, which is known as LACFD Station

Outside of her contributions to the city, Michele spent a week in honored last month as "Woman of the Year" by Assemblymember New Orleans in March of 2006, where she participated in Hurricane Katrina relief efforts. Michele helped restore a damaged store and helped transform it into a home for the Neighborhood Story Project. The project is a literacy program that partners with the University of New Orleans. Most recently, she was appointed by LA County's 4th District Supervisor Janice Hahn to Artesia's Cemetery District.

> Christina Padilla-Birkey (Bellflower): Christina, known by her peers as "Chrissy," is currently the Executive Director of "Kingdom Causes", a community-based organization that focuses on bringing together local churches and city residents to build a strong, thriving community. Chrissy spearheads the organization's various efforts to combat homelessness, engage the community, create affordable housing, create access to better employment and job training opportunities.

> Chrissy has been with Kingdom Causes since its inception and has furthered her education and work skills by attaining her Masters in Urban Affairs.

> Outside of her work for Kingdom Causes, Chrissy is a member of the Bellflower Kiwanis Club, which is a service club that strengthens communities by helping children and young adults. She also sits on the Executive Board for Caring Connections, a non-profit organization based in Bellflower that seeks to meet the needs of children and families in need.

> Chrissy is also a tireless advocate for combating homelessness and providing much-needed services both within the scope of Kingdom Causes and outside of it. Whether it is her work within Kingdom Causes or her broader efforts to tackle homelessness, and current incarceration rates, Chrissy's motto is to "not only provide direct services, but to mobilize stakeholders in the community to get involved in these issues."

> Reyna Reyes (Bell Gardens): After leaving her country of Honduras in 1995, Ms. Reyna Reyes started a new chapter here in California. She settled in the City of Bell Gardens, where she is currently raising her three young boys. With her ambition to create a safe community, Reyna quickly became involved with the Bell Gardens Neighborhood Watch Program.

> For the past fifteen years, Reyna has not only connected her immediate neighbors to the program but has extended invitations to many families in her surrounding community. Through her efforts,

Downey man gets 6 years in prison for robbing fruit vendors

DOWNEY – A 26-year-old Downey man was sentenced last week to six years in state prison for robbing fruit vendors over a span of five months, the Los Angeles County District Attorney's Office announced.

At the court appearance on April 5, Miguel Rodriguez pleaded guilty to one count of second-degree robbery.

He also admitted that he was previously convicted of seconddegree robbery in 2007. A restitution hearing is scheduled for July 5 in Los Angeles County

Deputy District Attorney Simone Shay, who prosecuted the case, said Rodriguez robbed three separate fruit vendors on Sept. 11, 2016, Jan. 17, 2017 and Feb. 2, 2017, in the 6900 block of Paramount Boulevard in Long Beach.

On Feb. 14, Rodriguez was arrested in connection with the

The case was investigated by the Long Beach Police Department.

the program has had a turnout of 60 to 70 community members per meeting. Reyna also cooks home-made meals to provide food at these and the Cerritos Optimist Club. meetings, which incentivize residents to attend.

Through her efforts, the City of Bell Gardens has developed an active Neighborhood Watch Program that keeps families aware of recent crimes, educates families on crime prevention and encourages families to report suspicious behavior. Aside from volunteering around her neighborhood, Reyna serves as a parent liaison between Bell Gardens Elementary and the Bell Gardens Police Department. Reyna's passion for public safety is also evident in her participation at the National Night Out and at National Police Week, where she helps with outreach and attendance. Moreover, she shares this passion with her three boys, who also volunteer and accompany their mother in passing out information, brochures, and safety tips.

Lastly, Reyna is an active member of the Citizen's Patrol, a community led program where volunteers survey local areas to identify suspicious behavior or criminal activity and report it to law enforcement.

Mary Jane Fujimura (Cerritos): Originally born in Hawaii, Mary Jane was raised in a family whose parents and grandparents instilled a sense of community and giving back.

Mary Jane has volunteered all throughout her youth and college career. Always carrying a passion for the arts, Mary Jane became involved with the "Friends for the Performing Arts", an organization based in the city of Cerritos that supports the performing arts and provides scholarships to students excelling in their field.

As an educator, Mary Jane has served on the Teacher's Board and later chaired the Guild for the Friends. She also serves on the board for

the Hawaiian Senior Club, where she engages the youth and exposes guidance over a prolonged period of time. them to the Hawaiian culture. Mary Jane is also a member of various clubs, including the Soroptimist International Artesia-Cerritos Club

Outside of her efforts to engage disadvantaged communities, including youth and women, Mary Jane's self-declared great passion is volunteering for the "Go for Broke Organization." "Go for Broke" strives to honor the virtue and valor of World War 11 Japanese-American veterans. It also recounts the dark chapter of history for many Japanese-Americans who were forcibly relocated in intermittent

Overall, Mary Jane continues to live her life according to her parent's wisdom that it is "not about money but the giving from the heart."

Vanessa Perez (Commerce): For Vanessa Perez, a lifelong Commerce resident, things have come full circle. Vanessa spent her teenage years frequenting the City of Commerce Teen Center. She has since made her career there by working her way up to the position of the Teen Center Senior Recreation Leader.

Vanessa first began working for the city's center as a Teen Leader, where she helped expand various programs. Under her supervisor at the time, Vanessa expanded the center's annual camping trip, which is now known as "Adventure Club". Vanessa transformed the club and organizes various excursions for the teens. Not only do the students gain valuable volunteer experience, Vanessa says she enjoys taking the city's youth to different places to expand their horizons and visit places they "would not be able to go otherwise", such as visiting Skid Row. Vanessa undertakes the responsibility of fundraising for the trip, including the expenses for students' room and board and all excursion

Vanessa has worked at the Center for over 14 years and currently leads a "Girlology", a program at the Teen Center that provides young girls with the skills and resources to empower themselves. Under the program, young girls have the opportunity of going to various excursions and journaling about their experiences. Most recently, Vanessa took the students to see "Hidden Figures," a film on the untold story of African American Women working at NASA. Vanessa is not only a role model in her community, but a true asset that inspires young individuals to become invested in their community.

Sona Fundukian (Montebello): Sona Fundukian is the proud parent of 3 children and 2 grandchildren. She has been happily married for 55 years. Sona is currently the Chairperson of the Nairy Chapter of the Armenian Relief Society (ARS), which was established in Montebello in 1968. The Nairy Chapter of the Armenian Relief is one of ARS's 26 chapters and is dedicated to offering humanitarian aid, education, and various social services to those in need. ARS aims to promote and preserve the rich traditions of the Armenian culture by educating Armenian youth about their heritage.

During her time on the Executive Board, Sona realized there was a need to educate the local Armenian-American youth in and around her community. In 1982, she helped establish a Saturday School in the City of Montebello, which provides young Armenians the resources to learn their language, history and culture.

Sona also sits on several committees, including the ARS Scholarship Committee, which she originated. More specifically, she was instrumental in the creation of the "Nairy Scholarship," which awards deserving Montebello High School students of Armenian descent.

Outside of her work for ARS, Sona has a teaching career spanning over 33 years, including 5 years of teaching for the Sacred Heart of Mary High School in Montebello and 28 years at Bell High School. She child's education. has received a grant from the National Endowment for the Humanities (NEH) in 1995.

Mercedez Quintanilla (Norwalk): Mercedez Quintanilla is the current Executive Director and Founder of Door of Hope, an organization committed to providing supportive and caring team members that will serve as mentors to the youth. Mercedez is an action oriented leader, she saw a need for after-school programing for at-risk youth she knew that they would benefit from the sustained

She also has served as an administrator for the Norwalk Sheriff Station's "Personal Responsibility in Developing Ethics" (PRIDE) Program for the past seven years. This mentorship programs helps at-risk youth redirect their lives and teaches the lessons of taking responsibility for one's actions.

While serving as the PRIDE Program Administrator, Mercedez visited countless homes and helped at-risk youth connect with valuable social services. Due to her tireless efforts, she was recognized by former Los Angeles County's 4th District Board Supervisor, Don Knabe, as the 2013 Volunteer of the Year.

She also has served on the SARB (School Attendance Review Board) Panel and SART (School Attendance Review Team) for the Norwalk/LA Mirada School District. It was her time working with SARB and SART that she discovered a need for helping young students develop their attitudes and improve their academic success.

Bethania Perez (Pico Rivera): Bethania Perez is currently a senior at El Rancho High School and is on route to be the first in her family to attend a college. She is a leader in various clubs and organizations within her school and carries a passion to help first-generation students like her pursue a higher education.

She was recently selected to be part of former First Lady Michelle Obama's "Better Make Room" Student Advisory Board. The application for this competitive position drew in over 300 applications and Bethania was one of two students chosen from the State of California. The Campaign promotes higher education and a "college-going" culture in high schools throughout the county.

Bethania is currently the president of her school's California Scholarship Federation and is a link crew member, where she mentors middle school students as they make their transition into high school. This program creates a welcoming environment for high school freshman as they adjust to a new environment.

where she is one of 12 advisors that help their fellow students navigate various college applications and complete the FAFSA form to determine eligibility for federal student aid. In the near future, Bethania has her sights to attend Columbia

In addition, Bethania is a peer advisor at El Rancho High School,


University, where she would like to pursue a major in biomedical engineering and hopes to make a positive impact for females pursuing careers in STEM fields.



DOWNEY - The Downey Police Department is deploying extra traffic enforcement officers this month in search of distracted drivers.


"Downey PD is spreading the message that distracted drivers are not only a danger to themselves, but everyone else on the road," the department said in a statement.

Melba Bailey, retired teacher, dies at age 101

DOWNEY – Melba Prieta Thompson Bailey was born to Ada Lutz Thompson and Ford Thompson, Nov. 9, 1915, in Attalla, Alabama. She passed away Dec. 10, 2016, in Red Bluff, Calif.

Melba and her younger sister, Pearl, lost their father who died of typhoid fever in 1920. Ada relocated with the girls to Bakersfield, where she worked odd jobs to support her family.

When Ada contracted tuberculosis she could no longer care or the girls. In 1923, Melba and Pearl journeyed by

for the girls. In 1923, Melba and Pearl journeyed by train from Bakersfield back east to Cullman, Alabama where they entered the Alabama Odd Fellows Home for children. There they joined about 200 children in the care of the "Home." Their father had been a member of Odd Fellows, which had as a benefit the care of children under the age of 16 if their parents became unable to care for them.



It was there that Melba met an older 10 year old boy, Quinton C. Bailey. He was in the home with several of his brothers and sisters following the death, in 1918, of his parents, from the great influenza pandemic.

Following graduation from Cullman County High School in 1935, Melba enrolled in a teacher education program at State Teachers College in Jacksonville, Alabama, where she worked her way through college. She earned a bachelor's degree in 1938 in Elementary Education with a minor in Physical Education and a Special Education credential.

Quinton and Melba were married in Downey on Sept. 11, 1938, a marriage which lasted 69 years until Quinton's death in 2007.

The Baileys continued to reside in Downey where she obtained her first part time teaching job home schooling critically ill or disabled children. She was not employed full time because female teachers were not allowed to be married. A World War II shortage of teachers ended the marriage restriction enabling her to teach full time for 11 years in Southern California. At the same time, Quinton was working in the aircraft industry as a machinist.

In 1950 the family decided to return to rural life, and purchased an almond/walnut orchard in Durham, California. Melba taught in the Durham Unified School District for 26 years until 1976, but continued to substitute teach for 17 more years until 1993.

Melba and Quinton had three children, three granddaughters and nine great-grandchildren. The children are Gwendolyn Curran (Claude) of Ashland, Oregon, born in 1940, Vicki Bailey, born in 1945, and Craig Bailey (Jan) born in 1949. Both Vicki and Craig reside in Red Bluff, California. Melba and Quinton's granddaughters are Kirstin Curran Cronin (Tom) of Talent, Oregon and their children, Hayley, Kelsey and Lilly; Mardiss Curran Madden (Mike), also of Talent and their children, Taylor, Sean, and twins Aidan and Scott; and Kasia Curran Mannix (Seamus) of Milwaukie, Oregon, and their children Annora and Deagan.

A memorial service was held March 31 in Durham. In lieu of flowers, the family requested donations be made in Melba's name to the Durham Volunteer Fire Department, C/O Durham Community Foundation, PO Box 454, Durham, California 95938.



Here's what you can do for Middle East peace

While news swirled around health care and climate rules last month, another potentially momentous development slipped through the cracks.

It was the Senate's quiet confirmation of David Friedman to serve as the new U.S. ambassador to Israel. That vote threatens to create a mess of new problems in the already troubled Middle East.

Friedman, a Trump appointee, strongly supports Israel's settlements on Palestinian territory, which are illegal under international law, and opposes the formation of a Palestinian state.

Support for a Palestinian state — and opposition to Israeli settlements — has been the basis of U.S. policy for years. But Friedman's appointment represents a shift.

Since Trump took office, the Israeli government has approved the construction of over 6,000 new Israeli homes in West Bank and East Jerusalem settlements. And in early April, Israel approved the construction of its first completely new settlement in 20 years, deep in the heart of the West Bank.

The U.S. response? Near silence.

Under past administrations, we could have expected immediate condemnation. But earlier this year it took four provocative settlement announcements to elicit even a tepid U.S. response.

These changes are important.

For more than a decade, officials have been warning that the window of opportunity for realizing the two-state solution is closing. This begs the question: Do these changes mark the formal closure of the Middle East peace process? And, if so, what does that mean?

Israel's settlement policy has long stood in the way of a twostate solution. By putting Israeli homes on Palestinian land, they make it nearly impossible to draw a border between Israel and a viable future Palestinian state.

In the early 1990s there were approximately 110,000 Israeli settlers in the West Bank and another 150,000 in East Jerusalem settlements. Today, there are over 350,000 settlers in the West Bank and more than 300,000 in East Jerusalem. In total, settlements now It is a play about the Challenger space shuttle disaster. control over 43 percent of all West Bank land.

So, what should those concerned with peace do?

Simply speaking out is no longer enough. Neither is calling for a return to the established peace process, which has failed for a quarter-century now.

Instead, what's needed now are actions to impose a cost on Israel for its settlement building and continued occupation.

For governments, that means cutting bilateral assistance programs, modifying or ending special trade arrangements, and implementing sanctions. For individuals, it could mean boycotting and divesting from companies complicit in Israel's settlement enterprise and military occupation.

It's these concrete actions, not just words, that will make change.

At the same time, the international community must also take time to evaluate the peace process to understand why it's failed. We must ask what a new goal might look like if two states can't be had lots of rain, we still are not out of the woods with our drought. achieved.

What does it mean to build peace in a post-two state environment? How can equality and justice be achieved for all Palestinians and Israelis regardless of where they live? What might they are a problem. a peace process look like if it were based on the idea of achieving justice and equality rather than ethnic separation?

Exploring these questions won't bring immediate relief to people whose land is being confiscated or who are victims of violence, but answers may open paths to change. And change is needed.

The plan also cuts the effective tax rates on the wealthiest A seminal study by Professors Benjamin Page, Larry Bartels, individuals and most profitable corporations, those doing phenomenally well right now.

> This draconian effort would intentionally and literally push working families into the cold, by zeroing out the Low Income Home Energy Assistance Program. If that weren't savage enough, the administration also wants to cut the Women Infant and Children (WIC) food program that provides nutrition assistance to about half the babies born in this country.

> The poor in this country often don't see themselves as poor, the late author John Steinbeck noted, but as "temporarily embarrassed millionaires." Maybe that's why some working class people support this administration.

I want to thank our California legislators for passing SB1, the transportation bill to fix our roads and bridges, which are badly in

Starting November 1, this law will raise the gas tax 12 cents a gallon, about \$10 per month for the average driver, which is less than the cost of a movie ticket, and will also raise vehicle registration fees, according to the value of one's vehicle.

The gas tax, which goes for road and highway repairs, had not been raised in over 20 years, since Governor Deukmejian was in office, and the money collected is now only worth half what it was then. In addition, the population of California has increased and the cars and trucks we drive use less gasoline on average. Electric cars have paid no gas tax at all. (They will pay a separate annual \$100 fee under the new law). All these factors have made it impossible to keep up with maintaining our essential transportation infrastructure.

The latest rains have done more damage to already potholedamaged roads, adding nearly a billion dollars to the cost of repairs in California. As the roads deteriorate, the cost of fixing them goes up. According to Governor Brown, if this law had not passed, it would have cost twice as much for repairs in 5 or 6 years.

To me, this is a win-win law: Jobs will be created in California and people will buy more fuel-efficient cars and trucks, which will help reduce global warming pollution.

As far as complaints that the money may be used for other purposes, we as citizens have the obligation and responsibility to communicate with our representatives in order t make sure the money is spent for the purpose it was intended, for fixing the roads.



1-in-4 students say they've been exposed to secondhand aerosol from e-cigarettes

being exposed to secondhand aerosol from e-cigarettes at least once within the past 30 days, according to data from the Centers for Disease Control and Prevention (CDC).

This includes about 4.4 take million students who are not combustible tobacco products current e- cigarette users, and more than 1 million students who are not exposed to secondhand smoke from combustible tobacco products like cigarettes, cigars, and hookahs.

The U.S. Surgeon General has concluded that e-cigarette aerosol can contain harmful and potentially harmful substances, including nicotine. E-cigarettes can also be used to aerosolize marijuana and other illicit drugs.


The data, the first to document the extent of secondhand aerosol exposure among the nation's youth, comes from the 2015 National Youth Tobacco Survey (NYTS) and are published today in JAMA Pediatrics.

"We know that secondhand e-cigarette aerosol is not harmless," said Brian King, Ph.D., M.P.H., deputy director for research translation in CDC's Office on Smoking and Health and a co-author of the study. "It's critical to protect our nation's youth from this preventable health risk."

Findings from the study

Overall, exposure secondhand aerosol e-cigarettes in an indoor or outdoor place was reported by 24.2 percent of students. By subgroups, exposure was:

- 9 percent among males; 26.7 percent among females
- 0 percent among non-Hispanic whites, 24.5 percent

Whittier eighth-grader overcomes physical challenges to lead team in STEM competition

WHITTIER – Los Nietos Middle School eighth-grader Jared Avalos an exercise he repeats each evening. He attends physical therapy lets his imagination soar each time he meets with classmates for the school's Mathematics, Engineering, Science Achievement MESA Program, escaping all his day's real challenges.

Jared's road to the competition has been more challenging than most. Three years ago, he suddenly lost the ability to walk, MESA Regionals, though he has already scored a high mark with his confounding his family. The 24-year-old Norwalk native has been working on his 16 song debut mixtape entitled "The Beginning" for the past year and is finally ready to release it later this month.



NEW CAPTAIN: James Tatreau assumes leadership of Norwalk Sheriff's Station

NORWALK - Norwalk Sherriff's Station has a new captain in the form of James Tatreau.

Tatreau says that he feels he was destined to be an officer, coming from a lineage of public service.

"I come from a law enforcement family. My dad, he was an LAPD commander," said Tatreau. "I think I was destined to be a police officer. I really think being a police officer was a job created for me...I truly love helping people, and helping people in my sense of that word was being a guardian over those people that needed that help and couldn't do for them what I could do for them as a police officer."

Tatreau's career started when he was 20 years of age when he spent around five and a half years at the Men's Central Jail, moving on to Pico Rivera and eventually to Norwalk, where he originally was a deputy.

He has spent a fair amount of time at the Norwalk Station throughout his tenure, however spent some time away after moving on to Headquarters Bureau and being promoted to sergeant and arriving at Lennox Station.

"I've hit this station at every rank," said Tetreau. "It seems to be kind of like my home, if you will, because I keep coming back...I've only been gone a year and a half, so I know it very well still."

Now as captain, Tatreau says he intends to "lead from the front."

"To lead by example and to show the deputies by example what it means to be a professional law enforcement officer, and how to foster and cultivate good working relationships with the business owners, the community people, and the kids as well as the seniors in this community," said Tatreau.

"It's those relationships that help us do our job more effectively."

The local community has expressed concern about an increase in crime and violence – notably an increase in shootings - over the last several years.

This has not gone unaddressed by the new captain.

"I'm concerned as they are with the shootings. Shootings are up; there has been an increase in shootings," said Tatreau. "I've got a couple plans in place to tackle that...I hope to have some success there."

When asked what some of his strategies might be, Tatreau said that it has to do with bringing more personnel in from outside of Norwalk.

"It's not a lot of secret stuff," said Tatreau. "It's bringing in people and showing that we're here and that we're going to do some enforcement."

Tatreau has been in his new position for just over a week now. He asks the community for its continued support.

"Continue to be a good partner with us," said Tatreau. "If you're skeptical, give us a chance...For those who have had a negative experience with us in the past, I just ask that you not judge all of us by that one experience because we all make mistakes."

Tatreau continued: "Just because I'm wearing this uniform doesn't mean I'm going to defend my people blindly; I will defend them, but I will also be reasonable and fair." --Alex Dominguez, staff writer

Flipping houses -- it's not like TV

Flipping a house can seem like a walk in the park when it's wrapped into a few montages during a half-hour TV segment. Find a run-down property. Buy it. Take out a few walls, paint, replace carpets, upgrade the kitchen and voilà - you could make tens of thousands of dollars in just a short time.

Reality is seldom so straightforward. Flipping a home can be risky, and there's no guarantee you'll profit.

Finding and buying the right house at the right price point can be difficult: The shows often start with the submission of a winning offer on a home. You may not realize that it takes a lot of work to determine what a potentially good flip looks like and find a property to match.

Experienced flippers have learned how to estimate costs and work backward. A rule of thumb in the industry is to take 70 percent of the potential selling price (what's known as the after-repair value, or ARV), subtract the renovation costs and use that as the maximum buying price.

You'll need a lot of background information, including comparable selling prices of similar homes, to figure out the right numbers. The ability to be honest with yourself while estimating the cost of parts and labor is also important.

For example, if you estimate that you could sell your renovated home for \$200,000, you'd start at \$140,000 (70 percent of a \$200,000). If you calculate that the renovation costs will be \$40,000, you'll arrive at the maximum buying price of \$100,000. The 30 percent margin that remains if everything goes according to plan isn't entirely profit; you may still have expenses like closing costs or reimbursing your investors.

You need a lot of working capital: While paying cash for a home can expedite the sale and increase profits, it might not be an option for beginner flippers. However, traditional



lenders don't necessarily offer unexpected if you're trying to fix up a dilapidated home. Even when they do, you might not be able to borrow enough to cover all your expenses.

Instead, some flippers turn to hard-money lenders, private between the purchase and individuals or companies that issue short-term loans backed by real assets (such as the and property maintenance, home you're buying). agent to get access to the multiple listing service (MLS), a directory of homes that are for sale. Others look for homes that are for sale by owner (FSBO) or use direct mail campaigns to reach out to prospective sellers.

Once you buy the home, there's another race against time to complete the work and make a sale. Working with a trusted contractor and real estate attorney could expedite the project. Once you've developed a strong working relationship, you may even want to invite others to join your team and contribute their work in exchange for a cut of the profits.

Bottom line: Flipping homes can be profitable, particularly for those who have professional real estate experience, but don't expect it to be easy money. Months of hard work can go into a flip without any guarantee of success.
