Di Loreto raced his 1968 McClaren M6B, unique in that he has


**DOWNEY** - A former Downey mayor and retired Superior Court restored it to originality as opposed to something more modern or powerful.

## Downey students bring home 47 medals at SkillsUSA competition



**DOWNEY** – Downey Unified students brought home 47 medals including 28 gold medals -- at a SkillsUSA competition held in San Diego over spring break.

Bringing together the top SkillsUSA students from across California to compete in areas of technical and soft skills, Downey Unified was represented by nearly 300 high school, middle school and adult school students.

"We are proud to announce that 28 of our students will be moving on to the National Championship Competition that will be occurring this summer in Louisville," said Phil Davis, Downey Unified's CTE and STEM Director. "This final outcome is a true testament to the hard work and focus that our teachers and students put in throughout the entire year."

Included with the 28 students who received gold medals, 11 received silver and eight earned bronze medals in a variety of handson and job-related competitions; making a grand total of 47 medal recipients combined from the competing Downey Unified students.

Downey Unified's gold medal recipients will be traveling in June to Louisville, Ky., to represent the state of California in the following areas of competition: Quiz Bowl, Esthetics, Career Pathway Showcase-Health Services, Masonry, Opening and Closing Ceremonies, CNC Milling, Career Pathway-Services Business and Employment Application Process.

Victoria Real and Xavier Valencia are the third set of SkillsUSA students from Downey Unified to be elected as SkillsUSA student delegates representing the state of California. Real will be stepping down as President and serving as a National Delegate and Valencia will be acting as a State Officer for this year's SkillsUSA student delegate board.

On April 27, Downey High School held its annual SkillsUSA Banquet

following the return of their students from San Diego. This banquet fell in succession with Warren High School's SkillsUSA Banquet.

Held at the Rio Hondo Event Center, this evening concluded with the 2017 SkillsUSA Student of the Year awards being presented to two students for embodying an exemplar competitor within the SkillsUSA realm at DHS. Currently a senior, DHS' Valerie Cortez was one of the students presented with this prestigious award.

Competing at the state level the last two years, Cortez attends Cerritos College in the early mornings and will graduate in June with her high school diploma. Additionally, already attaining 22 transferable University credits from Cerritos College, she will be attending Seattle University beginning her sophomore year.

Nicolas Acosta joined Cortez as being selected as one of the 2017 SkillsUSA Student of the Year award recipients. Acosta has been competing in SkillsUSA since his freshman year and has competed in the National SkillsUSA Championships in Mobile Robotics and Career Pathway: Government and Community Service.

He will be attending college in San Diego in the fall.

Currently with over 15,000 school chapters, Downey Unified is one of the largest chapters involved in SkillsUSA, with one or more students qualifying for Nationals every year since 2009. Last year resulted in 500 students competing in the Regional Championships, 300 qualifying for the State Championships, 36 making it to Nationals and ultimately culminating with two finishing as National Champions.

SkillsUSA is a partnership of students, teachers and industry working together to ensure America has a skilled workforce. Launched in 1967, this National Championship has grown from 54 competitors in three contests to more than 6,000 competitors in 99 hands-on occupational and leadership skill areas.

Young singer and philanthropist Eileen Garrido, 18, was honored with the Violet Richardson Award for her work with Children's Hospital Los Angeles, Children's Miracle Network and the formation of the Beating Hearts Foundation.

"Children's causes are very near to my heart, quite literally, said Garrido, who was born with a rare congenital heart defect and has already undergone three major surgeries for it in her lifetime. "My hope is that with similar views of health, fitness and philanthropy, one day we will eradicate rare diseases in children, and bring equality for women around the world.

Soroptimists also honored four individuals - Beth Crawford,

Catherine Page, Melissa B. Zarate- Ashley and Michelle. Galvan, and Giovanna "Giggy" Saab - as Women of Distinction.

Below are full bios on each of the award winners:

Philippa Sklaar: Philippa Sklaar is a survivor of abuse, author, coach and advocate.

Philippa immigrated to the USA after she fled from a violently abusive marriage and resolved to learn a lesson and be more careful next time. In America, she met a man who, on the surface, was everything that her first husband was not. Until she owned her own contribution to the dance of abuse, she was destined to repeat the pattern. Her story exists as proof of this.

She co-wrote "When Loving Him Hurts -- Recovery from an Abusive Relationship" and "The Affair --Recovery from Illicit Sex, Lies and Betrayal.'

She is also the author of "Hot Cuisine," and her clients included dignitaries such as Nelson Mandela, and Elizabeth Taylor was her first client in L.A. She appeared in Food Network's "Guy's Grocery Games" and with Margaret Cho in "Blind Dinner Party."

Her commitment to reduce domestic violence led her to create ABC at both of her girls' schools a non-profit, The Women's Voice Project. Her programs have been accepted by the Los Angeles Unified School District, the LAPD (Newton Division) and the California Institution for Women.

Catherine Page: As an active member of the community, Catherine has worked with many young people to develop life skills through Girl Scouts, Downey PTA, pageantry, her church and Special Olympics. She is a certified Special Olympics coach for both basketball and softball.

Catherine is an active member of the Gypsy Johnson chapter of the Assistance League of Downey where she has held the positions of philanthropic chair and recording secretary.

After completing her master's degree and post-graduate studies Children's Hospital Los Angeles. at USC, she taught at Cal State Long Beach and Dominguez Hills, and at University of Phoenix as a clinical teaching assistant. She is now a professor gerontology content expert and the assistant director for the Associate Degree Nuring Program at Rio Hondo College.

She has been at PIH Health Downey for 35 years and is the clinical nurse specialist in Adult Medical-Surgical Nursing and Wound Ostomy Continence Nursing. She has contributed to several nursing texts and most recently contributed to the cycling book "The No-Drop Zone."

She currently holds the title of "Mrs. Elite Downey, WOA." Catherine has been happily married for 30 years to Greg, and is the mother of

Melissa B. Zarate-Galvan: Melissa is married to Mario Galvan and mother to two young girls. She loves to workout, hike, barbecue and spend time with her family and

Melissa was introduced to the PTA HELPS Room about seven years ago and really took a liking to it. She feels it's a great place to see the direct benefit of the people and community it serves.

Having graduated from Warren High, Melissa feels a greater sense of prode knowing that when she helps, it directly helps her community.

At work, she started the employees' committee on an annual canned food drive. Now they do two can drives annually, plus assist with a toy drive. Keep Downey Beautiful also inspired her to organize two extra clean-up events for city employees to be involved with.

Melissa also helps with Little Kings Treasures, a local non-profit that serves children that are in the hospital on major holidays. Their mission is to share happiness with the kids and let them know others are thinking of them.

Melissa has been in PTA and and values her involvement in their education and that environment where they spend so much time.

Eileen Garrido: Eileen Nicole Garrido was born in 1999. Shortly after her birth, doctors informed her parents that Eileen had been born with a serious heart condition known as Tetralogy of Fallot, a complex heart condition that is fatal if left untreated.

At the age of 5 weeks, Eileen underwent her first heart surgery. She spent the next 12 months in and out of the hospital.

At the age of 13 months, Eileen underwent her second heart surgery. In June 2014, she underwent her years. third heart surgery, this time to insert a missing pulmonary valve. All the surgeries were performed at

After attending a rare disease conference in 2009, Eileen formed the Beating Hearts Foundation, which is dedicated to helping children with cardiovascular illnesses. The organization's motto is "Because every child deserves a healthy, beating heart."

In January 2007, at age 7, Eileen began taking voice lessons with Grammy-nominated voice coach Marta Woodhull. That December, Eileen recorded her first CD, titled "Part of Your World."

In 2009, Eileen recorded her second album, "Angel of Music," featuring music from Les Miserables, Disney, Phantom of the Opera, and an original song she wrote titled "Melody."

This spring, Eileen began work on her next album, a compilation of Broadway classics with proceeds benefiting the Heart Institute at Children's Hospital Los Angeles.

Through sales of her CD's, musical performances, fundraisers and speaking engagements, Eileen raises money and donates it to her primary benefactor, Children's Hospital Los Angeles. She supports CHLA programs such as Holidays from the Heart and the Literally Healing reading progarm, along with her annual foundation toy drives and gala dinner.

She supports and donates her time as a junior ambassador to CHLA and the Children's Miracle Network (CMN). Since 2009, Eileen has participated in events that have helped raise millions of dollars for CHLA, CMN and other children's

Eileen has been featured on local radio stations, and speaks and performs at venues throughout Southern California and the U.S., including The Mirage, MGM, Disney World, Staples Center and Dodger Stadium.

She has been recognized by California Assemblymembers Cristina Garcia and Ian Calderon and state Sen. Isadore Hall for her community work.

She was inducted into the Downey Kids Hall of Fame for her volunteerism, and was selected from more than 50,000 entries as a national winner in the Kohl's Kids Who Care Scholarship Contest.

Eileen was the recipient of the Kiwanis Youth Service Award and was made an honorary princess by the Downey Rose Float Association

Beth Crawford: Beth lives in Burbank with her two children, Tara and Erich. Both her children grew up at the YMCA, and her daughter Tara followed in Beth's footsteps, working at the YMCA of Burbank for nine

Beth says that the YMCA has played a big part on her children's lives as her children "grew up at the

Beth started working at the Burbank YMCA in 1992. She has managed several programs and is constantly wearing different hats. "It makes work fun, exciting and gives you a chance to learn so many things," she says.

Beth calls her 25 years at the YMCA "such a rewarding experience." She loves working at the Y, and calls it her home away from home.

"The YMCA is an organization that touches so many lives and makes a difference in people -- what else can you ask for in a job," Beth




Aside from teaching, he is the English department chair, serves on various leadership teams, occasionally subs in the dean's office at Warren and is a published author.

### How I survived death 3 times during **World War II**

#### By Harold Hougland

I avoided death three times in World War II.

The ship I was serving aboard during the spring of 1945 was operating with a taskforce off the coast of Japan.

Because the air was so stale in our sleeping compartment, I sometimes slept in a hammock on the forecastle where the air was fresh. As I crawled into my hammock one night, little did I realize that we were headed into a typhoon where the waves would grow to a height of 100 feet.

Luckily, before the waves grew that high, the spray woke me up -and when I put my hand down beside my makeshift bed, I discovered two feet of water beneath me.

Wide awake, I moved at maximum speed to the nearest hatch and scampered inside. The next wave would have washed me overboard as it did some 20 men sleeping on the catwalks around the flight deck, which is 90 feet to the waterline.

"cat fever," which results in a temperature of about 101, accompanied by a general nauseous and achy feeling. I knew the sick bay area was in a fairly restricting location,

On another occasion I contracted what the old salts referred to as

which led me to believe it might be difficult to get out of in case of emergency. Deciding not to turn myself in, as did the drummer of our band, I stood my midnight to 4 a.m. communications watch after which I hit the sack.

from the Japanese. When the first bomb exploded, I bounced up in the air about a foot from my bunk. And the first breath I took smelled of explosives and burning steel.

That morning we were hit with the 500 lb. armor-piercing bombs

I made a mad dash toward my battle station to discover it in

blackness and filling with smoke. We called damage control only to learn they were trapped by fire and smoke. We then formed a human chain and made it to an area where we could breathe.

one of the bombs which exploded right next to the chow line.

Later on I learned that all the patients in sick bay died due to suffocation. In all, more than 700 lost their lives that fateful morning.

God must have been listening to all those prayers going up to bring me through it safely and decided to answer them affirmatively.

I thank Him every day and don't take any of His blessings for granted.

## In Memory of Grace Wormer August 25, 1930 - May 2, 2017

Grace Wormer of Ontario CA died on May 2, 2017 of complications from a massive stroke and pneumonia, in hospice care at Inland Christian Home. She was 86, having been born Gretha Cornelia Tientjes on August 25, 1930 in Utrecht, The Netherlands to Bernardus and Grietje de Ruiter-Tientjes.

Grace grew up on a tennis club in Zeist where her father strung tennis racquets by hand, and her mother served concessions from the kitchen of their home attached to the clubhouse. As WWII broke out in Europe,

Grace and her brother climbed a tree to watch the German Luftwaffe bomb the village behind them, and she would gather food scraps from German soldiers occupying a nearby school. Her father worked for the Dutch underground, and her parents sheltered defectors from the German military and Allied soldiers. After the war, Grace excelled in the "Household School" and became an accomplished cook and seamstress. She created abundant needlework in crochet, knitting, counted cross stitch, hardanger, tatting, and later quilting. Grace taught kindergarten before marrying the love of her life John Wormer on November 7, 1956. Three months later, the newlyweds began a new life in America working together for a wealthy La Jolla CA family with John working as chauffer/gardener/butler and Grace as cook/ maid/governess. John and Grace became naturalized US citizens, moving 13 times their first two years in San Diego accommodating four of John's six brothers whose emigration from Holland they sponsored, again after the births of daughters Lucie and Peggy, and then to Bellflower/Lakewood for 27 years. The family was very active at Good Shepherd Lutheran Church in Downey, where in 1971 Grace returned to her love of teaching at the church's school. She taught a combination 1st/2nd grade class for 18 years, and her retirement money tree was spent chiefly on Legos to play with her six grandchildren. Grace also taught Sunday School, led Girl Scouts, and was a Youth Group leader with John. Later, John and Grace lived in Chino for 5 years and happily enjoyed retirement in Escondido for 6 years. After losing John in 2001, Grace moved to Inland Christian Home and joined Peggy's Sew Blessed Quilters ministry, where she was loved by many and known by them all as "Oma" until being called Home to be reunited with her beloved John.

Grace was preceded in death by her husband John in 2001. 

### Survey: Americans just as polarized as Congress

As bad as political polarization is in the nation's capital, the comparison between state and federal government. problem is worse in the citizenry beyond the Beltway, according to a survey of public attitudes about Congress and public affairs conducted by the Indiana University Center on Representative

Seventy-seven percent of those surveyed in late 2016 said that the American public is about as, or more, polarized than members of Congress. That's a significant jump from 2015, when the survey found 63 percent rating Congress and the public as similarly afflicted by polarization (which is defined as the movement of members of the two parties to the ideological extremes).

Indiana University has been conducting its public survey for more than a decade; the annual effort is overseen by Edward G. Carmines, Distinguished Professor, Warner O. Chapman Professor of Political Science and Rudy Professor at IU. "In 2016, we broadened the scope of the questions to gauge Americans' views on the relative importance of various elements of our representative government," Carmines said.

"I thought it was striking that majorities rated as "very important" both "a free and independent press" (54 percent) and "checks and balances in the exercise of power by the Congress, the President and the Supreme Court" (57 percent)," said Carmines.

An "independent judiciary" was rated as "very important" to representative government by 49 percent, and "a Bill of Rights that guarantees the rights of a political minority" earned the "very important" rating from 42 percent.

Only 30 percent rated as "very important" having "a Congress with power equal to that of the President."

The public's low regard for politics in Washington was strikingly evident in responses to several survey questions that posed a

When asked, "Should the federal government or state governments exercise more power in terms of policymaking?" 58 percent preferred state governments. To the question, "In general, do you believe that members of state legislatures or members of the U.S. Congress are more ethical in conducting their official duties?" 65 percent chose state legislators.

And when asked, "If you had a problem, are you more likely to seek assistance in solving the problem from your state or the federal government?" 75 percent said state government.

The contrast in the public's regard for state and federal legislators is sharp. Asked "How responsive do you think that your state legislature is to the concerns of people like you?" 54 percent said "very" or "moderately" responsive. But asked, "How responsive do you think that Congress is to the concerns of people like you?" 75 percent said either "not very" or "not at all."

"One notable finding in the survey is that the public holds a more favorable view of state governments even as it pays comparatively less attention to government at that level," said Michael M. Sample, IU vice president for public affairs and government relations and director of the Center on Representative Government.

When asked, "Do you pay more attention to news about the federal government or your state government?" only 31 percent said they follow state government news more than news about the federal government.

"This finding raises the question of how public attitudes might change if the media devoted more resources to covering legislative action in the state capitals, which typically do not receive as much scrutiny as Congress," said Lee Hamilton, who served 34 years in the House and is now a distinguished scholar at IU and a senior advisor

to the Center on Representative Government.

The survey found near-unanimous sentiment — 93 percent that polarization is a big problem for the functioning of Congress. Asked what steps might be taken to reduce polarization in the national legislature, the public seemed very open to suggestions.

Nearly half those surveyed thought it "very important" to end the gerrymandering that creates non-competitive elections in many House districts. About the same number saw it as "very important" to change the congressional calendar so members of Congress spend more time in Washington, where presumably they could focus on building relationships with colleagues across the aisle and forging legislative compromises, rather than spending so much time in their districts cultivating voter support.

More than half those surveyed saw it as "very important" to curb anonymous campaign attack ads and place term limits on members of Congress to ensure regular turnover.

The 2016 findings are based on a nationwide survey of 1000 people conducted in November and December by the internet polling firm YouGov Polimetrix.

Women's health is on the chopping block - again By Leslie Watson Malachi

My nieces, who range in age from 17 to 25, grew up in a very different world from the one I knew coming of age in the 1970s.

For their entire lives, abortion has been legal. And Planned Parenthood and other women's clinics have served as a steadfast source of health care.

Although access to reproductive care is still too often contingent on income or zip code, until recently it felt like our fundamental rights were, by and large, standing on solid ground.

It no longer feels that way — and that makes me truly afraid for my nieces

Politicians putting women's health on the chopping block isn't new. But the pain feels so much sharper with this Congress and White House chipping away at constitutional rights and slashing funding for women's health. The burden will fall heaviest on women who can least afford cuts, but who will be forced to pay the heaviest price.

These attacks, which are part of the larger war on women, have already begun in the few short months since Trump took office.

Not surprisingly, in April President Trump signed legislation to undo a rule protecting the Title X family planning program. I wonder if he knew or cared that Title X is a vital safety net program that has supported access to affordable health care — including cancer screenings, well-woman exams, and birth control — for millions of low-income people.

Does he know or care that about one in five Title X patients are African merican, nearly one third are Latino, and around half are white? That the vast majority of people who use Title X make do on incomes less than 150 percent of the federal poverty line?

The sad reality is most of those served by this program simply can't afford care on their own, and this administration doesn't care.

This newly signed repeal lets states prevent Title X patients from accessing critical health services if their local health care provider also provides abortions, like Planned Parenthood. This should be seen for what

it is: a shameful move that puts partisan politics above the health of lowincome women and their families — including many who voted for this administration.

Despite recent failed attempts to repeal the Affordable Care Act, extreme politicians remain committed unnecessarily to "defunding" Planned Parenthood. Why unnecessary? Because since 1976, Congress has had a rule — the Hyde Amendment — that prevents federal dollars from paying for abortions.

That means Planned Parenthood already can't spend tax dollars on abortions. So when politicians talk about "defunding" it, what they're really talking about is preventing women who rely on programs like Medicaid from accessing other services — like pre-natal care — through Planned

If Congress were to successfully shut down Planned Parenthood health centers, a breathtaking 2.5 million people, both men and women, would no longer have access to cancer screenings, birth control, and other critical services each year — likely causing a national health care crisis.

Whether she lives in the city, a suburb, or in a rural community, a lowincome woman would find herself with a personal health care crisis like no other in recent times. For many, there are simply no other affordable options to turn to if their local Planned Parenthood center shuts down.

Our right to safe, affordable, accessible health care is on the chopping block. As the attacks ramp up, women of all ages, ethnicities, and racial identities should be talking together, sharing together, and demanding together our right to be healthy. Our health — and that of our families and communities — should never be disregarded for the sake of political expediency.

For my nieces' generation — and for women across the country — the price is just too high.

of the world's natural wealth. Therefore, 11 million new people isn't nearly enough. We should send out a call for many hundreds of millions more to join.

It's so obvious that one has to wonder why the UN isn't working

After all, surely any country that hoards a planet's wealth for its benefit should expect to care for a proportional number of that planet's people. Setting aside who precisely benefits from the use of resources in any country, this principle is sound. It even has flexibility, depending on the resource you think is most important.

What would that add up to for say, fossil fuels?

According to the Worldwatch Institute, we use "about a guarter of the world's fossil fuel resources — burning up nearly 25 percent of the coal, 26 percent of the oil, and 27 percent of the world's natural gas."

accounts for 19 percent of the world's population. Think what we will about China, even as the world's biggest carbon emitter it's consuming far less energy than its fair share — thank goodness.

That's more than China and Russia combined, and China alone

By that calculation, the U.S. should be home to a quarter of humanity, meaning that 1.8 billion people should be passport-carrying U.S. citizens. So, rather than building walls and piling up restrictions to immigration, we should fling our borders wide open to welcome 1.5 billion more.

But if an additional 1.5 billion people isn't appealing, then let's use another measure.

How about copper? In 2015, the total worldwide copper consumption amounted to 21.8 million metric tons, of which our share was approximately 1.7 million, or 8 percent. Fine, that's easier to bear, but it does mean that we still need to increase our population by 281

We can close our borders and even ask the 11 million immigrants to please leave because we've decided to relinquish our claims to the world's resources. Or we can do the same because we're going to reduce our consumption to the 4.4 percent we're rightly allotted.

Or we can simply grant citizenship to the 11 million undocumented migrants and millions more because it's the right thing to do. Surely that's a sensible alternative to foolishly consuming ourselves and the planet to death while cruelly expelling people.



### Things You Didn't Know About Downey: Downey Cemetery

**DOWNEY** - The only cemetery in Downey opened in 1868 and holds many graves of the city's pioneers. Many tombstones at the cemetery feature designs and material which are no longer being

The cemetery was marked as a historical site in May 1981 in conjunction with the Memorial Day service that year. The Downey Historical Society dedicated its ninth historical plaque at the cemetery during the Memorial Day service and members of veterans organizations participated in the ceremony.

The cemetery began as a family burial plot and now, according to some records, is the final resting place for more than 3,000 individuals, including veterans of every war from the 1846 Mexican-American War to the Vietnam conflict. Many founding fathers, pioneer preachers, early aviators, frontier homemakers and their little children are buried

When the cemetery started it was surrounded by farmland and had many wooden markers. The first known accounts of cemetery management began in a ledger dated 1889. According to ledger notes, some expenses were for mending fences to keep out chickens, and for purchasing a scythe for clearing grass.

Notes from the 1920's stated the cemetery was covered with weeds, gophers, gopher snakes and lizards to the point that the cemetery was looking very creepy and sad. Lakewood Boulevard was not there at that time and the old, deep wagon road to the cemetery was covered heavy with sand.

Some famous Downey people buried in the cemetery are the Ardis family, John Kirby Banks, Thomas Blythe, Andrew Jackson Bramlette, Dr. William Andrew Brown, Issac Newton Cochran, Maston Duke Crawford, Alegeron Sidney Gray, William Hammerton, Emily Nelson, Sidney L. Parke, Benjamin Franklin Witherspoon (our early constable and sexton of the Downey Cemetery) and a grave for Indian Joe, a Kaweah Indian.

Take a walk through the Downey Cemetery and see if you can recognize some of the names of the early pioneers. See how many of them have been honored with streets being named after them.

If you want to learn more about the history of the cemetery, visit the Downey history center.

### At Santa Fe Springs elementary school, chess is cool again

SANTA FE SPRINGS - Chess typically involves silence, poise and restraint from its players, but not at Rancho Santa Gertrudes Elementary School. Those matches are a mix of cheering and laughter.

The Rancho Chess Club features 27 members and meets weekly as students exercise creativity and lateral thinking. The club is readying for its final tournament of the year on May 20 at Rancho Santa Gertrudes where they will face off against other Los Nietos School District students.

As the club nears the end of its year, fifth-grade teacher and Rancho Chess Club coach Joe Nevarez has moved beyond the basics of the game and is showing students more intermediate tactics. Such moves include "The Fork," an attack that threatens two pieces at once; and a "Pin" that traps valuable pieces.

Nevarez started the Rancho Chess Club 10 years ago to provide bored K-6 students with a meeting space while passing on his love of Chess to a younger generation. Nevarez also sought to teach critical thinking to his Chess Club members and help them to see creative processes of chess.

"When you're playing chess, you have to be creative and you have to be able to think ahead. It's a development booster of their metacognitive thinking," Nevarez said. "When Common Core standards started transitioning into the District, we saw the Chess Club as another opportunity help student achievement.

Using creativity to beat an opponent is an especially exciting aspect of the club.

"The club is fun because you get to learn everything about how to play chess," second-grader Arrielle Lieb said. "It's a fun game because it really makes you think about what moves you should do and how to think things out."

The program has also shown to be consistently popular, with attendance ranging from 25 to 40 kids each year and many students staying in the club until they leave the school.

The club has also been rewarding for Nevarez, who enjoys watching the progression of each player.

"The best moments of being the coach of this Chess Club are when a kid beats me," Nevarez said. "I know I shouldn't feel good about a child beating me at chess, but I do because I feel like I did my job and taught them well."

Though the Rancho Chess Club takes up a great deal of Nevarez's personal time with meetings and events, the sacrifice yields positive results for many students on a yearly basis.

"The Rancho Chess Club is a shining example of how our District goes beyond classroom instruction to ensure student improvement," LNSD Superintendent Jonathan Vasquez said. "After-school programs like this Chess Club are important because it's a fun way for students to grow and improve."

After passing the State Bar in 1971, Conley maintained a private practice as a litigator for many years specializing in criminal and fraud cases, although qualified for eight specialties.

Conley's love of NCAA Men's March Madness resulted in him being a guest sports writer for the Sacramento Observer for many years. Since 1982, Conley attended every NCAA Regional and Final Four game, with the exception of the year his mother passed away.

### High school students tour Downey courthouse

**DOWNEY** – Several Downey and Warren High School students were given the opportunity to tour the Downey Court and converse with many of the professionals who work there.

"It brings reality to that which hopefully they've been learning in the classroom," said Coto-Lopez. "A lot of the information that we learn throughout our academic life is premised on books or and occasional video presentation. But when you actually get to walk on to the location, walk in to the court house, you get to see the dynamics in play. You get to see how each individual fills its roll, not just in theory but now in practice."

In 1945, the first atomic bomb was dropped on Hiroshima, Japan, by the United States, which ended World War II, thus eliminating further casualties of U.S. soldiers and of Japanese too.

Hiroshima is my father's ancestral home. In the fall of 1989 I

I never forgot the story my uncle told me about when the bomb fell. He said, "I rushed to the city to help. There was destruction all over. Amidst the rubble, I found a little girl – three or four years old – crying on the beach for her parents. I looked all over for her parents, but couldn't find them. Everyone was homeless. The city was destroyed. There was nowhere to take her, so I brought her

He had four children of his own. Food and other necessities

At the time I visited, the girl had already married and was living There stood the Gambaku Dome, translated Atomic Dome, the in Tokyo quite away from Hiroshima. I asked my uncle, "Does she remember you?"

> He answered, "Yes, she has never forgotten and comes to visit me from time to time."

> In 1999, ten years later, I visited Japan again. Sadly, my uncle property next to a forest.

> He told me something I had completely forgotten. After the war, he said, "You sent me a box of old clothing. In it were a sweater and gloves. The winter was cold. Those things helped me so much."

I believe that because of this we became very good friends. Unfortunately, our friendship came very late. My uncle's name was Yoshima Uyeno.
