DOWNEY – Downey High School will induct seven alumni its its Hall of by the industry with several prestigious awards including, Ernst & Young's Fame on May 19.

This year's inductees include:

- Jim Stecklein, park design visionary and community volunteer
- brothers Paul and Peter Martini, cyber security entrepreneurs

■ and Wesley Terasaki, Rodney Terasaki, Stanley Terasaki and Carey Terasaki, brothers who have earned a combined 11 university and advanced degrees, including two medical degrees.

Induction ceremonies begin at 10:30 a.m. in the Downey High School theatre. Below are brief bios on each of the inductees, as provided by Downey high School

JAMES STECKLEIN (CLASS OF 1947): While a student in TERASAKI: Certainly, the impressive accomplishments of all four children Downey schools, and during his college years and his years of military service, James Stecklein excelled in athletics and demonstrated effective leadership, both on and off the field. Although the Stecklein family had a successful business* in Downey that was central to the needs of its citizens, it was Mr. Stecklein's passion for sports, interest in physical activities and fitness, combined with his aptitude for service, that channeled his efforts into a lifetime of dedication in strengthening the community through focusing upon the need for shared recreation.

More recently, iboss was ranked #3 for Security Companies in the Deloitte Touch Fast 500.

Peter is active in the community, serving on the board of the San Diego Economic Development Committee and on the California Office of Emergency Services Cyber Security task force.

The Martini brothers have pioneered proprietary algorithm technology that has paved the way for their iboss cybersecurity product and corporation to become one of the leading companies in the web security market.

THE FOUR SONS OF DR. SHIGEO AND MRS. RYO of Dr. Shigeo and Mrs. Ryo Terasaki satisfy the threshold for induction into Downey's Hall of Fame; however, it is examining the Terasaki sons' achievements in light of their full context and background, which makes for a powerfully inspiring story. The Terasaki parents made a choice to be positive and productive - despite encountering vexing circumstances.

Stecklein had a vision for a park, not only to be a place of relaxation, exercise, and escape, but to provide a setting where people can join together in celebration of the arts through music. Stecklein's conception and establishment of a park, designed with a concert venue as its central feature, has significantly influenced both the layouts and activities of today's community parks.

Following his retirement from the Parks and Recreation program, Stecklein continues to work with the cities of Downey and Whittier. His keen interest in the importance of community and prioritizing recreation is evidenced by his on-going dedication to developing programs, which draw communities together. His efforts concentrate upon reaching out to youth, as well as all-the-way through the more-seasoned members of these communities, by his volunteerism with the local philanthropic historical societies.

Stecklein's work in preserving and sharing the historical and cultural aspects of a community, help society hold onto the rich heritage of its unique history while he endeavors to help foster the neighborhoods of today.

* Steck's Hardware & Furniture Store, from 1931 – 1960, located on Front Street aka Crawford Avenue aka Downey Avenue. The store location did not change; only the street names changed. The family sold the building in the 1970's. Today, the old hardware store is the site of the Assistance League Thrift Store on Downey Avenue.

PAUL MARTINI (CLASS OF 1997): Paul Martini is the CEO, cofounder and chief architect of iboss Cybersecurity, where he pioneered the award-winning iboss Cybersecurity Platform that protects networks against malware, advanced threats and data loss direct-to-cloud, with an innovative node-based architecture.

Prior to founding iboss, Paul was with an electrical engineering firm where he developed proprietary security solutions for clients such as Phogenix, the U.S. Navy and Hewlett Packard, leading the design and implementation efforts for HP's e-tester used in their TU print heads.

Paul holds a computer science degree from the University of California, San Diego and has had his work published in prestigious scientific journals including, the Journal of Foundations in Computer Science, and Journal of Analytical Biochemistry. Paul has been recognized for his leadership and innovation, receiving the Ernst Young Entrepreneur of the Year award in the technology category for San Diego, and one of Goldman Sachs' 100 Most Intriguing Entrepreneurs of 2014.

PETER MARTINI (CLASS OF 1997): As President and co-founder of iboss Cybersecurity, Peter Martini has played a major role in developing iboss' innovative technology and has helped shepherd iboss' phenomenal growth, since its founding. He has been awarded dozens of patents focused on network and mobile security, and with his brother, has been recognized

WESLEY TERASAKI, PH.D., MD (CLASS OF 1965): Wesley

Terasaki graduated from Downey High in 1965. He earned his bachelor's degree in biochemistry at the University of Southern California in 1969 and immediately started graduate school there in cellular and molecular biology. USC awarded him his PhD. in 1974.

He found a research position at the School of Pharmacology at the University of Virginia and conducted research there until 1979. He also taught at the School of Pharmacology. His research addressed the metabolism of cyclic nucleotides, and resulted in three patents, including a betaadrenergic blocker and a machine to automate immunoassays.

Terasaki entered a special program at the University of Miami (FL) School of Medicine, in which all students are holders of doctorate degrees. The program compressed medical school into two years; he graduated in 1981. (His completion of medical school in 2 years inspired his youngest brother, Carey, to complete law school in 2 years.)

Terasaki's medical career took him to the Seattle area; he served his residency at Virginia Mason Medical Center. He is board-certified in Internal Medicine, and practiced as an Internist for more than 30 years, retiring in 2016.

He recorded "Waves Upon the Sand" in 1985 and "An Evening with Wes Terasaki and Friends" in 1997; both are compilations of his faith-inspired songs. He has written approximately 100 songs total.

STANLEY TERASAKI (CLASS OF 1968): Stanley Terasaki was

a 1968 Downey High School graduate. As a senior, he ran track, including a leg on the mile relay team, which set the DHS record that lasted until metric distances became the norm. He graduated the University of Southern California in 1972 and began his career in teaching, for the Los Angeles Unified School District.

He earned his Master's degree in counseling and guidance in 1990, from Cal State Los Angeles. He was employed by LAUSD for 36 years, primarily at the secondary level. He did almost everything one can do in education, including teaching aide, teacher, counselor, assistant principal, and principal.

Terasaki has written a children's book, "Ghosts for Breakfast," which was published in 2002. It won Lee and Low Books' New Voices Honor and was one of Smithsonian magazine's Notable Books of 2002. He has also written two drama/musicals, "Gardena, U.S.A." and "A River in the Desert: Christmas in Manzanar." The backdrop of those plays is the World War II imprisonment of Japanese-American civilians; the plays have been performed in Southern California. He has conducted writing workshops and spoken at writing conferences throughout California.

He retired in 2010, and is currently helping his son establish a church in north Texas; their experiences in establishing the church are on his blog at https://aplanolife.wordpress.com/.

Downey High graduate of the prestigious Class of 1971. As a senior, he was the fastest sprinter on the swimming team and was its captain and MVP.

He became somewhat of a Renaissance man after graduation, earning bachelor degrees in English and in biology; prior to entering medical school, he drove ambulances and taught middle school. He graduated from the medical school at Tulane University in 1983, with honors. His medical career took him to the Seattle area; he served his residency at Virginia Mason Medical Center. He is board-certified in Internal Medicine, and has practiced as an Internist for more than 30 years. He has taught students at the medical school at the University of Washington since 1993.

Today, Terasaki continues with his love for water and for the practice of medicine. He competes for age group titles in several triathlons each year and enjoys time out on the waters of the Pacific Northwest, chasing the elusive king salmon. He enjoys filling-in for primary care practitioners at Pacific Medical in the Seattle area.

Carey Terasaki, J.D. (Class of 1973): Carey Terasaki has had the good fortune of two rewarding careers, the first in the aerospace industry and the second in federal government service. An engineering graduate of the University of Southern California, he served as an Engineer/ Scientist for the Douglas Aircraft Company in Long Beach, helping to design transport airplanes.

In 1984, Southwestern University School of Law awarded him a John J. Schumacher scholarship; he completed Southwestern's Conceptual Approach to Legal Education program in the requisite two years. Terasaki was hired by the Federal Aviation Administration in 1987 and was fortunate to complete his career there as a staff attorney and manager. At the FAA, he became a recognized expert in administrative law, rulemaking and civil penalty enforcement, with special emphases on aircraft maintenance and aircraft airworthiness issues. He represented the FAA in several capacities, including as counsel for the agency's Europe, Africa & Middle East Area Office in Brussels, and as Deputy Regional Counsel in Los Angeles.

Carey Terasaki retired in 2016.

BACKGROUND: Both Terasaki parents, Shigeo and Ryo, were born in RODNEY TERASAKI, MD (CLASS OF 1971): Rodney Terasaki is a the United States (California). Being Japanese-Americans in California in the 1920's and 1930's presented unique struggles of finding opportunities for employment. But the events on and subsequent to December 7, 1941, brought a new set of challenges.

> In 1941, Shigeo attempted to volunteer for the US Air Force - and later the Navy and Marine Corps - and was denied based on his ethnicity. Soon thereafter, the US Army did draft Shigeo. Meanwhile, following the Pearl Harbor attack, Executive Order 9066 required that Ryo (and nearly all the members of her family) be imprisoned.

> The family was initially moved to live in horse stalls at the Santa Anita Racetrack, and then was relocated to an internment camp in Wyoming. Through a chain of events, Ryo and Shigeo met in the Southwest and were married in 1945. When the West Coast ban was lifted against Japanese, the Terasaki couple moved back to California, essentially restarting their lives from the ground floor (or possibly the basement, considering the lingering prejudices held by many). Each had obtained some college studies before returning to California, which were ultimately completed, resulting in advanced degrees: Shigeo earning a medical degree and establishing a successful family practice, and Ryo receiving nursing credentials.

> Later, Ryo earned a teaching credential, and also developed an avocation for the arts through the medias of oil and watercolor. She devoted many decades to her passion in furthering the arts through creating, competing, demonstrating, and also teaching art in several Southern California communities' programs. For the Terasaki parents, rather than viewing the world as a place filled with obstacles and roadblocks, they saw the beauty in opportunity.

> The journey of parents Shigeo and Ryo provided life-lessons for their family, upon which their sons have fashioned their own lifeworks, instilled with key core values: tenacity and hard work are rewarding; education is viewed as a means to grow and to fully contribute to the community; in spite of current circumstances, one makes a decision to rise each day to see beauty, finding both humor and pleasure amid the toil; and achieving the ultimate satisfaction in knowing that good work remains to be done.

Average sales price of Downey home tops \$600K

DOWNEY – The average sales price of Downey real estate last month was \$600,687, up 11 percent from April 2016, according to data released by the Downey Association of Realtors.

In April 2017, there were 66 new listings in Downey, up 16 percent from 2016. There were 31 closed listings, which was a 3 percent reduction from 2016.

Year to date, 140 homes averaging a selling price of \$586,275 have sold in Downey

There is currently an inventory of 122 Downey homes for sale.

Whittier seeks \$120K from property owners

DOWNEY – The city of Whittier is demanding \$120,000 from a Downey couple who own a Whittier apartment complex that was red-tagged last year.

Hector and Francisca Iribe own the property at 12724 Whittier Blvd., which was red-tagged after the structure was deemed unsafe.

According to the Whittier Daily News, the 24-unit complex was deemed unsafe by a judge who personally visited the property in December. Among the property's problems were exposed wiring and a "door to nowhere:" a second floor door that led outside with no balcony.

The property was also zoned for commercial, not residential use.

Whittier had to pay \$30,000 in relocation benefits to affected families, plus \$70,000 in attorney fees, \$8,000 in staff time, and \$7,100 to board up the property, city officials claim.

Condo project moves forward

DOWNEY – The City Council on Tuesday unanimously approved a zone change for 10361 Foster Rd., paving the way for a 14-unit condominium complex.

The two-story homes will range from 2,431 to 3,122 sq. ft.,

Each home has its own two-car garage, with an additional 52 off-street parking spaces.





Downey city planner William Davis calls it a career

DOWNEY – After over 16 years in service to the community, trying to do for the last 20 years or so." longtime City Planner William Davis is retiring.

Davis began his service to Downey in January of 2001. Until then, he public servant. says he had no prior experience with Downey.



SPORTS: Vikings swim to league championships

The Downey High School girls' swim team is the 2017 S.G.V.L. champion.

The Lady Vikings finished their season with an undefeated record. Downey won all three relays at league finals and crowned several individual league champions: Nektaria Anagnostou won the 100 and 200 freestyle, Jania Gregorio won the 100 butterfly and Maritza Ochoa won the 100 backstroke.

The finish for the 100 backstroke was exciting and came down to the final stroke.

Captain Valerie Vazquez placed second in the 50 and 100 freestyle and junior Alejandra Villa placed second in the 100 breaststroke and 200 IM. Coach Sal Castro is extremely proud of how well his swimmers competed.

C.I.F prelims and finals were May 10 and May 12, respectively (results unavailable at press time).

The Downey High School boys' swim team also claimed the S.G.V.L. title. This marks the sixth straight S.G.V.L. championship for the Downey boys' swim team.

Downey swimmers swam some of their fastest times when it mattered most. The Vikings were led by senior captain Marcus Powell who set two individual S.G.V.L. records. Powell placed first in the 200 IM with a time of 2:02.72. This time was two seconds faster than last year.

Powell also placed first in the 100 breaststroke with a time of 1:02.03. This time was also a new record.

The Vikings also placed first in two of the three relays. The 200 freestyle relay was swam by Powell, Dominik Del Carpio, John Choi and Andrew Cabrera and finished in a time of 1:32.57. The 400 freestyle relay also finished first with a time of 3:24.51 and broke the league record that stood for six years. This relay consisted of Powell, Del Carpio, Cabrera and Nathan Lopez.

In the 100 butterfly, juniors Uriel Angeles (57.64), Humberto Banuelos (56.73) and sophomore Jesus Marguia (57.91) all placed but more importantly dropped time to qualify for C.I.F.

Downey and Warren went back and forth throughout the meet. Downey was able to clinch the meet by placing first, second and third in the 100 breaststroke. Powell finished first, junior Werner Rosales (1:05.38) finished second and senior John Choi (1:06.52) finished third.

Coach Delhousay is extremely proud of this year's squad, especially the seniors, and looks forward to competing in C.I.F prelims and C.I.F. finals.

The Downey High School boys' volleyball team finished S.G.V.L. play in second place with an overall record of 16-10 and a S.G.V.L. record of 7-3. The Vikings are currently ranked 7th in Division 4 and are back in the playoffs for the first time in three years.

The Vikings defeated Heritage Christian in five sets 25-22, 25-17, 23-25, 24-26 and 21-19 in their first round playoff game on Tuesday. Downey played Long Beach St. Anthony's (19-6, 9-1) yesterday in the second round of Division 4 play (score unavailable at press time).

The Downey High School boys' tennis team finished S.G.V.L. finals with five players advancing to semifinal and final round play and three players claiming individual league champion honors.

Nico de la Pena took first place in singles play and the team of Simon Choo and Renzo de la Pena took first place in doubles play. David Reoyo and Justin Park finished in third place and are first alternates.

Downey High School boys' golfer Victor Macias has won his second straight S.G.V.L. championship.



The budget process remains broken

Think about this for a moment: Two days away from a federal shutdown, Congress comes up with a stopgap measure to keep the government operating... for a week. A few days later it arrives at a bipartisan budget deal lasting a bit over four months. This, in turn, moves the President to take to Twitter with the following statement: "Our country needs a good 'shutdown' in September to fix mess!"

With respect to President Trump, this assertion seems more focused on settling political scores than on the good of the country. There is no such thing as a "good" shutdown. The last time it happened, in 2013, it cost the economy \$24 billion, according to Standard & Poor's at the time. National institutions get shuttered, federal workers are out of a job for an indeterminate period, federal loans and support for veterans are frozen, state and local governments — and all the businesses, non-profits and community organizations that depend on them — face cash shortages, and the country's most economically vulnerable must shift for themselves. All that and more happens during a shutdown.

Yet this is the state of budget politics in this era. We're the world's greatest democracy, and every few months we have to contemplate the very real possibility that the government might close its doors. Is this really the best we can do?

If the non-profit or business you respect most operated in this manner, would you be anything but appalled? Somehow, we've allowed ourselves to see this as standard operating procedure for the federal government.

government — remember, the budget is the national blueprint for vhat we'll do and how we'll do it — gets handled in such a distressing, irrational, ineffective, uneconomic, and almost nonsensical manner?

I'll tell you how: We keep electing people who tell us they're distressed about conducting business in this fashion and then year after year fail to get us back on track.

Because make no mistake, we know how to do it better. Congress did it for many decades. It handled appropriations bills through committee hearings, gathered expert opinions, allowed members to propose improvements, and vetted federal taxing and spending thoroughly in both the House and the Senate before passing it on to the President. We had a steady annual process that may have had its difficulties, but offered the country a democratic and politically rational mechanism for deciding on our priorities and how to fund them

we've been forced to live with a process marked by high-stakes fiscal brinksmanship. Every important decision of government is reflected in the budget, but now we operate through omnibus spending bills and continuing resolutions, all of which put the government more or less on automatic pilot. Operations and processes that should be reviewed annually get no real scrutiny. New initiatives are rarely considered.

The current budget deal, negotiated between Republicans and Democrats, at least has the virtue of having included both parties

How can it be that the most important document of the federal at the table with give and take on both sides. In Washington these days, that's what passes for good government.

> But let's not mistake it for good process. Congress is still putting the budget together with no accountability, no transparency, and scanty debate. Most of it is written in secret largely by leadership staff. The process largely excludes ordinary members of Congress, except to vote after very limited debate. It offers little opportunity to consider amendments or expert testimony, or to conduct careful evaluations of proposed improvements and reforms. The ordinary self-corrective mechanisms that should keep government on an even keel are not operating.

And here's the interesting thing: in all my conversations with public officials familiar with the current state of affairs, I can't find a single one who defends it. They all know it's bad process. But they keep using it year after year.

This is a real challenge to our representative democracy. The We haven't followed it since the middle of the 1990s. Instead, government faces enormous responsibilities at home and abroad, and the budget is the blueprint for how it's going to deal with them. Isn't it time we started getting it right?

Can police officers get a fair trial in America?

Lock your doors. Hide your children. Police officers, be on alert:

Al Sharpton's cop-bashing circus is back in full swing.

Harlem's godfather of racial hoax crimes is in Oklahoma this week to stir up trouble as jury selection begins in the manslaughter trial of Tulsa police officer Betty Shelby.

Shelby is white. Terence Crutcher, the man she shot and killed during a tense traffic standoff last fall, was black. That's all the demagogue demolition team needs to know. Damn the facts. Screw due process. Powder up Showbiz Al and hustle over to the media tent.

Lights, cameras, agitate!

Sharpton's "prayer vigil" isn't about expressing faith in God. It's about stoking the fires of identity politics at the altar of social justice. Sharpton's no man of peace. He's the fetid pile of human manure who ruined New York prosecutor Steven Pagones' life with the incendiary Tawana Brawley rape hoax. He stoked anti-Semitic hatred in Crown Heights after a tragic car accident — leading to the frenzied mob murder of rabbinical student Yankel Rosenbaum. He has inveighed against "crackers" and cracked jokes about "offing the pigs.'

Also headlining the self-serving service in Tulsa this week: Sharpton's rabble-rousing heir and fellow race fabulist, Benjamin Crump. He's the Florida-based celebrity lawyer for the Trayvon Martin and Michael Brown families who gained international notoriety perpetuating the "Hands Up, Don't Shoot" lie. Crump first parachuted into town last fall to snatch up the Crutcher family as new clients and to instigate protests outside Tulsa police headquarters their stories after being approached and coached by confirmation demanding Officer Shelby's scalp.

This week, the Oklahoma Court of Criminal Appeals rejected a motion by lawyers Randy Coyne and J. Christian Adams to submit an amicus brief in the Holtzclaw case on the dangerous hijacking of the courts by the social justice mob. Their message deserves to be heard.

"There is a First Amendment right of free speech. There also is a First Amendment right to petition the government for a redress of grievances. say they just won't buy his \$21 billion boondoggle. But Mexicans are the ones blunting Trump's other major attack on them — an attempt to slap a 20-percent border tax on products shipped into the US.

"Nobody knows more about trade than me," The Donald crowed during his presidential run. Narcissistic hyperbole aside, it turns out that Mexican farmers do know a lot more about corn than he does and they know that a lot of U.S.-Mexico trade consists of corn.

This drove hundreds of thousands of Mexican producers out of business and made Mexico - where corn originated — dependent on imports from the U.S.

But now, Mexicans are turning that imported corn into a political weapon against Trump's trade bluster. Rather than buy from the U.S., they're negotiating to import corn from Brazil — and even more significantly, they're planning to invest in their own farmers to make Mexico self-sufficient again in this important crop.

Their counter-offensive has caused apoplexy among congressional Republicans from the U.S. corn belt. About 75 percent Planned Parenthood does not provide prenatal care. However, they of Iowa's corn, for example, goes to Mexico, and losing that market do provide the killing of 300,000 pre-born children every year, which would devastate Iowa's economy.



Paging Dr. Frischer...

Joe, my dear friend from back in my medical school days, was a hemophiliac. He was frequently a recipient of blood transfusions.



Many of us know someone who has needed a blood transfusion. Perhaps they had a disease, like Joe, or were in an accident, or became dangerously anemic. Perhaps they had the luxury to choose whether or not to have a blood transfusion, or perhaps they faced an emergency life or death situation requiring an immediate transfusion. What are the benefits and risks?

In 1628, a British physician discovered that blood circulates throughout the body. The first

successful blood transfusion occurred in England in 1665 when one dog received the blood from another.

Finally in 1818, a British obstetrician performed the first successful transfusion of human blood to a patient, to treat postpartum hemorrhage.

A patient may receive a blood transfusion when they have lost blood from a trauma, have had surgery with blood loss, lost blood due to an ulcer, or has a disease that causes a shortage of red blood cells. An *autologous* red blood cell transfusion is when a donor's

own blood is used for them at a later date, usually before a planned approximately one in 1.5 million transfusions, and the risk of getting surgery.

A blood transfusion can save a life. It replenishes the body's red blood cells, which reduces the symptoms of anemia, such as lightheadedness, fatigue, weakness, and shortness of breath; and in the case of heart patients, even angina or a heart attack. New guidelines recommend that red blood cell transfusions be considered when the hemoglobin level drops to about seven or eight, depending on the age and general health of a patient, and depending on whether there is active bleeding.

If it is not an emergency, the blood will be typed and crossed in order to make a proper match and avoid possible serious complications. In an emergency where time is of the essence, a patient will receive the universal donor blood type, O Negative. Even O Negative blood can lead to serious reactions, but is the best for an emergency.

However, blood transfusions are not completely without risk:

 Incompatible blood can possibly cause an anaphylactic reaction or hemolytic anemia. Serious safeguards are in place to prevent this, such as type and cross procedures and multiple staff verification of bags. Medication can be given before a transfusion to reduce risk.

It's possible for pathogens to be introduced into the blood stream, leading to infections. Fortunately, this risk has diminished dramatically over time - for example, the Mayo Clinic lists the odds of developing HIV at around one in every two million transfusions (less likely than being killed by lightning); the risk of hepatitis C at

hepatitis B at about one in 300,000 transfusions.

Bacterial infections are possible but rare.

Jehovah's Witnesses may oppose blood transfusions on religious grounds. Refusing the possibility of a transfusion may lead to the refusal of a surgeon to conduct a surgery. Today, Jehovah's Witnesses have a Hospital Liaison Committee to address legal or moral conflicts.

My friend and classmate Joe's story ended tragically. Our medical school was in San Francisco, and the time was the early 1980's. AIDS was just being identified, and he became one of its earliest victims. Had he received those blood products today, they would have been effectively tested for the AIDS virus, and even with hemophilia, he could possibly still be with us today.

Blood transfusions are an extremely valuable, life-saving, and safe treatment. The Red Cross provides about 40% of the blood used for transfusions, and I urge everyone to donate blood.

A BRIEF HISTORY OF THE DOWNEY MASONIC LODGE

DOWNEY - During the summer of 1871, about the time the typewriter was put on the market and Alexander Graham Bell made to attend the Grand Lodge and petition that body for a charter. Bros. his first call over the telephone, a group of Masons in the community of Downeyville met to discuss plans to formulate a lodge of Free and Adams, J. W., were elected. Accepted Masons.

It was not easy – the men had to come from nearby communities and traveling was limited to the trot of old Dobbin. But they recognized the necessity of perpetuating Free Masonry and dedicated themselves to the task with the vigor and courage that sustained the pioneers of that time.

At the second meeting the name of "Downey" Lodge was decided upon. Lexington Lodge No. 104 of El Monte was requested to recommend the petition for a dispensation.

A third meeting found all necessary papers ready, and it was voted to forward them to the Grand Secretary for the approval of the Grand Master. The dispensation was approved and on Oct. 30, 1871, the first meeting was held in the "Mercantile house of Bro. Frank E. Adams", located at the southeast corner of what was then known as Santa Gertrudes and College Ave., now Paramount Boulevard and Alameda Street.

In the by-laws adopted at this time we note: Art. III Sec. 1, "The Stated meetings of this Lodge shall be holden on the Saturday of or next preceding the full moon in each month." A motion was passed making the dues "50c per month payable quarterly. able quarterly."

The next few years the Lodge prospered along with the community which saw the town site of Downey planned and laid out by the then ex-Governor John Gately Downey and his brother-in-law, Judge M. D. Crawford. Also, the Southern Pacific Railroad was completed through Downey during these years.

In these early days picnics and box socials were quite popular, and the members of Downey Lodge were always present as noted in the minutes of the meeting of April 20, 1872: "An invitation to join the I.O.O.F. in a Pic Nick on the 26th inst. was accepted" as "friends and citizens.'



On Sept. 14, 1872, a resolution was introduced to name delegates Woodville M. Andrews, W. M.; William W. Edwards, SW.; and Frank E.

The first meeting under charter was held Nov. 1, 1872, at which time They met at the home of the Methodist minister, Rev. W. A. Spurlock. Bro. Samuel Prager, Past Master of Los Angeles Lodge No. 42, acting by authority of and as proxy for the Grand Master, officiated at the institution of Downey Lodge.

> The exact date is not known, but it was either at the abovementioned meeting or shortly thereafter that J. G. Downey, Governor of California during 1860-1862, presented Downey Lodge with a set of silver jewels in appreciation for naming the Lodge "Downey" Lodge.

> On Nov. 9, 1872, the Lodge ordered a vote of thanks sent to Gov. Downey. This item is of particular significance as these same silver jewels are being worn by the officers of the Lodge today.

> On this same date a bill of \$18 for carriage hire was ordered paid if the carriage was used by Bro. Samuel Prager as transportation "to come to Downeyville from Los Angeles to institute Downey Lodge and install its officers."


> During 1873 a Masonic Cemetery site was purchased. It was improved and landscaped into a beautiful cemetery and remained in control of the Lodge until 1925, at which time it was deeded to the County of Los Angeles. It is located at the northeast corner of Lakewood Boulevard and Gardendale Avenue.

> During the latter part of 1873 it was decided to sell the Lodge's interests in their meeting place and occupy it on a rental basis. Later we learn that in 1874 the I.O.O.F. had formed an association known as the Los Nietos Building Association and that the Downey Lodge purchased 40 shares at \$10 per share.

> When the I.O.O.F. Temple was completed, it was arranged that the Masons would meet in this temple. It appears that Downey Lodge met in the I.O.O.F. Temple from Aug. 1874 until the present Masonic Temple was completed in April, 1923.

> On Nov. 18, 1883, at a meeting of the Lodge, several brethren made request for demits to form Norwalk Lodge No. 315. Bro. Geo. Frampton, affiliated with Downey Lodge from Idaho Lodge No. 1, was one of this group. Also Bro. J. E. Elliott, a Past Master of Downey Lodge, who was elected first Master of Norwalk Lodge, Bro. Geo. R Frampton, a son of George, joined Norwalk Lodge when he was 21 years of age in 1895 and is now the present Grand Bible Bearer of the Grand Lodge of California.

> The years that transpired from 1874 until 1920 were in all probability normal years for Downey Lodge. However, during this period Southern California was growing by leaps and bounds and the people of Downey were witnessing such events as: in 1877 the first carload of oranges was shipped to the East; in 1880 the University of Southern California was founded; in 1882 the first telephone was put in service; in 1889 Orange County was formed from Los Angeles County; in 1899 work began on Los Angeles Harbor; in 1904 the first motion picture was produced; in 1914 the first ship arrived via the Panama Canal.



Many other developments that were formally looked upon as fantastic dreams were now realities and important factors in the improvement and progress of our community. The Brethren of Downey Lodge wanted to be a part of this progressive movement, and on Feb. 6. 1920, a committee consisting of Bros. Reeves, Doherty and Willard was appointed to obtain information regarding the construction of a Masonic Temple for Downey.

On June 4, 1920, the committee was instructed to proceed with incorporation proceedings and the Masonic Building Association of Downey was formed. On Nov. 4, 1921, Bro. Walter M. Booth reported that a meeting of the Board of Directors of the Masonic Building Association would be held on Nov. 8, after which a vigorous campaign would be instituted to raise the balance, about \$3,500, to bring the amount to \$10,000.

Bro. Booth has worked untiringly as a member of the Board of Directors and much if the success of the development of the Temple is due to his foresight and judgment. Bro. Arthur L. Darby on June 2, 1922 reported for the committee that a sufficient amount to qualify with the Corporation Commission had been paid and that we were in position to proceed with the actual building of the Temple on the site at 3rd Street and Crawford Avenue. Later, Crawford Avenue became Downey Avenue.

It is an interesting fact that the contractors for the construction of the temple were "Bogue and Towne". Bro. Waldo Towne was Worshipful Master and Bro. William Bogue was Senior Warden of Downey Lodge during the completion of the Temple. Thus, the Brethren of the Lodge were assured that wisdom and strength would be molded into the framework of the structure.

The cornerstone of the temple was laid without ceremony on Monday, Nov. 13, 1922, due to the inability of the Grand Master, Samuel E. Burke, to come to Downey at that time.

Bro. Arthur L. Darby asked for and received the distinguished privilege of presenting the Lodge with the letter "G". The presentation was made prior to the meeting of April 6, 1923.

Worshipful Master Waldo Towne announced on March 2, 1923, that the meeting for April would be held in the new temple. At that meeting two petitions for the Degrees of Masonry were read, one from Chas. M. Van Dusen, now a Past Master, and one from Lester Lane.

A committee was appointed to arrange for an open celebration to be held the last Friday of the month. At a special meeting on May 16, 1923, the Grand Lodge F. and A. M. of the State of California was opened in due form for the purpose of dedicating the new Temple of Downey Lodge No. 220 F. and A. M.

The ceremony was attended by approximately 80 members of the fraternity. Since that time the Lodge has steadily grown from the handful of pioneers to our present membership of 386. It has survived three wars and several depressions and yet that same spirit of tolerance and effort once displayed by its founders is ever present with those that are entrusted with the future of our Lodge.


Let us dedicate our efforts to the memory of those "Builders" of the past so that those who follow will inherit a temple well built on the foundation of brotherly love, relief and truth.

Summer Escape: San Antonio

Visited by more than 28.1 million annual visitors, San Antonio is a beautiful city at the axis of three different geological terrains: Hill of San Antonio, is an excellent place to explore by day and party by to the world-famous Shamu the killer whale. There are also thrill Country, South Texas Plains and Prairie and Lakes.

There's a lot to do in this city: fine art museums, historical missions and plenty of amusement parks in addition to great dining and lots of drinking. The culture and people are vibrant and interesting. Its downtown is one of the most lively in the nation.

San Antonio is considered to be the cradle of Texan liberty. Its most well-known landmark is the Alamo, the site of the famous battle (1836) where Davy Crockett and Jim Bowie were killed. Though it must be said that when most visitors see the Alamo for the first time, their common reaction is, "Hmm, I thought it would be bigger."

No other city in Texas reflects the state's Spanish and Mexican heritage better than San Antonio. Hispanics make up a considerable fraction of the population though and it shows in most places. The Hispanic atmosphere of San Antonio makes it a truly unique U.S. city. This becomes most evident during Fiesta Week, a yearly celebration that attracts 3.5 million people to its 110-plus events from all over to enjoy parades, music, festivals, fairs and food and drink in the charming downtown streets of the city.

San Antonio, with a population of around 1.4 million, and a metro population of nearly 2.3 million, still enjoys a small-town feel despite their stories, crafts, music, dances, and foods to share with visitors in the hustle and bustle. Its people are friendly, open and multi-cultural, and the concentration of population around its center makes it easy to get just about anywhere within a 30-40 minute drive.

Climate: During the summer it can get hot, and sometimes humid. Temperatures in the 90's and 100's are typical from May to September, though there are some days that stay cooler. April and October have also been known to get into the 90's even 100's, and during the winter it typically is cool and rainy. Carry a light sweater, you never know when the weather may change in San Antonio

Getting Here: San Antonio International Airport serves over 30 national and international destinations with non-stop service, and many more with one-stop service.

Only airport-area hotels have free shuttles, and they come to the airport only after you call them for a pickup. Downtown hotels may state that shuttle service is available, but they do not have their own shuttles; they are referring to the private services available at the airport.

Taxis are the cheapest option for service for 2 or more passengers going anywhere in the city if not taking the public bus, because they are priced by the car load rather than per person. Taxis are monitored by the city and the metered rate for downtown is in the range of \$27-29.

What to See:

The Alamo: Considered to be hallowed ground and the Shrine of Texas Liberty, the Alamo is a former mission which was also the site of the Battle of the Alamo (1836). Admission is free, although donations

are appreciated. Revenues from an adjacent gift shop fund the historic preservation efforts.

River Walk: The River Walk area, one level below the street level night. 

Shared Stories: Always doing her best

In this tribute to her mother, Yolanda Reyna recalls the modest circumstances of her childhood and her mother's talent for meeting the needs of a large family. Shared Stories is a weekly column featuring articles by participants in a writing class at the Norwalk Senior Center. When I was a young girl growing up, my family didn't have much. We were raised on welfare, but I do remember my mother making the best of everything!

Just going to cash her welfare check, she made sure she was properly dressed. She'd fix her hair so pretty, find the right outfit to wear, and put her lipstick on so perfectly.

My father also made the best of everything. I don't recall my father ever owning a suit, but when he got dressed, he'd put on a plaid shirt, a pair of blue jeans, and work boots. He also made sure that he was properly dressed, so he could drive my mother to cash her check and take her grocery shopping.

Back then my father owned a blue Chevrolet pick-up truck and most times the children rode along with them in the back of the truck. Sometimes I got to sit in front between my parents. It was so much fun! I'd stretch my neck out just to look out the window as my father drove down the streets. I still recall the sounds of the gears shifting.

There was a check-cashing place where my father drove my mother to. I remember the lines being so long! We had to wait for hours for our mother. While my father sat in his truck and waited, he would listen to the radio, while the children waited patiently in the back.

When my mother was done cashing her check, my father drove us to "Phil's Market." That was the grocery store where my mother shopped. I remember that market being on Rosecrans Blvd. in Compton. My mother would buy the children new toys on that day. The girls got miniature dolls and the boys got miniature toy army men!

When the grocery shopping was done my father drove us back home. We were so excited to get new toys on that day. We couldn't wait to play with them. While my sisters and I played in our room, my brothers played outside.

My mother really made the best of things when she was in the kitchen. While she cooked dinner, my father sat in the garage drinking his beer and listened to his music.

My mother did her best with what she had in the kitchen. When she cooked, she never measured anything. We didn't have measuring cups. I don't even recall us having salt and pepper shakers! She'd pour the salt in one hand and with the other hand, she would use her fingers to toss the salt in the pan, and all she needed was salt and pepper to season her meals.We never owned a whole set of dishes. We had plastic dishes and most of them had a burnt spot somewhere, or part of the edge was melted because she used them as lids for the pots as she cooked.

My mother never owned any Tupperware. She would use a cup or a bowl for anything that was leftover. The cup was mainly used for leftover tomato sauce. A meal that was often made was macaroni and tomato sauce.

She also made cut-up hot dogs and tomato sauce, or as she would call it "chopped up weenies and tomato sauce!"

We also had hamburger meat with potatoes and tomato


sauce. That was a specialty in our family, often handed down from generation to generation. That meal would later be called "The Poor Man Meal."

One more thing my mother made the best of, was her old fashioned remedy, Vicks! When one of the children got sick with a cold or cough or if one of us got a leg ache, which was often because we loved playing and running outdoors, she'd rub Vicks all over our chests or our legs!

My mother, the shopper, the cook, the hairdresser, the healer! Her legacy!

Within the first four months of being elected to the Downey City Council, I have had the opportunity to get an inside look at our community. I've started working on some key issues affecting our city but most importantly I've seen firsthand the many areas where our city shines and excels.

Community involvement and veteran recognition pride are high priorities in Downey, but I also wanted to help involve all service groups. From our council meetings, I have heard the concerns of our residents and I'm proud to see the recognitions that we bestow on so many deserving Downey citizens.

Some issues such as homelessness and coyote attacks on our small pets do not have simple solutions. However, the DNA of Downey involves the big heart of volunteers. Recently, I was proud to host a gathering of our service groups, churches and nonprofit organizations with in the City of Downey. Over 120 volunteers showed up to help organize and effectively manage the problems we face as a community. I was excited and encouraged to be reminded what an amazing city we have.

Here is an update on some of the things I have been working on for the past 100 days:


DOWNEY - Downey High School's Music Department will present its 2017 Jazz Gala Concert on Thursday, May 18, in the Downey High theater.


