Man killed in possible gang-related shooting

DOWNEY – Homicide detectives are investigating a fatal on Wednesday night.

Police officers responded to the location at about 7:30 p.m. after receiving reports of shots fired. They found a male adult suffering from what appeared to be multiple gunshot wounds.

Downey Fire Department paramedics transported the man to St. Francis Medical Center where he died. His identity has not been publicly released.

"During the course of their investigation detectives discovered shooting that occurred on the 7100 block of Luxor Street in Downey information that suggests this crime may be gang-related," police officials said.

New principals announced for 2017/18 school year

DOWNEY – The Downey Unified School District has announced two new principals and a director of special education for the 2017-18 school year, which begins Aug. 16.

Dr. Kathy Estevez will take over as principal at Gallatin Elementary, while David Cid will be at Rio San Gabriel Elementary. Dr. Patricial Sandoval is the district's new Director of Special Education.

The Downey Board of Education approved the appointments in May.

Dr. Kathy Esteve

As a product of Downey Unified, attending Gallatin Elementary School and Doty (then East) Middle School, Dr. Estevez has children who are enrolled in Downey Unified schools.

Estevez joined the district in 2014 as an assistant principal at Downey High School (DHS). In her tenure at DHS, Estevez oversaw the budget, AVID, Special Education, Cheer and Dance, and the School Site

Prior to joining Downey Unified, she served in several other secondary education positions including being an assistant principal at Los Padrinos Juvenile Hall, a Special Education Teacher Specialist, and a Math, Science and Health teacher in a continuation high school setting in Redondo Beach.

Although Estevez has been at the secondary level the past few

years, she began her educational career at the elementary school level for nine years; teaching fourth grade for six years and second grade for three years for the Redondo Beach Unified School District. During this time, Estevez was named District Teacher of the Year for Redondo Beach Unified. She also served as an elementary school summer school principal in Redondo Beach.

David Cid:

Mr. Cid has been a part of the Downey Unified family for the past 20 years, beginning his career for the district working as a substitute teacher from 1998 to 2004.

From 2004 until 2014, he worked as a Resource Specialist Program teacher at Carpenter and Rio San Gabriel elementary schools. During this time, Cid also served on the Instructional Leadership Team, was the coordinator of Character Counts and 504 plans.

San Gabriel Elementary School in 2014, and in 2015 through 2016 he worked as an administrator for summer school. Last year, Cid was hired as the vice principal split between Rio San Gabriel and Imperial elementary schools.

In addition to his experiences in Downey Unified, Cid also has past experience as a coach/manager for DJAA and the YMCA, served as the Director of Summer Programs for the Southern Baptist Association, acted as a Group Home Counselor and Manager, and was a church youth director.

Dr. Patricia Sandoval:

Although she began her career in Downey Unified in July, Dr. Patricia Sandoval is not new to the city of Downey. Growing up in Bell and currently residing in Downey, she comes to the district from the Anaheim Elementary School District where she served as principal for the past seven years.

Sandoval was highly regarded within Anaheim Elementary School District known as an expert at building a positive organizational culture. In the last year, she was handpicked to lead the efforts to transform a campus, a true tribute of her abilities as a leader.

Prior to her experience in Anaheim, Sandoval was a bilingual psychologist for five years and a bilingual teacher for eight years in the Los Angeles Unified School District.

Sandoval earned a Bachelor of Arts in Ethnic Studies from the University of California, Berkley, a Master of Arts in Education from UCLA, a Master of Arts in Counseling from CSULA, and a Doctor in Education (Ed.D.) in K-12 Leadership from USC. She has been an adjunct professor at California State University, Fullerton, and has presented at numerous educational conferences on topics such as "College Knowledge in the Classroom" and "Sheridan's Student Success Teams."



DOWNEY – A local business owner says his restaurant is slowly starting to recover after struggling to contend with major road construction.

Jack Wannebo, owner of Stox Restaurant & Bakery at 9518 Imperial Highway, says that recent road construction located on Bellflower Boulevard and Imperial Highway cost him and his restaurant \$300,000 in sales over 10 months.



Lopez has been swimming his entire life and is looking forward to his junior year. As a freshman, Lopez was on the J.V. water polo team and qualified for C.I.F. but did not compete. As a sophomore, Lopez was on a S.G.V.L. champion J.V. team and placed ninth overall in the 200 IM and tenth overall in the 500 Freestyle in C.I.F. Division Four competition.

Lopez is currently competing for the Downey Dolphin Swim Club in the Western Zone Championships being held at West Clovis High by smaller schools in Ohio and Illinois. Nathan would like to be a School near Fresno. This event started Tuesday and will conclude fireman after he is done competitively swimming.

Good communication lies at the heart of our democracy

Do ordinary citizens still have a voice in Washington and in their state capitals? Despite the cynicism of these times, my answer is, yes, we do... But we have to exercise it.

I don't just mean going to a town hall meeting and yelling, or shooting off a letter or email. I mean making an appointment to sit down with your representative — in his or her office, at a cafe in the district, or wherever else you can meet — and holding a real conversation. We don't do this often enough in our country, perhaps because most people think it's impossible to arrange. It's not, although it might take patience to get an appointment with a busy to communicate with their representatives.

This is important because the heart of a representative democracy does not lie in its electorate, or even its elected officials. It rests in the communication between them, in the give and take that allows each to understand the other. Over my years in office I noticed a few things about how to make this conversation more fruitful and effective, and, for what it's worth, I pass them along.

My guess is that in almost all cases, the representative will be gracious, attentive, and welcoming; he or she will see the meeting as a chance to reach out and perhaps win a constituent's support. What makes the difference in these meetings is the manner in which the voter approaches them.

So my first comment is that you want to keep the discussion respectful and polite. Incivility and confrontation are counterproductive. If you want to have an impact, do not be argumentative or confrontational. Explain how the issues affect you personally and make it clear that you're seeking to establish ongoing communication, not just a 'one and done' meeting.

If your representative comes to respect you because of your approach and your knowledge, that's an important step forward in expanding your influence. Because don't forget that the reverse can also be true: You'll make it easy to ignore you by behaving

This next part may seem daunting, but it shouldn't be: Do your homework. It goes without saying that you should identify yourself and whoever else is with you, let your representative know whom you're representing — don't exaggerate your numbers — and above all, make it very clear what you want him or her to do or not to do. And you'll be far more effective if you're well-informed about the core facts on the issues and about the person you're speaking to: his or her party, length of service, committees, interests, views, ratings and

Understand that legislators deal with many challenging representative. And to my mind, it's the most effective way for citizens relationships: voters, donors, constituents, interest groups, party officials, congressional or legislative leadership, governors and presidents, and an array of others. So, listen carefully and ask a lot of questions, and get clarity about where your representative stands on your issues and why. Test his or her knowledge of the issues, and the depth of commitment to the views he or she takes. Be firm in insisting on direct answers, but don't be adamant or unreasonable. If you want to, record the session, but be sure to advise the representative you are doing so.

> In short, having a productive conversation with elected representatives comes down to being informed, remaining courteous, being curious and open to dialogue yourself, and stating your views and understanding of the issues as clearly as possible.

> If you engage in this fashion with your representatives on a regular basis, I think you'll have reason to be satisfied that you're stepping up to your responsibilities and raising your effectiveness as a citizen. And if conversations of this quality are multiplied across the country, it really will improve the quality of our representative democracy and contribute to the direction and success of our country.

This should also simplify the work of our police and fire because the law is one that covers all of California, and not just a patchwork of cities.

Paralyzed from the waist down, Willie Young III discovers how to be a kid again

DOWNEY - When a stray and family were frightened for bullet from a drive-by shooter Young III, his family was shattered. The playful little boy known as "Three" suffered a spinal cord injury on Jan. 7 that would leave him paralyzed from the chest

His father, newly ordained as a pastor, was due to give his first sermon the morning after the shooting. In one second, the family's moment of triumph descended into tragedy.

"There was no movement or sensation below the gunshot wound," said the child's father, Willie Young II. "It was a tough pill to swallow, but you can imagine, you're just happy he's alive."

Three's medical condition was stabilized at Harbor-UCLA

their son's future. He was referred wounded six-year-old Willie to Rancho Los Amigos National Rehabilitation Center to begin the journey of rehabilitation that meant the whole family learning to adapt to a new way of life.

> Three's dad remembers: "The first thing I really remember is how many people I saw in wheelchairs and walking apparatuses. This place was full of people who were not giving up. Everybody wheeling by had big smiles on their faces. You saw people doing things. You saw guys on the campus who were sweaty and had a basketball on their lap. We realized this is where people come to regain the rest of their lives."

Rancho, now in the midst of its Rancho Rising 2020 expansion and upgrade, is the jewel of the vast Los Angeles County public healthcare system. One of the jewel's brightest facets is the veteran pediatric care team that rolled into action when Three arrived. Rancho pediatrician, Dr. Melanie Sarino, spoke to the parents first, helping them understand the extent of his injury and the purposes of rehabilitation.

"As the child grows older, his independence will become more important," Dr. Sarino said. "We train the family on how to help their child become independent. It is understandable for a family to feel helpless at first. But now they know what they have to work with."

One of the first tasks was encouraging Three and his eightyear-old sister that it was safe to play together.

Occupational Therapist Heidi Disneyland. Dombish said, "Being a kid is his job. His job is to play and to go to school. We showed him and his family that Three could do everything he could do before, just a little differently."



DOWNEY – A 27-year-old man from Hawthorne has been arrested on charges that he attacked a fast food restaurant manager after the restaurant refused to serve him for cutting

The attack occurred June 24 at Raising Cane's restaurant at Stonewood Center, police said.

Deandre Lorick allegedly cut in front of other vehicles in the drive-thru, prompting the restaurant to refuse service. One of the occupants of Lorick's vehicle filled a Gatorade bottle with what appears to be water and threw it at the manager, striking him in the face.

The vehicle fled westbound on Firestone Boulevard.

The attack was filmed by someone inside the vehicle and was subsequently posted online. As of Monday, the video has been seen more than 300,000 times on World Star Hip Hop.

Lorick faces a misdemeanor charge of aggravated assault. He is scheduled to appear in court Aug. 25.

This revelation sparked an idea in Farina, who desperately wants to make a connection with each and every one of her students and to make an impact on their lives.

Farina now shows "Freedom Writers" at the beginning of every

"Not to toot my own horn, but I have a very good rapport with my students," said Farina.

Recently, a unique opportunity presented itself; a five-day "Freedom Writers" conference that would put Farina under the tutelage of the teacher that she idolizes.

"I can't explain to you how amazing this conference was," said Farina. "That teacher - Ms. Gruwell - changed 150 students lives and continues to change people's lives... I walked in as one person on Friday and walked out a different person on Tuesday."

Farina has already starting to utilize many of the techniques and strategies that she learned at the conference. The conference also provides another potential opportunity, as Farina is now considered an official "Freedom Writer teacher" and can teach the course at Warren should the school decide to offer the class.

"Troubled teens need that, they need that guidance. They need that hand holding, they need that love," said Farina. "...Or even just a hug, letting them know that 'it's going to be ok, I'm here for you."



Downey space center receives 3D printers

DOWNEY - The Columbia Memorial Space Center, Challenger center, and New Matter announced Wednesday that the Challenger Center located within Downey's museum had been selected to receive five award winning MOD-t 3D printers as a part of the initial phase of the recently announced Challenger Center-New matter partnership.

The new printers – which were donated by New Matter - were immediately implemented into CMSC's 3D printing summer camp, where they will be used to help teach the basics of 3D printing as well as 3D designing and prototyping.

New Matter is a 3D printer company whose mission is to bring affordable 3D printing to homes, schools, and offices.

The partnership was announced at a press conference held at the Space Center, attended by museum staff, city officials, and several students who were attending the museum as a part of a field trip.

"We believe that 3D printing is a transformative way to bridge the divide between the digital and physical worlds," said Steve Schell, CEO of New Matter. "Working together [with the Challenger Center], we can drive STEM learning programs in meaningful new ways."

This is not the first time that the CMSC has utilized 3D printers into their programming. However, the new printers are "faster and more accurate," according to Dickow. He says the printers will be utilized in several different ways.

"Because this is a relationship between Challenger Center, New Matter and the Space Center, we're going to be integrating them into our Challenger Center program," said Dickow. "As far as new stuff goes, the 3D printing class summer camp is a brand new thing that we've started; we'll be doing more than that. Eventually, we do want to remake the first floor into a public makerspace, and we hope that there will be more than the five printers there for people to work on."

Details are still being worked out on how the day to day operations of the printers will unfold, however Dickow says that any museum guest should be able to come off the street and be able to use the printers "for the most part," with some kind of timing control involved.

LOS ANGELES - The Los Angeles County Arts Commission has announced \$4,518,000 in two-year grants to 196 non profit arts display at the Queen Mary in Long Beach. organizations through its Organizational Grant Program (OGP).

Grant amounts range from \$3,100 to \$152,600. Grantee organizations provide services throughout LA County with offices located in 46 of the county's 88 municipalities. "Through the ongoing funding commitment of the Board of Supervisors, OGP is able to support organizations that are making a tremendous impact for residents, neighborhoods and communities Countywide."

Applications were reviewed and scored by over 70 knowledgeable panelists from the arts community, including artists, nonprofit arts administrators and members of the academic community.

Grantees by discipline breakdown as follows: Arts Education (30), Arts Service (6), Dance (22), Literary (4), Media Arts (10), Multidisciplinary (36), Music-Choral Opera (11), Music-Instrumental (22), Presenting (2), Theatre (42), Traditional and Folk Art (5), Visual Arts (6).

Grantees included the Long beach Chorale and Chamber Orchestra (\$15,700), Long beach Community Band (\$4,000), Long Beach Community Players, Inc (\$24,5000), Long Beach Opera (\$44,300), Long Beach Symphony Association (\$47,900), San Gabriel valley Music Theatre, Inc. What are closing costs and how much are they?

Closing costs are fees purchase that are paid at the closing of a real estate transaction. Closing is the point in time when the title of the property is transferred from the seller to the buyer. Closing costs are incurred by either the buyer or seller.

Closing costs vary widely based on where you live, the property you buy, and the type of loan you choose. Here is a list of fees that may be included in closing. The list is inclusive of fees you may see, but it's not likely that your loan will include all of the fees listed here.

Application Fee: This fee covers the cost for the lender to process your application. Before submitting an application, ask your lender what this fee covers. It can often include things like a credit check for your credit score or appraisal as well. Not all lenders charge an application fee, and it can often be negotiated.

Appraisal: This is paid to the appraisal company to confirm the fair market value of the home.

Attorney Fee: This pays for an attorney to review the closing documents on behalf of the buyer or the lender. This is not required in all states.

Closing Fee or Escrow Fee: regulations and CC & Rs. This is paid to the title company, escrow company or attorney for conducting the closing. The title company or escrow oversees the closing as an independent party in your home purchase. attorney be present at every

Courier Fee: This covers the cost of transporting documents to complete the loan transaction as quickly as possible.

Credit Report: A Tri-merge credit report is pulled to get your credit history and score. Your credit score plays a big role in determining the interest rate you'll get on your loan.

Escrow Deposit for Property Taxes & Mortgage Insurance: Often you are asked to put down two months of property tax and mortgage insurance payments at

associated with your home Insurance Premium (UPMIP): policy that protects you in the shared fences on the property. If you have an FHA loan, you'll be required to pay the UPMIP of 1.75% of the base loan amount. You are also able to roll this into the cost of the loan if you prefer.

> **Flood Determination or Life** of Loan Coverage: This is paid to a third party to determine if the property is located in a flood zone. If the property is found to be located within a flood zone, you will need to buy flood insurance. The insurance, of course, is paid separately.

Home Inspection: You will likely get your own home inspection to verify the condition of a property and to check for home repairs that may be needed before closing.

Home Owners Association Transfer Fees: The Seller will pay for this transfer which will show that the dues are paid current, what the dues are, a copy of the association financial statements, minutes and notices. The buyer should review these documents to determine if the Association has enough reserves in place to avert future special assessments, check to see if there are special assessments, legal action, or any other items that might be of concern. Also included will be the loan servicer to be paid at Association by-laws, rules and closing.

Homeowners' This covers possible damages office, usually city or county, to your home. Your first year's for the recording of public land insurance is often paid at closing.

Policy Title Lender's Some states require a real estate Insurance: This is insurance to a survey company to verify to assure the lender that you own the home and the lender's mortgage is a valid lien, and it protects the lender if there is a problem with the title. > Lead-Based Inspection: Covers the cost of evaluating lead-based paint risk.

Loan Discount Points: "Points" are prepaid interest. One point is one percent of your loan amount. This is a lump sum payment that lowers your monthly payment for the life of your loan.

FHA Up-Front Mortgage Insurance: This is an insurance all property lines and things like event someone challenges your ownership of the home. It is usually optional.

> **Origination Fee:** This covers the lender's administrative costs. It's usually about 1 percent of the total loan but you can sometimes find mortgages with no origination fee.

Pest Inspection: This fee covers the cost to inspect for tax paid when the title passes termites or dry rot, which is required in some states and required for government loans. Repairs can get expensive if evidence of termites, dry rot or other wood damage is found.

Prepaid Interest: Most lenders will ask you to prepay any interest that will accrue between closing and the date of your first mortgage payment.

Private Mortgage Insurance (PMI): If you're making a down payment that's less than 20% of the home's purchase price, chances are you'll be required to pay PMI. If so, you may need to pay the first month's PMI payment at closing.


