Downey offense erupts for 56 points in win over San Pedro

DOWNEY – The Downey High School football team defeated San Pedro at Downey last Friday night, 56-42, improving to 3-1 on the season.

With the loss, the Pirates fell to 3-1.

Last Friday night's game saw 14 total touchdowns scored and 98 points put on the scoreboard. The game certainly had a Madden 18 video game feel to it with all the scoring. Downey defeated San Pedro last season at with the hard-fought, 20-12 win. San Pedro, 27-21.

San Pedro scored the first touchdown and Downey trailed 14-7 at the end of the first quarter. The Vikings came alive in the second quarter and scored three touchdowns. The Pirates scored one more touchdown and Downey took a 28-21 lead into the locker room at halftime.

San Pedro outscored Downey 14-7 in the third quarter and the score was tied at 35 as the third quarter came to an end. The Vikings put the game away in the fourth quarter as they scored three more touchdowns to San Pedro's one. Downey came away with the hard-fought, 56-42 win.

Downey has scored 133 points over the last three weeks, an average of just over 44 points per game. Viking quarterback Kijjon Foots and running back Baraq Ross have played well in leading the Viking offense. The Downey offense now appears to be clicking on all cylinders after being shut out by the Trinity League's Santa Margarita in week one.

Downey will host a 1-3 Santa Fe team Friday night. The Chiefs defeated South Torrance 42-0 last Friday night to get their first win of the season.

Coach Williams, his staff and players will conclude their preseason bye week next week and will open league play when they host Paramount 3-1 while Dorsey fell to 0-3. at Downey on October 6.

The Vikings will travel to cross-town rival Warren for their annual city The St. John's Cadets are currently 2-1 and ranked 46th nationally. showdown on October 27.

■ The Warren High School football team defeated Lakewood at Lakewood last Friday night, 20-12. With the win, the Bears improved to 3-1 on the season.

With the loss, the Lancers fell to 0-4. Lakewood defeated Warren last season at Warren, 28-22.

The Bears will host a 2-2 St. Paul team later tonight. St. Paul defeated

Swordsmen defeated the Bears 47-37 last season in an offensive contest. Warren is looking for a different result this season.

In the Warren/Lakewood game, the score was tied 6-6 at the end of the first quarter. Warren scored a touchdown in the second quarter and led 13-6 going into the locker room at halftime. Lakewood scored six points in the third quarter but Warren still led 13-12.

The score remained 13-12 as the fourth quarter began. The Bears added a touchdown and extra point in the fourth quarter and came away

Warren has scored 152 points over the last four weeks, an average of 38 points per game. Bear guarterback Chris Venegas has been outstanding thus far as have his receivers Robbie Colenzo and Desmond Carnes. The Bears' offense appears to be clicking on all cylinders.

Downey sales tax to reach 10% next month

DOWNEY – Downey's sales tax rate will increase to 10% on Oct. 1, the third tax increase in Downey this year.

According to the California State Board of Equalization, Downey's sales tax rate stood at 8.75% as recently as March 31.

It increased to 9.25% on April 1 to reflect voters' November 2016 approval of Measure S, a half-cent sales tax to fund public safety and infrastructure improvements in Downey.

Measure M, a half-cent sales tax approved by Los Angeles County voters in November 2016, pushed Downey's tax rate to 9.75% on July 1.

The latest tax increase occurring Oct. 1 can be attributed to Measure H, a .25 percent tax to raise money for homeless services in L.A. County.

The maximum allowable tax rate in California is 10.25%.

Downey named a finalist for 'Most **Business-Friendly City'**

DOWNEY - Downey has been named a finalist for most "Business-Friendly City in Los Angeles County."

In its nomination remarks, the Los Angeles County Economic Development Corporation praised Downey for its "great housing stock, a high quality of life, a skilled workforce, and a diverse population."

Other finalists include Compton, Inglewood, Lakewood and Long Beach for cities with populations of at least 68,000.

One winner from each category will be announced live at the 22nd Annual Eddy Awards on Thursday, Nov. 9, at the new Intercontinental Hotel at the Wilshire Grand in Downtown Los Angeles.

Business-friendly programs and services are a critical factor in jobcreation. The finalists were selected through independent review by a panel of blue ribbon judges, based on the following criteria:

- o Demonstrated priority commitment to economic development
- o Excellence in programs and services designed to facilitate business entry, expansion, and retention
 - o Competitive business tax rates and fee structures
 - o Availability of economic incentives
 - o Effective communication with and about business clients

Developer denied request to subdivide Orange Estates property

DOWNEY - The Planning Commission on Wednesday denied a developer's request to demolish a 19,000-sq.-ft. home in Downey's Orange Estates neighborhood and build two homes on the lot.

Located at 7741 3rd St., the 2-bedroom, 2-bathroom property was built in 1940 and features a 2,246-sq.ft. single-family home and garage.

According to property records, the property was sold April 29, 2016, to 3-E Enterprises Inc. for \$654,000.

The company proposed to subdivide the property into two lots, demolishing the house and replacing it with two single-family homes on separate lots measuring 8,972 square feet each.

The proposal complies with Downey's housing development standards, which require lot sizes of at least 5,000 square feet.

Vandals topple headstones at Downey Cemetery

DOWNEY - City staff says that repairs are nearly complete after several headstones were knocked over and damaged last weekend at the historic Downey Cemetery.

Public Works staff says that roughly 20 to 25 monuments were knocked over at the cemetery, which was discovered early Saturday morning by a regular cemetery visitor.

Downey Police were called and took a report of the incident. Work to repair the headstones and set them upright began Monday.

A staff member attached to the repair work said that as of Wednesday afternoon, only a few remained to be fixed, and would probably be done by Thursday.

According to public works staff, this is not the first time that an incident such as this has happened. Staff has also previously found paraphernalia possibly associated with ritualistic activity – such as cow tongues attached to trees and chickens either free-roaming or with their heads removed on the cemetery grounds.



Bernie Casey, actor and football player, dies at 78

Bernie Casey, a professional football player turned poet, painter and actor known for parts in films such as "Revenge of the Nerds" and "I'm Gonna Git You Sucka," has died. He was 78.

Casey died Tuesday in Los Angeles after a brief illness, his talent agent Erin Connor said.

Born in West Virginia in 1939 and raised in Columbus, Ohio, Casey excelled in track and field and football and attended Bowling Green State University on an athletic scholarship.

He went on to play wide receiver for the San Francisco 49ers and Los Angeles Rams before going back to his alma mater to get a master's degree in fine arts.

For Casey, the arts always came first. He painted and published books of poetry, but the football association that he viewed as a stepping stone followed him.

"It was just a gig," he told the Washington Post in 1977 about football. "But it limits the way people perceive you. That can be frustrating. People have tremendous combinations of talents. A man can be a deep-sea diver and also make china."

His art in particular captivated many famous minds, including Maya Angelou.

"His art makes my road less rocky, and my path less crooked," Angelou said of a 2003 exhibit of his works.

Casey's professional acting career began with "Guns of the Magnificent Seven," a sequel to "The Magnificent Seven," in 1969.

He appeared in some 35 films, including "Boxcar Bertha," "The Man Who Fell to Earth," "Brian's Song" and "Never Say Never Again."

Reminder: During an earthquake, drop and take cover

LOS ANGELES – The recent 3.6 magnitude earthquake that struck near Westwood at 11:20 p.m. on Monday and 7.1 magnitude earthquake near Raboso, Mexico on Tuesday prompted a reminder from Los Angeles County authorities that a catastrophic earthquake could occur at any time.

The following are some preparedness tips on what to do during an earthquake, provided by the Office of Emergency Management:

you experience shaking, the recommended actions are to drop under a piece of furniture. Take cover under the piece of furniture by protecting your head and neck with one arm/hand. Hold on to the piece of furniture's leg to keep it from shifting or uncovering you until the shaking completely stops.

Never run out of buildings during an earthquake as most people are injured by falling debris as they try to exit buildings during the shaking.

- If you experience shaking and are in a wheelchair or walker, lock your wheels; cover your head and neck area with a pillow or some type of object that will deflect the debris from falling on to you.
- When you are in public places, be aware of your surroundings and identify your safe spaces.
- To receive emergency notifications, register your cellular telephone and landlines at Alert LA County, go to lacounty.gov/emergency/alert-la.

Immigration proposals

Dear Editor:

I'd like to address illegal immigration with series of proposals.

The first thing to point out, though, is that there is a difference between illegal immigration and illegal immigrants. Congress' last major attempt to "fix" illegal immigration under President Reagan focused mainly on illegal immigrants. And despite Reagan's promise that the law wasn't just another amnesty, that's exactly what it turned out to be: an amnesty that encouraged more illegal immigration.

If the goal is really to reduce illegal immigration (that is the goal, correct?) then yet another amnesty - even "an amnesty to end all amnesties", or an amnesty with a border wall, or an amnesty with more enforcement - isn't the solution. Permanent policy changes need to be instituted which reduce the drivers of illegal immigration.

Here are my suggestions

1) End "birthright citizenship". Yes, this is a Constitutional Amendment, and amending the Constitution is a major step. but we've amended the Constitution to prohibit alcohol (18th Amendment) and then amended it again to repeal the prohibition (21st Amendment). If we can dither on whether alcohol should be legal or not, surely, we can amend our Constitution for something this important.

Birthright citizenship is an unintended consequence of making former slaves citizens, and no longer serves its original purpose. Instead, what it does is create the phenomena of "birth tourism" and "anchor babies"; and once children are born as American citizens the cry then becomes to "not split up families". So, lets not split up families- let's mandate that children born in the USA are born with their parents' citizenship.

2) Make English the official language of the United States. Another Constitutional amendment! A very smart friend of mine once said, "There are no nations, only language groups". His point was that people identify themselves primarily by the language that they speak, not lines on a map.

After all, he said, look at Poland: Sometimes it was a very large nation, sometimes it disappeared from the map for decades at a time. And yet, it always reappeared, because there was a large group of people who spoke a common language and identified themselves and each other

A common language is also a practical requirement. This doesn't mean that other languages are prohibited, simply that government and business aren't required to provide services in other languages (except as required by treaty).

3) Withdraw from "free trade" agreements. NAFTA is widely recognized as having driven Mexican corn farmers out of business, leading many to seek work in the border maquiladoras or here in the USA. This was a purposeful result of NAFTA, which sought to allocate certain kinds of production to each nation which, in the view of the negotiators, was "most efficient" (eg. corn to the USA, cheap labor to

This arrangement of interlocking, interdependent, international production (like the old Soviet Union) may be more "efficient" but it is incredibly fragile to natural, political, and economic shocks. My own view is that, for security, durability, and financial reasons, each nation should be as self-sufficient as possible.

"Free trade" agreements also exploit people because they're negotiated and enforced in secret conferences and tribunals, outside of democratic input. The entities which wind up benefiting the most from convince you I'm right. "free trade" agreements are the transnationals who play one labor force against another. We should end our participation in anything other than the WTO

4) It must be recognized that part of the reason for poverty in Central and South America is the USA's constant interference in domestic governments of other nations, in favor of banks, transnational corporations, and the elite. Land reform and social justice movements were often thwarted by the USA; military juntas were often supplied with weapons, intel, and training from USA AID and other organizations. The United States should adopt a policy of nonintervention in foreign governments. Democratic processes in other nations should be allowed to function without intervention so that each nation can seek its own path.

5) Chinese immigrants have told me how wealthy Chinese Riverbed cleanup exploit one kind of visa by sponsoring their parents and then setting them up on benefits. Technical professionals tell me how H-1B Dear Editor: visas suppress American wages. But we have something like 60 different non-citizenship visas, and about as many citizenship-path visas. Those roughly 120 different sets of requirements are impossible to enforce. We need to simplify our system, attach fewer benefits (such as Medicare) to our non-citizenship visas, and find a way to be able to identify and deport those who overstay their visas.

6) Also, there should be a standard procedure for citizenship. When I listen to those who have gone through the process, I have to say that there doesn't seem to be any set procedure; the requirements seem to be guixotic and changeable, a person is told one thing by one person and another thing by another person. This is almost as bad as our tax and Social Security laws.

Once those policy changes are in place, we can address immigrants.

Hosting the Olympics isn't always good news for host cities

This summer, Los Angeles officials reached a deal with the International Olympic Committee to host the 2028 Olympic Summer Games.

For its trouble, the city hopes to generate hundreds of millions in savings and additional revenues. However, over the past few decades, world sporting events have come with a huge price tag for their host cities' residents — especially the poorest ones.

After the medals are awarded and the fireworks die down, these residents are left to deal with the results.

I can still remember watching Dominique Dawes and the U.S. women's gymnastics team win the first U.S. women's gold medal in their sport at the Atlanta games in 1996. However, many Atlanta residents better remember the country's first housing project, Techwood, and the neighboring Clark Howell complex being destroyed to make way for this gold medal occasion.

The city relocated 6,000 residents from public housing leading up to the Olympics. After the games, rapid gentrification followed, displacing another 24,000 people, the Center on Housing Rights and Evictions

The pattern replayed itself in Brazil, which hosted the 2014 World Cup. I remember sitting in my apartment cheering on Ghana and laughing while my friends reenacted the soccer team's dance moves. What we couldn't see from our television screens were the stark levels of inequality that blighted the host country.

Though Brazil was ranked 12th globally in social inequality, the government managed to find \$14 billion to host the games, money that could've been spent to benefit poor and working Brazilians. To make matters worse, more than 250,000 people were either directly or indirectly forced to leave their homes — often violently.

Brazil didn't learn its lesson, apparently, because more violence followed in advance of the 2016 Olympics in Rio de Janeiro. About 70,000 people were displaced by the Olympics, and almost a thousand poor people — mostly black men — were killed during "pacification" efforts to clean up the city's image between 2015 and summer 2016.

games bring to hosting cities. According to a 2008 report, the six Summer Olympics held between the 1988 Seoul Games and the 2008 Beijing Games forcibly evicted or otherwise displaced more than 2 million people.

Though Los Angeles is famous for its conspicuous wealth, it also has the highest rate of chronic homelessness in the United States and struggles to provide affordable housing to its residents. Even with these issues, LA officials believe they can protect themselves from the dark legacy of world

The city will receive \$160 million from the IOC to fund youth sports programs in the city. They also plan to use facilities already there, including the new football stadium currently being built, and to use UCLA to host the Olympic Village.

By not having to build new facilities to host the games, officials believe they will minimize displacement. Officials also say the 11-year wait will give them an opportunity to develop a failure-proof plan.

L.A.'s bid committee estimated it will cost \$5.3 billion to stage the games. But if they're wrong about displacement, imagine the cost to the families left without homes.

A third of Americans still don't believe in climate science

If you don't already agree with me on something, odds are I can't

There's plenty of science showing that the global climate crisis is already affecting us, that vaccines don't cause autism, and that humans evolved from a common ancestor with apes. Yet many Americans don't believe in man-made climate change, the safety of vaccines, or human

for a moment how you'd feel if you did believe the planet was warming,

A new study found a 5 percent chance that the climate crisis could reach catastrophic levels by 2050, and a smaller chance — but still a chance — it could wipe out all of humanity.

I'll be honest: I'm scared. Scared enough to seriously consider whether it would be wise or ethical to have children. And I'm frustrated and angry that our country isn't doing enough to prevent the coming crisis.

I don't want to take away anyone's car or air conditioning. I don't For the two-thirds of Americans who believe in human-caused climate want to force anyone to go vegetarian, or limit the number of children change, the future is terrifying. If you fall in the other third, try to imagine Americans can have. There must be a way to decrease pollution and roll back the clock on climate change without compromising our lifestyles in

> But it won't happen while we're all bickering about whether or not the climate crisis is happening in the first place.

> I can imagine how this looks to someone who doesn't believe the climate is changing. Some treehugger wants you to turn your life upside down for a made-up climate crisis that isn't even happening. No way.

While the disagreement is most often on scientific terms, actual scientists don't have any doubt at this point. The question isn't whether the climate is changing, but how fast it's changing and what will happen

But it's only a small percentage of Americans who are truly scientifically literate. It takes a lot of education — not to mention time and access to academic journals — to actually comb through the literature and find the facts as researchers see them.

Most of us just base our conclusions on media reports of scientific studies or one of Al Gore's movies.

Part of the problem is, perhaps, economic. It's nice to talk about switching to clean energy, but that means jobs in fossil fuel industries would go away. So far, this country hasn't done much in the way of helping people transition to new careers.

No environmentalist wants coal miners or oil workers to be unemployed. We want them to have well-paying, satisfying jobs that allow them to live the lifestyle they enjoy — without hurting the planet.

The good news it that solar generation alone now employs more people than oil, gas, and coal combined. But in some places, the only alternatives to good coal jobs, for example, may be poorly paid service jobs with lower wages. Perhaps some people would have to move (or else demand their states invest more in renewables).

Ultimately, we need to find a common language to have a discussion, and we need to get serious about providing for anyone whose job will be lost by switching to clean energy.

Because the alternative is doing nothing — and then figuring out later how to help people whose homes are under water from sea level rise or increasingly violent hurricanes.



The total eclipse as seen from Bigby, Idaho

It was perfect serendipity that we were able to experience the 2017 total solar eclipse in Rigby, Idaho, once home to Philo T. Farnsworth, inventor of the first all-electronic television system. There we were, taking pictures and videos of the eclipse with our cameras during the few minutes of its totality and sending the images over invisible radio waves for all the world to see via Facebook, Twitter, Instagram, etc.

What an appropriate coincidence that the heavenly bodies had aligned over a former high school of Philo's just weeks before the 90th anniversary of his first television transmission. There were no strangers. What a gift it was to share these hours with so many fellow enthusiasts, and especially the astronomy geeks who set up telescopes and said to everyone, "Come,

Frank and I had stumbled into a most rewarding location to view this celestial event, and the camaraderie of the day was palpable.

The small town of Rigby (population just under 4,000) was virtually dead-center in of the path of the 70-mile-wide shadow made by the moon as it passed in front of the sun. With crowds expected in the tens of thousands, Rigby had generously opened its rodeo grounds for people who didn't mind spending the night in a dirt lot. City workers had cleared weeds, filled in holes from the rodeo, and installed the cleanest portapotties I had ever seen, smelled, or used.

Fearing gridlock on the roads, most people had come the night before. Some traveled in comfy motor homes or trailers, while others were happy to pitch a tent. Families had plenty of time for a leisurely breakfast before the eclipse started around 10:30 a.m. A NASA volunteer handed out scores of free safety glasses and time passed quickly as people shared stories of where they were from and how far they had traveled.

I felt a rush (adrenaline?) when someone finally yelled, "It's starting!" Using a variety of methods - pinhole viewers, protectives glasses, telescopes – we monitored the images of the Sun's changing shape as the Moon moved in front of it. Ooh's and Aaah's sounded across the campground. It would take close to an hour to reach totality.

Frank set up his two-piece variation of a pinhole viewer that used a lens from cheap reading glasses. It projected a larger and sharper image and lots of people took pictures of it.

Sounds silly, but I was thrilled to see someone wearing a cardboard box on his head. This was another form of a pinhole viewer. I got in line and tried it myself. This was device was popular among teachers during an eclipse in the 1950's because students couldn't accidentally look at the sun and damage their eyes.

As the Moon edged closer to complete covering of the Sun, one lady began experimenting to see what other objects might work as pinhole viewers. Her first was a wooden spoon with three holes. Sure enough, the sunlight passing through the holes and hitting a tarp on the ground did not make a complete circle. The dark arc of the moon looked like a bite had been taken out of the sun. Then she started making holes with her fingers that revealed the shape of the moon. This worked as well and I the path of the eclipse. captured the images on my cellphone.

Keeping her back to the Sun, she looked like a dancer, moving her hands over her head as she worked to position her fingers just right. For a while, there was a dance troop of other people copying her experiment.

We were well primed as totality approached, and the heavenly bodies did not disappoint. The Sun must have been more than three quarters covered before I could say the light was noticeably less bright. People put on their jackets as it got colder. In the final last seconds, we perceived waves moving across the ground as the sunlight was refracted through the moving molecules of air.

Shouts of joy erupted as we watched those last few seconds, through

scopes and glasses, for the Sun to disappear completely. We were in awe, but not silent, when we finally removed our protective glasses, exclaimed, nudged one another, looked directly at the Sun's corona around the Moon, and took pictures with our unprotected cameras.

Surprising to me was the fact that we were not in total darkness. Low to the ground, all the way around the horizon, you could see sunlight beyond the shadow of the moon. It was like seeing the first rays of dawn, 360°. If the animals got quiet, there is no way of knowing – we were too exuberant.

I know the wonder I felt at being able to observe this phenomenon, but I think I would have to experience it alone to properly reflect on it.

It was the communal experience of these hours that was most affecting. We were literally a pop-up community, but the awareness of our common humanity was deep. I savored the joy of being with others who shared my appreciation. For these few hours, all other thoughts were gone. This amazing experience was a gift to me - it was nothing I earned, nothing I deserved. I was one of the lucky people in a position to experience this

A few days earlier, a young woman had posted online that she could not think about the eclipse because events in our country were too disheartening. I have learned that it is precisely because of life's constant troubles that we need such moments of grace. Experiences like this eclipse instill wonder and help recharge our spirits. Heaven knows that we need it.

When the universe gives you a gift, take it and say Thank You. And then keep working to make the world a better place.

Back Roads, and An Extra 360 Miles, Led Us To Rigby

Our plans to see the eclipse were relatively last minute - about three weeks before the event - and our original target was Idaho Falls, which would be inside the shadow of the moon. We started worrying about traffic the day before we left, when the LA Times ran a front-page story about preparations in Idaho Falls.

The closest accommodations I could get were in Tremonton, Utah, 140 miles short. No problem, we thought, we'll drive the rest of the way early Monday morning, the day of the eclipse. After talking with a German family whose goal was Rigby, we decided to consider this small town. Rigby was only 20 miles past Idaho Falls and pretty much dead center in

We knew there was plenty of time to drive to Rigby on Monday morning before the eclipse, but it was starting to look like many Utah

residents would be doing the same thing. I voted to explore Idaho roads the day before, Sunday, to scout possible detours in case of gridlock.

Our landlady told us that there was a back way into Rigby, through Logan and Preston, that involved a gravel road, well-maintained by the county, through Bone, Idaho. Sounded good. Such a plan.

The backroads of Utah and Idaho led through beautiful country, but the gravel road would not be an optional detour, no matter what. We could only drive about 20 mph due to washboard conditions and there was no cellphone service or GPS. We would take our chances on the paved roads Monday morning, keep our expectations in check, and be glad with what we could see.

We finally reached a paved road after Bone, which was a popular watering hole with lots of cars in the parking lot that Sunday, and sailed into the eastern edge of Rigby, small farms all the way. In the center of town we saw the sign advertising overnight camping at the Rigby rodeo grounds. We weren't going to spend the night, but we wanted to see what the town had planned.

There we met Steve Cook, Rigby's Director of Parks and Rodeo Grounds, who had a check-in table set up beside his own trailer where he would spend the night with his daughter, Kathy Anderson. Steve told us that city officials first became aware of Rigby's prime location when someone called about two years ago making plans for a large group of people to see the eclipse. In the end, the group stayed elsewhere because Rigby didn't have enough hotel rooms.

About six months ago Steve said the town decided to make the rodeo grounds available for the public. The porta-potties were the cleanest I had ever seen, smelled or used, and Steve and his daughter were so nice to us that we decided this was where we wanted to be for the big event.

It's a little embarrassing to admit that we drove 360 miles that Sunday as we explored Idaho in preparation for the eclipse. But if we hadn't done that, we wouldn't have met Steve and Kathy. We ended up in the best place possible because of the wonderful people as well as the location.

We left Tremonton about 5:30 Monday morning, and it was smooth driving all 160 miles to Rigby - no heavy traffic. We reached the rodeo grounds about 8:30 a.m.

But coming back was a different matter. We thought we were smart, treating ourselves to lunch in Idaho Falls before heading home. Apparently most people thought the same thing, and it took us five hours to return. Totally worth it!

We've been at it again: the Merriam-Webster.com dictionary has gotten bigger, this time by over 250 new words and definitions.


These terms have shown themselves to be fully established members of the language, some after hanging about on the fringes for decades, and others after proving themselves too useful to ignore in relatively short order. All have demonstrated significant use in a variety of sources, making them words our readers expect to find in the dictionary.

As always, the expansion of the dictionary mirrors the expansion of the language, and reaches into all the various cubbies and corners of the

New vocabulary is the spice of life, and among this group of new additions is sriracha—the pungent hot pepper sauce now appearing on even diner counters where only ketchup formerly reigned—and another spicy (and sweet) newcomer, Saigon cinnamon, also known as Vietnamese cinnamon. You might try the former on **bibimbap**, a Korean dish of rice with cooked vegetables, usually meat, and often an egg, either raw or fried, and may we suggest a **choux pastry** as dessert?

Be warned: Callery pear may sound like a nice fruit, but it is not recommended for consumption. And some of you may now feel better about calling frozen yogurt froyo, if a dictionary's official sanction makes this version of the term go down more smoothly.

The **Internet of Things** is something that's promising to make all kinds of tedious tasks go down more smoothly with information being sent to and received from household objects and devices—say, your bedroom fan or your toaster oven—using the internet.

Also frequently (but not necessarily) internet-related we have a new sense of **troll** meaning "to harass, criticize, or antagonize (someone) especially by provocatively disparaging or mocking public statements, postings, or acts," and the threat of ransomware, which is malware that requires the victim to pay a ransom to access encrypted files.

Both practical and theoretical medical advances are represented in terms like cardioverter, which refers to a medical device used to administer an electric shock to restore normal heartbeat, and working memory, which contrasts with long-term and short-term memory in referring to memory that involves storing, focusing on, and manipulating information for a relatively short period of time (such as a few seconds) kind of like the RAM in your computer.

The term **onboarding** has sidled in from the business world with its first and primary meaning still firmly in that realm—"the act or process of orienting and training a new employee"—but it's developed a couple other meanings along the way, one having more to do with technology than business.

And pregame has ventured from its transparent adjectival meaning into new territory: as an informal verb meaning "to begin drinking alcohol before an event or activity (such as a party or a night out)." Also taking on new meaning is the very old world front.

As a verb, **front** is now also used informally to mean "to assume a fake or false personality to conceal one's true identity and character."

Other contributions are from the world of sports: bunny is a basketball term referring to an easy shot taken close to the basket, and face mask in American football refers to a penalty imposed for grabbing and pulling an opponent's face mask during play.

Another sports term that's found its way into the Merriam-Webster. com dictionary is schneid, a slang word that refers to a losing streak and has its origins in some German phrases disparaging tailors.

With politics seeming to be ever-prominent in the public's mind, terms like alt-right and dog whistle are not surprising additions. The latter began, of course, as something only for canines, but in political contexts it now refers to an expression or statement with a secondary meaning that only a particular group of people is intended to understand.

We've also added two terms having to do with carrying firearms in public: concealed carry and open carry.

And sometimes a biological term develops a second life as something analogous and less specific, as we see in the case of hive mind; what began as a way to talk about the coordinated ways that colonies of social insects like bees and ants behave has come to be applied also to the collective thoughts, ideas, and opinions of a group of people seeming to function as a single mind.

There's no telling what vocabulary the hive mind will be using in the future, but we'll be watching it every step of the way.



Scene with Lake and Bees

Two men stand knee-deep in lake water, lake at their backs, in front of them lakeshore, feeble beach made of rock and dust, some mud between the lap-lap of the water and the hush-hush of mothers with toddlerstired, the mothers and the toddlers, from the day that has spun itself around them and wrapped them up in a gold-dust cocoon and dropped them here, chrysalised, in late afternoon. The bees, wearing their tiny black and yellow costumes, get what they can from the sand. The men wade out of the water and into the dust. The lake is not sorry to see them go. She'll take her curtain call for tonight in an hour or two, then let the moonlight have its way.

I was 23 years old when I decided to abandon my mother, my father, and my siblings. I wanted to run away from my house and all those family reunions that we had almost every other weekend. My main purpose was to find happiness, improve my English, travel, and visit another country for the first time.

I wanted to find a good job that would allow me to buy all the things that my parents couldn't afford. But 25 years later, I am still looking for that idea of happiness that I now believe only existed in my mind.

Back in 1979 when I was 10 years old, I think I was a happy kid, but I can't really say it because I don't remember even thinking about it. I grew up with my mom, dad, three brothers, and three sisters in a small house outside of Mexico City. We did not have many material possessions, but my parents always made sure we had food on the table and a roof over

To be honest, at that age I didn't care too much about everything and I didn't know much either. My biggest concern was playing soccer on the street with my friends. My dream was to become a professional soccer player and earn enough money to buy a big house and have a lot of toys and possessions, like the beautiful people in TV commercials with big smiles on their faces who seemed to have everything.

During the first 10 years of my life, the population in Mexico grew so fast that in the decade of the 80's, it became known as the largest populated city in the world. During that time, most of the families had an average of five to seven children and usually the father went out to work while the mother took care of their kids.

There weren't many opportunities in the urban areas because society was growing rapidly. Many people went out to live in the suburbs. In many cases, they lived without having the basic services at all, but people manage to survive.

Even though the community we lived in was considered one of the low-income areas, we didn't mind because at that time we didn't associate having money with being happy. It wasn't until the 70's, when the television became the main source of entertainment for most people, that we realized how poor we were.

During my teenage years I always complained to myself about the conditions we lived in because I could not have what I wanted. Nevertheless, I remember my older brothers telling me that I was the lucky one in the family because I hadn't suffered at all. By the time I was born, our house already had power, running water, and a full bathroom.

One of the questions I disliked the most was when people would ask, "What are you going to be when you grow up?" Most likely it bothered me because I didn't know what to answer.

I recall being next to two of my older sisters when a teacher asked the oldest one the same question. Her response was, "A journalist."

My other sister gave the same answer. So, when it was my turn I also said I wanted to be a journalist even though I didn't know what it was. After that, every time someone asked me, I always gave the same

By the time I was 20, I was already on my way to becoming a journalist, although I was still very ignorant about the injustices and inequalities that prevail in most societies. However, I believe that the busy trend of life doesn't allow us to see the whole picture of the problem and in many ways, people remain busy trying to find their own happiness, fulfilling their material needs.

According to Socrates, the Greek philosopher, "Happiness flows not from physical or external conditions such as wealth and power, but from living a life that's right for your soul. If you don't know what's good for your soul, then you will be misled into pursuing happiness based on what's conventional or easy."

Right after I finished college, I came to the United States looking for a stable job that would allow me to have a better life. Ironically, I left my house, my family and friends - all those things that during my first 23 years of existence made my life easier, and I would even say happy, without even realizing it.

I promised my family that I would go back in a couple of years speaking English, so I could get a better job and with some money in my pocket, so we would live happily ever after. Twenty-five years later, I never went back to live there and most of my family has never come to visit me.

At the age of 30, I was already living in Los Angeles. I was lucky enough to have a small business, a career, and a house of my own. By then, I asked myself if I was finally happy. My answer was NOT really. Even though I had a beautiful wife and a great son, my thoughts about my family in Mexico never left me.

Nevertheless, it wasn't just the need for my family in Mexico. By the time I reached 40, I was more aware about the injustices and inequalities that exist in almost every single society, including in the richest country in the world. So it was impossible for me to pretend that one day I would find happiness when there is so much pain and suffering all around caused by Mother Nature and by us humans.


Now I am 48 and have concluded that the idea of happiness associated with material possessions, achievements, and pleasures is very relative. I am certain those factors can provide some level of satisfaction, but regarding happiness, real happiness, I'm not sure exactly what that means.

The best thing I can do is try to enjoy the moment I am living now, not in the future, not in the past, but today. Value every day the people and things around me and never stop living without a purpose.



DUI checkpoint Friday night in Downey

DOWNEY – The Downey Police Department will conduct a DUI/ Driver's License Checkpoint on Friday, Sept. 22, at an undisclosed location within city limits between 8 p.m. and 2:30 a.m.

In California, alcohol-involved collisions led to 1,155 deaths and nearly 24,000 serious injuries in 2014 because someone failed to designate a sober driver.

Over the course of the past three years Downey PD officers have investigated over 1,200 DUI collisions which have claimed 2 lives and resulted in more than 120 injuries.

Officers will be looking for signs of alcohol and/or drug impairment, with officers checking drivers for proper licensing. When possible, specially trained officers will be available to evaluate those suspected of drug-impaired driving, which now accounts for a growing number of impaired driving crashes.

Drivers caught driving impaired can expect the impact of a DUI arrest to include jail time, fines, fees, DUI classes, license suspensions and other expenses that can exceed \$10,000.

Funding for this checkpoint is provided to the Downey Police Department by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.
