## Downey real estate increased \$450M in total value last year

**DOWNEY** – The total value of Downey real estate increased by \$540 million last year, a 5.1% jump, according to data included in the Los Angeles County Assessor's 2017 annual report, which was released last week.

The report reflects strong economic growth and a recordsetting increase in the assessed value of all taxable real property and business personal property in the County of Los Angeles.

## Downey alumnus attempting to make rocket history

**DOWNEY** – A Downey High alumnus and current sophomore at UC Berkeley is hoping to help put the first completely student developed rocket into space.

Paul Shin is currently leading the Space Enterprise at Berkeley Organization, which has taken it upon itself to tackle and complete an extraordinary task.

"The organization that I'm currently leading right now, it's primarily about sending things into space," said Shin. "We want to be a launch provider organization."

To achieve that goal, Shin says that a vehicle is required. For shin and his team, that boils down to a rocket. That's where Project KARMAN! And EUREKA-1 come into play.

"The literal definition of Project KARMAN! for us means to be the first university group to successfully fund, design, and build a rocket entirely developed by students that can be launched into space," said

While other universities and groups have tried, Shin says there has yet to be a successful attempt to fund and build a rocket that could

successfully pass the 100-kilometer mark called the Karman line, which is commonly seen as the boundary where "the sky ends and space

The rocket that Shin and his team hopes will pass that mark is the 16-inch in diameter, 30-foot in height liquid-fueled EUREKA-1, which would be able to take a payload mass of 5 kilograms.

"We call it EUREKA-1 because we thought it would be kind of respectful to pay homage to the state that's kind of supporting everything we're doing," said Shin. "We thought EUREKA was a fitting name because not only is it the motto for California, but it also is a word that is used to kind of indicate something new, like the start of something great."

The team is currently on schedule to launch EUREKA-1 in nine months in July 2018 at SpacePort America, New Mexico.

Shin said that should Project KARMAN! and EUREKA-1 succeed, it "would show the new capabilities of what college students are able to

"Simply proving to the world that college students are able to do such a feat and accomplish such a feat, it's a eureka moment," said Shin. "It's an awakening... our big vision is to inspire the youth, the young in different continents, different backgrounds, to pursue their dreams, especially in the space industry...'

## Downey spoils Bears' grand opening party with 13-7 win

**DOWNEY** – The Downey and Warren High School boys' water polo teams took to the Murdoch Fraser Aquatics Center Pool on Tuesday for their annual rivalry game.

Warren celebrated the grand re-opening and re-dedication of the pool before the game and the atmosphere was festive and energized. Downey defeated Warren 13-7.

With the win, Downey is now 9-18 overall and 2-1 in San Gabriel Valley League play. With the loss, Warren is now 6-12 overall and 2-2 in league

Downey defeated Paramount at Downey 19-6 on 9/26, was defeated by Cerritos at Downey 17-6 on 10/3 and defeated Warren at Warren on Tuesday. The Vikings will conclude their regular season schedule when they travel to Gahr next Tuesday to face the Gladiators.

As the San Gabriel Valley League stands right now, Cerritos is in first place with a record of 3-0, Downey is in second place with a record of 2-1, Warren is in third place with a record of 2-2, Paramount is in fourth place with a record of 1-2, Gahr is in fifth place with a record of 0-2 and Whitney is in sixth place with a record of 0-3.

Warren defeated Whitney at Warren 15-5 on October 12, was defeated by Paramount at Paramount 10-8 on October 3, defeated Gahr at Warren 13-5 on October 10 and was defeated by Downey at Warren on Tuesday.

The Bears will conclude their regular season schedule when they travel to Cerritos to face the Dons on Tuesday. Downey and Warren both compete in C.I.F. Division 6 and are looking to qualify for postseason play.

WARREN HIGH POOL: The Warren High School pool celebrated its grand re-opening and re-dedication on Tuesday.

The pool is officially named the Murdoch Fraser Aquatics Center and festivities began shortly after 5:30 p.m. Warren High School Assistant Principal Jeff Giles served as the Master of Ceremonies.

The pool deck was open with displays of past and present pictures at 5:30 p.m. and the speaking began at 5:45 p.m. with the Warren boys' water polo team taking to the pool at 6:00 p.m. to prepare for their 6:15 p.m. cross-town rivalry game with Downey.

In the Warren/Paramount game, the Pirates got out to an early lead and never looked back. Paramount led 7-0 at the end of the first quarter and 28-7 going into the locker room at halftime.

The Pirates picked up in the second half right where they left off in the first half. Paramount scored a touchdown and extra point in the third quarter and led 35-7 as the third quarter ended. The Pirates added 15 more points in the fourth quarter and came away with the 50-7 win.

Bear starting quarterback Chris Venegas did not play due to an injury he sustained last week against Lynwood. Backup quarterback Jared Gonzalez got his first start in Venegas' place and completed 5/16 pass attempts for 44 yards and two interceptions.

The Bear ground game was led by Nikko Fierro-Tuala's 20 carries for 65 yards. The Bear receiving corps were led by Robbie Colenzo's two Mark Fetter, contributor catches for seven yards and **Desmond Carnes** one catch for nine yards.

Coach Lara, his staff and players are all looking forward to the game against Gahr later today. Gahr is currently tied for first with Paramount on top of the San Gabriel Valley League with matching league records of 2-0.

If Warren wants to earn a part of the league title they must beat Gahr tonight, beat cross-town rival Downey next week and beat Dominguez in their league finale. The Bears also need Gahr to beat Paramount when they play head-to-head.

In the Downey/Dominguez game, the Vikings scored early and often. Downey led 28-7 at the end of the first quarter and 48-14 going into the locker room at halftime. The Vikings added a touchdown and extra point conversion in each of the third and fourth quarters and cruised to the

The Viking defense was led by **Anthony Lopez's** four solo and three assisted tackles and Malcolm Perry's one solo and five assisted tackles.





## Requiring pet stores to sell rescue animals puts small businesses at risk

Two of America's largest pet care associations, a California breeder association, and a California pet store owner said California Governor Jerry Brown put small businesses at risk this weekend with his signature of Assembly Bill 485.

AB 485 implements a statewide ban on the sale of non-rescue, nonshelter dogs, cats, and rabbits from pet stores.

in pet and consumer protections," said Pet Industry Joint Advisory Council (PIJAC) President Mike Bober, who in a video release in September urged Brown to veto AB 485. "It also strips consumers of many pet store protections, risks hundreds of jobs, and reduces pet choice.

American Kennel Club (AKC) vice president of government relations, Sheila Goffe, said that AB 485 "fails to distinguish between professional breeders and pet profiteers."

"AB 485 blocks all of California's pet lovers from having access to

professional, licensed, and ethical commercial breeders," said Goffe. "This is not good for Californians or their companion animals.

Bober said the amendment, which exempted pet stores from warranty laws, consumer information requirements, fines, and other important regulations, left consumers without proper protections.

"Governor Brown regretfully did not recognize the harm AB 485 will "Assembly Bill 485 reverses California's tradition of leading the nation do to his constituents, including the many stores, breeders, and business associations across the Golden State that contacted him," said Bober and

> Stormy Hope, Secretary of the Southern California Kennel Owners and Breeders Association, joined in the concern for California's pets and their purchasers. "The enactment of AB 485 represents a troublesome new reality for California's pet owners. Their choices will be limited to pets from unknown sources, with unsubstantiated health backgrounds, and without consumer protections."

Animal Kingdom founder Adam Tipton, whose three stores employ 26 people, has been a California small business owner since 1995. He said Brown's signature endangers "not just my employees, but also my

"Animal Kingdom has had thousands of customers from all over California, other states, and even other countries come to us because of our professionalism and animal care practices," said Tipton. "For 22 years, our focus has been to choose happy & healthy pets for our customers. AB 485's ban will leave us without a ready supply of pets."

According to Tipton, "The public has been put at great risk by the false information that was used to pass this law. Our relationships with breeders mean we know exactly what pets are going to our customers; by targeting California's pet stores, this law will allow unregulated breeders to flourish as customers find other sources for their pets. AB 485 risks customers' ability to get the best pet for their circumstances."

## From Bob Hertzberg: Let's follow Kentucky, but only when convenient

California State Sen. Bob Hertzberg (D-Van Nuys) has logged some serious miles in his endless journey to try to find a state he can hitch his no-bail wagon onto.

First, he touted New Jersey's pretrial system as the model for California.

But when New Jersey's nine-month old experiment began crumbling, Hertzberg turned his attention to Washington, DC as the model for

But his infatuation with DC didn't last long. When Washington, DC police chief Cathy L. Lanier was deciding to transition to the head of security for the National Football League, she told the Washington Post that the city's pretrial system "is beyond broken... You can't police the city if the rest of the justice system is not accountable." The Post wrote, "Lanier has previously expressed frustration with the criminal justice system and said it allows for repeat offenders to be released."

After Lanier's comments, Hertzberg then high-tailed it down to the greener pastures of Kentucky, a state he is now trumpeting as Ithe atest model for California.

Wait a second. Kentucky? Isn't this one of California's pariah states? After all, just a year ago Hertzberg voted for Assembly Bill 1887 - a measure to ban California public officials from traveling to and patronizing states like Kentucky over gender equality issues. Specifically, Hertzberg supported a bill that would:

"Prohibit a state agency and the Legislature from requiring any of its

state-funded or state-sponsored travel to, any state that, after June 26, 2015, has enacted a law that voids or repeals, or has the effect of voiding or repealing, existing state or local protections against discrimination on the basis of sexual orientation, gender identity, or gender expression or has enacted a law that authorizes or requires discrimination against samesex couples or their families or on the basis of sexual orientation, gender identity, or gender expression, as specified, subject to certain exceptions."

With Hertzberg's AB 1887 vote, he was vilifying Kentucky's branches of government for failing to 'protect the civil rights and prevent discrimination based on sexual orientation, gender identity, and gender expression, among other characteristics.'

On Aug. 23, Sen. Hertzberg lead a rally in support of SB 10 on the north steps of the California State Capitol where Hertzberg stated, "I just came back from Kentucky last week and I sat in a court room where there were a hundred dispositions and I watched people for six dollars a day, get home monitoring system."

"Me too."

I posted those words on Facebook recently, along with what seems like every woman I know. A post went viral asking each woman to write the words "Me too" if she'd been sexually assaulted or harassed.

A man exposed himself to me once. Ten years ago. He was in a car, and I was on foot. He called me over and asked me directions to the freeway. I disappointed him by actually giving him directions and not noticing that he was exposing himself until he pointed it out. Then, I walked away.

I called the cops, and they warned me that it was a small step from flashing a woman to actually assaulting her. I was lucky nothing happened

A friend of mine had an even scarier experience. A man grabbed her on the street and then flashed her. When she yelled for help, bystanders mistook her cries for a woman having a spat with a boyfriend, and they ignored her.

Under the #MeToo tag, the stories kept rolling in.

Before long a question arose: Has any woman not been sexually assaulted or harassed?

I know several people who've been raped. In fact, I'm not sure I know any woman who's never faced sexual assault or harassment. Most women can probably say the same, and that's a travesty.

I doubt there's a woman alive who's never been catcalled, but sexual harassment goes far beyond an unwelcome comment or greeting.

For example, right now I know a woman who's facing sexual harassment from a superior at work that could potentially ruin her career, and another one who already lost a job due to harassment. Sometimes men who catcall women follow them, and make them fear for their safety.

Sexual violence isn't something that happens rarely. Most of it isn't the heinous acts that appear on the news — it's the everyday acts that don't.

If you want to see the faces of rapists, look around you. Just look around. Men who do this look like anyone. One of the men who assaulted me is now a pediatric neurologist at a prestigious hospital.

Odds are you can't find a woman — or trans person — who won't say

How many men that you know perpetrated these crimes?

We can't stop sexual violence until we understand how very mundane it is. Men act shocked and horrified to hear of women's sexual assaults, but remain ignorant that the perpetrators are other men around them — their coworkers, their buddies, their family, and maybe even themselves.

## So many tax lies, so little time

In most cases, it's best practice to cut through the media noise and go straight to the source to understand what's happening in public policy. and eliminating it benefits only them. Donald Trump's tax plan is not one of those cases.

about his plan to cut taxes on the very wealthy. Of course, he's not using those words, but that's what his plan will do.

If you want to understand what's in Trump's latest tax plan, skip the bluster and look straight at the numbers.

Three figures in particular shed a light on the actual impact of the plan.

80 percent:Trump's tax plan is essentially a collection of tax cuts for individuals and businesses. Of the cuts on the individual side, 80 percent of them will go to the wealthiest 1 percent, according to the nonpartisan Tax Policy Center.

When Trump says he's out to help the middle class and not the rich, his words are directly countering the actual impact of the plan. This could be because he doesn't understand his own plan — a valid possibility.

More likely, though, it's because he's lying through his bleached teeth.

0.2 percent: Trump's tax plan would repeal the federal estate tax, also known as the inheritance tax.

This often misunderstood portion of the tax code is a levy on the intergenerational transfer of immense wealth, and by immense I mean more than \$11 million. Only the wealthiest 0.2 percent of households will ever pay the tax, an exclusive group of multi-millionaires and billionaires.

Trump and others would like you to believe the estate tax is levied on the \$10,000 your grandmother left you, or the \$400,000 house your

parents want to pass down. Again, not the case.

Don't get it twisted: The estate tax only impacts the extremely wealthy,

15 percent: Trump often says he'd like to see the corporate tax rate The president is crisscrossing the country giving speeches to crowds drop to 15 percent, down from its current statutory rate of 35 percent. Cutting the rate by more than half is going to usher in a jobs boom like we've never seen before, he rants.

Nuh-uh.

First off, the plan overall would cost a whopping \$1.5 trillion over 10 years. That alone is enough to pay more than 18 million elementary school teachers to improve our education system over the same period of time. (Maybe then we'd know the basic arithmetic that our president chooses

Second, it could lead to a dramatic drop in jobs.

A recent report from the Institute for Policy Studies looked at profitable companies who, thanks to loopholes, paid an effective tax rate of 20 percent or less. Those companies, on average, cut their workforce even while the rest of the private sector saw a 6 percent jobs increase.

Cutting taxes doesn't create jobs, the report concluded. It does, however, contribute to higher and higher CEO pay. Just what we need!

The Trump tax plan is a giveaway to the ultra-wealthy, and selling it as anything other than that is a misrepresentation of the facts. Don't take my word for it — look at the numbers!



## Shared Stories: Miracle on a Winter Night

Illness or injury to a parent can be terrifying for a young child. Vickie Williams recalls one freezing night when her father's nosebleed could not be stopped and there was blood everywhere. The mercury had dropped below 32 degrees Fahrenheit. It was a deep freeze night. The moon was full. It was the scariest night of my life. Death came threatening, knocking at our door, at least I thought. Uncertainty filled

My father, returning home from visiting a friend, developed a nosebleed. It was a cumbersome task to drive, but he made it home. That night was a bane and a blessing. Looking back, a miracle occurred at 814 Camp Street, Monroe, Louisiana.

I was about ten years old. Our tears flooded heavily with panic and pandemonium. Questions danced in my head. My mother Lucille, two sisters Peggy and Jo, and I were sitting around the open face heater in the dining room, as we bore witness to the unexpected. Our hearts pounded with fright.

My father walked through the front door bleeding from his nose. His white handkerchief was stained blood red. His movements were slow as a boxer surprisingly stung by an uppercut. He entered the house with measured steps, carefully holding a bloody handkerchief close to his nose, so the blood would not drip on the floor.

We were sitting, chatting, trying not to think of how cold it was outside, and hovering close near the flickering blue, yellow, and red flames. As daddy approached us, we stood up. His bleeding commanded our attention. We rushed to his side, blood dripping on his army green-colored jacket and

My sisters and I in haste lifted his arms to remove his jacket, after he had sat in a chair adjacent to the dining table. Mother rushed to his side. "Oh my God Dorsey, be still," Mother instructed. "Get me a brown paper bag. Hurry," she exclaimed.

I don't remember who rushed to the kitchen one room over, a few steps away, to get the bag. All I remember is one of us did. Mother tore the bag, rolled a larger piece of brown paper and placed it underneath his top lip to no avail.

As time ticked forward, the flow of blood gushed with quickening momentum. It only got worse. The blood jetted like a spigot turned on at full speed. Even big clots came gushing out of his mouth.

My sisters and I gathered towels, newspapers, and even a dishpan

to catch the blood. It looked like a crime scene out of a dark movie. My stomach revolted full of butterflies, as I gagged. Mr. Harvey Gibson, an angel always watching over our shoulders and a dear friend to the family, just happened to drop by and arrived just in time.

He rushed Daddy to the hospital. As my father leaned on him to get in his

truck, we were all dazed, wandering if he would return home. Mother stayed

home to comfort us, encouraged by Daddy to do so.

My father's face was like a motherless child stumbling in a dark abyss. His eyes were sunken, his face gripped with fear. He had a look of defeat. Our minds were in a state of disarray. We silently wondered if he would

Mother's hands so stained with blood were shaking. She struggled holding back her tears. "Lawd have mercy," she cried out loudly. We slowly gathered the wet newspaper. My sisters and I, sobbing, somehow managed to collect the soiled bloody towels and placed them in a tin tub of cold

To mop the floor, one of us fetched a bucket with bleach, soap, and warm water. I don't remember who did so. As night gathered further into darkness, mother paced the floor and we all stayed up anticipating a phone

The bleeding stopped and Daddy stayed in the hospital overnight. A balloon was placed in his nose inflated with enough air pressure to stop his nosebleed and I recall it was the best news in the world I had ever received when Mr. Harvey called. That night I balled up in a knot, said a simple prayer, "Thank you Jesus," and fell asleep wanting to be a Christian in my heart. What a miracle that happened at 814 Camp Street!

## FULL TEXT: Janice Hahn pushes more action on homelessness in State of the County address

LOS ANGELES - On Wednesday, Supervisor Janice Hahn delivered but I really do. her first State of the County address at a lunch hosted by the San Pedro Chamber of Commerce at the Port of Los Angeles Cruise Terminal.

Hahn told the 600 person crowd that she believes the County of Los Angeles can and will be a "model for the nation-- not because we do not have any challenges-- but because we are able to be honest about problems we face, earn the trust of residents, and face big challenges head on with even bigger solutions."

She discussed her first 11 months in office and reflected on her decision to leave Washington and come back to local government. She lamented failures of Congress and pointed to LA County's ability to rise up to meet residents' needs when Washington fails.

The Supervisor's speech focused on the county's budget, economic development efforts, her view of the homelessness crisis and solutions to it, and the several initiatives that the Supervisor has undertaken since coming into office.

On homelessness, Hahn expressed hope for Measure H funded policies providing services to the 58,000 homeless individuals in the County and said that she is worried our biggest obstacle "is not a lack of funding, but

She challenged local city leaders in the 4th District to fight back against NIMBYism and propose new plans to build housing for homeless individuals in their cities. Supervisor Hahn pledged that she would stand by them and put County funding behind the project to ensure it gets built.

Hahn also announced her plan to partner with Habitat for Humanity to build permanent supportive housing in Downey for homeless veterans. She promoted the County's landlord incentive program and touted local landlords as "LA County's secret weapon in the fight to end homelessness."

#### From Congress to the Board of Supervisors

It has been almost a year since I was elected to the Los Angeles County Board of Supervisors. I can say without hesitation that this is the honor of

I am still getting used to it. Members of my staff sometimes slip and call me Congresswoman. I even do it once in awhile.

But honestly I could not be happier that my days in Congress are behind me. People in DC could not believe I was leaving "the pinnacle" of American political positions for a spot on a county board. And I would tell them, I am running to represent 2 million people, on a board that represents 10 million people, in a County bigger than all but seven states, with a budget of \$30 billion dollars-- PLUS my name is already on the building.

Partisan politics never suited me. I was raised in a political family but not a partisan one. I cut my political teeth in a non-partisan office and I will admit that I was not wholly prepared for the level of partisanship that had taken over Congress when I arrived in 2011 and it only went downhill

That is why I am so happy to be a part of this Board of Supervisors. I know it is a place where I can get real things done for the people I represent. Where the federal government falls short, LA County has already shown it of public assistance. This includes everything from child protection can step up to the plate and deliver for people.

I believe that LA County can and will be a model for the nation. We operate on a scale bigger than any other county. We face bigger problems than any other county but we combat them with even bigger solutions. We are an innovative, caring, forward-thinking county and we programs. That includes everything from our four county hospitals, our stand in stark comparison to what Americans have grown to expect from government.

## **New Board**

I may serve on the same Board of Supervisors that my dad served on for so many years... but it looks quite a bit different these days.

For the first time in the history of the Board of Supervisors we have a female majority. It is about time! For decades we were lucky to have one woman on the board and nobody gave that a second thought.

## The 4th District

Each of my colleagues probably thinks that they have the best district locally owned small businesses making them eligible for about \$1 Billion

The 4th District is the economic powerhouse of LA County. It includes LAX, one of the largest and busiest airports on the globe. It is home to LA's formidable and innovative aerospace industry rooted at the Los Angeles Air Force Base. It is the center of the young but growing biotech industry which employs 700,000 LA County residents in some of the highest paid jobs in the country. Our beaches and beautiful coastlines attract visitors from around the world and fuel our tourism industry. And here we are at the Port of Los Angeles, which together with the Port of Long Beach are responsible for 40% of our nation's imports and billions of dollars in economic activity and tens of thousands of local jobs. The port itself is becoming a promising new hub for education and ocean exploration with the development of AltaSea.

#### **Economic Development Policy**

With over 100,000 employees and a \$30 billion dollar budget, the County itself is an economic powerhouse for the region. I want to use those resources to help YOUR businesses expand, grow, and create good paying jobs.

Over the next five years, \$60 million dollars will be available through our County Economic Development Program. About half of the \$60 million will be invested into high-growth sectors like bioscience, manufacturing and clean-tech. We are also creating a brand-new loan fund for businesses who want to relocate their offices near transit lines-- giving their employees easier commutes and cutting down traffic for everyone.

We also have over \$750 million in capital and infrastructure projects going on, all over the region. Our County is giving itself a make-over, with new libraries being constructed, new office buildings, and expansions to LA County hospitals. And I'm proud to say that all of this is being done by working hand in hand with our friends in labor. If there is even one dollar of County funding invested in a project, we insist on a project labor agreement, because we know taxpayer dollars go further when they not only invest in infrastructure, but invest in the people who build that infrastructure.

By far the best economic development policy involves investing in an educated, well-trained workforce. That is why you will see me put money every year towards job training programs, youth education, and afterschool programs, like the Boys and Girls Club, that keep our kids on track to go to college.

## The Budget and Contracting to Small Businesses

As a Supervisor, one of my most important roles is as a responsible steward of your tax dollars. This year we approved a \$30 billion balanced budget.

28% of our budget, about \$8.1 billion, goes to public safety that funds the brave men and women of our sheriff's department, firefighters, and county lifequards. When natural disasters befall our neighbors and friends, we all struggle with how we can do our part to help. But being a part of LA County means you ARE helping. This budget funds the Search and Rescue Teams made up of our best and bravest that have gone to help in the aftermath of hurricanes in Houston, Florida, and Puerto Rico, and the devastating earthquake in Mexico.

27% of the budget, around \$7.7 billion, goes to the broad category services and care for foster youth, services for the disabled, and hundreds of millions of dollars in new revenue dedicated to addressing OUR

32% of the budget, about \$9.1 billion, will fund health and sanitation 18 health clinics, our departments of public health and mental health, and everything that goes into keeping LA County neighborhoods clean and healthy. Lately more of that money has gone to purchasing Hep A vaccines and going to fund outreach workers who are going to our homeless encampments to try to prevent the spread of Hep A like we saw

A huge portion of our services and projects are not actually implemented by the County itself but are carried out by businesses and nonprofits that we contract with. These contracts are great business opportunities especially for locally owned small businesses.

Right now, the County has a goal to award 25% of its contracts to

in contracts. But last year, small businesses were awarded just \$214 million in contracts. There is money being left on the table that should be going to you!

If you own a small business and you are wondering how you can get in on this action -- the first step is get registered and certified with the County as a locally-owned small business. Getting registered is easy-you can do it online or to make it easy for you, we have someone here today who can help you. Once you do that you will be contacted about opportunities and ways your business can contribute to LA County.

#### Homelessness

By the latest count, there are 58,000 people without homes in LA County. I say that number so often I fear it has lost its meaning. That is more people than fit in Dodger Stadium. There are families with children living in cars, veterans living in tents, and people who have no option but to sleep on the sidewalk every night. It is a humanitarian crisis.

Last year at my first meeting as a Board Member, I led the effort with Supervisor Mark Ridley Thomas to put Measure H on the ballot-- a quarter cent sales tax that will raise \$355 million dollars every year for the next ten years for homeless services. Thanks to the generosity of LA County voters, Measure H passed with overwhelming support.

While we only started collecting the tax on October 1st, we have already been putting YOUR money to work. We are sending mental health professionals out with sheriff's deputies on difficult cases to make sure mentally ill individuals end up in treatment, not our jails. We have hired mental health specialists, doctors, and addiction treatment professionals to go into encampments and deliver help to people in need.

Ultimately we know that nobody can put their life back together if they are living on the streets. That is why we are expanding our shelter system, putting millions of dollars toward hotel vouchers and funding rental assistance to give a hand to people on the brink of losing their homes.

What we really need to do is to build more homes people can afford. But we have also seen communities unleash huge backlashes against affordable housing projects.

The biggest obstacle facing us is not a lack of funding but NIMBYism, and a lack of willingness by communities to take on a fair share of the

This is a shared problem and it demands a shared solution. There are 58,000 people in LA County who need homes. No one community will bear the burden of housing all 58,000, but no community can house zero

The City of LA and Councilman Joe Buscaino are doing their part.

Councilman Buscaino is getting 160 new units of housing for those previously homeless built in Harbor Gateway!

And I will do my part. My office is identifying County-owned land in the Fourth District where we can build units.

I am happy to announce today that I will be partnering with Habitat for Humanity to build housing for homeless veterans in Downey at a Countyowned lot. The new building will have 40 units of housing for homeless veterans and 40 units for previously homeless families.


I want to encourage the city leaders here today to identify sites in your community where you can build new housing units. I know this is not a simple ask. We have seen neighborhoods turn against politicians for homeless housing proposals. But we cannot allow this to become the new third rail in our local politics. If city leaders in my district propose a project, not only will I stand by you, but I will put county resources behind you to make sure you get it built.


The City of Long Beach has proposed building 95 units of affordable housing on Long Beach Blvd. It is an innovative, mixed-use proposal that makes sense for Long Beach and I was happy to commit \$1.5 million of the Fourth District's housing fund to make it happen.

## Landlords

Of course, none of these projects will be built overnight. And while I believe we need to build more housing stock if we want to solve this crisis long-term, there are policies at work right now that can get people off the

This includes paying landlords to hold a unit while we identify a tenant, paying a person's first and last month's rent as well as monthly rental assistance if-needed, and guaranteed reimbursement for any damage to the unit. This gives landlords peace of mind and a reliable check at the first of every month

Since this program launched last year, 875 people who were living on the streets have signed leases and are living in homes they can call their own.

Landlords are the County's secret weapon in the fight to end homelessness and I know we have plenty of landlords in this room. This is a program that works and I challenge every property owner here today to put it to the test. Pledge to rent just one of your units to a formerly homeless family. There are parts of my dad's legacy that forever changed the landscape of LA County that people take for granted.

My dad brought the Dodgers to LA. He designed the County Seal and the County Flag.

He brought a hospital to Watts. He had the idea for emergency call boxes on the sides of freeways.

And let's not forget one of my dad's greatest accomplishments-raising Jim Hahn! My brother, the Dodger's first honorary bat boy, grew up to be City Controller, City Attorney, Mayor of Los Angeles, and now Superior Court Judge and I am so glad he was able to make

And in the late 1960s, when my dad's cardiologist told him that

heart attacks if they could treat them before they got to a hospital, my dad went to Sacramento to lobby then-Governor Ronald Reagan for the creation of the nation's first Paramedics program.

### **Mobile Stroke Unit**

Today we are facing a new challenge. Doctors are seeing evidence that they can save more people after strokes and prevent lasting brain damage if they can treat them in the field before they ever get to a hospital. Doctors in some of the nation's top hospitals are developing mobile stroke units which carry CT scanners and specialized equipment to identify and treat stroke victims. Evidence shows that mobile stroke units can help prevent debilitating paralysis, memory loss, brain damage, and even death. This could be the next breakthrough in stroke treatment and I want Los Angeles County to have one of these Mobile Stroke

I have been working with doctors at UCLA who are developing pilot program. I was able to get UCLA the \$1.5 million it needed and the mobile stroke unit will be on the road next week.

## **Bring Our Loved Ones Home**

Another health challenge here in LA County is the increasing rate of dementia and Alzheimer's.

Many of you have seen the stress it puts on families to have to supervise a loved one 24/7 and live in fear of what could happen if they left your sight.

Last October, 56 year old Manhattan Beach resident Nancy Paulikas visited the Los Angeles County Museum of Art with her parents and her husband, Kirk. For years, Nancy worked at Northrop Grumman but in 2015 was diagnosed with early onset Alzheimer's. She lost her ability to communicate. That day at LACMA she wandered away from her family.

Twelve months and three days later, Nancy is still missing. Kirk has

Sadly, Nancy's story is not unique. 60% of individuals with Alzheimer's and half of children with autism will wander at some

searching for his wife.

In February I launched the Bringing Our Loved Ones Home Taskforce with the goal of

developing a countywide program

to locate individuals faster and

return them to their family.

One model they are considering is already being used in Glendale. It is a system of wristbands distributed to interested families each equipped with a small transmitter. If a person goes missing, police can activate the receivers and be led directly to the person in a matter of minutes. So far 7 people in Glendale with wristbands have gone missing and all 7 were found and brought home

Kirk believes that this kind of wristband could have brought Nancy home to him that day. This is a system that gives families support in a worst case scenario and much needed peace of mind. I think it is one solution that could work for LA County and I look forward to implementing it as soon as possible.

#### Metro

I cannot talk about the State of the County without talking about the State of our Transportation System. Traffic is worse than ever. Last Thursday I was stuck in so much traffic on the harbor freeway I missed a commission meeting! The traffic in our county is taking its toll on productivity, on goods movement, and on quality of life.

I heard loud and clear that residents have felt left out, left behind, and misled about transportation projects in the Fourth District. The fact is my constituents do not have a lot of good alternatives to the freeway.

As a Metro Director, my pledge to you is to speed up the projects in this district. I want to see the West Santa Ana Branch go from Downtown LA to Artesia. I want to see the Gold Line Extended to Whittier. I want to see the Green Line actually connect to Torrance. I want to see big improvements to the 710 so we can get trucks in and out of our ports faster. And I don't want to wait until 2050 for the funding to get these projects

On February 20, Whittier Police Officer Keith Boyer was shot and killed by Michael Mejia, an exconvict who was serving probation under LA County's supervision.

The incident was heartbreaking for the City of Whittier and raised alarm among people who worry that recent statewide criminal justice reforms like AB109 and Prop 47 have threatened public safety.

The fact is, we as a county cannot and should not attempt to roll back these reforms. They were passed by voters and our state legislature to address real problems with our incarceration system that have kept low-level, mostly minority offenders behind bars for decades. Our state prisons were inhumanely overcrowded and packed with people who would be better served in a mental health facility.

LA County is set to admit hundreds more former inmates into our probation program in the next year. That is why I joined Supervisor Barger to create a Blue Ribbon Commission on Public Safety. This commission will take a critical look at how we have implemented AB 109, Prop 47 and other reforms, what their impact has been on public safety, and what we can do to implement them better.

Ribbon commission will agree. sides of this issue. Law enforcement and their allies understandably We are going to raise over want a justice system that keeps

safe and keeps dangerous people off our streets. Criminal justice activists want a criminal justice system that treats people fairly and allows people who have served their time to have a second chance.

There is no reason those two concepts cannot be compatible. This is a conversation that we make up just 2% of the workforce need to have and this Blue Ribbon on any given Metro project right commission is the venue to have it

I would like to wrap up this speech with an issue that has become very important and personal to me.


Six weeks ago it was announced that the Deferred Action for Childhood Arrivals program known as DACA would end.

Unfortunately, one of the hundreds of thousands of young people affected by this announcement is a member of my staff. Carlos was born in Mexico and brought to LA as a baby. President Obama signed DACA the day that he graduated high school and he told me it was the best graduation gift he could have asked for.

## Before you start house hunting, obtain a mortgage pre-approval

### What is a Mortgage Pre-Approval?

When you are pre-approved for a mortgage, it means a lender has determined how much you can borrow, the loan programs that you may qualify for, as well as the interest rate you qualify for. This assessment is based on things like credit score, income, debts, and employment history.

You'll generally get a written statement from a lender stating this information, which can be used to give sellers confidence that you'll be approved for a loan after they accept your offer. Most preapproval letters are good for 60 to 90 days.

#### **Does Pre-Approval Guarantee** a Loan?

No. Even if you receive a preapproval letter from a lender, you may not get a loan from a lender and you are not guaranteed a specific rate or loan term. Regardless of pre-approval, a lender may require additional income and asset verification, as well as the satisfaction of other conditions, before extending you a loan.

Pre-approval letters are subject to modification or cancellation if your financial situation or other conditions change. A pre-approval commitment to make a loan, or a guarantee of specific rates or terms. It is not an application for credit. Also, having a pre-approval letter does not guarantee that an offer you make on a home will be accepted by a seller.

#### Why Should You Get Pre-Approved?

There are many reasons why you should get pre-approved. The most important reason is that you will get an accurate idea of how much home you can afford. This can help to target your home search and ensure you only look at houses that are truly in your price range.

A pre-approval letter also helps you prove to real estate agents and sellers that you're a credible buyer and able to act fast when you find the home you want to buy. Some sellers might even require buyers to submit a pre-approval letter with their offers, though having a preapproval letter does not guarantee that your offer will be accepted by

A pre-approval letter can make you stand out in a competitive real estate market. If you make an offer on a house without a pre-approval, your offer may not be taken as seriously as an offer from another person with a pre-approval.

#### letter is not an offer to lend, a What Details Are Required in the **Pre-Approval Process?**

A lender will generally start by asking for some basic information about you and your financial history. If you have a co-borrower, the lender will also need this information about them.

Generally, a lender will then request your Social Security number and permission to pull your required credit report (and your coborrower's, if you have one). If the information you provide and the information obtained from your credit report satisfies the lender's guidelines, the lender will make a preliminary determination in writing stating that you would qualify for a particular loan amount subject to the conditions outlined in your preapproval letter.
