Downey intersection named one of state's most dangerous

STUDY: Downey is home to 11 of California's most dangerous intersections based on 2015 data.

DOWNEY - According to a recent study, Downey is home to several of the most dangerous intersections in California.

Estey and Bomberger LLP, along with data visualization firm 1point21interative released list of the 444 most dangerous intersections in the state based on over 435,000 collision records, including every motor vehicle crash recorded by the Statewide Integrated Traffic Records System (SWITRS) in 2015.

The study takes total number of crashes, injuries and fatalities into account and gives each intersection a score. The higher the score received, the higher an intersection is placed on the list and therefore deemed more dangerous.

The intersection at Firestone Boulevard and Lakewood Boulevard took the fourth highest rank on the list, with 36 crashes, 32 injuries and no fatalities. It's final "danger score" was placed at 132.00, compared to the average 68.24.

This wasn't the only intersection in Downey to make the list.

the city of Downey are certainly higher than we would prefer and efforts are continually being made to reduce that number, we believe that context is needed to properly interpret the results.

The Downey Police Department has always prided itself on service to our residents. As such, our department is one of the few California law enforcement agencies that will take a traffic collision report upon request, even if there is no injury. This is significant because the only way that a traffic collision can be recorded in the Statewide Integrated Traffic Records System is if there is a formal report. In other words, if the involved parties exchange names and information, or no report is taken, there is no record of the traffic collision in SWITRS and it would not be

> "The safety improvements completed at the City's intersections and roadways are intended to address the types of collisions observed at the given street or intersection through the accident history of the particular location.

"The City is always pursuing grant opportunities to fund such safety improvements and, in fact, recently completed traffic safety improvements based on observed accident history at the Florence Ave. and Lakewood Blvd., Florence Ave. and Old River School Rd.-Tecum Rd. and Bellflower Blvd. and Imperial Hwy. intersections, which were cited in the newspaper article.

"In addition, the city has secured a grant through the Los Angeles County Metropolitan Transportation Authority (Metro) to improve safety at the Lakewood Blvd. at Firestone Blvd. intersection and the design work will begin as soon as the funding agreement between the City and Metro is executed. Exotical Hawaiian has survived where others did not.

"We've outlived everyone else because the economy turned real rough in 2008, and a lot of niche, kind of unnecessary businesses businesses that sell groceries or regular clothing that people wear every day, stuff like that - a lot of niche businesses went out of business simply because nobody had the extra funds to throw around at that kind of thing," said Orloff. "Most of the Hawaiian businesses

"My grandfather's indomitable will," said Orloff. "He liked this business and it was one of the things that really attached him and reminded him of his wife - my grandmother passed away in 2004 so he was really holding on to this business and he didn't want to let it go. Plus, he had nothing else that he wanted to do in his life; he was at the end of his years and so he threw his own personal assets and money back into the business to keep it afloat."

After his grandfather's passing, Orloff's father officially took over. Orloff himself got involved around five years ago.

Orloff says that as Downey has changed and developed around the store, there hasn't been much adaptation for the store itself; and there may not need to be much.

"I think the way that we run things and the way that we've done things is kind of evergreen," said

"It's not something that needs include: to adapt much as long as we keep on the straight and narrow of taking care of our customers, taking care of our business making sure it doesn't fall apart, and just keeping on the straight and narrow with it."



LONDON – Dolores O'Riordan, lead singer of Irish rock band The Cranberries, died suddenly on Monday. She was 46.

O'Riordan died in London, where she was recording, publicist Lindsey Holmes said.

"No further details are available at this time," Holmes said, adding that the singer's family was "devastated" by the news.

Formed in Limerick, Ireland at the end of the 1980s, The Cranberries became international stars in the 90s with hits including "Zombie" and "Linger" that fused the alternative rock edge with Celtic-infused pop tunefulness.

Irish President Michael D. Higgins said O'Riordan and the band "had an immense influence on rock and pop music in Ireland and internationally."

"To all those who follow and support Irish music, Irish musicians and

LONDON - Dolores O'Riordan, lead singer of Irish rock band The the performing arts, her death will be a big loss," he said in a statement.

O'Riordan was The Cranberries' chief lyricist and co-songwriter, and her powerful, sometimes wailing, voice was key to the band's distinctive sound.

The group's 1993 debut album "Everybody Else Is Doing It, So Why Can't We?" sold millions of copies and produced the hit single "Linger."

The follow-up, "No Need to Argue," sold in even greater numbers and contained "Zombie," a howl against Northern Ireland's violent Troubles that topped singles charts in several countries.

The band released three more studio albums before splitting up in 2003. O'Riordan released a solo album, "Are You Listening," in 2007, and another, "No Baggage," in 2009.

The members of The Cranberries reunited that year, releasing the album "Roses" in 2012.

The Cranberries released the acoustic album "Something Else" in 2017 and had been due to tour Europe and North America. The tour was cut short because O'Riordan was suffering from back problems.

In 2014, O'Riordan was accused of assaulting three police officers and a flight attendant during a flight from New York to Ireland. She pleaded guilty and was fined 6,000 euros (\$6,600).

Medical records given to the court indicated she was mentally ill at the time of the altercation. After her court hearing O'Riordan urged other people suffering mental illness to seek help.

O'Riordan is survived by her ex-husband, the former Duran Duran tour manager Don Burton, and their three children.

Hugh Wilson, creator of the classic sitcom "WKRP in Cincinnati"

CHARLOTTESVILLE – Hugh Wilson, creator of the classic sitcom "WKRP in Cincinnati," has died at the age of 74, according to multiple news sources.

His family announced that he died on Sunday at his home in Charlottesville, Virginia.

Wilson was an advertising copywriter and a radio sales executive before he moved into writing for television. He was a writer for the legendary sitcom "The Bob Newhart Show" and then a writer for "The Tony Randall Show."

In 1978, Wilson created the hip sitcom "WKRP in Cincinnati," about the misadventures of the staff at a struggling radio station in Cincinnati. Howard Hessman as DJ "Dr. Johnny Fever" and Loni Anderson as the receptionist Jennifer Marlowe were breakout stars. Other popular characters on the ensemble show were Tim Reid as cool DJ "Venus Flytrap" and the fussy news reporter Les Nessman, played by Richard Sanders.

The series ran on CBS from 1978 until 1982. "WKRP" featured an all-time iconic episode called "Turkeys Away," in which the station decides to drop live turkeys from a helicopter on Thanksgiving Day, not realizing that domestic turkeys can't fly.

In 1983, Wilson was asked to rewrite a screenplay for a movie about a group of misfits trying to join the police force. In a 2015 interview with the Archive of American Television, Wilson talked about the script that would become the classic comedy film "Police Academy."

"I got this script, and it was such a lousy piece of junk," "I told my agent that I was in no way interested." "He came back to me and said, 'This is The Ladd Co., it's an important company, part of Warner Bros., a lot of important people are attached — and they're saying that if you do a rewrite, they'll let you direct it.' I said, 'That's a whole different story.'"

Wilson created three other TV series. "Frank's Place, starring WKRP's Tim Reid; "The Famous Teddy Z" with Jon Cryer and "Easy Street, starring Loni Anderson.

In the movies, he directed "First Wives Club, starring Goldie Hawn and "Guarding Tess," starring Shirley MacLaine.

He is survived by his wife of 40 years, Charters Smith Wilson; children Cannon, Price, Margaret, Hugh and Caroline; and four grandchildren.



Jeff Sessions gives a boost to the legalization of pot

When Winston Churchill's party lost an election in 1945, evicting him from the job of prime minister of Britain, his wife ventured that the defeat might be "a blessing in disguise." He replied, "Well, at the moment, it's certainly very well-disguised."

For those who favor legalizing recreational and medical use of marijuana, there is plenty of bad news in Attorney General Jeff Sessions' decision to reverse the Justice Department's previous hands-off policy toward state experimentation. He ordered federal prosecutors "to enforce the laws enacted by Congress." That directive poses a threat to cannabis growers, dispensaries, investors and users who had been operating under a permissive regime.

"This is going to create chaos in the dozens of states whose voters have chosen to regulate medical and adult use (of) marijuana rather than leaving it in the hands of criminals," said Neill Franklin, executive director of the Law Enforcement Action Partnership, which favors legalization. The Drug Enforcement Administration could raid dispensaries that states have bill to let states make their own choices on cannabis. She may find little allowed, as it did under President George W. Bush and even under Barack

But the crackdown could amount to the last gasp of marijuana prohibition. The best way to get rid of laws that are generally unpopular and destructive is to enforce them stringently. By threatening an assault on a sector that has established itself across the country, Sessions has picked a fight he is bound to lose.

His policy puts him at odds with the 29 states (and the District of Columbia) that allow medical use of the drug. Together, they comprise nearly 60 percent of the U.S. population. His order is especially hostile to the eight states that have legalized recreational pot. They include Colorado, Washington, Oregon, Alaska, Nevada, Maine, Massachusetts and California, which account for 20 percent of Americans.

It also creates conflict with many people in his own party. Sen. Cory Gardner of Colorado said the shift contradicted the assurance Sessions had given him, and he threatened to block all Justice Department nominations

Fellow GOP Sens. Dean Heller of Nevada, Lisa Murkowski of Alaska and Rand Paul of Kentucky objected. Rep. Dana Rohrabacher of California accused Sessions of a "profound misreading of the Constitution, which allows states, not the heavy-handed federal government, to determine such issues.

Sessions is a prisoner of his immutable belief that "using drugs will destroy your life." But the more than 100 million Americans who have consumed cannabis, and particularly the 35 million who enjoy it on a regular basis, know better. The attorney general seems intent on proving that you don't have to be stoned to be detached from reality.

He is also inviting a backlash. Just hours after his announcement, the Vermont House of Representatives approved a bill to allow recreational use of cannabis, which the Senate had passed last year, and Republican Gov. Phil Scott supports the idea. This week, the New Hampshire House voted to legalize possession of small amounts of pot, though Republican Gov. Chris Sununu is opposed.

Illinois, which allows medical marijuana, could benefit. State Sen. Heather Steans, who had already introduced a bill to legalize recreational use, says, "What the attorney general did may be pushing states further."

Rohrabacher thinks Sessions' move will encourage Congress to foil him. House Democratic leader Nancy Pelosi said she will introduce a opposition. Politico reported that it "could not find a single member of Congress who had issued a statement in support of Sessions' actions."

His mistake was to disturb a status quo that allowed members of Congress to accommodate public support for legalization without having to vote for it. Deference to state liberalization could be couched in terms of keeping the federal government from interfering with matters beyond its responsibilities — an approach that largely satisfied both Democrats and Republicans.

Sessions is forcing many members to choose between supporting prohibition of cannabis and siding with their own states and constituents. Given that two-thirds of Americans want to allow recreational weed, it's not a shrewd strategy.

His position is more likely to boost support for legalization than to diminish it. That's partly because he works for a president who is notably unpopular and partly because he himself has an approval rating of 24 percent. Legalization supporters could not ask for a more useful adversary.

They may lament Sessions' ill-informed and punitive decision now. Someday, they may remember it as a blessing in disguise.

Constitutional ignorance -- perhaps contempt

Hillary Clinton blamed the Electoral College for her stunning defeat in the 2016 presidential election in her latest memoirs, "What Happened?" Some have claimed that the Electoral College is one of the most dangerous institutions in American politics. Why? They say the Electoral College system, as opposed to a simple majority vote, distorts the oneperson, one-vote principle of democracy because electoral votes are not the rest of the nation. That forces a presidential candidate to take into distributed according to population.

To back up their claim, they point out that the Electoral College gives, for example, Wyoming citizens disproportionate weight in a presidential election. Put another way, Wyoming, a state with a population of about 600,000, has one member in the U.S. House of Representatives and two members in the U.S. Senate, which gives the citizens of Wyoming three electoral votes, or one electoral vote per 200,000 people.


and 55 electoral votes, or approximately one vote per 715,000 people. While we're at it, should we make all congressional acts be majority rule? Comparatively, individuals in Wyoming have nearly four times the power in the Electoral College as Californians.

Many people whine that using the Electoral College instead of the popular vote and majority rule is undemocratic. I'd say that they are absolutely right. Not deciding who will be the president by majority rule is not democracy. But the Founding Fathers went to great lengths to ensure that we were a republic and not a democracy. In fact, the word democracy does not appear in the Declaration of Independence, the U.S. Constitution or any other of our founding documents.

How about a few quotations expressed by the Founders about democracy? In Federalist Paper No. 10, James Madison wanted to prevent rule by majority faction, saying, "Measures are too often decided, not according to the rules of justice and the rights of the minor party, but by the superior force of an interested and overbearing majority." John Adams warned in a letter, "Remember Democracy never lasts long. It soon wastes, exhausts and murders itself. There never was a Democracy Yet, that did not commit suicide.

Edmund Randolph said, "That in tracing these evils to their origin, every man had found it in the turbulence and follies of democracy." Then-Chief Justice John Marshall observed, "Between a balanced republic and a democracy, the difference is like that between order and chaos.

The Founders expressed contempt for the tyranny of majority rule, and throughout our Constitution, they placed impediments to that tyranny. Two houses of Congress pose one obstacle to majority rule. That is, 51 senators can block the wishes of 435 representatives and 49 senators. The president can veto the wishes of 535 members of Congress. It takes twothirds of both houses of Congress to override a presidential veto.



To change the Constitution requires not a majority but a two-thirds vote of both houses, and if an amendment is approved, it requires ratification by three-fourths of state legislatures.

Finally, the Electoral College is yet another measure that thwarts majority rule. It makes sure that the highly populated states — today, mainly 12 on the East and West coasts, cannot run roughshod over consideration the wishes of the other 38 states.

Those Americans obsessed with rule by popular majorities might want to get rid of the U.S. Senate, where states, regardless of population, have two senators. Should we change representation in the House of Representatives to a system of proportional representation and eliminate the guarantee that each state gets at least one representative?

Currently, seven states with populations of 1 million or fewer have one California, our most populous state, has more than 39 million people representative, thus giving them disproportionate influence in Congress. When we're finished with establishing majority rule in Congress we then move to change our court system, which requires unanimity in jury decisions, to a simple majority rule?

> My question is: Is it ignorance of or contempt for our Constitution that fuels the movement to abolish the Electoral College?

So our leaders in Washington have to make the smart decision. Immigrants living in this country are an asset - not a liability.





After his death at age 19, King Tut disappeared from history until the discovery of his tomb in 1922. Since then, studies of his tomb and remains have revealed much information about his life and times, making Tutankhamun one of the best known ancient Egyptian





MMA prospect Aaron Pico to fight Saturday on national TV

BELLFLOWER - Aaron Pico, a boxing and wrestling standout who signed a professional MMA contract while still a sophomore at St. John Bosco High School, will fight on the main card of a nationally-televised event Saturday.

Pico (1-1) will face Shane Kruchten (12-3) in a featherweight matchup at Bellator 192, taking place at The Forum in Inglewood.

Lakers to honor Elgin Baylor with statue outside Staples Center

LOS ANGELES - The Los Angeles Lakers will honor Elgin Baylor with a statue outside Staples Center, the organization announced this week.

The statue will be unveiled April 6 during an outdoor ceremony prior to the Lakers facing the Minnesota Timberwolves.

"I am thrilled that 60 years after the Minneapolis Lakers drafted Elgin, we are able to celebrate and honor him with a statue," Lakers CEO and controlling owner Jeanie Buss said. "Not only is Elgin a part of the Lakers family, his contributions to the game of basketball earned him a place in the Hall of Fame. His list of accomplishments are unparalleled and I can't wait to see his statue at Star Plaza alongside the other Lakers legends."

Drafted first overall by the Minneapolis Lakers in 1958, Baylor averaged 24.9 points, 15 rebounds and 4.1 assists as a rookie en route to Rookie of the Year honors.

The Washington, D.C. native would go on to play 14 seasons for the Minneapolis and Los Angeles Lakers, earning NBA All-Star honors 11 times, with 10 First Team All-NBA appearances.

Inducted into the Naismith Memorial Basketball Hall of Fame in 1977, Baylor's jersey (#22) was retired by the Lakers on Nov. 3, 1983. Over his 14-year career, Baylor averaged 27.4 points, 13.5 rebounds and 4.3 assists in 846 games.

Baylor's statue, created by artists Julie Rotblatt Amrany and Omri Amrany, will join those of former Lakers Jerry West, Kareem Abdul-Jabbar, Earvin "Magic" Johnson, Shaquille O'Neal and former Lakers broadcaster Francis "Chick" Hearn, boxer Oscar De La Hoya, former Kings hockey players Luc Robitaille and Wayne Gretzky, and LA Kings broadcaster Bob Miller.

The generosity of strangers

Most people have personal longevity milestones that they cherish.

Eli Manning started 210 consecutive football games. Bruno Sammartino held the WWF heavyweight championship an astounding 2,803 days. Jerry Seinfeld went 13 years and five months without throwing up.

I went 18 years without being involved in a single car accident. Unfortunately, that all changed last week.

On Saturday morning, after a late breakfast in Long Beach, my wife and I were returning home via the northbound 605 Freeway. Traffic began to slow near the Katella Avenue exit, where the freeway makes a slight bend. A CHP SUV was on the right shoulder, its red and blue lights blinking.

Everyone slowed. Well, almost everyone. I heard a loud BOOM behind me and my entire body jerked towards the steering wheel. My wife's neck snapped violently back and forth. My Nissan Altima lurched forward but rolled to a stop before a second collision occurred.

The driver that hit us somehow ended up in front of me. I'm always reading stories about hit-and-run drivers leaving the scenes of accidents but luckily this person did the right thing and followed me to the freeway

I'm an even-keel guy, but nothing irritates me more than people who are rude and people who don't pay attention behind the wheel. Was this guy texting while driving? Distracted by the police activity? Jamming out

What happened next caught me off-guard: the other driver was actually nice. Very nice. Over the top nice.

"Hey, sorry about that, it was a total accident," he said, his hand on my shoulder. "Guess this is why we have insurance, right?"

Dude, I wanted to be mad. I wanted to whoop and holler and throw my arms up in exasperation. But no, not only had this man hit me, he robbed me of a justifiable opportunity to act like a raving lunatic.

The damage to my car didn't appear terrible. The rear bumper was scuffed and hanging loose from the left side. The other driver's Mercedes coupe appeared to have absorbed the brunt of the damage. But after we exchanged information and went on our ways, the Altima suddenly lost power, with barely enough juice to roll towards an off-ramp.

This was scary. Nobody ever thinks about having to stop on a freeway. You're not accustomed to having to look for disabled vehicles blocking

The entire electrical system was down, disabling my hazards. Cars zipped by at an alarming speed. People craned their necks, wondering what I was doing. "Hey, you might want to turn on your hazards!" one person shouted. Thanks for the advice, buddy.

As my wife called for help, I noticed two men walking my way. Both were heavily tatted, their faces obscured by various green tattoos except for a pair of red pursed lips. One of the men had a child's portrait inked on his neck. I have no idea where these men came from.

"You need help pushing?" one of the men asked.

"Yeah, that'd be great."

We pushed the Altima off the freeway and into the parking lot of a nearby Yum-Yum Donuts. I was barely able to thank them before they jogged back to their car and drove off.

My car wasn't properly positioned so I was blocking three parking spaces. That's when a homeless man emerged from a grassy area near the freeway off-ramp, carrying an orange cone. Without saying a word, he placed the cone behind my car as a safety measure.

My car was eventually towed to a body shop and all the insurance claims are being worked out. (The other driver admitted fault, which is making things a lot easier.)

But long after this ordeal is over I'll carry with me the kindness of strangers, who helped make a stressful situation so much easier to handle.

Don't stifle that sneeze -- it could kill you

learned that lesson the hard way and had to spend two weeks in the hospital due to his resulting injury. That's according to a case report with the cringe-inducing title "Snap, crackle and pop: when sneezing leads to crackling in the neck." The report was published Monday in the medical journal BMJ Case Reports.

According to the report, this "previously fit" man pinched his nose and kept his mouth closed during a "forceful" sneeze. He later told doctors he immediately felt a popping sensation in his neck. He didn't notice any problems right away, but a couple of hours later he felt pain in his throat and neck. When it became swollen and his voice changed, he took himself

If you are about to sneeze -- even if you are in a quiet place -- doctors last 30 years or so, but this time it was different," case report author Dr. would advise you to let it rip. A 34-year-old unnamed man in Britain Wanding Yang said. She works in the department of ear, nose and throat at the University Hospitals of Leicester NHS Trust.

> Initially, doctors saw swelling in his neck and when they examined the soft tissue they heard popping and crackling. Yang said that meant there were air bubbles getting into the man's muscles and deep into his tissue.

> Scans confirmed the problem. The tests showed actual streaks of air in the retropharyngeal region and extensive surgical emphysema in the neck anterior to the trachea. In other words, by trying to hold in his sneeze, he actually blew a small hole in his throat.

> When you sneeze, it's your body's protective reflex to get rid of an irritant that has gotten into your nose. With a sneeze, a significant amount of air pressure builds up in the lungs and forces its way through the nasal cavity to get rid of that irritant.

> A sneeze can propel mucus droplets at a rate of 100 miles an hour. If you hold a sneeze back, that pressurized air will need to go somewhere. In this case, it injured the tissue in the man's throat. In past cases, doctors have also seen a stifled sneeze cause sinus problems, middle and inner ear damage, ear infections and a ruptured eardrum.

> The patient was given antibiotics and had to be fed through a tube, which was removed after seven days. His symptoms got better while he rested and gradually he was able to eat soft food.

> This kind of sneezing injury is unusual, according to the report. Doctors have seen patients with similar injuries after coughing heavily or after vomiting forcefully.

> "It is a rare injury that we would more likely see with trauma, like if someone were to be in a car accident or was injured with a gunshot or knife, or if they swallowed something sharp," said Dr. Adam M. Klein, who did not see the British patient and was not involved in the study. Klein is the director of the Emory Voice Center and chief of the division of laryngology in the department of otolaryngology.

> Klein said if you are worried about spreading germs with your sneezes, rather than hold it in, the best thing to do to avoid injury is to let it out. If you don't have a tissue, sneezing into the crook of your elbow, rather than onto your hand, is "a good practice."

5 must-do's before buying your first home

You've decided to go for it. You know rates are at attractive lows.

Buying a home can be thrilling and nerve-wracking at the same exactly what to expect. The learning curve can be steep, but most of the issues can be resolved by doing a little financial homework.

1. Check your credit

The homebuyer's credit score is among the most important factors when it comes to qualifying for a loan these days.

"In addition, the standards are higher in terms of what score you need and how it affects the cost of the loan," says Mike Winesburg, formerly a mortgage planner with McKinley Carter Wealth Services in Wheeling, West Virginia.

Scour the reports for mistakes, unpaid accounts or collection accounts.

Just because you pay everything on time every month doesn't mean your credit is stellar, however. The amount of credit you're using relative to your available credit limit, or your credit utilization ratio, can sink a credit score.

The lower the utilization rate, the higher your score will be. Ideally, first-time homebuyers would have a lot of credit available, with less than a third of it used.

Repairing damaged credit takes time — and money, if you owe more than lenders would prefer to see relative to your income. If you think your credit may need work, begin the repair process at least six months before shopping for a home.

Evaluate assets liabilities

So you don't owe too much money and your payments are up to date. But how do you spend your money? Do you have piles of money left over every month, or are you on a shoestring budget?

A first-time homebuyer should have a good idea of what is owed and what is coming in.

"You should understand a little bit about monthly cash flow," Winesburg says.

"If I were a first-time homebuyer time, especially for a first-time and I wanted to do everything right, homebuyer — it's difficult to know I would probably try to track my spending for a couple of months to see where my money was going,"

Additionally, buyers should Take these five steps to have an idea of how lenders will view their income, and that requires becoming familiar with the basics of mortgage lending.

According to Winesburg, the self-employed or independent contractor will need a solid two years' earnings history to show.

3. Organize documents

When applying for mortgages, homebuyers must document income and taxes.

Typically, mortgage lenders will request two recent pay stubs, the previous two years' W-2s, tax returns and the past two months of bank statements — every page, even the blank ones.

"Why it has to be every single last page, I don't know. But that is what they want to see. I think they look for nonsufficient funds or odd money in or out," says Floyd Walters, owner of BWA Mortgage in La Canada Flintridge, California.

Buying a home can take a long time, but knowing what you need and where to find it can save time when you're ready

4. Qualify yourself

Ideally, as a first-time homebuyer, you already know how much you can afford to spend before the mortgage lender tells you how much you qualify for. Bankrate's "How much house can I afford?" calculator will help.

By calculating debt-to-income ratio and factoring in a down payment, you will have a good idea of what you can afford, both BankRate.com upfront and monthly.

Though there's not a fixed require, the old standard dictates that no more than 28 percent of your gross monthly income be devoted to housing costs. This percentage is called the front-end

The back-end ratio shows what portion of income covers all monthly debt obligations. Lenders prefer the back-end ratio to be 36 percent or less, but some borrowers get approved with back-end ratios of 45 percent or higher.

"Find out what you can afford and then you can back into everything else. We know the money you have available to put down, we know the monthly payment and we can solve (the equation) for the third variable — and that is the home price," Winesburg says.

Now that you know how much you can afford, check out Bankrate's comparisonmortgage rate shopping tool today.

5. Figure out your down

It takes effort to scrape together the down payment.

There are programs that can assist buyers with qualifying incomes and situations.

"I've helped arrange assistance loans for \$10,000, which are interest- and payment-free, and forgivable after five years. Although considered a loan, they're more like grants. Other programs can provide up to \$40,000 interestfree," Winesburg says.

"Each state is different, but most of this money comes from the HOME Investment Partnership Program, which is a federal block grant to create affordable housing,"

Finally, speak with mortgage lenders when you're starting the process. Check with friends, coworkers and neighbors to find out which lenders they enjoyed working with and ask them questions about the process and what other steps first-time homebuyers should take.



How to get rid of private mortgage insurance (PMI)

If you bought a house with debt-to-income ratio that lenders a down payment of less than 20 percent, your lender required you to buy mortgage insurance. The same goes if you refinanced with less than 20 percent equity.

> Private mortgage insurance is after you have met some conditions.

How to get rid of PMI

To remove PMI, or private mortgage insurance, you must have at least 20 percent equity in the home. You may ask the lender to cancel PMI when you have paid down the mortgage balance to 80 percent of the home's original appraised value.

When the balance drops to 78 percent, the mortgage servicer is required to eliminate PMI.

Although you can cancel private mortgage insurance, you cannot cancel Federal Housing insurance. You Administration can get rid of FHA insurance by refinancing into a non-FHA-insured

Canceling PMI sooner

Here are steps you can take to cancel mortgage insurance sooner or strengthen your negotiating

Get a new appraisal: Some lenders will consider a new appraisal instead of the original expensive, and you can remove it sales price or appraised value when deciding whether you meet the BankRate.com 20 percent equity threshold. An appraisal generally costs \$450 to \$600. Before spending the money on an appraisal, ask the lender if this tactic will work in the specific case of your loan.


