Hookah lounge appeals sanctions to City Council

APPEAL: Hookah Hub files appeal after the Planning Commission rescinded its live entertainment permit and cut its hours.

DOWNEY – A downtown hookah lounge has hired an attorney as it appeals the Downey Planning Commission's decision to modify its conditional use permit, cutting its hours and revoking its ability to host live entertainment.

Planning commissioners took the action Nov. 1, 2017, in response to reports that Hookah Hub, located at 8323 Firestone Blvd., was draining police resources due to fights, stabbings and gang activity at the location.

City officials also accused the hookah lounge of being in violation of fire and building safety codes, namely that the business illegally blocked the front entrance by installing a substandard security door.

Planning commissioners criticized the hookah lounge for "lack of responsible management of the business, management's disregard of the approved conditions of approval, and the misrepresentation of the proposed business operations during the original public hearing."

In addition to pulling its live lounge. entertainment privileges, commission scaled back Hookah Hub's permissible hours operations.

In a letter announcing its appeal, attorney Benjamin McFadden said the sanctions would "effectively eliminate Hookah Hub's business in violation of Hookah Hub's vested fundamental right to operate a hookah lounge...

The commission's decision to modify the conditional use permit, McFadden added, was "in error" and "not supported by the evidence."

The City Council was set to consider the appeal Tuesday but the hearing was rescheduled to Feb. 27.

It's not the first time Downey appeal. has had issues with a hookah

In December, the Planning Commission revoked entertainment at Mosaik Hookah Lounge, located at 11029 Downey

Downey Police had been called to the hookah lounge 18 times since Nov. 13, 2016, for a variety of complaints, including arguments, yelling, fighting, theft, and drinking in public.

In addition to eliminating live entertainment at Mosaik Hookah Lounge, commissioners also raised the minimum age of customers to 21, prohibited outdoor loitering, and rolled back its hours of operations.

Downey approves third rooftop restaurant in downtown

DOWNTOWN: Realtor Don Jervis will renovate his property at 2nd Street and Downey Avenue with a secondstory addition and rooftop dining.

DOWNEY - A third rooftop restaurant is coming to downtown

The Planning Commission last week signed off on a new rooftop eatery at 11100 Downey Ave. No tenant has signed a lease for the space yet.

The property is owned by realtor Don Jervis, who plans to add a 776sq. ft. rooftop deck, along with a 580-sq. ft. second-story addition. Jervis will also add 150 square feet election campaign. of outdoor patio seating.

Construction will include a fullheight wall on the south side of the building and a cover over the rooftop dining area to mitigate noise concerns, officials said. The building is located directly west of a 50-unit apartment complex.

After renovations, the building will have "a rustic look and feel,"

Located across from Mi Cielo and Bastards, the property has been mostly vacant since 2013. It was briefly used by Councilman Rick Rodriguez during his 2016

Mi Cielo was the first restaurant in downtown Downey to feature a rooftop lounge. It opened in 2017.

Redevelopment of the former Avenue Theatre also includes plans for rooftop dining.

The theater, purchased for \$750,000 by the Downey Restaurant Group in 2016, was originally constructed in 1925 and has been vacant since 2004.



Garcia will keep trying to eliminate 'tampon tax'

DOWNEY – Assembly member Cristina Garcia announced she will introduce -- for the third time - legislation seeking to eliminate sales tax on feminine hygiene

Garcia first introduced a bill in 2016 that would have done away with sales taxes on tampons and maxi pads. The bill passed through the legislature but was vetoed by Gov. Jerry Brown, citing the

Garcia introduced a similar bill last year but that legislation effectively died this week when it was held on suspense by Assembly member Lorena Gonzalez Fletcher, chair of the Assembly Appropriations Committee.

In a statement, Garcia said she would reintroduce the legislation again later this year.

"Every month, for 40 years of our lives, we are being taxed for having a period," Garcia said. "Every month of our adult life we are taxed for our biology. Every month we are told our periods are a luxury, while also being told they are something to be ashamed of and we must hide.

"The state budget should not be balanced by a tax of a woman's uterus; our tax codes should be gender neutral."

Oprah Winfrey's remarkable Golden Globes speech rocked not only the event's A-list attendees, but almost all of America.

Winfrey cited the under-told story of Recy Taylor, a young black woman who was raped by six armed white men during the Jim Crow era. Despite threats to her life, Taylor reported her story to the NAACP where Rosa Parks made it her mission to help her find justice.

That justice was never seen, but Oprah ended her speech on an optimistic note. "A new day is on the horizon," she said. "A lot of magnificent women" and "some pretty phenomenal men" are "fighting hard to make sure that ... nobody ever has to say 'Me too' again."

In typical modern fashion, #Oprah2020 began trending on Twitter.

I'm a huge fan of Oprah. But I disagree with the masses who want her to run for president.

Not because she's a political amateur, but because America has a history of looking to black women to save Americans from themselves while not providing the proper recognition for their labor or even respect.

John Dean, a White House counsel under Obama, tweeted an endorsement that sums this up: "She could end Trump's, and the GOP's, misogyny and racism like no one else!" he predicted, tagging his post

But why should the burden of cleaning up Trump's mess fall on a single black woman?

This notion goes all the way back to the days of slavery, when enslaved black women were forced to breast-feed their slave master's babies with their own breast milk. Known as wet-nursing, this exploited the motherhood of black women while forcing them to disregard their own children.

And when America's earliest forms of feminism began to unravel, it was Sojourner Truth who inserted what's now known as intersectionality recognizing not only gender discrimination but also its overlap with racial discrimination — in her famous poem "Ain't I A Woman?"

The list goes on. Black women like Ida B. Wells-Barnett and Mary Church Terrell fought passionately for women's voting rights without ever getting the recognition that better known white suffragettes enjoyed.

Even today, the cultural revolution around sexual assault and harassment owes a huge debt to the #MeToo movement founded by Tarana Burke, a black woman who started the movement a decade before

And it plays out through our elections. In the Alabama Senate race, 98 percent of black women voted for Doug Jones. They're the reason he beat Republican Roy Moore, who was widely known for making inappropriate sexual advances on teenage girls.

Many Americans did recognize the black women who kept Moore out of the Senate. That's good news. But it was still a white former prosecutor they were sending to Washington, who may now shy away from black women to please conservative whites in his deep-red state.

If we're serious about having black women lead, we can't stop at America has always trusted black women to do the work, but it's recognizing them. We need to empower them both economically and

Trump wrong to expand libel laws

Don't use Dreamers as political pawns

President Donald Trump said, "We are going to take a strong look at our country's libel laws so that when somebody says something that is false and defamatory about someone, that person will have meaningful recourse in our courts." The president was responding to statements made in Michael Wolff's new book, "Fire and Fury: Inside the Trump White House."

Our nation does not need stronger laws against libel. To the contrary, libel and slander laws should be repealed. Let's say exactly what libel and slander are. The legal profession defines libel as a published false statement that is damaging to a person's reputation. Slander is making a false spoken statement that is damaging to a person's reputation.

There's a question about reputation that never crosses even the sharpest legal minds. Does one's reputation belong to him? In other words, if one's reputation is what others think about him, whose property are other people's thoughts? The thoughts I have in my mind about others, and hence their reputations, belong to me.

One major benefit from decriminalizing libel and slander would be that it would reduce the value of gossip. It would reduce the value of false statements made by others. Here's a Gallup Poll survey question: "In

general, how much trust and confidence do you have in the mass media such as newspapers, TV and radio — when it comes to reporting the news fully, accurately and fairly — a great deal, a fair amount, not very much or none at all?" In 1976, 72 percent of Americans trusted the media, and today the percentage has fallen to 32. The mainstream media are so biased and dishonest that more and more Americans are using alternative news sources, which have become increasingly available electronically.

While we're talking about bad laws dealing with libel and slander, let's raise some questions about other laws involving speech — namely, blackmail laws. The legal profession defines blackmail as occurring when someone demands money from a person in return for not revealing compromising or injurious information. I believe that people should not be prosecuted for blackmail. Let's examine it with the following scenario.

It's 5 o'clock in the morning. You see me leaving a motel with a sweet young thing who's obviously not Mrs. Williams. You say to me, "Professor Williams, the First Amendment to the U.S. Constitution guarantees me the right to broadcast to the entire world your conduct that I observed." I believe that most would agree that you have that right. You then proposition me, "If you pay me \$10,000, I will not exercise my right to tell the world about your behavior."

Now the ball is in my court. I have a right to turn down your proposition and let you tell the world about my infidelity and live with the consequences of that decision. Or I can pay you the \$10,000 for your silence and live with the consequences of that decision. In other words, blackmail fits into the category of peaceable, noncoercive voluntary exchange, just like most other transactions.

If I'm seen voluntarily giving up \$10,000, the only conclusion a third party could reach is that I must have viewed myself as being better off as a result. That's just like an instance when you see me voluntarily give up money for some other good or service — be it food, clothing, housing or transportation. You come to the same conclusion.

What constitutes a crime can be divided into two classes — mala in se and mala prohibita. Homicide and robbery are inherently wrong (mala in se). They involve the initiation of force against another. By contrast, blackmail (mala prohibita) offenses are considered criminal not because they violate the property or person of another but because society seeks to regulate such behavior.

By the way, married people would tend to find blackmail in their interest. Extra eyes on their spouse's behavior, in pursuit of money, would help to ensure greater marital fidelity.







Our visit to Newcastle and the statue of Martin Luther King Jr.

We went to Newcastle last December on a lark – to see some English soccer games – when fate added a gift. Our arrival coincided with the culminating events of a year-long celebration of Martin Luther King, Jr.'s visit to that city 50 years ago.

A magnificent statue of King, commissioned by the University of Newcastle, was dedicated on November 13, 2017, the exact anniversary of King's visit to the school to receive an Honorary Doctorate in Civil Law in 1967.

I heard about this statue only weeks before our December trip while listening to National Public Radio, and the announcement sent me racing to the internet. What was this renowned civil rights activist doing in Newcastle, England? And only five months before his assassination? Newcastle is so far north of London – it's almost in Scotland!

A web search gave immediate answers. In the midst of deepening tensions at home over the direction of the civil rights movement, opposition to the war in Vietnam, and the rioting in major urban centers, King had accepted the invitation because he felt the honorary degree promoted awareness of the ongoing struggle against racism in the US and throughout the world.

King's impromptu speech at the time is now on YouTube. Although he wasn't expected to talk, King did so without notes, and it was his last speech outside of the US before his death five months later in 1968.

Despite jet-lag and the overnight train trip from London, King gave an eloquent answer to critics who claim you can't legislate

"It may be true that the law cannot change the heart but it can restrain the heartless. It may be true that the law cannot make a man love me but it can restrain him from lynching me..."

The civil rights movement is a personal memory for many of my generation, and it is impossible to forget images from that era: the violent Southern response to school integration and voter registration in the early 1960's, the terrorist bombing of the Birmingham church, Stokely Carmichael, Malcolm X, the Black Power movement, and the summer rioting in major cities in

While I remember exactly where I was when I heard of Martin Luther King's death in 1968, I never realized that these events had a world-wide audience as well. I was awed by the

At the time of King's visit, school officials said there would be no recording because they did not want King to feel pressured to talk. Decades later, examination of photos revealed what looked like microphones, and a search uncovered the long-ignored film.




Barney Nipp was born October

Mark Smith, lead singer of The Falls, dies at 60

The Fall, died Wednesday. He was 60.

The Fall manager and Smith's partner Pam Vander — also known as Pam Van Damned — said Smith died at his home. The cause of death wasn't immediately available. The band had canceled a string of shows last year because of Smith's "medical issues."

Smith formed The Fall when punk hit 1970s Manchester, and the gray industrial English city sprouted innovative bands including Joy Division and The Buzzcocks.

Irascible and inimitable, Smith kept The Fall going for four decades and more than 30 albums. He was the band's only permanent member, hiring, firing and falling out with several dozen musicians along the way.

Spiky, unpredictable and poetic, the band was never a huge commercial success but had a big influence on other artists.

Simon Wolstencroft, who was The Fall's drummer from 1986 until 1997, said Smith was "iconic."

"His influences travel a long, long way to bands like Pulp, and new bands now like Cabbage, and many other bands have been influenced by him. It's a sad day," Wolstencroft told the BBC.

"Babydriver" director Edgar Wright tweeted that Smith was "not merely a legend of indie music but someone who, for me, was a gateway into that very genre."

JOEL TAYLOR: Joel Taylor, one of the stars of "Storm Chasers" on the Discovery Channel, has died, according to multiple news sources. He was

Taylor's death was announced by fellow "Storm Chasers" star Reed Timmer on Twitter on Tuesday, Jan. 23, 2018.

"RIP my best friend and storm chasing partner, Joel Taylor," Timmer wrote. "We chased so many intense storms, and I wish we could have just one more storm chase."

The cause of death has not been announced.

Taylor joined the cast of "Storm Chasers" during its first season in 2008. The documentary series focused on the lives of weathermen as they intercepted tornadoes in Tornado Alley, an area of the United State known for its severe storms. He stayed with the show until it was canceled in 2012.

The scientific data gathered by storm chasers is valuable, but it is a dangerous job. In 2013 former "Storm Chasers" star Tim Samaras, his son, Paul Samaras, and Carl Young, died while chasing a tornado in El Reno,

An Oklahoma native, Taylor studied meteorology at the University of Oklahoma and was currently storm-chasing with Elk City-based Team Western OK Chaser.

"He was one of the most level headed chasers on the roads and truly a classy guy outside of chasing. He didn't chase for the glory he chased because he had a true passion for storms," the team wrote in a Facebook

JACK KETCHUM: Jack Ketchum, a prize-winning horror and screenplay writer known for such fiction as "The Box" and the controversial "Off Season" and once labeled by Stephen King as likely the scariest writer in America, has died.

Ketchum's friend and webmaster Kevin Kovelant told The Associated Press that Ketchum died Wednesday morning at 71. No other details were immediately available. Jack Ketchum is the pen name for Dallas Mayr.

Ketchum, whose admirers include King and Chuck Pahlaniuk, was a Newark, New Jersey, native. He won several prizes for horror and his books also were a source for filmmakers, including "The Girl Next Door" and "The

His first novel, the cannibalistic "Off Season," was so violent that publisher Ballantine pulled back on support. The 1980 release was republished in 2015.

Paging Dr. Frischer...

My wife grew up with her beloved Mittens the cat...and a box of tissues always within reach.

Some 10% of us are allergic to dogs, and cat allergies affect about twice that many. Some of us also react to birds, rabbits, guinea pigs, ferrets, and rodents.

Why do allergies afflict us? Our immune system produces antibodies to fight off harmful germs. An allergen is a normally harmless substance, but for those with allergies, it triggers the immune system to react. This can lead to symptoms like itching or watery

eyes, runny nose, coughing, sneezing, wheezing, asthma and eczema. Interestingly, allergic reactions can change over time and even disappear. As we age, some of us leave our hay fever, pet allergies and food allergies



It is actually the proteins found in a dog or cat's dander (tiny flakes of skin), and not their fur itself, which cause allergic reactions. Dander is also found, in smaller quantities, in an animal's saliva and urine. Dander can be carried on our clothes, circulate in the air, settle in furniture and bedding, and stay behind on dust particles. In addition, pet hair or fur can collect pollen, mold spores and other outdoor allergens.

What can we do to reduce the symptoms of pet allergies? The best treatment is to avoid contact with cats, dogs, and the spaces they live in. Keep pets out of your home or especially your bedroom, and avoid visiting homes with pets. However, if a pet-free household is not an option:

- Washing a dog weekly can reduce the dust and dander significantly. Regular human shampoos are not the best choice; a dog's skin might become dry or irritated, leading to more sloughing of dead skin cells.
- Keep your home clean. Clean furniture covers, carpets, drapes, and pet bedding often. Keep the pet off of your bed, and consider using air purifiers.
- Medication for the human can help, including over the counter products like Benadryl, Claritin, Allegra, and Zyrtec.

No pet is 100% hypoallergenic. All dogs produce dander, including hairless ones, but low shedding dogs tend to release less dander. Some of the better dog breeds for allergy sufferers are poodles and many poodle mixes, Portuguese and Spanish water dogs, terriers, bichon frise, Chinese crested, Irish water spaniel, Maltese, standard schnauzer, Italian greyhound, and havanese.

Some of the better cat breeds for allergy sufferers are Siamese, Balinese, Siberian, Bengal, Burmese, colorpoint and Oriental shorthair, Cornish and Devon rex, Javanese, and sphynx.

Pets can be such a wonderful and healthful part of our lives. When seeking a new member of your family, I encourage you to research allergenic potential along with the animal's size, personality, and other

In 1968 I graduated from High School and still didn't have my own car. I had been working at a local pizzeria for \$1.75 an hour and by late summer had saved a little over \$400. Up to that time I had four modes of transportation:

- 1.) Walking this was reserved for shorter distances and used only when the other three were not available.
- 2.) Riding my bike this was my main mode of transportation at the time but had the drawback of not always being available because of technical difficulties.
- 3.) Getting rides from friends this was a great way to get around in style but had the drawback of only being available when friends were available.
- 4.) Borrowing my mom's car This was a special occasion mode of transportation, reserved only for dates, which were few and far between in those days.

One day, in the fall of that year, I was walking down Valley View Blvd. I was walking because the bike had a flat, my friends were all preoccupied and my mom had her car at work. As I passed by a local manure business, I noticed a green car with a "for sale" sign on the front window. As I got closer, I could read that they were asking \$350 for it.

When my dad got home that evening he agreed to go and check out the car to verify it was running and worth \$350. After seeing and testing the car, he said yes. I paid the \$350 cash and drove my very

It was a 1963 Mercury Comet two-door. It had an in-line, 6 cylinder and 3-on-the- column. It had drum brakes all around. It had a working AM/FM radio, but the first thing I bought for it was an 8-track tape player.

It had bench seats and accommodated six easily because it didn't have seatbelts. This also made it easy for my date to sit anywhere on the front seat she wanted.

One of the first young ladies I took out on a date in my new car was Maria, a close friend from high school. On our first date, she sat right next to me. The second date she sat in the middle of her portion of the front seat. On our third

date, she hugged the armrest of On Monday, Los Angeles County the passenger door. There was no fourth date.

The previous driver of my Comet was the company's salesman who just happened to be a chain smoker. Because of the saturation of smoke on the headliner, the threads holding the sections together disintegrated and the headliner above the front seat hung down to just touch my head.

I tried to clean it. I tried to sew it. I tried to tape it. In the end, I removed the entire headliner and spray painted the exposed metal. It had a great sound when it rained.

One day, Bonnie and I were coming home on Interstate 10 after a college group retreat in the San Bernardino Mountains. I had a strong headwind to drive into but I wanted to show that my Comet could keep up with the other cars so I kept pushing it.

Eventually, it blew the head casket, overheated, and blew up one of the pistons. A piece of the piston got wedged in the oil pan and froze the engine. My dad had to come and tow us home.

I was too innocent to know just what I was getting myself into DUI checkpoint but I decided to do all the repairs myself. Plus, I couldn't afford to have someone else do it. It took me a while but I eventually got it back together and it ran.

I learned a lot about an internal combustion engine by taking it apart and putting it back together. I've even done it a couple of times again on other engines. Once, a friend said I could have his car that had a blown engine if I could get it running again. I didn't have a car at the time and so it worked out great.

Another time, a mutual friend of Bonnie and mine had a crack in her block and I replaced it. I saved her a couple of thousand dollars and had fun doing it.

In the end, the Comet and I parted ways when I was in boot camp and my parents got tired of it being in their driveway. They sold it and fees exceeding \$10,000, plus to the junkyard for \$20 which they jail time. applied to my phone bill.

Oh well, it was just a car.

New law holds adults responsible for underage drinking at their properties

Supervisor Janice Hahn pressed her colleagues to enact a "social host ordinance" in the unincorporated areas of the Palos Verdes Peninsula, which would impose fines on adults when underage drinking occurs at their property.

While all four cities on the PV Peninsula have passed similar social host ordinances, the city ordinances do not apply to the peninsula's three County unincorporated areas, known as Academy Hills, Westfield, and the Estates.

Hahn's proposal aims to close these "donut holes" where local parents worry house parties will continue.

"The cities of the Peninsula are working together to prevent underage drinking and house parties that too often end in tragedy," said Hahn. "By enacting a similar ordinance in the Peninsula's County unincorporated areas, we are presenting a united front.

"I hope we can provide local parents some peace of mind – and give our law enforcement another

"What we don't want is for parties to be driven from incorporated cities to unincorporated County areas of the peninsula with no such ordinance. We appreciate Supervisor Hahn for her leadership filling in the gaps and helping us prevent the

at teen parties."

"The Palos Verdes Peninsula a tight knit community and although we are are four cities and an unincorporated county area, we are one when it comes to being standard second-reading as soon neighbors and parents," said Rolling Hills Estates City Councilmember Velveth Schmitz.

"This ordinance allows us to treat the unincorporated area as it is seen by our community. We are all in favor of this ordinance through our PTA, our law enforcement our families. Keeping it consistent is imperative to its success amongst a geographically close community but also one that doesn't see jurisdictions but rather neighborhoods."

The proposal heard Monday by the board would enact a Social Host Ordinance to the three peninsula unincorporated areas in the form of a one year pilot program.

During the pilot program, data will be collected to observe its effectiveness. In addition to underage drinking, the ordinance would also impose fines on adults who provide underage individuals with recreational cannabis.

Although cannabis use is legal under state law, it is illegal for
