### Millions pay excess fees to file taxes online

► Few taxpayers use the Free File system — intended to help moderateand low-income filers — and that benefits companies like Intuit and H&R Block.

WASHINGTON, D.C. - As internet use took off at the turn of the millennium, the Office of Management and Budget asked the Internal Revenue Service to create no-cost electronic tax-filing options for low- and moderateincome taxpayers. The techchallenged agency turned to the online tax-preparation industry for help and soon struck a deal with companies such as Intuit (the maker of TurboTax) and H&R Block, which had organized as a 12-member consortium called the Free File Alliance.

The Free File Alliance agreed to offer tax-prep service to millions of Americans at no charge. In exchange, the IRS pledged to "not compete with the Consortium in providing free, online tax return preparation and filing services to

The arrangement went into effect in 2003 and the IRS and the alliance have kept the framework in place ever since. Today the Free File system appears on track to become permanent. In April, the House voted unanimously to enshrine the provision into law, and the Senate is now considering whether to follow the influence of drugs or see what was going on...I looked repaired, however, crews still

It's hard to argue with the goal of the program. Free File sinkhole formed and swallowed theoretically allows 70 percent of American taxpayers to prepare and file their taxes at no cost. More than 50 million no-cost returns have been filed using the program over the past 16 years, according to the IRS, saving users about \$1.5 billion in fees. Intuit lauds the program as "an example of a public/private partnership that works." And Tim Hugo, executive director of the Free File Alliance, called Free File "a great product," adding, "Free File has changed the market."

But 50 million returns over 16 years represents only about 3 percent of eligible tax returns. By ProPublica's estimate, that suggests U.S. taxpayers eligible for Free File are spending about \$1 billion a year in unnecessary filing fees.

A key reason for the anemic usage, according to experts, is that many taxpayers are unaware of the program. "I don't have an advertising budget," said Hugo, who acknowledged the lack of awareness. He argued that it's the IRS' responsibility to publicize the program. "The companies are already donating the services. It's a philanthropic endeavor."

Critics say low usage is exactly what Intuit, H&R Block and others are seeking. The tax-preparation companies "want the status quo," said Nina Olson, the national taxpayer advocate, whose role is to be the voice of taxpayers inside the IRS. The agreement with the companies not only keeps the federal agency from developing a direct filling option, but also an automated "return-free" option in which the IRS would calculate most individuals' taxes. A 2013 ProPublica investigation found that the industry has successfully lobbied against such a system.

Another reason few taxpayers use Free File is that finding and

# 8-unit apartment complex approved for 4th Street

**DOWNEY** – Efforts to further infuse downtown Downey with residential development continued Wednesday when the Planning Commission approved a proposal to build a two-story, eight-unit apartment complex.

Real estate agent George Sanabria proposed to build the apartment complex at 8139 4th St. on property currently occupied by a 1,326 sq. ft. single-family home. Sanabria owns the property.

The apartment building will feature eight two-story units, each with two bedrooms and two bathrooms. Units would range in size from 822 square feet to 1,011 square feet; four of the units will feature porches on either the first or second floor.

Plans include a carport with 12 total parking spaces – eight spaces for residents and four parking spaces for guests.

City officials said they tried to secure two parking spaces per unit but "the applicant stated that the addition of two parking spaces would require eliminating one unit, which would render the project infeasible."

According to the Downtown Downey Specific Plan, the development could have reached four stories tall, but city staff members and Sanabria agreed to a two-story maximum to keep the apartment building in character with nearby two-story duplexes and single-family homes.

As presented, the apartment building would be built in Spanish architectural style, with tiled roofs, wrought-iron balconies and wall sconces.

Planning commissioners approved the project on a 3-1 vote with Steven Dominguez in opposition. Commissioner Nolveris Frometa was absent.

# **OPINION:** It's time to start mandating more parking with new housing

Before buying our first home, my wife and I lived in a cozy 1-bedroom, 1-bathroom apartment on Muller Street in Downey. It's a nice neighborhood just north of Stonewood Center. Great neighbors, great landlord.

The 6-unit complex was built in 1956 in classic ranch-style architecture indicative of the times (complete with mahogany cabinets and a flamingo pink bathroom).

Another sign that the building was built in the 1950's: the complex was built with a carport that allocates exactly one parking space per unit.

Maybe that was suitable in the '50s, but today, most everyone drives a vehicle. My wife and I each had cars for commuting, so one of us was required to park on the street.

This wasn't a big deal until a couple years ago, when the city council granted a preferred parking district to residents of Shellyfield Road. What that meant is when the street got crowded – which was basically every day after 5 p.m. – we now had to park the next street over, on Clancey Avenue; a minor inconvenience for us, but more so for residents of Clancey, who now had apartment residents parking in front of their homes.

You can't blame Downey's city planners of 60 years ago;

they had no way of forecasting the decline of single-income households and the rise in use of personal automobiles. One vehicle per apartment unit was appropriate back then.

We have no such excuse today. Times have changed and households today have multiple vehicles, yet Downey still relies on an antiquated formula that allows developers to build housing with insufficient parking, pushing cars onto side streets and clogging our downtown.

The townhomes on 3rd Street and La Reina utilize tandem parking (an elongated garage with cars parked in front of each other). How long before residents ditch the hassle of asking their spouse to move their car and simply park on the street?

A proposed apartment complex on 4th Street near La Reina will feature eight units with 12 parking spaces (eight spaces for residents and four for guests). It's naïve to think that such parking is sufficient.

The city of Downey should put the needs of its residents ahead of those of developers. Update the Downtown Specific Plan and mandate that new residential developments include sufficient parking to meet the needs of residents, both incoming and existing.

We're talking quality of life and simple common sense.

### 2,000-plus Downey students celebrate high school graduation



# Trump's giving diplomacy a chance. Critics should, too

Some critics have knocked President Trump for making "too many concessions" to North Korean leader Kim Jong-un at the historic Singapore Summit — the first-ever meeting between a U.S. president and North Korean leader.

Trump's foreign policy instincts have had me white-knuckled for the past year and a half. But against a backdrop of possible nuclear war, it would be overly cynical not to recognize the meeting's potential for good.

At best, the meeting set the stage for North Korea's denuclearization — and possibly even an end to the nearly 70-year-old, stalemated Korean War. If you're against war, this is a good development.

Just six months ago, reasonable people had reasonable fears of the world's first two-sided nuclear war, as President Trump and North Korean leader Kim Jong Un traded middle-school insults and flaunted their nuclear arsenals.

There are still countless ways the negotiations could go wrong, and real reasons to fear that hardline members of the administration — and its opposition, too — would allow that to happen. But diplomacy offers who have been needlessly killed throughout our warzones. A full-scale war chances for bigger gains, and smaller losses, than war.

Unfortunately, the U.S. spends more than 20 times more on war and militarism than we do on diplomacy each year.

Our choices have been stark.

The U.S. chose war in Iraq over diplomacy in 2003. Our leaders chose certain risk over likely rewards by pulling out of the Iran nuclear deal. And they chose a lone plunge backward over a carefully planned march forward when they stepped back from the Paris climate accord before

This must not happen when it comes to the North Korea negotiations.

The costs of war are horrifying. The current wars in Iraq and Afghanistan have cost the U.S. \$5.6 trillion, and 6,800 U.S. soldiers have lost their lives. That doesn't include non-fatal casualties, or the human and economic costs of PTSD and family stress that echo far beyond the battlefield.

And it doesn't count the hundreds of thousands of innocent civilians

with North Korea would likely be many times worse.

The North Korea negotiations are far from over, and could still tip from a fragile diplomacy back to middle-school insults and perhaps even to war. But we can and should be more optimistic than that. Diplomacy isn't just the better way. It's the only way.

For the Korean talks to work, this administration will have to value diplomacy more than it did in its narrow-minded rejection of the Iran deal. It will have to value diplomacy more than it did when it pulled out of the Paris climate agreement.

There's so much to gain from open communication and keeping our word. And there's so much more to lose if we allow things to fall apart.

### We should expect more from our leaders

Are we Americans unworthy? That's certainly the message we're getting from our government.

Over 40 percent of us are poor or low-income. How is that possible in the wealthiest country in history?

"The United States is alone among developed countries in insisting that while human rights are of fundamental importance," explains UN rapporteur on poverty Philip Alston, "they do not include rights that guard against dying of hunger, dying from a lack of access to affordable health care, or growing up in a context of total deprivation."

Alston says that "the persistence of extreme poverty is a political choice made by those in power" — which means that "with political will, it could readily be eliminated." Unfortunately, our government's political will is increasingly exercised to make things more not less difficult for us

Most Americans don't know it, but in 1977 the U.S. actually signed an international treaty called the UN Covenant on Economic, Social, and begins at the beginning of our lives. Indeed, many of us struggle to survive we come to deem ourselves less worthy than others? Cultural Rights, which mandates government responsibility to ensure their citizens do more than merely survive. Unfortunately, one

U.S. administration after the other has completely disregarded it, and Congress never ratified it.

Our leaders have apparently judged that we either don't need — or don't deserve — things like an adequate standard of living and universal health care. As one dizzy U.S. congressman claims, "Nobody dies because they don't have access to health care."

164 countries have ratified the treaty, but ours won't. Are their people more deserving than we are? Is it something we've done?

It can't be because we're doing fine without those rights.

I mean, look at our minimum wage. There isn't a "single county or metropolitan area," as a Guardian report put it, where a minimum wage can get you a "modest two-bedroom home, which the federal government defines as paying less than 30 percent of a household's income for rent

to our first birthday. Citing figures from the Centers for Disease Control, the Washington Post declared our infant mortality rate "a national

embarrassment," noting that it's higher "than any of the other 27 wealthy

That's painful enough. But they went on: "Despite health care spending levels that are significantly higher than any other country in the world, a baby born in the U.S. is less likely to see his first birthday than one born in Hungary, Poland, or Slovakia. Or in Belarus. Or in Cuba, for that matter."

And a recent UNICEF assessment of how children are faring found the U.S. near the bottom of 41 rich countries when it came to meeting goals on child poverty, hunger, health, and education.

Well, there's an important difference between us and other prosperous countries: Their citizens expect and demand more of their governments than we do of ours. And governments do only as much as their citizens The price we pay for this disregard for our fundamental human rights expect — not more! So why do we accept so little from ours? How have

### Traumatizing kids is an unspeakable evil

Let's be clear about something: Separating children from families, as the Trump regime is doing to undocumented immigrants, isn't just cruel. It's going to cause irreparable damage to the children involved — and probably to the parents too.

The difference is that developmental trauma — trauma experienced in childhood — is much more difficult to heal that trauma suffered as an adult. Trauma itself can be healed, but it's painful, difficult, and as is often the case in this country, expensive. For many it's simply out of reach.

I suffered childhood trauma. Here's what it's like. I knew from my earliest memories that something in me was not right. I thought it was my fault. I thought I was just born bad.

Trauma is both physical and emotional. My body behaved abnormally, and I didn't understand why.

I was hungry all of the time. I would eat and an hour later, I was hungry

again. All day, every day.

I was tired all of the time. I was up until 4 a.m. and then I would sleep at least 10 hours. I couldn't fall asleep earlier even if I tried, and if I attempted to wake up earlier, I'd get a migraine. It interfered with my ability to hold

Worst of all, I got migraines every day for 23 years. Every. Day. It interfered with every part of my life.

Then there was the emotional and behavioral toll. When I was around others, I was panicked. I dealt with it by adopting a number of rather antisocial and embarrassing strategies to help myself feel more in control. I knew that I was annoying or upsetting or offending those around me while I was doing it, but I couldn't stop.

I thought there was something fundamentally wrong with me that made me unlikable and unworthy of love. I would try to get close to people, get scared, and then push them away.

All of these things are changing after years of therapy, and only just in the last two months. During most of this time, I did not see myself as a trauma victim. I saw myself as a loser. Lazy. Dysfunctional. A bad person. Unlovable. Wrong. Broken.

Trauma is often invisible to the person suffering it. Your body acts strangely, and you react emotionally to others in ways you can't understand — and either you don't even know you are doing it, or you don't know why. You can't control it. You think it's your fault and so does everyone around you.

This is what we're doing to these immigrant children. And what I went through is nothing compared to what they're suffering.

I grew up in a wealthy, white, educated family, and I was born a U.S. citizen. I was able to get therapy. Most of the children Trump is locking in cages likely won't get that opportunity. Already pediatricians are warning about the lasting damage they're likely to suffer from this cruel treatment.

Now we've found out why Trump is doing this: It's a bargaining chip in order to get his dumb wall, even though net migration across the border has been zero or negative in recent years (and a wall would scarcely prevent it anyhow).

Even if the wall were a good idea, traumatizing innocent children in order to get it is unspeakably evil.

If it passes, I hope when they make another constitution they leave Article 3, Section 6 of the California constitution out. This way, our politicians won't have to lie when they take office.



# Consumers are paying millions in unnecessary tax preparation fees

understanding the options can be confounding. "Trying to navigate the Free File sites," Olson once said in congressional testimony, is "a bit like living in the Wild, Wild West."

Tax-preparation companies sometimes complicate the matter by using confusingly named products. Intuit, for instance, has a "Free Edition" of TurboTax, which handles federal 1040EZ or 1040A forms gratis but charges for state forms. It also offers a "Freedom Edition," which is the Free File version and handles both federal and state forms at no cost.

Intuit acknowledges the discrepancy in its support pages: "don't confuse Freedom Edition with Free Edition at TurboTax.com. These similarlynamed products are completely different."

Moreover, the Freedom Edition isn't visible on TurboTax's homepage. Indeed, only one of the 12 Alliance

(One of those taxpayers was then able to persuade TurboTax to refund the \$89.98 in fees they had spent on this year's return.)

Determining exactly how many taxpayers are eligible for – but not using — Free File is almost impossible. The IRS said it does not have data on filing fees paid by taxpayers and none of the Free File Alliance companies would provide it. "It's not totally advantageous for us to share all of that information," said a representative for TaxAct.

a very rough approximation is possible. About 53 million returns were filed using do-it-vourself online or downloadable software last year, according to IRS data. Free File is meant to cover 70 percent of taxpayers, or about 37 million among the DIY returns.

But only about 2.5 million actually utilized Free File, leaving some 34.5 million eligible taxpayers that potentially incurred fees.

Using what the IRS calls "conservative \$30-fee estimate" for each return, that would translate to around a billion dollars in avoidable preparation and filing costs. (That estimate doesn't include fees to file state returns. It also doesn't capture taxpayers who paid an offline preparer, though about 3.5 million of those people used other no-cost government programs, such as Volunteer Income Tax Assistance and Tax Counseling for the Elderly).

For its part, the IRS believes it's doing everything it can to make Free File successful. "We feel like we do promote Free File fairly heavily," said Ken Corbin, the IRS' commissioner for wage and investment, which oversees the program. Terry Lemons, the IRS' chief of communication and liaison, adds that the agency has its own budget woes to contend with. "There's a lot of demands, and we've got fewer resources.

The IRS says it once had \$1.5 million a year to promote Free File, but that funding was eliminated in 2015. The agency also claims that budgetary constraints kept it from File permanent in both 2013 and implementing a 2007 inspector general recommendation that the IRS better evaluate Free File, including more closely surveying taxpayers who aren't

Some critics argue for drastic change. "The program has to be radically reconceived" if not eliminated altogether, said Dennis Ventry, a tax-law professor at the University of California Davis and chair of the IRS Advisor Council. He says the council is currently looking into Free File and will present its recommendations in November.

Ventry expressed concern about companies up-selling products and obfuscating Free File user agreements, among other issues.

The Free File rules are laid out in a memorandum of understanding between the IRS and the Free File Alliance. The memorandum, which is renegotiated every few years (the current version runs through 2020), is "incredibly favorable to the industry, according to Ventry. "The IRS let it be that way."

Clauses prevent the IRS from collecting certain data and limit the agency's ability to disclose any "deficiencies" they might requests posed to the IRS.

"It's amazing how much the companies dictate the rules,' said one industry insider, who Free File Alliance members Any accurate calculation, the acknowledge the threat of spokesperson argued, depends government entrance into the filings, calling the possibility "a continued competitive threat potentially have material and adverse revenue implications."

> Dozens of other countries, from the United Kingdom to Japan, have ways for at least some taxpayers to electronically file directly with the government. But according to Olson, the National Taxpayer Advocate, the U.S. has never really explored what such a system might look like. She argued that current programs such as Free File should be re-examined. "What I believe Congress needs to do is to have a conversation about why taxpayers aren't using it," Olson said. "What do taxpayers want?"

Congress overwhelmingly supported Free File. "It's a great program that helps save the government money and do free tax filings for people who can't afford it, said a spokesperson for Rep. Peter Roskam, R-Ill. Roskam introduced bills to make Free 2017. Records show that H&R Block and Intuit lobbied in favor of the latter effort.)

When asked about potential issues with, or improvements to, the Free File program, Roskam's spokesperson replied, "we don't have anything to contribute to

Free File bills never made it very far on their own in the past. This spring, though, the idea was rolled into a broader IRS reform package known as the "Taxpayer First Act," which asked for anonymity given includes a variety of provisions the sensitivity of the subject. aimed at improving customer service, beefing up cybersecurity and assuring proper notice before asset seizures. That bill passed the House in April 414-0.

> Now it's the Senate's turn to debate its approach to IRS reform and, consequently, the merits of Free File. Although the provision has generally seen support, it does have at least one outspoken detractor. "Doing your taxes shouldn't be this hard — or this expensive," said Sen. Elizabeth Warren, D-Mass., who has introduced legislation calling for a "return free" filing option.

> Intuit is sticking by Free File, as is H&R Block. The latter provided a statement, asserting that taxpayer feedback on Free File "is overwhelmingly positive," and adding, "we are proud to have helped millions of Americans file their returns under this program.'

> Intuit said it began providing no-cost tax preparation service to low-income taxpayers in 1998 and that it has spent millions of dollars to support and promote no-cost services such as Free File and Volunteer Income Tax Assistance. Most recently, the company says it put \$1.5 million into a new campaign to promote no-cost filing known as Tax

### Things you didn't know about Downey

DOWNEY - One of the early pioneer families were the The home was the scene of many parties and after church husband in a mercantile business which allowed her to meet

Judge Henry W. Hammerton immigrated from Peterboro, England at the age of 18 - barely a year after the 1849 Gold Rush in California. In his trip to California he worked along the way as a brick mason and blacksmith. He also was employed with the government for several months at the Old Fort Buchanan (later Camp Crittenden) driving teams of horses.

Henry spent a year in Tulare County where at the age of 28 he met and married a 14-year old Texas girl, Orpah J. McCollough. Later the married couple moved to Downey in 1863.

They bought 67 acres of land (on today's property that would be Old River School Road) in November 1864. Henry built the first brick house in Downey, which looked like a home from native England. He hauled the bricks from Wilmington by wagon and slept under the wagon at night before heading back to his property. He built a handsome two-story, nine-room

gatherings. Hammerton was prominent in the Odd Fellows Lodge (one of the earliest fraternal groups in the area) and was elected Justice of the Peace for Downey Township.

Some of the Hammertons are buried in the historic Downey

■ Around 1935, the notice of Mrs. Mary Steel's death appeared in a Downey newspaper. The notice stated that she was the oldest woman in Downey and a beloved and respected citizen of the community.

With the passing of this pioneer, many Downey folks expressed that they felt like that they had lost their best friend.

Steel was born in Mechaniesburg, Mississippi on Jan 7, 1838, being one of nine children. At the time of her obituary notice, only one brother had survived.

Steel had lived in Downey 64 years and woven her life into All the Hammerton children were born in the brick house. the very fabric of the community. She was associated with her

with people from the community. Her motto for life was that she would divide anything she had with anyone who had less than she. She was married March 9, 1854 to Wesley H. Steel. The couple left Magnolia, Arkansas to come to Downey in 1871.

Her husband passed away 10 years earlier than she, and upon her passing she was laid to rest beside him in the Downey

According to the Downey Livewire on March 7, 1929, another early settler of Downey, Benjamin Franklin Witherspoon, died on a Saturday morning.

Witherspoon was born in Missouri on December 21, 1855. After several moves he ended up in Downey in 1862. He was deputy sheriff and constable of Downey Township for about 38 years. He was a faithful member of the holiness church.

He was also buried in the Downey Cemetery.

### Short film festival returns to Santa Fe Springs

SANTA FE SPRINGS - The Green Salon Short Film Festival returns to Santa Fe Springs on Saturday, June 23 at 7 p.m. The festival, which features the work of local filmmakers, happens the fourth Saturday of each Summer month – June, July, and August - at Studio GalleRoy, the painting studio of Roy Anthony Shabla.

It is a free-admission event.

The Green Salon is a monthly gathering of artists, poets, musicians, filmmakers, and other cultural enthusiasts. It is usually located in Downey, in the private garden of Roy Anthony Shabla, but moves to Santa Fe Springs for the Short Film Festival each Summer. It is the longest-running monthly cultural event in the immediate area.

The Green Salon always hosts an open mic and featured reader. This month, the featured reader is Jo Scott-Coe, author of Teacher at Point Blank, Listening to Kathy and most recently, MASS: A Sniper, a Father, and a Priest. She is an English professor at Riverside City College and facilitates limits. community writing workshops for the Inlandia Institute.

The Green Salon will also host favorite filmmaker Dustin Michael Krapes this month/Krapes gravitates toward the surreal, comedic, and absurd. His film this month, Beverly Sauce 90210, is an absurdist romp through the difficult life of being a condiment.

This ties into a food theme to much of the work this month. Wear a lobster on your head and receive a free glass of wine.

This year, the festival is combined with a small art fair. Local artists and craftsmen will exhibit and sell their work on site. Drawing and painting, sculpture, jewelry, and ceramic art will be featured. Studio GalleRoy itself will exhibit a different series of large paintings each month, encouraging the public to attend all three evenings of film and art.

One of the Art fair featured artists is Anthony Cano, a selftaught ceramicist and painter who will exhibit a variety of objects d'art including tile and ceramic sculpture – especially depicting sea life, organic material face-masks, and recycled bottle art. His work emphasizes the natural world and shines a spotlight on the ecological issues of our time.

Also, Studio GalleRoy shares space with Gallery Frames, a fine-art framer. Any framing job brought and booked the evenings of the festival receives a 20 percent discount.

# With Milky Way Tea House, Downey finally gets its boba fix

**DOWNEY** - With summer on the way, who wouldn't like a unique, cool tasty drink to combat the heat?

Tucked within the Downey Gateway is Milky Way Tea House, a small, family-owned and operated business known for their boba teas and floats.

Manny Medina, 29, was always a neighbor to Downey before moving into the city around three years ago. But to get his boba fix, he found himself driving out of city

"We kind of wanted to bring something different to Downey," said Medina. "I would have to go out of Downey to get some boba. I would have to go to Pasadena, Cerritos. I figured Downey was missing something like that.'

Medina owns the shop, with his wife, sister and cousin helping him run it. Medina's kids can also be found playing behind the counter on occasion.

"Family, straight family," said Medina.

The teahouse has served customers for around a year and some change, offering various flavors of mixed green teas, black teas and slushes.

"For me so far it's been an interesting path that I've taken," says Medina. 

# **SHARED STORIES:** Making Steel

If you were driving on Slauson Avenue in the dark in the in the 1970s or 80s, in the city of Vernon, you might be treated to an amazing sight. Just past the chain link fence on the south side of the street, heavy tongs from up high would drop down to pull a glowing rectangular mass, 10 tons of orange steel, out of a high pit.

As the overhead crane lifted the ingot clear and carried it toward the fence, you would feel the heat on your face through the car window.

The crane would trolley along, parallel to the road, with the hot steel hanging upright until it was lined up with a set of rollers as thick as a man. The crane would bang the hot steel into the rolls and lay it down sideways, and as it did so crusts of molten metal would get knocked off onto the ground.

Then the rollers would carry the heavy ingot out of sight into the dark bowels of the mill, leaving the pieces of slag to glow on the ground, casting eerie shadows as the metal cooled toward gray.

This was the Bethlehem Steel Plant in Vernon, California, where I had the good fortune to work from 1973 to 1982. I had dropped out of graduate school in 1972. Heartsick over the on-going Vietnam war, and no longer enchanted with the remnants of the 1960s counterculture, I began to work in a machine shop, looking for something more "real." The pay wasn't the greatest, and when I heard Bethlehem Steel was hiring, I jumped at the chance.

The Bethlehem Vernon plant was a sprawling affair. Its property stretched almost a half a mile along Slauson between Maywood Avenue and Boyle Street. The plant was a scrap re-melt plant, meaning that new steel was made by melting down scrap metal rather than extracting it from iron ore. Much of the property was open, filled with mountains of scrap metal tended by a few cranes that loaded and unloaded the rail cars.

The heart of the plant was one of the heavy industry plants the south side of Slauson and in nearby Vernon. 




