Kaiser breaks ground on new hospital tower

► GROUNDBREAKING: The Downey hospital is adding 96 beds, making it the second largest Kaiser Permanente facility in Southern California.

DOWNEY -Kaiser Permanente officially broke ground on their new hospital expansion Wednesday morning, kicking off a project that will add more than 90 new beds and updated technology to the campus once completed.

Once erected, the new tower will house 96 additional beds, as well as the best of "high-tech" and "high-touch" medicine in the form of the latest technological innovations currently in medicine.

"The hospital tower expansion gives me great pride," said Dr. Binesh Batra, Area Medical Director. "Our membership continues to climb; we have 390,000 members now, and we think in the next five years we might be going up to 445,000.

This is a comprehensive list, judging each burger based on flavor, meat quality, and the uniqueness of the burger.

Without any further ado, let's dive in and see which burger joints were told, "You just made the list!"

5. Stewart & Grub - Downey

Stewart & Grub is relatively new to the area, but it makes the list due to being one of the best at creating a simple, down-to-earth burger.

Our favorite is the "Carpenter", a shout-out to an all-too-familiar Downey staple; this burger boasts a 100 percent angus beef patty, bacon, barbecue sauce, cheddar cheese and their own house-made thousand island sauce. This smoky, carnivorous combination will give you the genuine burger diner experience at a fraction everyone saw White Ćastle as of the price.

4. Nexx Burger - Downey

Downey once again makes the list with yet another newbie, Nexx Burger.

Their burgers simple, opting not to go for the over-the-top combinations commonly found nowadays, but what they do, they do very well. Their bacon cheeseburger has an unprecedented level of freshness not found so easily, unless you're making it yourself. You also have the option to add special

Now it's time to get crazy.

You want variety, Grub Burger Bar has got it. For us, it doesn't get much more innovative than their Mac N' Cheese Burger. To be specific, you get macaroni and cheese on a burger; combine that with additional melted cheese and topped with an onion ring, and you've got yourself a burger worthy of an appetite for destruction.

2. Burgerim - Vernon

Remember the days when the gold standard for sliders? Not anymore.

Burgerim not produces sliders with a flavor that makes White Castle taste like high school cafeteria "Colossal Burgers," but they do it with a variety of meats. Take, for example, exhibit A: the slider 3-pack with a spicy seasoned Merguez beef burger, prepared caliente style with pepper jack, jalapeños, and habanero mayo.

Alongside it is a lamb burger with bacon, cheese, BBQ sauce and an onion ring. And of course, as you can probably tell by now, we're suckers for the

ingredients, like avocado or classic beef burger. Without exaggeration, each burger makes your mouth water, and melts in your mouth as you're enjoying it.

Downey arts groups selected for county grants

DOWNEY - The L.A. County Arts Commission on Friday announced the recipients of \$4.5 million in grants, including two nonprofits from Downey.

The commission has provided funding for arts and cultural programming since 1947. For the last 20 years, the program has focused on local small and mid-size arts organizations.

"We want every person in this county to have access to the breadth, depth and diversity of the arts in Los Angeles," said Supervisor Sheila Kuehl, chair of the Board of Supervisors. "These grants support local arts organizations and help bring concerts, theater, exhibitions and school education programs to all 10 million county residents."

The Downey Symphonic Society, which funds and operates the Downey Symphony, was chosen to receive \$16,800.

The funds will be used to "support performances that regularly feature contemporary composers from different cultures in order to expand the symphony's appeal and accessibility...'

Another Downey organization selected to receive a grant is Japanese Culture and Traditions Inc., which received \$3,900 to support the continuation of the annual Coming-of-Age Ceremony in LA.

Stay Gallery launches membership


DOWNEY - Stay Gallery has launched a membership drive as it seeks to raise additional funds to finance the gallery's operating costs.


Membership packages range from \$150 (the Warhol Membership) to \$10,000 (Michelangelo), with each package offering a variety of perks and benefits.



An American Life

Last week, in Ridgewood, New Jersey, a 92-year-old unsung American patriot lost his battle with congestive heart failure. He had been surrounded by his wife and children and their spouses and their children. He left this vale of tears in his wife's arms, peacefully and with dignity.

His was an American life.

He was born in Newark, New Jersey, during the Roaring '20s, the son of Italian immigrants who had come to America as children. When he was 4 years old, he met a curly-haired little girl in the neighborhood who was just three days older than he. She would become his high school sweetheart and his best friend for 88 years and his wife for the last 70 of them.

In a large public high school, he did not excel in academics, married. but he was a superb athlete; and he had an unquenchable interest in electronics, a subject not taught in the public schools in those

His graduation from high school in 1943 was accelerated from June to January because the country was fighting in World War II and it needed the boys to join the effort quickly. Our boy enlisted in the Navy.

Four months after graduation, at age 17, he completed Navy boot camp and was excited about his first assignment on a submarine in the north Atlantic. As he was boarding the submarine at a naval base in Rhode Island, he slipped and fell on a wet dock and broke his right foot. He was hospitalized for two months. The submarine he was about to enter never returned and was never found.

He was then assigned to a destroyer escort, which cruised the Mediterranean and supported Patton's Army in the liberation of Italy. Aboard ship, he excelled in electronics and boxing — always the athlete yet reading about wires and batteries and electrical currents until late in the night.

One day, shortly after the liberation of Naples, the city of his father's birth, he was on leave with his buddies and he saw an old man who resembled his grandfather sitting on a curb stone. The

old man himself was without shoes.

Our friend resisted the collective wisdom of his buddies and took off his military-issued boots and gave them to the old man. He had his buddies sneak him back aboard ship before his superiors could see him in his stocking feet.

When he was charitable, he hid it.

He returned home to New Jersey in 1946. The little girl had grown up to be a beauty and a brain. During the war, she worked in the Newark Public Library for 17 cents an hour. She borrowed and read a book a week in the 21/2 years of our man's involvement

Two years after he came home, he and that grown-up girl got

His first and only adult job was with the New Jersey Bell Telephone Co. He started out climbing telephone poles, and he went on to install equipment in homes and offices. He soon moved into management and eventually went into teaching his favorite job.

He taught electronics to new employees and colleagues and even to executives who wanted to advance themselves. This was the electronics he had learned in the Navy, supplemented by the electronics that he had taught to himself.

He and his wife had three boys, one of whom followed him into the telephone company and two of whom received scholarships to Ivy League schools. He taught tough lessons to his boys at home — lessons about honesty, humility, self-reliance and teamwork. His favorite one-liner was, "Anything worth doing is worth doing well."

He practiced what he preached. He was a tough taskmaster who demanded much and gave much; and he always forgave. Andrew Napolitano is a senior judicial analyst for Fox News. Always. He was an iron fist inside a velvet glove.

He was the first person in his family to vote Republican, and he took a lot of heat for that. FDR had catered to immigrant families in the big cities, and they formed a healthy part of the

old man's home had been destroyed by Allied bombing, and the base of the Democratic Party in the 1930s and '40s. But when the boys came home from Europe and the Pacific and started families and then when Ike ran and many of his soldier and sailor buddies could vote for their former supreme Allied commander, he did so.

> Voting Republican in the late '40s and early '50s was anathema in an Italian-American Roman Catholic family in the Northeast. Today it is pretty much the norm.

> He would explain to his parents and in-laws and sons that he feared the Democrats would give away the store to stay in office. Though he loved the Navy and respected the police, he was skeptical of government in general, and he loved Jefferson's mantra "that government is best which governs least.'

> He was a devout Roman Catholic. He loved the New York Yankees, the New York Football Giants and Fox News — and he loved that girl he married, more with each passing day.

> In his waning years, his wife sacrificed dearly for him because his tobacco-ravaged heart was unable to do its job alone. Yet modern science and a wife who overlooked nothing added many happy years to his life.

But nature has her rhythms, and they can be unforgiving.

There is a time for living and a time for dying. Even God died. After this marvelous man received the Anointing of the Sick and he said a peaceful, loving goodbye, the angels came and brought his soul to heaven.

I knew this man well and loved him with all my heart. He taught me all his values.

His name was Andrew Alexander Napolitano.

He was my father.

Requiescat in pace, Dad.

Unless, of course, his highness arbitrarily nullifies 230 years of legal protections for the people's democratic rights.



Paging Dr. Frischer...

By Dr. Alan Frischer

Most of us have at least one irrational food dislike, right? Mine is mushrooms.

My wife told me to not write about this topic because I am incapable of being objective. In fact, when my daughters were young, I would visit their classrooms to give the doctor/dad health talk. Somehow my anti-mushroom bias would sneak in, and I hereby apologize to any impressionable young minds I may have impacted. Hopefully my other, more scientifically based, messages got through.

I am now older and hopefully more mature, so here is a far more balanced evaluation of the literature on the health impact of mushrooms.

Mushrooms have been consumed for thousands of years. Early Greek, Egyptian, Roman, Chinese, and Mexican civilizations valued the mushroom as both a culinary delicacy and as a medicine. They are normally classified as a vegetable or an herb, but mushrooms are actually fungi. They are found in a variety of shapes, sizes, and colors. Poisonous mushrooms can be difficult to identify in the wild, so unless you are skilled too good to be true - and probably are. in picking them, always buy from a reliable source.

interesting research includes the following:

One study substituted mushrooms for meat, thereby reducing calories over a six-month period. Those on the mushroom diet experienced a significant loss in body weight, BMI, and inches around the waist. However, the meat group did as well, and the difference between the two groups was not statistically significant. One guess is that when we cut out one source of fat, we tend to substitute another.

· A shitake mushroom extract was tested to see if it could improve oral health by slowing tooth demineralization and alter the microbes in our mouth. The study looked at a placebo, the shitake extract oral mouth rinse, and a leading gingivitis mouthwash. The mushroom rinse performed best, followed by the gingivitis mouthwash, and last was the placebo.

·An association was demonstrated between mushroom intake and a lower breast cancer risk for women with certain types of tumors.

·Various mice studies have demonstrated improvements in the gut microbiota, mental cognition, and immune function. However, human studies haven't yet confirmed such findings.

But this much is clear: mushrooms are fat-free and quite

Claims abound that certain mushroom species, consumed low in calories and sodium, and are therefore a good food for as either food or extracts, may reduce the risk of disease. Some people trying to control calories and blood pressure. They are also an excellent source of potassium (a portabella mushroom has more potassium than a banana), which helps to further lower blood pressure.

> They are loaded with antioxidants, including selenium, which help to protect the body from damaging free radicals that can lead to heart disease and cancer. They are a significant source of beta glucan, which is a form of soluble dietary fiber that helps to lower cholesterol and regulate blood sugar. Mushrooms are rich in the B-vitamins riboflavin, niacin, and pantothenic acid. They are rich in copper, which helps the body make red blood cells and vitamin D.

> With enormous reluctance, I must conclude that mushrooms are a nutritionally sound food, filled with substances that may very well boost our health. While I still have absolutely no intention to add them to my own menu, I will admit that they certainly can be a part of a sound and balanced diet.

Things You Didn't Know About Downey

DOWNEY - There was a story printed in February 1969 about how Downey was almost not called Downey.

In 1876, there were citizens of Downey who were disgruntled with the inconveniences caused by the name Downey, and a change was suggested. One of the unhappy residents was G.B. Fagan, the postmaster.

On Wednesday, March 22, 1876, a number of citizens met Park. in the Odd Fellows Hall to consider the feasibility of changing the name of the town. Dr. Rives was chosen as president of the meeting, Mr. H. Gray vice president, and Fagan secretary.

Fagan stated the purpose of the meeting: "Mail matter frequently miscarried on account of Downey City, Downieville, Darwin City and Denver, Colorado being somewhat similar, with mail intended for those localities coming here and Downey's going there created a great deal of confusion.

Mssrs. Benbrook and McDonald argued in favor of postponing the meeting until a fuller representation (they were not favoring the change). Mssrs. Smart and Bailey wanted immediate action, thinking another meeting would not bring a larger crowd, and favoring the name change. It was agreed to hold another meeting and Governor Downey was requested to be present.

On Saturday, April 1, the citizens met again to express views on the name change. Governor Downey did attend, and being called upon to give his views, stated the only way a change could be made, "and it would cause considerable trouble and expense especially to the incorporated companies, lodges, etc...was through the legislature, who only had the power to make such a change.

So, the name of the city was preserved more-or-less by one of its co founders.

CERRITOS – The Cerritos City Council approved a \$127 million combined financial program for fiscal year 2018-19 on June 28, with a total city funds surplus position of \$1.4

The budget emphasizes public safety; maintenance of trees, facilities and infrastructure; and quality community services and programs. The new fiscal year began July 1, 2018 and concludes on June 30, 2019.

Capital Improvements

Approximately \$13.5 million has been allocated toward capital improvement projects. 

the pedal, now step it up," clapping her hands loudly issuing instructions.


