Housing crash not likely anytime soon, economist says

► ECONOMIC FORUM: The 2008 housing crisis was created by overborrowing and over-building, which is not happening today, said economist Christopher Thornberg.

Thornberg made the comments at the Gateway Cities Economic Forum at Downey's Rio Hondo Event Center.

DOWNEY Today's economics suffer from a constant focus on the wrong questions and issues, according to one economist.

Financial Partners Credit Union hosted its second annual Cities Economic Gateway Forum last Thursday at the Rio Hondo Event Center, featuring economist Christopher Thornberg as its keynote speaker.

Thornberg set the tone early, making it clear that his speech would not surround current economic policies in Washington

"It's amazing all the things we're not talking about because, of course, all our conversations are wrapped around what's happening on a day-to-day basis in the White House," said Thornberg. "To think of Trump as a cause is a mistake; he's not a cause, he's an effect. He's president in large part because he basically rode into the office [due to] the incredible partisanship that existed prior to him even arriving on the stage. We have to remember he's a reflection of

agree as a nation on what the addition of fiscal stimulus." the problems were, but we would debate on how to fix those problems. Today, the partisanship, the divide between left and right is so great that we can't even agree with what the problems are.

Much of Thornberg's speech followed a theme of "asking the wrong questions," however, he noted that "the economy is great" currently.

"The economy has been great for the last, four, five, six these underlying problems in our party."

years. Things have been going at a very good, stable path," said "Thirty years ago we would Thornberg. "This year, 2018, is all of 2017's strong economy with

Thornberg added that he saw no chance of recession in the next 12 months, with a very limited chance of one in the next 24 months.

However, addressing the bad elements of the economy, Thornberg said that "we are debating issues that are completely irrelevant."

"For example, we're not talking about under investment and infrastructure. We're not talking about rising wealth inequality. We're not even having any serious conversation about healthcare cost inflation, pension and entitlement reform " said Thornberg. "We're too busy arguing about manufactured issues that don't actually exist than to actually turn around and confront the problems that do."

He added that while shortterm he's optimistic about the economy, he's worried about the medium term.

One of the biggest issues facing the economy currently a big misconception surrounds jobs.

"It's not labor demand, it's labor supply," said Thornberg. 'The unemployment in the United States right now is 3.9 percent...the job openings rate in the United States right now is 4.1 percent. In other words, there are more job openings than there are people looking for work. We don't have a shortage of jobs, we have a shortage of workers."

"We need to stop with the jobs conversation...we need workers, particularly qualified workers to fill those holes."

Part of the solution, Thornberg says, is immigrants.

"If you want to debate how they come to this country, who comes to this country, fine," said Thornberg. "But in the end, the right answer is more, not less. Anybody who think immigrants are a problem for our economy, you're out of your mind. They're

part of the solution.

"If you don't want them here...accept the fact if they don't come our economy can't grow fast...have the honest conversation.

Some of the consequences of labor shortage include the increase of labor costs.

"Watch the corporate profits, watch the Stock Market because that's where it's gonna hit,' said Thornberg. "The other part of it...if you can't hire someone, you got to buy a machine, and that's what's going on.'

Statewide, Thornberg claimed California to be the eighth fastest growing economy in the last five

"We've added 2 million plus jobs, 2.6 percent growth per year," said Thornberg. "Our state output is growing faster than the national basis... Between 2012 and 2016, we added 1.3 million full-time jobs. Of those 1.3 million full-time jobs, 600,000 are paying over \$100,000 a year... right now 18 percent of California households make over \$150,000, compared to 11.6 percent for the rest of the nation.

Still, Thornberg noted the slowdown in the rate of job growth within the region, and the related factors contributing

"The slowing we're seeing boils down to a lack of bodies... if you don't have a person, you can't hire them, and we hit that wall," said Thornberg. "Labor force is basically growing at a fairly slow basis.

Some of this issue boils down to homes, or as Thornberg alluded to, a lack thereof.

"Everybody talks housing, and you should. But how we talk about it is fairly important," said Thornberg. "It's not a bubble; bubbles are overbuilding or over-borrowing; nothing like that is occurring.

"We need more housing, and we're just not building it.

DOWNEY - More than 1,000 healthcare workers and their allies will mark Labor Day at 10:30 a.m. Monday by marching from

Independence Park to the Kaiser Permanente Medical Center to protest the corporation's plans to outsource and relocate employees.

organizers also March promised "civil disobedience" by workers participating in the

Permanente raking in money but acting like it has no choice but to outsource employees and relocate others to areas where they would be paid far less," said Steve Allman, a 16-year Kaiser Permanente employee who said his job at a Downey warehouse may be outsourced.

"Families like mine will have the legs cut out from under us and patients will suffer. We take pride in the work we do to make sure Kaiser facilities have the medications millions of patients need, accurately and on time.

"You just can't outsource the kind of efficiency, expertise and pride that me and my co-workers put into our jobs."

A similar protest will be held Sept. 3 in Oakland, where an additional 1,000 Kaiser Permanente employees and allies will march on Kaiser Oakland Medical Center and also engage in civil disobedience.

According organizers, Kaiser plans several job cuts, incuding:

Outsourcing 70 pharmacy warehouse workers in Downey;

Outsourcing 34 couriers at a laboratory in North Hollywood;

Moving 742 jobs from call centers in Hollywood, Baldwin Park and Woodland Hills to other areas of the state where workers will earn \$2 per hour less;

Outsourcing 96 pharmacy warehouse workers in Oakland and Livermore;

Outsourcing 43 licensed vocational nurses in San Francisco, Oakland, San Leandro, Santa Clara and Walnut Creek;

Shutting down a skilled nursing facility in Manteca and throwing the families of 18 workers and patients into chaos effective Oct. 31, 2018; and

Outsourcing 16 parking attendants and shuttle drivers in San Francisco.

More than 55,000 Kaiser Permanente employees in California are members of SEIU-United Healthcare Workers West (SEIU-UHW).

Kaiser Permanente officials disputed the union's version of events, insisting they are adding jobs and share "a strong commitment to labor."



John McCain and me

About four years ago, I was browsing through one of Manhattan's last remaining independent bookstores, when my cellphone rang. I didn't recognize the incoming telephone number, with its 202 area code, but I assumed it was a Fox News colleague from our Washington

When I answered the phone, a somewhat familiar but somber voice said: "Judge Napolitano, your reward for what you did today will not come from your colleagues or viewers or even on earth but in heaven.'

What had I done to deserve this?

Earlier that day, Dianne Feinstein, a Democrat from California who was then the chair of the Senate Intelligence Committee, had defied her own committee members, congressional leadership from both houses of Congress and from both political parties, officials of the CIA, and even the Obama White House when she released on the floor of the Senate a 6,000-plus-page report detailing the use of torture by CIA officials in the George W. Bush administration — all

She actually made the report public while physically standing on the floor of the Senate, where her speech is absolutely protected from government retaliation by the Speech and Debate Clause of the

That clause recognizes and protects for members of Congress their complete freedom of speech while on the floor of the House or Senate, while doing congressional work and while traveling to Capitol Hill. Thus, even though she revealed top-secret materials in the report — which, if you or I had revealed them or if she had revealed them in Los Angeles rather than in Washington, would have constituted the crime of espionage — she was immune from all

In response to the Feinstein revelations, my Fox News colleague

and friend Shepard Smith and I spent about 30 minutes on-air that afternoon on his Fox News Channel show discussing the criminal behavior Feinstein had revealed, the constitutional protections she, as a member of the Senate, enjoyed, and the political firestorm she had courageously ignited.

As a believer in the rule of law and the bodily integrity of all people, I was full of praise for what Feinstein had just done. When the government breaks the laws it has sworn to uphold, Shep Smith and I argued, the people have a right to know about it.

But many of Sen. Feinstein's colleagues did not see it that way. Many of those who never endured torture and those believing that the end justifies the means accepted the myth that torture works that the victim tells the truth; and in their view, obtaining the truth is worth the cost in lawbreaking and body-breaking.

Only one Republican senator publicly supported what Feinstein had just done. He was my caller that afternoon in the bookstore, John

I thought of his call and our many ensuing conversations when I learned of his death this past weekend, a few days shy of his 82nd

McCain and I had hundreds of conversations. He knew that I knew that he was a bellicose warmonger and an uncritical supporter of unlimited military spending; and he was often indifferent to the consequences of those views.

But he was also the victim of prolonged and horrific torture during the Vietnam War, which he could have avoided. He told me many times that torture so distorts the mind that the victim's consequent speech is utterly unworthy of belief.

prime congressional mover of making it all unlawful — the Bush Department of Justice notwithstanding, it already was unlawful at the time Bush ordered it — and one of the few Americans anywhere who

could speak on this detestable subject from the personal experiences of a victim.

Platitudes aside, the essence of the telephone conversation we had that day was that Bush had committed war crimes; that torture is absolutely prohibited by the Constitution, several treaties to which the United States is a party and numerous federal statutes; and that Sen. Feinstein had performed a positive public good by revealing it.

It was Sen. McCain's view that even if he was powerless to prevent government lawbreaking, it is better for the American people to know painful truths than to remain in the dark.

Shortly after our phone conversation, McCain went to the floor of the Senate and delivered one of his classic tirades against torture. In it, he attacked President Bush, who ordered and authorized it, and President Barack Obama, who covered it up.

This week, those two former presidents. firmly in McCain's crosshairs four years ago, are each delivering a eulogy at McCain's funeral — willingly, dutifully and at his request.

The John McCain I knew discussed only torture, the right to life, and immigration with me — perhaps because he knew we disagreed on nearly all other matters. But this tough old Arizona bird, this lifelong warrior, this unorthodox maverick who really was neither a Republican nor a Democrat, knew how to keep friends and monitor

He was a multidimensional man in a secular era, and he was not happy about America at the end of his days.

Yet in this age of few heroes, and on topics that intimately touch the human heart and soul, he was the genuine article.

The left's long war on conservative free speech

In the competition of ideas, you can't win the game if you're not on the playing field.

That's why Silicon Valley bigwigs' stubborn refusal to put business above their own personal partisan biases doesn't just rankle. It reeks. Equal access to social media is not just about sharing food pics, pet videos, makeup tutorials and travelogues. It's about ensuring the ability to disseminate and distribute political speech on the world's

Although I started in the metro newspaper industry in 1992, my years as an independent conservative blogger and internet entrepreneur have been the most journalistically enriching. I launched my first website in 1999, my namesake blog in 2004, my first group blog and video content platform HotAir.com and my YouTube channel in 2006 (where I broadcast reports from Iraq), my Twitter account in 2008, my second group website Twitchy.com in 2012, and my documentary-style web series, "Michelle Malkin Investigates,"

I don't just preach the First Amendment. I practice it for a living.

Early adopter status was important for us non-leftists who saw the disruptive influence and narrative-setting opportunities that new media and social media offered. I was ridiculed by mainstream media colleagues for wasting time on the internet, derided as "just a blogger" (which I proudly turned into a hashtag), and mocked for starting a Twitter aggregation business long before corporate media outlets copied the idea.

Over the years, I've joined other independent conservative social

media users in exposing coordinated "flag-spamming" campaigns against right-wing personalities and causes. Pro-life, pro-border security and anti-jihadist journalists and activists have all been selectively gagged on Google/YouTube, Facebook and Twitter. I've worked with a few good-faith employees at these companies who tried to treat conservatives fairly. But in the unhinged era of the anti-Trump resistance, intermittent purges, "accidental" suspensions and suspicious deletions of conservative content have spiked to a level of systemic censorship.

Twelve years after its founding, Twitter has abandoned its corporate motto of "Defend and respect the user's voice." Twitter co-founder Jack Dorsey, set to testify before Congress in two weeks, admitted his company's left-wing bias and dismissed revelations from his own engineers, who confided to undercover Project Veritas journalists that they were creating algorithms to "ban a way of talking," "down rank" users based on politics and employ "machine learning" to create special triggers and keywords — "the majority of (which) are for Republicans.

In April, the brilliant anti-leftist street artist Sabo disappeared from Twitter without warning or explanation.



Whenever the president complains about "Fake News," always capitalized and often punctuated with exclamation points, rest assured that he doesn't mean the actual sources of fraudulent information that infest the internet and haunt American politics.

No, Donald Trump's definition of "fake" has nothing to do with factuality or responsibility in media. It merely means news he doesn't like, usually truthful reporting about him, his family, his administration or his cronies produced by credible newspapers and

It's easy to dismiss these outbursts as simply more of the daily spew of falsehoods on his Twitter feed. And it's comforting to pretend that they don't matter. But Trump's conscious campaign to discredit honest journalism is dangerous to our democratic culture. Does that sound lofty and academic? It isn't. The denigration of real reporting and the elevation of fraudulent conspiracies have real consequences in the everyday life of Americans.

Indeed, the most compelling example right now is the sexual abuse of children — a major news story that also exists as a phony right-wing meme. It is instructive to compare and contrast how the fake-news outlets praised by Trump and the real news organizations excoriated by him are dealing with that most unspeakable of crimes.

Websites and Twitter personas that back Trump — and are supported in turn by him and his family — have spent the past few years fabricating and promoting a nasty fantasy that they call "Pizzagate," which claims that Democratic elites including Hillary Clinton, George Soros, former Clinton campaign manager John Podesta and a variety of Washington, D.C., and Hollywood personalities are guilty of child sex trafficking or worse.

Thanks to conspiracy broadcaster Alex Jones, a Trump favorite who spread this toxic mythology without a scrap of evidence, and his imitators, Pizzagate reached enough gullible minds that one man traveled to Comet Ping Pong pizzeria in Washington, where he believed child sex slaves were being held, and discharged a rifle. Nobody was harmed except that pitiful dupe, who is now in prison.

Fearing legal action, the cowardly Jones scuttled away from Pizzagate after the 2016 election. But he and kindred voices on the far right continue to spread fake stories about pedophilia, weaponizing a smear that distracts from real news and mesmerizes an idiot constituency. It is a parody of journalism and as foul a misuse of the

First Amendment as we have seen in decades.

Notwithstanding that torrent of politically motivated lies, child sexual abuse exists in our society, perpetrated over many years by such trusted figures as priests, athletic coaches and even doctors. Those heinous crimes have been exposed not by hucksters and con artists on Infowars or Fox News but by established news outlets that spend thousands of hours and hundreds of thousands of dollars to find the truth, and prove it.

Without the dedicated and courageous journalists who reported out the crimes of a former House Speaker, an Ohio State wrestling coach, an Olympic gymnastics physician and hundreds of Catholic clergymen, nobody would ever have held those monsters accountable.

Anyone who wants to understand the difficult and oftenwrenching work behind that kind of investigative journalism should watch "Spotlight," the remarkably realistic 2015 feature film that shows how a team of Boston Globe reporters ripped away the Catholic Church's scandalous cover-up of pedophilia in the priesthood.

Their work required knocking on doors, searching out documents, forcing institutions to account for their failures, taking risks. It is work that sometimes leads to errors, which must be acknowledged and corrected.

But it is the best and often the only way to address and remedy wrongdoing in government and business, and across our institutions, including the press itself.

The newspaper editor who led The Globe investigation is Martin Baron — who now runs the Washington Post, where his reporters produce the best reporting on national issues and politics under the slogan "Democracy Dies in Darkness."

Of course, Trump hates the Post and every decent newspaper. For his own self-serving reasons, he would prefer a nation that gets all of its information from crooks like Alex Jones and Rupert Murdoch — a nation more like Russia, where lies suffocate freedom.

But that would be a society most inhospitable to the welfare of children and all other living things.







Shared Stories: The Number 9 Car

Not everyone knows that Los Angeles used to have a very effective mass transit system up until 1963. The Los Angeles Railway System left a big impression on Anthony Caldwell as a young boy. I grew up in Los Angeles with its trolley car system. It was known as the Los Angeles Railway System. Little railroad-type, electricpowered rail cars went all over Los Angeles.

The trolley cars took you to wherever you wished by transfers that had to be punched, and by a set of numbers or alphabetical letters - A through Z. Ours was the Number 9 car.

We lived on Hoover Avenue and 47th Street, so our family took the Number 9 and it would take us north to greater Los Angeles and Wilshire Blvd, or west to Baldwin Park on Crenshaw Avenue.

People had to climb up about five feet to the main platform where

the conductor stood. For a young kid, it was fun. People would help elderly people up the stairs and the folding step that came down at the bottom to help you climb. For other people, it was just part of from the oak-timbered body. the process.

The contraption had a coin counter-separator that sounded like who usually smiled and waved back. coffee grinder as it sorted out change. An electric compressor chugged as it compressed air for the brake system.

It was the height of efficiency, as the hard, slatted seats would let air circulate and were reversable depending on the direction. The air-conditioning was adjusted by passengers opening or closing the windows manually.

Vents in the wood roof let hot air escape, and as speed increased, the side windows supplied circulation. To me as a child, it was like the equivalent of taking the space shuttle to Mars!

The thing jerked and ground to a halt at street intersections. People stepped off the sidewalk and into a white rectangle painted on the street next to the tracks. It was the designated loading zone.

People in the cars obeyed the rules and waited for people to exit or enter the trolley and return to the sidewalk.

Somehow turns were negotiated at intersections accompanied by shrieks of metal wheels grinding on steel rails and wood groaning

We could look down into automobiles and wave to the occupants,

Now Los Angeles came into view, with its famous Richfield Building of black marble and gold-leaf décor. There was also the completely modern Bullock's Wilshire with its outside entrance ceiling decorated in modern scenes of tri-motor airplanes and Queen Mary-type ships.

Then we saw the huge eight-story high department stores, J.W. Robinson Co., Desmond's, and May Co. We also had access, if we wanted, to the public library and Grand Central Market with the million-dollar theater above the huge, subterranean labyrinth of tunnels for the Pacific Electric Inter-Urban Railway System. (This latter building is still there and being reused again.)

When our trip ended, we left the "Big Town" and caught Number 9 back to South Central Los Angeles.



Gov. Brown signs legislation ending bail in California

U.S. to end monetary bail for those awaiting trial after Gov. Jerry Brown signed landmark legislation to reform the bail system on Tuesday.

Senate Bill 10, which goes into effect on Oct. 1, 2019, was approved by the state legislature a week ago before being sent to the governor, according to KTLA sister station KTXL in

"Today, California reforms its bail system so that rich and poor alike are treated fairly," Brown said in a news release announce the signing.

The legislation eliminates money-based bail as an option for someone to be released from jail awaiting trial.

Instead, counties will follow a pretrial risk assessment of a person before releasing them.

"Wealth is not the measure

By will become the first state in the eliminating cash bail, we are eliminating cash bail, we are saying that those with the least ability to pay should not be released or incarcerated solely on the basis of their wealth or poverty. SB 10 is only one leg of the long journey toward perfecting our justice system, but it is an important one," Assembly Speaker Anthony Rendon said in a news release.

> The bill faced sharp criticism from the bail bond industry and the ACLU. Critics have said the bill would cost the state hundreds of millions of dollars to establish, would increase the number of people in jail and would also give more power to judges.

> The California Police Officers Association had come out against the bill before switching their stance to neutral.



"We have to help each other." said Roy. "Imagine living in a world without art."

Fifty white folding chairs invited the audience to sit and enjoy the short short films and documentary by local film makers, which were effectively shown on the brick garage wall.

The evenings are provided free by Shabla, and always feature live music and an open mike.

Complimentary finger food for noshing was offered, and wine and keg beer were free, with a suggested donation and an honor

If "laid back" weren't such a square term nowadays, it would fit for the mellow evening. A nearly full moon rose in a clear blue sky, a light breeze whispered: a perfect California

"I haven't lifted a brush in 10 years," said Roy, as he held open house in his immense storehouse and workroom. "All my paint is flicked or poured or dripped onto the canvas.

The ceiling of the atelierwarehouse is 20 feet high, and the sliding garage door opens like what the untrained ear might a carriage entrance, big enough for Roy's over-size abstract works to be carried in. There are also all-white collages of baseball bats; and a white telephone; huge black cubes with beige and red dice-like spots hovered over the

Music lovers will remember the two mammoth canvases displayed three years ago on the big side stages in the Downey Theatre. Roy's two abstract canvases with thick 3-D deeprelief drops of blue and green acrylic, titled "Water Music: Blue and Gray 2015," were each eight feet high and 18 feet long. They evoked the idea of sunlight on water, as the Downey Symphony Orchestra performed Scheherazade by Rimsky-Korsakov and ballet selections from a Swan Lake Suite by Tchaikovsky.

The sun had not quite set when the music began. A casually dressed, mostly youngish crowd strolled around the private lot while musicians Eldorado Collective played a martini-jazz quartet influenced by Herbie Hancock and Santana.

Later, Esmoladera's Gabriel and Steven Armenta, and other guest musicians, improvised

call New Age Sound. Pleasant melodies and unexpected chords, not so loud as to impede conversation, a civilized plus at events these days.

The evening's entertainment was presented by two featured poets familiar to Downey patrons of Poetry Matters evening events over the last six years. Tamara Madison, one of the evening's featured poets, has read at Rives Mansion and Stay Gallery. She read from her newest book, Moraine (Pearl Editions, 2017), and her poems have bite and vibrancy.

As she read, a nearby evening freight train sounded its mournful whistle, and Tamara went with the flow, as though the music of the train had been scripted into her poems. Poetry in motion.

"Twenty years ago," Donna said, "my husband was killed in a freeway accident, a life-changing event. They said those had been

his last words before he was hit." Her poem concludes, "Your season ended."


In "Avocado" she writes: "She drove west on 66/ until its end at the ocean,/ ocean where her new world unfurled/ under trees bearing fruit,/ fruit like a fist/ or a mottled green womb. / One taste, avocado, was just/ what she wanted. Good Lord,/she knew she was home."

Short films were shown, one of them consisting of silent color TV test patterns and sign-offs and one whose dots and slots looked like digitalized bank robbers in ski masks. Then Jennifer Abod presented her groundbreaking and much needed short documentary, "The Passionate Pursuits of Angela Bowen", about the first black ballet dancer ever to break the racist taboo and appear on the stage in New York.

After she had conquered that barrier, by performing in "Swan Lake," Angela later came to teach at Cal State Long Beach. As a pioneer Long Beach State Women's Studies professor, and a pioneer equal rights activist whose reputation reached across the country, she was honored at the first Lavender Graduation in CSLB's history. Bowen died just one month ago.

Roy Shabla's over-sized paintings are "probably too big for your living room," he admitted, "but just right for industrial and corporate spaces." Fans of the Green Salon can look forward to Saturday, Sept. 22, when Roy will join in an annual world-wide event, "100,000 Poets for Peace," poets, musicians, and artists around the world in a demonstration/ celebration to promote peace, sustainability and justice, and to call for serious social, environmental and political

Writing workshops and poetry readings, including an open microphone, will again be backed by musicians and Roy's customary vegan buffet, with beer, and wine and cheese. Expect Roy's works in progress to be on display, along with a vast collection of books and chapbooks he has written.

Elements of a real estate offer: Money, timing and waiting

So you've found a house you want and you're ready to buy. It's not as simple as knocking on the front door and announcing that you'll take it. Your decision triggers the start of an intricate dance between you and the seller, typically with real estate agents guiding and advising you both. You're about to make an offer, which can be daunting whether you've done it before or are a first-time buyer.

Elements of the offer

When you make an offer you are telling the seller not just what you're willing to pay, but how you're going to do it. You're also going to put an expiration date on your offer and either give yourself an escape route if you find out something about the house that the seller won't fix, or you are going to handcuff yourself to the house no matter what.

Set your price

The seller set their price when they listed the home. But that's just a starting point.

Your agent should do a comparative market analysis, looking at what similar homes have sold for and helping you reach a price. You can also do your own research by looking at market "comps" on Zillow. In fact, you have quick access to more reliable information about real estate pricing than any time in history, so use it.

With your agent's help and your own research, you are an informed consumer. So now's the part where you set your price. If the market's hot, and the house just came up, you may actually offer more than what the seller was asking. If it's been languishing on the market, maybe you offer less than asking.

Explain yourself

If your offer is much different from the asking price, you should consider "loading" it. Essentially, that means including a letter that recaps your offer in simple terms as well as the information you got from doing a comparative market analysis. If you offer less than what the seller listed the property for, it could be a shock to them. Or they could be offended. You can't rely on their agent to present them the comps you found, but they are legally bound to provide anything you present in writing to the seller. So let them know how you reached your offer price and that it isn't because you didn't like their taste in window coverings. Your letter will both help them understand your offer and the market

conditions that led you to make it.

The clock is ticking

Just like milk, an offer to buy a house has a shelf life, and you get to set it. How long your offer is good depends on what's customary in your area and how hot the market is. It can range from hours to days. There are different strategies for setting this sell-by date, depending on how competitive the housing market is and your real estate agent will help you decide that.

In a hot market, you want a short window for the seller to consider your offer to prevent someone else from sneaking in another offer and getting the house. (In a really hot market, you may want to consider an escalation clause.) And in some cases where the seller is already gathering multiple offers, they may set a specific time that they will open and consider all offers.

Your offer will also include a closing date for when you want the deal to be finished and the house to be yours.

Show them the money

In addition to how much you're willing to pay for the home, the offer will also include details about how you're going to do that. The seller is going to want to know that you have financing in order and that it's solid.

A pre-approval letter, which is often required by sellers, can help give the seller confidence to accept your offer. It will demonstrate that you are working with a lender and that the lender is willing to loan you the money needed to finance

The seller doesn't want to accept your offer, take the house off the market and then discover in three weeks that you can't get a home loan.

No, really, show them the money

You'll likely be asked to write a good faith "earnest money" check or money order. If the seller accepts your offer, the check will be placed into an escrow account and used as part of your down payment.

Earnest money is essentially a deposit and shows the seller that you are serious. Without it, you could be making offers on several houses at the same time, costing sellers precious days on the market.

How much should you put down? It can range from 1 percent of the purchase price to 10 percent or more in a particularly hot market. It's the money you are putting at risk if you back out for reasons not outlined in the offer.

An escape route

Depending on your jurisdiction, you may have a specified amount of time to just back out without giving a reason. But those "cool-down" laws are actually quite rare. So you may want to create your own escape route so you don't lose your earnest money if you find something wrong with the house or your financing falls through.

The way to do that is with contingencies. The most common are inspection and financing contingencies. With an inspection contingency, your offer will specify that the seller has to make the home available within a certain number of days for you to bring in a professional inspector. The offer will also outline what happens if the inspection unearths any problems you'd like to have addressed.

Another common contingency is based on financing. If you can't secure a loan, a financing contingency will let you get out of the sale without losing your earnest money. This is rarely a problem if you're truly pre-approved and it won't help you if you simply decide you don't like the interest rate you're getting.

Beware! In a seller's market, each one of these escape routes is going to count against you and you'll be tempted to avoid them. especially if you've lost out on houses before. But think very hard about making an offer with

no contingencies. Sometimes it can't be avoided but it's usually a bad idea.

Keeping a poker face

Once you've completed the offer, your agent will meet with the seller's agent to "present the offer." This may be the house you've dreamed of all your life, but the seller won't see that on your face because the seller won't see your face. It's all business for the agents.

Waiting for the phone to ring

Now you wait to hear back. The seller will have either accepted your offer as-is, rejected it outright or made a counter-offer. If they accept within the time frame you allotted, you are now legally bound by its terms.

If they reject it, they either accepted another offer or yours was so far from what they want that there's not much point in continuing the

The last scenario is a counteroffer. Essentially, unless you nailed everything exactly as they wanted it in your offer, you'll get a counter. The counter is technically a rejection of your offer accompanied by their new offer to

If you can't come to an agreement, the contract is cancelled and you get your earnest money back.


