► CULTURE IN DOWNEY: The death of Hollywood great Miriam Nelson, a dancer and choreographer who lended her talents to shows with the Downey Civic Light Opera, is another reminder of Downey's further vanishing cultural

**DOWNEY** - Every major newspaper in the country ran a lengthy obit on dancer/ choreographer Miriam Nelson, who died on August 12 at the age of 98 and whose seven-decade career, as The New York Times put it, "spanned the golden ages of Broadway, Hollywood and television."

She worked with Judy Garland, Bette Davis, Audrey Hepburn, Ingrid Bergman and Jerry Lewis; she helped Shirley MacLaine perform a memorable striptease in "The Apartment" in which MacLaine removed nothing but her necklace; she choreographed the whole cast of "Cat Ballou" in a number; and she coaxed a terrified William Holden to dance with Kim Novak in one of Hollywood's immortal, sensually riveting scenes, in "Picnic."

On Broadway, as a dancer, she worked with Van Johnson, Ethel Merman and Danny Kaye, and appeared in six shows, including two by Cole Porter. As a film actress, she appeared in "Double Indemnity," and "Lady in the Dark." On TV, she worked on "The Red Skelton Show,"
"Father Knows Best," "The Lucy
Show" and "Murder, She Wrote."

Tall, slender, graceful, outgoing naturally and aristocratic in bearing, she and then-husband Gene Nelson were, along with Marge and Gower of what Downey has lost, and Champion, among the premier an indication of a city moving Broadway.

For quite some time I've been meaning to thank the Patriot for running that intriguing picture (April 11) of Marsha Moode, executive director of the Downey Civic Light Opera, taking tickets at the door of the Downey Theater prior to a Sunday matinee.

Moode, a former beauty queen and stage and film actress, and the only Downey woman beside Karen Carpenter to possess star quality (though of a different sort), is dressed in an evening gown in which she looks perfectly comfortable. More than a self-referential glamour puss, she's looking at one of her theater patrons directly in the eye and smiling in the way she had of making everyone feel happy and personally welcome at a DCLO performance, which consisted of a steady production schedule of the best musicals ever staged from the golden age of Broadway musicals, including works by Irving Berlin, Lerner & Loewe, Rodgers & Hammerstein and the Gershwin brothers

What's the connection here?

For much of the final decade of the DCLO's existence, Miriam Nelson was choreographer for Moode and the DCLO, in which Nelson's style, experience and brilliance seemed to make each show more dazzling and infectious than the one before. Mixing amateurs and pros, her dance numbers became more explosive, more confident and theatrical, full of the pizzazz of old Broadway at its most assured.

Long before its 2013 demise, a DCLO production was one of the few bright lights on what passes as Downey's dismal cultural scene. Moode also arranged and hosted opening night parties in which part of the Embassy Suites' ground floor was blocked off and city officials and business people mingled with cast members and dancers, alumni from other DCLO productions, L.A. actor friends and even a few university theater professors.

Miriam Nelson would be there too, friendly and beaming, a genial part of the fun, even though she had to drive home afterward to Malibu.

So why do I mention all this?

Because it's a reminder dance couples of Hollywood and in the wrong direction. I can Broadway. understand if local theater audiences, to whom the DCLO is already a distant memory, don't remember Nelson; she worked behind the scenes.

> But I'll bet a hefty sum that no one on the city council, whose job it is to know what goes on in the city, knew anything about the luminary in their midst, or for that matter, the pleasure the DCLO brought audiences who drove in from as far away as Ventura. (Alex Saab would be the exception; but he, like the rest of the council members at the time, didn't take in DCLO performances; they didn't show up for the Downey Symphony performances either, unless they were getting an award.)

A city without a cultural life is a dead zone, and as I watch architectural atrocities like held a few meetings to hear what the KB project on Paramount and 5th hog the landscape as they metastasize in bulk, and lament the short-sightedness that created the semi-desolate Promenade—Downey's great shot at the stuff municipal dreams are made of—I see a once-exceptional place bailing on its future.

I've lived here through more Downey election cycles than I care to remember, and there are a few council members I'm happy to see gone for the harm they've done that lives after them. But as I've observed the more recent parade of candidates pass through public scrutiny, each trumpeting the same tune about supporting police and business, business and police (as if a robust society consisted of nothing else), I'm struck more and more by the intellectual mediocrity, the absence of thought and imagination, of knowledge of how a well-rounded city and its rich satisfactions work, that has characterized our leadership.

The council as a body needs to snap out of its slumber. There have been notable efforts by Saab and Rick Rodriguez to get out and around, to listen to what's going

on in people's minds, to show a city presence. Sean Ashton has people have to say.

the Downey arts community, such as it is, should be appalled at its own unresponsiveness to gestures Saab has made both in meetings at City Hall, where the same 15 or 20 people showed up and offered little by way of a plan to promote their work; and at the Downey Theater, where he offered discounts and non-profit incentives to theater artists to make use of the space. Except for one or two whose sole purpose seemed to complain, the majority sat in passive silence. They wanted the city to do everything for them.

I can understand the city's reluctance to work with this bunch. Still, it has to do more. Without a cultural life, any urban locale is condemned to poverty of mind and spirit, stripped of historic continuity and the forms of expression that connect place and moment with the mystery that surrounds us, unrewarding to the inner lives of the people who live in it, something future generations can't wait to escape.

By cultural life I'm not just referring to visual and performing arts, literature and poetry. I'm referring to the physical landscape around us, both natural and architectural. Our political leaders have got to reverse the punishing trend of selling us out to real estate developers.

There are a number of Downey civic and fraternal organizations where people come together in hearty appreciation of living here, as in the recent tributes to Mary Stauffer and the celebration of the historic McDonald's on Lakewood and Florence. But if vou consider its leadership role, the city bungled the handling of the Downey Art Museum, the first in L.A. County, so that it could be destroyed by the senseless ire of one vindictive blowhard. Though the issue was complex, the city didn't protect the DCLO from a management firm that said, in effect, our way or the highway; a firm, incidentally, that acts basically as a pricey booking agency and does little to fulfill the purpose of the Downey Civic Theater as an anchor of Downey cultural identity.

Downey needs a staff architect to help give it a look more definitive than mere branding. It

# Warren High named ESPN Honor Roll school

High School is now a nationally recognized program. Warren High School, one of Downey Unified's comprehensive high schools, is one of 30 Special Olympics Unified Champion Schools selected last Thursday as part of the first class of ESPN Honor Roll schools.

The school is also the first Special Olympics Southern California Unified Champion School to be recognized as a National Banner Unified Champion School, joining the class of 2018.

By earning national banner recognition, Warren High School has demonstrated inclusion by meeting 10 national standards of excellence in areas such as unified sports, inclusive youth leadership, whole-school engagement and sustainability.

'Receiving the national banner validates the work and effort of our staff into creating an inclusive environment," said Christine Spino, a special education instructor in her 11th year at Warren High School. "It gives us an idea that we are headed in the right direction, keeping us motivated to continue along this path."

Warren High School makes a number of activities available to its students - both with and without intellectual disabilities. The school hosts everything from movie nights and dances to unified sporting events and tailgate parties, in addition to the traditional dances

"If they require support or help, we make it happen," stated Spin "Our students are acknowledged at all award ceremonies with their general education peers."

Before connecting with Special Olympics Southern California, the school started its shift to a more inclusive environment through Spino's social club Teen Connection, which started 10 years ago. The goal was to promote inclusion and create opportunities for her students to build friendships.

Spino invited 10 general education students to her classroom at lunch, sharing a pizza and playing board games, and by the end of its first month more than 50 general education students were attending. It became an official club on campus the following year, with 200

"Each year it has grown and each year I have more people supporting it," Spino said. "It's amazing to be part of such a supportive campus from top down - administrators, teachers, students, staff and parents. I am never told no when I have an idea, and always greeted with enthusiasm, support and positivity.'

As one of Special Olympics Southern California's Unified Champion Schools, Spino noted that the partnership has enhanced the school by providing a curriculum, ideas and support to reach more teachers, students and staff.

'Students and teachers have a higher respect and understanding of what it is like to walk in the shoes of our students' everyday life, she added. "Our students are typical teens and contribute to our school in a positive way.

"These programs help us ensure that we are doing everything we can to provide a great educational environment for all of our students. ... It raises awareness, and teaches tolerance, acceptance, compassion and respect."

**DOWNEY** – The theme of this year's Downey Christmas parade is "Christmas of Giving," and there are few who embody that message more than this year's grand marshal: Martha Sodetani.

needs to revive a knowledgeable arts commission consisting of energetic and conscientious figures like George Redfox of the Downey Conservancy, to help advise it in fields that are clearly beyond the city council's area of expertise.

The city should offer low rent loft and industrial space to local and L.A. artists and thereby gain entry into one of the hottest art scenes currently in the world, with no sign of cooling down. It should erase a lingering embarrassment by restoring the Downey Art Museum, and with

it, an old, unmistakable source of civic pride.

The same with the Downey Theater, which, in being the largest civic structure in Downey, dimensions superior to any other mid-size theater in Los Angeles County. Instead of the one-and-done commercial amateur presentations we have programmed now or in addition to them — the theater should be reconceived as a real theater, with classic and contemporary plays and theatrical performances.

Its management could offer invitations to the best college and university talents in the region to come and perform; ditto in partnership groups like the L.A. Theatre Alliance and others performing arts scene. It should

benefit from the knowledge of some of those visiting talents. Who doesn't like kids? The theater should be buzzing full-time, instead of looming in empty silence most days and nights like an abandoned morgue.

Who hasn't noticed the increased traffic, congestion, pollution and sheer noise that has characterized Downey life over the past decade or so? There isn't much the city can do about that. But it can find new spots here and there to put in walledrestorative peace and tranquility of spirit to anyone looking to get away from it all, or just catch a residents there.

All this and more could be thought. to cross-fertilize a regional discussed as an antidote to what we're losing, and should daytime performance be addressed to our current

programs for kids, who could city council, and perhaps even more crucially, the new faces competing for city leadership.

# The left's constant need to manufacture racism

To appreciate the level of dishonesty and societal harm the media, the Democratic Party and others on the left engaged in last week regarding Congressman Ron DeSantis, one has to know exactly

The day after he won the Republican primary for governor of gubernatorial primary, DeSantis said: "The last thing we need to do is to monkey this up by trying to embrace a socialist agenda with huge tax increases bankrupting the state. That is not going to work.

Therefore, according to the Democratic Party and the leftwing media, DeSantis used that term to send a "racist dog whistle" to fellow Republican racists.

As Washington Post columnist Jonathan Capehart headlined his column, "Ron DeSantis's 'Monkey' Comment Was Just the Start of His Racist Dog-Whistling." He wrote, "The obvious slur here is

'monkey this up.' Likening African Americans to monkeys, apes and chimps is a racist pastime."

The chairwoman of the Florida Democratic Party, Terrie Rizzo, tweeted, "It's disgusting that Ron DeSantis is launching his general election campaign with racist dog whistles.'

Florida Congresswoman Frederica Wilson, a Democrat who Florida and Tallahassee Mayor Andrew Gillum won the Democratic represents a district in South Florida, said: "They always find a way to add some sort of insult to African-Americans and make it racist. 'Monkeying this up' is clearly communicating that.'

> The NAACP Florida State conference said that "apes" and "monkey" are "by far the best-known racist references to African-Americans in our national folklore. It's only equal in racial semantics to the 'N-word.'

> Gillum himself said: "It's very clear that Mr. DeSantis is taking a page directly from the campaign manual of Donald Trump.

> On CNN, Gillum told Chris Cuomo, "Well, I'll try to be articulate" sarcastically referencing DeSantis' description of him as an "articulate" advocate of the leftist policies he espouses. This is normally a compliment, but it is now deemed racist when used to describe any black. "(H)e's apparently given up the whistle," Gillum continued. "They've gone to the bullhorn with these kinds of tactics."

> On the CNN website, LZ Granderson wrote: "White people linking black people to monkeys has been a racist trope for centuries. That's why when Florida Rep. Ron DeSantis, the Republican nominee for governor, used the phrase 'monkey this up' when talking about the handling of the economy by his black Democratic opponent, it was hard to believe that the word choice was an accident.

> The New York Times reported, "Sharon Austin, a professor of political science at the University of Florida, said she saw Mr.

DeSantis's language as a not-so-subtle racist dog whistle."

Princeton University African-American Studies professor Eddie Glaude Jr. said on MSNBC: "That's obviously a racial dog whistle. ... here we are once again. We are right back where we've always been."

Why does the left do this? Why does it incessantly libel Republicans and conservatives as racists?

The answers are as vile as they are obvious.

First, the left fears that unless blacks continue to believe Republicans are racists, they will not overwhelmingly vote Democrat. And if they don't, Democrats will not regain the White House for the foreseeable future. The same holds true for depicting Republicans and conservatives as women haters. There is no better way to persuade college-indoctrinated women to vote Democrat. And the same holds true for Latinos — Republicans must be continuously labeled "white supremacists" and "xenophobes" or they, too, may not reliably vote

Second, though most intellectuals are on the left, the intellectual foundation of left-wing beliefs is unbelievably weak. Leftism is almost entirely emotion-based. That's another reason the left smears conservatives and tries wherever possible to prevent conservatives from speaking in the university, on the internet and by the many big businesses in the hands of people on the left: Since leftists cannot debate conservatives, they have to smear them.

America is the least-racist multiracial, multiethnic nation in world history. The left's constant need to locate racism where it doesn't exist is proof of this.



# Speaking ill of the dead

"Too soon!" That was a standard response to my criticisms of John McCain after his death.

My cartoon and social media posts reminded readers that McCain had volunteered to bomb innocent civilians in an illegal war of aggression to prop up a corrupt and reviled regime at the time of his capture. The real heroes of the Vietnam War were the tens of thousands of draft dodgers forced to give up their lives to flee to Canada and the many conscripted veterans who came home appalled by what they had seen and done and spent the rest of their lives fighting for peace.

McCain, on the other hand, learned nothing from his experience. He never met a war — or a possible war — he didn't like. McCain voted for wars in Afghanistan and Iraq. He criticized Bill Clinton for limiting his war against Serbia to airstrikes; he wanted ground troops, too. He supported arming the Islamists in Syria and Libya, expanding the civil wars there. He threatened war against Iran. He engaged in saber rattling when it came to Russia. North Korea and even China were also in this deranged right-winger's sights.

These were not minor failings in an otherwise distinguished life. They were defining acts that erased the myths on which McCain built his career — his military service and his "maverick" persona. The war he fought in was disgusting and is now widely considered a mistake. McCain was a run-of-the-mill right-wing Republican warmonger. His straight-talk shtick was fake.

Media accounts sanitized the myriad very bad things McCain did throughout his life. So I've been doing my part to help counter the tsunami of BS.

"Do not speak ill of the dead." This dictum, attributed to the sixth-century philosopher Chilon of Sparta, may be appropriate at your uncle's funeral; who wants to hear that the dead man's widow discovered foot fetish websites in his browser history?

Public figures are different.

In cartoons and the written word, I have attempted to counter the fulsome praise that followed the deaths of people such as Ronald Reagan. I wasn't trying to be mean to Nancy Reagan when I criticized her late husband — though I doubt she read my work.

Ronald Reagan hurt and killed a lot of people. As much as Reagan's admirers didn't enjoy my reminders that he (we believed at the time) murdered Moammar Gadhafi's daughter or that he didn't care about

victims of AIDS, Americans who lost friends and relatives to the "gay plague" deserved to be acknowledged in assessments of Reagan's life and legacy. The media pretended Reagan's crimes never happened. I corrected the record.

The "too soon" and "can't you wait until the body is cold?" arguments fall flat. What better time to point out and discuss a dead leader's flaws than the time immediately after his death? That's when obituaries appear, the eulogies are said and the nation is focused on the issues and policies he affected and effected. A few weeks later,

Presumably referring to himself, former President Theodore Roosevelt argued in a 1910 speech that men of action, those "in the arena," matter and their critics do not.

"It is not the critic who counts, not the man who points out how the strong man stumbles or where the doer of deeds could have done them better," Roosevelt said. "The credit belongs to the man who is actually in the arena, whose face is marred by dust and sweat and blood, who strives valiantly, who errs, who comes short again and again, because there is no effort without error and shortcoming; but who does actually strive to do the deeds, who knows great enthusiasms, the great devotions, who spends himself in a worthy cause, who, at the best, knows in the end the triumph of high achievement and who, at the worst, if he fails, at least fails while daring greatly, so that his place shall never be with those cold and timid souls who neither know victory nor defeat."

Soaring oratory! But self-serving and obsolete.

If effort and taking chances are all that matter when assessing a person's life, the firefighter who enters a burning house to save a baby has no more worth than the serial killer who sneaks inside to kill it. Adolf Hitler, Josef Stalin and Osama bin Laden all had grand visions they strove valiantly to turn into reality. They were daring. They achieved. They counted, but so what?

These days, it's the "timid souls" who stand aside, keeping mum while the mass media wallows in sordid orgies of mawkish praise for problematic figures such as Reagan and McCain. Adding perspective and nuance to assessments of mass adulation requires courage. In this age of relentless propaganda and unmitigated BS, the critic is in the arena just as much as a dead senator.

# Shared Stories: My own best medical advocate

Mary Nieraeth contended with periodic epileptic seizures in childhood, and episodes reappeared under the stress of being a full-time working mother and wife. Ready for summer vacation, my parents, two younger sisters and I packed into our 1960's Chevrolet station wagon. Headed about four hundred miles from Illinois to Minnesota to visit relatives, I recalled playing Go Fish, I Spy and other games with my sisters to pass the time. While driving, my father suddenly veered off the road into a shallow ditch to avoid a head on collision.

We were jostled around since there were no seat belts in our vehicle. My sisters and I were thrown to the right side of the middle seat and my head banged into the window. This trauma to my head was disregarded by my parents. However, it has lingered in the back of my mind since it may have been a contributing factor to the story that follows.

A few weeks later, I began second grade. My parents and teachers both observed incidents when I stared out into the room in a trance-like had one last night." state for about 30 seconds. I never had any recollection of these incidents. After referred to a pediatric neurologist, an EEG and MRI of my head revealed normal results.

Because these staring episodes continued, the neurologist diagnosed this as epilepsy. Anti-seizure medication was prescribed but it took many months before finding the correct medication and dosage for my condition. In my mid-teens, the neurologist weaned me off the medication, with no further seizures during my high school and college

During my mid-twenties, I moved from Los Angeles to Boston for graduate school and employment as a registered dietitian. This was a stressful time with many life adjustments. Shortly after starting my job, some coworkers observed me doing a peculiar behavior while eating lunch together. I had no recollection of this but knew I needed to see a doctor.

My primary care physician expedited a referral to a neurologist. Following an EEG and MRI of my head, the results were normal. I was started on medication and instructed not to drive. Fortunately, I did not have a car and was using public transportation. Within a few months, my seizures were completely controlled.

The next twenty years were without any reported incidents of seizures. In my early forties, however, I was married, working full time, and had three children in middle school. On a busy Friday morning, the weekend of the annual school festival, I drove to the grocery store then planned to drop off some items at the festival. I was stressed from anticipation of being outside many hours that weekend in the hot September weather.

Returning home from the grocery store, I missed the turn into the school due to loss of consciousness. I had no recollection of this happening but, apparently, ran into a truck waiting at the traffic light. The impact caused my van to veer to the right, up onto the lawn outside a medical building, instead of into oncoming traffic.

After the accident, my life drastically deteriorated. I lost my driver's license, my job was terminated, and I continued to have uncontrolled seizures. My doctor referred me to a new neurologist.

Anxious, frightened and depressed, I had my first appointment. After a quick knock on the exam room door, a male doctor entered the room. Without making any eye contact with me, he announced, "I'm Dr. Indifferent." He picked up the clipboard and glanced at my completed

"So, you are here for seizures. When was your last one?"

"I'm not sure since I don't know when I have one. My husband said I

"Do you know what happens when you have one?"

"No, my family says I rock back and forth with my upper body or move my right arm in and out."

The doctor verified my seizure medication and dosage. Next, he checked reflexes in my elbows, knees and ankles, arm and leg muscle strength, peripheral vision, coordination, balance, hopping, and walking. He asked basic math computations, current history questions and checked my short and long-term memory. The process was exhausting.

Without comment on my test results, he took out his prescription pad, scribbled a higher dose of the same medication and handed it to me. As he walked out the door, he told me to return in one month.

During the following weeks, I decided to keep records of the date and time of my seizures, at least those seen by my family. Feeling proud of my efforts, I brought my notes to the doctor, but he refused to look at this

I felt discouraged about not having any improvement in my seizures with the higher medication dosage. He did not perform an assessment of

my physical and emotional state. I felt invisible in his presence, anxious and depressed about my severely limited lifestyle.

Finally, he handed me a prescription for a second medication and again told me to return in one month. Clearly, connection with his patient was low priority for this doctor.

Almost immediately, I became restless and drowsy on the new medication. I called the office but was told to continue the medication. My symptoms and seizures continued. I was losing hope about my worsening condition but refused to give up.

During my follow-up appointment, the doctor interrupted me and rudely exclaimed, "You have to learn to live with these symptoms. There is nothing more I can do!"

Feeling appalled and dismissed by his comments, I left the office and vowed to myself never to return to Dr. Indifferent.

A few weeks later, my husband showed me an article he read in the Parade magazine of the Los Angeles Times newspaper entitled "Their Best Chance for a Normal Life" (9/18/2005). This article discussed medical and surgical options for people with epilepsy.

My feeling of hope returned as I explored the referral process with my medical insurance to the UCLA Seizure Disorder Center.

Several months later, I had my first consultation with an epilepsy specialist. He assured me that the medical team's goal was to find the root cause and best treatment for my seizures.

During the next year, I completed many tests and medication changes as part of the preoperative protocol for epilepsy surgery. The functional MRI test found a noncancerous lesion in my right temporal lobe which appeared to be the cause of my seizures. My case was reviewed by the department's neurophysiology board.

The team of doctors concluded that removal of this lesion by surgery had a high probability of ending my lifelong seizures. In December 2006, I had brain surgery at UCLA and miraculously, since then, I have never had another seizure.

Many people seeking medical care place a blind trust in doctors' opinions which may lead to substandard treatment. I learned it was imperative to do an independent medical investigation of my condition and search for a doctor who was committed to finding the root cause and best treatment of my seizures. Not accepting the status quo in medical treatment launched my journey of becoming my own best medical advocate. That journey has no end in sight.



# Neil Simon, acclaimed playwright, dies at 91

**NEW YORK** - Neil Simon, one of the most popular and prolific playwrights and screenwriters of the second half of the 20th century, died Sunday, Aug. 26, of complications from pneumonia, according to his publicist Bill Evans as reported by CNN. He

Born July 4, 1927, in New York City, Simon grew up loving movies, especially comedies, and turned that love into a career when he began writing for some of TV's earliest comedy shows, including Sid Caesar's "Your Show of Shows" and "The Phil Silvers Show," both of which earned him Emmy awards.

Simon spoke later of the enormous influence these jobs had on his career, particularly the opportunity to work with some of the day's finest comedy writers: "I knew when I walked into 'Your Show of Shows,' that this was the most talented group of writers that up until that time had ever been assembled together.

The first play Simon wrote was 1961's "Come Blow Your Horn," which ran on Broadway for more than a year to favorable reviews. It had barely closed when Simon's next play, "Little Me," opened on Broadway, starring Caesar in multiple roles and with choreography by Bob

Simon continued to write prolifically, and as his reputation grew, his plays began to become instant classics. His list of notable plays includes great favorites such as "Barefoot in the Park" (1963), "The Odd Couple" (1965), "The Sunshine Boys" (1972), "They're Playing Our Song" (1979) and "Lost in Yonkers" (1991).

Many of Simon's best-loved plays were adapted into movies, most with screenplays written by Simon: "The Odd Couple" (1968), "Only When I Laugh" (1981, based on his play "The Gingerbread Lady"), "Brighton Beach Memoirs" (1986). In other cases, the movie came first, as when he adapted his 1977 film, "The Goodbye Girl," into a 1993 play.

Among Simon's critically acclaimed works is the trilogy of autobiographical plays, "Brighton Beach Memoirs," which won the New York Drama Critics Circle Award for best play, "Biloxi Blues," which won the Tony Award for best play, and "Broadway Bound." 1991's "Lost in Yonkers" was also greatly celebrated, winning a Drama Desk Award, a Tony Award and a Pulitzer Prize.

Simon's other honors include membership in the American Theatre Hall of Fame, the New York State Governor's Award, the Kennedy Center Honors and the clot on August 26 following a Mark Twain Prize for American double lung transplant.

# How to get rid of private mortgage insurance

If you bought a house and made a down payment of less than 20 percent, the lender required you to buy mortgage insurance. The same goes if you refinanced with less than 20

Private mortgage insurance is expensive, but you can't remove it until you have met some conditions.

### How to get rid of PMI?

To remove PMI, or private mortgage insurance, you must have at least 20 percent equity in the home. You may ask the lender to cancel PMI when you have paid down the mortgage balance to 80 percent of the home's original appraised value. When the balance drops to 78 percent, the mortgage servicer is required to eliminate PMI.

Although you can cancel private mortgage insurance, you cannot cancel Federal Housing Administration insurance. You can get rid of FHA insurance by refinancing into a non-FHAinsured loan.

### Ways to cancel PMI sooner

Here are steps you can take to cancel mortgage insurance sooner or strengthen your negotiating position:

Refinance: If your home value has increased enough, the new lender won't require mortgage

Get a new appraisal: Some lenders will consider a new appraisal instead of the original sales price or appraised value when deciding whether you meet the 20 percent equity threshold. An appraisal generally costs \$450 to \$600. Before paying for an appraisal, ask the lender whether this tactic will work to get rid of PMI for your loan.

Prepay on your loan: Even \$50 a month can mean a dramatic drop in your loan balance over

Remodel: Add a room or a pool to increase your home's market value. Then ask the lender to recalculate your loan-to-value ratio using the new value figure.

### Refinancing to get out of PMI

When mortgage rates are low, as they are now, refinancing can help you to not only get rid of PMI, but to reduce your monthly interest payments. It's a double dose of savings.

The refinancing tactic works if your home has gained substantial value since the last time you got a mortgage. For example, if you bought your house four years ago with a 10 percent down payment, and the home's value has risen 15 percent since then, you now owe less than 80 percent of what the home is worth. Under these circumstances, you can refinance into a new loan without having to pay for PMI.

Many loans have a "seasoning requirement" that requires you to wait at least two years before you can retinance to get rid of PMI. So if your loan is less than 2 years old, you can ask for a PMI-canceling refi, but you're not guaranteed to get approval.

## What is mortgage insurance?

Mortgage insurance reimburses the lender if you default on your home loan. You, the borrower, pay the premiums. When sold by a company, it's known as private mortgage insurance, or PMI. The FHA sells mortgage insurance, too.

## **Know your rights**

By law, your lender must tell you at closing how many years and months it will take you to pay down your loan enough to cancel PMI.

Mortgage servicers must give borrowers an annual statement that shows whom to call for information about canceling mortgage

### Other requirements to cancel PMI

According to the Consumer Financial Protection Bureau, you have to meet certain requirements to remove PMI:

You must request cancellation in writing.

You have to be current on your payments and have a good payment history.

You might have to prove that you don't have any other liens on the home (for example, a home equity loan or home equity line of credit).

You might have to get an appraisal to

demonstrate that your loan balance isn't more than 80 percent of the home's current value.

### **Higher-risk properties**

Lenders can impose stricter rules for highrisk borrowers. You may fall into this high-risk category if you have missed mortgage payments, so make sure your payments are up to date before asking your lender to drop mortgage insurance. Lenders may require a higher equity percentage if the property has been converted to rental use.

### Getting down to 80% or 78%

To calculate whether your loan balance has fallen to 80 percent or 78 percent of original value, divide the current loan balance (the amount you still owe) by the original appraised value (most likely, that's the same as the purchase price).

Formula: Current loan balance / Original appraised value

Example: Dale owes \$171,600 on a house that cost \$220,000 several years ago.

\$171,600 / \$220,000 = 0.78.

That equals 78 percent, so it's time for Dale's mortgage insurance to be canceled.

# Home prices rise when a Starbucks opens nearby, study shows

Each new Starbucks boosts the value of housing prices in a neighborhood. And not by an insignificant amount.

This data point is revealed in a broader study on gentrification by the Harvard Business School that relied on information from Yelp, the online restaurant review platform, and the United

A new Starbucks introduced into a ZIP code is associated with a 0.5 percent increase in housing prices within a year, the paper found.

It's not clear whether housing prices are rising due to the Starbucks opening itself or simply because more affluent customers that would go to the coffee chain have moved into

Harvard economics professor Edward Glaeser said Yelp data reveals it may be the latter. The study found that each 10-unit increase in the number of reviews is associated with a 1.4 percent increase in housing prices in the ZIP

"The most natural hypothesis to us is that restaurants respond to exogenous changes in neighborhood composition, not that restaurant availability is driving neighborhood change," the paper concludes.

This is the broader point of the paper, which surmises that gentrification is "strongly associated" with increases in the numbers of grocery stores, cafes, restaurants and bars

"Yelp data has the advantage of being more up to date than most official government statistics," the economist added. "It also contains metrics on things like cuisine, prices, and ratings that can be difficult to observe

What remains uncertain, though, is any idea of causality, Glaeser wrote.

"Yet, it seems true that Yelp establishments from 2007-2011 predict changes in education levels over the next five years, but education from 2007 to 2011 does not predict increases in the number of Yelp establishments, once we control for the initial level of Yelp establishments.'

So Starbucks may not be causing gentrification, but its arrival may confirm the gentrification trend.




