**DOWNEY** - Claudia Frometa and Giggy Saab emerged victorious Tuesday in two of the most hotly-contested races in Downey's recent history.

With nearly 48% of the vote, Frometa said in an interview well-known real estate broker who captured 41.44% of votes.

Tony Hernandez-Ayala, a fringe candidate who did little to no campaigning, pulled in 600 votes, or 10.6%.

Meanwhile, civic leader not change: public safety and Giggy Saab edged Carlos Avalos. an administrator at the Lennox school district.

Saab was victorious with 52% of the vote.

CITY COUNCIL: Frometa, Uva and Hernandez were each seeking to claim the City Council's fourth district seat, being left open by the departure of Councilmember Fernando Vasquez, who is termed out of office after eight years of representing Downey's northeast residents.

Frometa and Uva campaigned on similar platforms: each made public safety their top priorities while also advocating for greater government transparency and public engagement.

Both touted their extensive volunteer work in the Downey encumbered by term limits. community

Frometa, an emergency management consultant for Kaiser Permanente, was boosted by an early start to her campaign and secured endorsements from three sitting council members (Vasquez, Alex Saab and Rick Rodriguez).

Mayor Sean Ashton and Councilmember Blanca Pacheco backed Uva, who also received considerable support from local Realtors.

With all precincts reporting, Frometa finished with 2,715 votes to Uva's 2,346.

Frometa monitored election results from her campaign headquarters inside a vacant retail space at 3rd Street and Downey Avenue.

At one point, more than 70

Voters ultimately sided with Saab, who won the seat with 1,872 votes to Avalos' 1,722.

"I'm excited, very humbled and grateful for everyone's support," said Saab, a mother of three. "I'm ready to start making an impact on the future of our

Avalos was graceful in defeat.

"I want to thank each and everyone of my supporters, volunteers, family and friends. It was a humbling experience and I'm glad we stayed in the race til the end," Avalos wrote on Facebook.

"To everyone that made us feel hopeful and inspired us to keep going, thank you. I'm grateful to the Downey community for believing in me for a better D

**ASSEMBLY:** Embattled state Assemblymember Cristina Garcia cruised to victory over her Republican opponent.

Garcia was stripped of her committee posts and ordered to complete sexual harassment and sensitivity training after allegations that she sexually assaulted a former staffer.

An investigation cleared her of the most serious charges,

Voters on Tuesday gave Garcia an additional two years in office as she soundly defeated Mike Simpfenderfer, a mortgage banker and victims' advocate from Bellflower.

Garcia finished with 64.8% of the vote.

"Like many communities across California and our nation, voters went to the polls [Tuesday] and expressed their collective disdain for the politics of hate, division, and the undue influence of special interest groups over our civic government," Garcia said in a statement published on her website.

"In my district, voters went further by rejecting those who have attempted to blatantly distort and lie about the successes we have achieved in demanding that the needs of our communities no longer be ignored.

"Today, by honoring me with a large electoral victory, voters of the 58th District reminded those same special interests that they are not blind to the underlying motives for their negative attacks. By rejecting the deliberate negative campaign that spent over \$2 million in this race, residents of the 58th Assembly District made it clear that outside special interest groups will not decide who best represents their hopes and

"Finally, the voters of the 58th Assembly District have also made it clear today that bullying tactics aimed at keeping them, and their elected representatives, quiet on crucial issues such as environmental racism will never be accepted. We won't be bullied. We are not going back to the margins. We are taking our seats at the table.

"I am proud to be re-elected represent the residents of southeast Los Angeles County and will continue to be the same vocal advocate for justice and equity. I look forward returning to Sacramento and fully engaging in the legislative process and bringing a full legislative package that continues to address key issue such as environmental racism and economic opportunities for the communities I represent."

**SENATE:** Bob Archuleta coasted to an easy win in the race for the state Senate's 32nd seat, which encompasses Downey.

Archuleta, a Democrat, beat Republican Rita Topalian with 65.3% of the vote.

A reserve police officer before retirement, Archuleta previously served on the Pico Rivera City Council.

Archuleta won the seat vacated by Tony Mendoza, who resigned after several allegations of sexual misconduct.

"I will serve my district the best I can and make my family, friends, the people living and working in the 32nd District, and promise to make them proud as I serve them as a California State Senator," Archuleta said.

He will be sworn into office

HOUSE: Rep. Lucille Roybal-Allard (D) had no trouble winning re-election, beating Green party candidate Rodolfo Cortes Barragan by a wide margin.

Roybal-Allard 77.85% of all votes cast.

"I am deeply humbled to fight every day for our 40th District in Congress," Roybal-Allard said. 'I look forward to being part of a House Democratic majority that works for the people, so we can secure a better deal for all Americans.

"I'll keep fighting in Congress to create jobs, increase paychecks, lower the cost of health care and prescription drugs, make a good higher education accessible for everyone, enact comprehensive immigration humane reform, and clean the air, land, and water in our communities.'

# Voters reject Prop. 10 rent control measure

Tuesday that would have allowed more rent control as a way to alleviate the state's housing crisis.

Proposition 10 was losing by a 30-point margin with more than 3.6 million votes counted.

It was one of the most costly and contentious items on the ballot, attracting more than \$100 million in campaign contributions.

Opponents said the measure would have lowered real estate values and further decreased the state's already limited housing supply by discouraging building.

# McDonnell in danger of losing sheriff's job

LOS ANGELES - Los Angeles County Sheriff Jim McDonnell may lose his seat to retired sheriff's Lt. Alex Villanueva as the two remain in a neck-and-neck race a day after Election Day.

As of Wednesday afternoon, Villanueva had 50.2 percent of the vote to McDonnell's 49.8 percent, with all precincts reporting, but provisional and late-mail ballots had yet to be tabulated.

If Villanueva does win, it would be the first time a sitting L.A. County sheriff has been unseated since 1914.

A spokesperson for Villanueva said they were waiting on the final provisional ballot count and McDonnell had not called to concede. The challenger had a lead of just under 5,000 votes.

Villanueva held a news conference Wednesday and his campaign released celebratory photos after he and his staff saw the latest result numbers.

McDonnell, who raised eight times more in campaign funds than his opponent, was forced into the contest in June when Villanueva did well enough in the primary to force a runoff.

Villanueva had the endorsement of the union representing rank-and-file deputies and had the backing of the Coalition for Humane Immigrant Rights of Los Angeles, immigration activism McDonnell's organization. supporters included Los Angeles Mayor Eric Garcetti and county District Attorney Jackie Lacey.

Villanueva claimed that McDonnell had failed to reform the department.

McDonnell was elected in 2014, the first outsider to win an election as sheriff in a century. He spent most of his career in the LAPD and was chief of the Long Beach Police Department.

# Measure to limit dialysis clinics' profits fails

The measure would have barred dialysis clinics from charging patients more than 115 percent of what providers spend on patient care and quality improvement. If clinics exceeded that limit, they would have to provide rebates or pay penalties.

# Downey's early days in aviation

#### Things You Didn't Know <u>About Downey</u>

**DOWNEY** - In reading the Sunday Long Beach Press-Telegram dated Feb. 2, 2003, there was a section that listed the history of the Downey plant.

In 1929, industrialist E.M. Smith founded Emsco Aircraft Corp. and began building a single-engine plane. Emsco shut down in 1933 after falling victim to the Great Depression.

1936 by Jerry Vultee, former Emsco employee, and they built attack bombers under the name Vultee Aircraft Corporation. Vultee merged with Consolidated Aircraft Corp. in 1941 to form Convair and built warplanes and

Convair merged in 1947 with North American Aviation and built the Navajo intercontinental ballistic missile. By 1961, the Downey site was selected by NASA to design and build the Saturn V booster rocket and Apollo spacecraft.

North American Aviation merged with Rockwell Standard in 1967 to form Rockwell International. Apollo Astronaut Neil Armstrong became the first person to set foot on the moon in 1969.

The Downey plant was picked to design and build the space shuttle in 1972 -- the world's first reusable spacecraft. The Space Shuttle Columbia made its first flight in 1981.

In 1986, the Challenger, Downey's second shuttle, was destroyed during liftoff. disaster was later blamed on a faulty seal on a booster rocket.

The Downey plant rolled

out its fifth shuttle project, Endeavor, in 1991.

The Downey plant, along with all Rockwell assets, was acquired by Boeing Company in 1996. Boeing announced that 2,580 of the 3,100 people at the Downey site who were working on the Reusable Space Systems division would be transferred to the Huntington Beach complex in 1998. By the year 2000, the few remaining workers were moved out of the Downey plant.

The main story of February The plant was reopened in 2003 was the tragedy of the space shuttle Columbia which was lost in making its re-entry back to earth. The space shuttle glided toward a landing without power at 13,000 MPH. Seven astronauts died as the spacecraft disintegrated.

had a story about a trolley manufacturing company located in Downey.

It was located at 12222 S. Woodruff Ave. and the factory came to Downey in 1986 from Santa Fe Springs. Residents in Downey made many comments about seeing the trolleys taking test drives through the streets of west Downey.

The trolleys were made of oak interiors, brass railings and striped awnings. Underneath the frills, the trolleys were constructed of steel, making them very street-worthy as a bus. The trolleys could hold about 20 people.

The trolleys were built by Specialty Vehicle Manufacturing Company which was a privately owned corporation. When the Downtown Downey revitalization project was being planned, the Downey Chamber of Commerce and City Council were thinking of operating the trolleys in the area.

If you didn't have the chance to see the trolleys in the 1990s, come to the history center to view our pictures. WE have a photo of detailer Mary Romero doing touch-up work on the inside of a trolley in Downey.

**BRENT TAYLOR:** A Utah mayor who was also a Utah Army National Guard major training commandos in Afghanistan was fatally shot by one of his Afghan trainees, officials said Sunday.

Brent Taylor, 39, had taken a yearlong leave of absence as mayor of North Ogden north of Salt Lake City for his deployment to Afghanistan.

He was a military intelligence officer with Joint Force Headquarters and was expected to return to his mayoral job in January. Another U.S. military member whose name was not immediately made public was wounded in Saturday's attack that killed Taylor, who died from wounds from small arms fire, military officials said.

Maj. Gen. Jefferson S. Burton, the adjutant general of the Utah National Guard, told reporters that Taylor's mission was to help train and build the capacity of the Afghan national army.

"He was with folks he was helping and training. That's what's so painful about this. It's bitter," Burton said. "I do believe that Major Taylor felt he was among friends, with people he was working with."

Utah media outlets cited a statement from NATO saying that Taylor was shot by one of the commandos being trained and that the attacker was killed by Afghan forces.

As executive director of the ACLU SoCal from 1972 to 2011, Ripston oversaw the chapter's work on issues such as the Los Angeles Police Department spying on community activists, voting rights, abortion rights, racial profiling and gay rights.

She also led efforts to get California to spend more money on schools in poor and minority neighborhoods, ACLU SoCal said in a statement on its website.

**RAYMOND CHOW:** Legendary Hong Kong film producer Raymond Chow, who introduced the world to Bruce Lee and Jackie Chan and even brought the Teenage Mutant Ninja Turtles to the big screen, has died at age 91.

Hong Kong' secretary for commerce and economic development, Edward Yau, said in a statement Friday that Chow "helped nurture a pool of Hong Kong talents and brought them to the international stage."

Chow was a journalist who became a publicist for Shaw Brothers Studios, which churned out hundreds of films and popularized the kung fu genre. Studio founder Run Run Shaw soon moved Chow to the production side of the business after Chow complained that the movies — made on low budgets and short schedules — weren't good enough.

Frustrated with Shaw Brothers' assembly-line ethic, he created his own production company, Golden Harvest, in 1970.

He soon outmaneuvered his gigantic old employer to grab the actor who would become synonymous with kung fu movies. Chow signed Bruce Lee in 1971 after seeing him on a Hong Kong television variety show.

Golden Harvest signed Lee to a three-picture deal, with each breaking all Hong Kong box office records.

### Let Jim Acosta do his job

Relations between president and press have always been nettlesome, as they should be. The role of the news media in questioning and challenging power is as fundamental to democracy as the ballot. But however maddening presidents past have found reporters to be, none has wandered so far beyond accepted boundaries as President Trump.

Granted, suspending the White House press credential of CNN's Jim Acosta may not seem to rank high in the catalog of outrage that Mr. Trump has filled, especially on the heels of a midterm election in which the president's demagogy played so central a role and coinciding as it did with his forcing the resignation of an attorney general who dared put law and propriety above craven loyalty.

Mr. Trump has amply demonstrated his inability to deal with criticism or tough questions in any way other than to immediately, angrily and crudely counterattack. Mr. Acosta has regularly provoked the president to fury, and he did so again on Wednesday with questions about the Central American migrant "caravan" and the Russia investigation.

 $Anger is \, one \, thing, \, but \, in \, suspending \, Mr. \, A costa's \, press \, credential, \,$ Mr. Trump signaled that in his view, asking hard questions — the most basic function of a reporter — disqualifies journalists from attending White House briefings. That Mr. Trump's press secretary, Sarah Huckabee Sanders, would then use the demonstrably false claim that Mr. Acosta had laid "his hands on a young woman" as a pretext to throw him out compounds the cynicism.

If Ms. Sanders was so offended by that physical contact, what did she have to say when her boss praised as "my kind of guy' Representative Greg Gianforte of Montana, who was sentenced to anger management classes and community service for body-

slamming a Guardian reporter last spring?

What is most alarming in the Acosta incident is its illustration of the extent of Mr. Trump's ignorance of the role of a free press in American tradition and democracy, and of the president's role in defending it. Nobody would argue that the news media is infallible, and that, in the terrible polarization of American society, news reporters would feel targeted for attack for doing their jobs. Mr. Dear Editor: Acosta, for one, has been outspoken in his frustration with the White House press operation.

But it is Mr. Trump, with his incessant demonization of "fake news" and inflammatory characterization of news organizations as the "enemy of the people," who has systematically and dangerously done everything in his power to undermine a free and independent press. That someone like Senator Lindsey Graham, the South Carolina Republican who surely knows better, joins in bashing the press underscores the effectiveness of Mr. Trump's poison.

Mr. Trump would no doubt prefer that every member of the White House press corps be like Sean Hannity or Jeanine Pirro, the Fox News personalities who happily joined the president onstage at his last pre-election campaign rally in Missouri on Monday. Mr. Hannity has long been an unapologetic booster of Mr. Trump, but even his colleagues and managers at Fox were aghast at his participation in the rally, at which he went so far as to join in attacking "fake news" reporters at the back of the room, among whom was a Fox News White House correspondent, Kristin Fisher.

Mr. Trump is not likely to temper his rhetoric. But those he listens to, including Ms. Sanders, Senator Graham and the executives at Fox News, should try to impress on him the danger of confounding loyalty to Donald Trump with loyalty to the Constitution and to democracy.

Talking with other naturalized Hispanic immigrants, we all agreed that we should be prepared to leave the country if internment became a real issue. I had my bags packed in preparation of negative results in Tuesday's elections. Now I know that I have at least 2 more years before I despair about what actions POTUS takes against Hispanic immigrants to make himself look good to his nationalistic constituency.

Thank God for the democratic values of this country. I have been here as a legal immigrant for 58 years and as a naturalized citizen for 53 years, all my adult life, and I would like to stay here until I kick the bucket. God bless the US.

# The growing consensus for legalizing marijuana

The United States remains starkly divided between red and blue, with Republicans and Democrats each registering some gains and some setbacks in the elections. But on one important issue, a national consensus is emerging that transcends party and ideology. America is becoming Weed Nation.

On Tuesday, Michigan became the 10th state, along with the District of Columbia, to decide to legalize marijuana for purely recreational use. A quarter of Americans will live in states that let them get stoned without fear of the constable.

The states include not only reliably crunchy Oregon and Massachusetts but two that went for Donald Trump in 2016 — Alaska and Michigan. They range from the East Coast to the West and from the first in population, California, to the 49th, Vermont. The others are Colorado, Maine, Nevada and Washington.

Then there are the states that allow marijuana to be used for medical needs. On Tuesday, Missouri and Utah — Utah! — voted to join the club. That brings the total number of states that allow pot to be legally consumed in some circumstances to 32, according to the Drug Policy Alliance, plus D.C.

Pro-pot candidates also did well Tuesday. Illinois elected a governor, J.B. Pritzker, who favors allowing recreational cannabis. So did Connecticut (Ned Lamont), Maine (Janet Mills), Minnesota (Tim Walz) and New Mexico (Michelle Lujan Grisham). The winner in Wisconsin, Tony Evers, has said he is "not opposed" to it and would like a statewide referendum to settle the issue.

Cannabis has already run away with the contest for public favor. In 2000, according to the Pew Research Center, only 31 percent of Americans supported legalizing recreational pot. Today, 62 percent

But even in states where cannabis is legal, it isn't. Federal law still bans weed, with penalties that include prison time even for mere users. Sick people smoking it to relieve chronic pain, muscular dystrophy or epilepsy, in faithful compliance with their state laws, are not exempt from prosecution.

Under Barack Obama, the Justice Department adopted a handsoff policy toward states with permissive policies. Then-Attorney General Eric Holder issued directives instructing U.S. attorneys to defer to state laws on medical and recreational cannabis. The administration also tried to provide banks some assurance that they could handle the accounts of legitimate marijuana suppliers without being prosecuted.

But as soon as he was installed as attorney general, die-hard prohibitionist Jeff Sessions reversed course. He ordered prosecutors to fully enforce federal laws reflecting "Congress's determination that marijuana is a dangerous drug and that marijuana activity is a

Does Congress really still believe that? This ought to be an issue on which the two parties can come together — not on whether marijuana should be legal but on whether states should be allowed to make their own choices. Last year, Sen. Rand Paul, R-Ky., joined with Democratic colleagues Cory Booker of New Jersey and Kirsten Gillibrand of New York to propose ending the federal prohibition on medical cannabis.

The conservative Tenth Amendment Center regards the federal law as an unconstitutional usurpation of state sovereignty. It was Georgetown professor Randy Barnett, a darling of the conservative Federalist Society, who in 2004 argued before the Supreme Court that the federal government had no right to stop individuals from growing pot for personal use.

He lost the case, but the court's most conservative justice agreed with him. "Our federalist system, properly understood, allows California and a growing number of other States to decide for themselves how to safeguard the health and welfare of their citizens," Clarence Thomas wrote in his dissent. "If Congress can regulate this under the Commerce Clause, then it can regulate virtually anything."

Neither party is consistent on matters of federalism. But this is the rare occasion when Republicans could enlist Democrats in curbing Washington's meddling in matters that can be handled perfectly well at the state level — deploying a concept that liberals might find attractive under President Donald Trump, Senate Majority Leader Mitch McConnell and Justice Brett Kavanaugh.

Republicans might gain politically from eliminating the federal role. Taking a more moderate position on a matter that millions of people regard as no business of politicians could soften their image among independent voters. Passing an important measure with bipartisan support would demonstrate that the 2018 election results country. didn't prevent our lawmakers from getting anything useful done.

## Jp next: Gridlock

It was almost unsettling to wake up the morning after the election and realize it turned out pretty much as we expected. There were, of course, some individual surprises, but nothing on the seismic shock scale of 2016

For months, it had been expected that Democrats would win a modest House majority, and they did. The popular vote margin for the Democrats was just about right where the ScottRasmussen.com Generic Congressional Ballot projected it to be (and also about the same as the RealClearPolitics average of all election polls).

In the Senate, it had long been recognized that the Republicans were likely to gain a few seats, and they did. In the campaign's final days, there were five or six very close races where either candidate could win. But while Democrats could have won any of those individual races, the GOP was favored to win most of them. That's just what happened.

So now that we got the election we expected, where do we go from here?

The conventional wisdom suggests gridlock is coming. In that view, there's no way a Nancy Pelosi-led House will forge significant bipartisan deals with a Mitch McConnell-led Senate and President Donald Trump.

The likelihood of gridlock is very high, but I'm not sure how much it matters. Over the past two years, the Republican-led House also struggled to reach agreement with the Senate and the president. Other than the tax cut and repeal of the Obamacare mandate, little was accomplished in the

But the lack of legislation does not mean a lack of impact. The Trump Administration did take some modest steps to reduce the regulatory burden. That accomplishment seems especially significant because it followed decades of enormous regulatory growth.

The deregulatory effort is almost certain to continue. Among other things, there will be an ongoing effort to give Americans a greater degree of control over the health insurance they purchase. Lower-cost insurance that doesn't cover every imaginable procedure may be frowned upon by bureaucrats in Washington, but they are welcomed by millions who have to buy their own insurance.

Additionally, with an increased Senate majority, the president will find it easier to confirm judges who are skeptical of an all-powerful federal government. That's especially true because the Republican Senate victories in 2018 make them early favorites to retain control of the Senate in 2020. If there is another Supreme Court nomination in the coming years, the confirmation will be a lot smoother with a bigger Republican majority.

For their part, the Democrats are likely to launch many investigations of the president. But they will feel an ongoing tension between a progressive base demanding impeachment and more moderate Democrats fearful of offending centrist voters. That tension will carry over to issues like health care, where progressives dream of banning private insurance companies and forcing all Americans into a government-run health care system. The moderates recognize that such a plan is not popular with the rest of the

So, over the next two years, we're likely to experience gridlock. But that doesn't mean a lack of action. Instead, we'll see deregulation and judicial appointments from Republicans. And Democrats will try to resolve their party's inner tension before the 2020 presidential election.



#### Paging Dr. Frischer...

While enjoying a bowl of cereal I noticed something suspicious floating in the bowl. Of course, that was the end of that bowl of cereal; I tossed it down the drain. It was probably nothing, but it got me wondering: what in the world was in there?



Nobody wants to find insect parts, rat hairs, mouse poop or maggots in their food. However, the Food and Drug Administration allows low levels of those unsavory items to be present in our food. In fact, the FDA considers this to be natural and unavoidable.

Most of us have never heard of the FDA Defect Levels Handbook. This is (I hope!) the most disgusting government publication in existence.

For more than 100 food items, from allspice to wheat flour, this booklet spells out the maximum allowable levels of "defects" that are permissible before the agency considers the food to be unacceptable. It actually spells out just how much mold, rot, parasites, bugs, and other contaminants are allowed in our food.

The handbook puts it this way: "The FDA set these action levels because it is economically impractical to grow, harvest or process raw products that are totally free of nonhazardous, naturally occurring, unavoidable defects."

Given the large amount of food that is produced daily in the United States, it is unrealistic to think that some outside materials won't

make their way into the finished product. When grain is harvested, it is inevitable that there will be a bug in there somewhere. After field with the broccoli. The limit is 60 creatures per 100 grams - or harvest, when it is being processed at a factory, or being stored, or in transit, there might be a mouse, and therefore...mouse poop. These "defects" exist in the environment where foods come from, and it is just impractical and too expensive to remove every little bit if it does not actually pose a threat to our health.

If it's at all reassuring, do note that food-processing systems are far cleaner, more effective and more efficient than ever before.

The motivation for setting limits is to utilize this inevitable contamination as an indicator of whether there is something dangerously wrong. One mouse hair in food will not harm us, but many hairs may be evidence of an infestation at the factory. Along with an infestation may be bacteria, viruses, or other harmful microorganisms.

Consider these examples of FDA limits:

· A 16-ounce box of pasta may contain no more than nine rodent

· Perhaps there are dark specks in your cornmeal. Maybe they're just cornmeal, but the FDA's action levels do allow for up to 13 fragments" of rodent excreta in a 24-ounce container.

• The government permits three maggots in a 28-ounce can of tomatoes.

· A 16-ounce jar of peanut butter may contain up to 136 insect fragments and four rodent hairs.

· Beer drinkers take note: there is a limit of 2,500 aphids for every 10 grams of hops.

· Tiny bugs such as aphids, thrips, or mites may come in from the 204 in a 12-ounce bag of frozen broccoli.

6% of potato chips may contain rot. However, only 5% of prunes can be moldy, decomposed, or insect-infested.

15 ounces of golden raisins may contain no more than 40 milligrams of sand and grit...as well as 65 fly eggs.

Mushrooms can contain up to 20 maggots per can.

· The cranberry sauce accompanying your Thanksgiving turkey may contain an average of 15% mold filaments.

Honestly, after perusing this FDA handbook, I thought twice about ever eating again. These imperfections sound disgusting.

The good news is that the FDA reassures us that these allowable imperfections present no health hazards. Although the FDA has established these acceptable defect levels, and can take action if a food exceeds those levels, the amounts actually found are much lower. In fact, most food companies set their own quality standards at far stricter levels than these FDA limits.

Note that today's column does not address intrinsically harmful food contaminants such as pesticides, metals or environmental chemicals, but "merely" defects in food quality. Keep this in mind as you consume your next grasshopper leg.

# **Duncan Hines** cake mix recalled

Four types of Duncan Hines cake mix are being recalled after they were found to contain a possible salmonella contamination, according to the Food and Drug Administration.

Duncan Hines Classic Yellow Cake mix with best if used by dates of March 9, 10, 12, and 13, 2019 and the UPC code 644209307494.

Duncan Hines Classic Butter Golden Cake mix with best if used by dates of March 7, 8, and 9, 2019 and the UPC code 644209307593.

Duncan Hines Classic Confetti Cake mix with best if used by dates of March 12, and 13, 2019 and the UPC code 644209414550.

Consumers are advised not to consume the mix and return it to where they bought it.

"Several of the individuals reported consuming a cake mix at some point prior to becoming ill, and some may have also consumed these products raw and not baked," the FDA said. "Consumers are reminded not to consume any raw batter."





# Downey's pumpkin patch is a labor of love

DOWNEY - Four-thirty on Hallowe'en afternoon and the October sky is still bright blue and clear. The littlest trick and treaters are beginning their rounds early and only a few parking places were open at the Barbara Riley Senior Center at Apollo Park, even though the event out back didn't start until

Every year the Downey Optimist Club sponsors the Pumpkin Patch, a festivity hosted in Apollo Park by the Department of Parks and Recreation, and every year thousands of Downey families take advantage of the safe surroundings and balmy evening to bring their children to a completely free Halloween celebration complete with hot dogs, soft drinks, cotton candy, popcorn and ribbon-prizes for the costume parade. All ages invited.

The Optimists bring the hot dogs and members of the Humanitarian Club at Warren High School at Warren join with the ladies of the Downey Soroptimist to wrap over 4,000 dogs in bright aluminum foil. Jackie Pardo, Humanitarian advisor when she isn't teaching Spanish at Warren, says there are about 125 members, "and about 80 are here right now."

Other activities the high school teenagers enjoy are assisting at Rancho Los Amigos National Rehabilitation Center at Christmas. During the year they help at the Rancho Foundation's annual black-tie Amistad Ball. Today they're stuffing bags with popcorn, handing out the condiments for the hot dogs and making sure there is a constant supply of sugar for the cotton

Members of Soroptimst, which stands for "best for women," fill the buns and wrap them into shiny aluminum foil packages, and then they go over to work the judging stand for the costume parade, which goes on all evening.

But it is the Optimists, led by Sam Mathis, and the Warren High School Humanitarian Club, who are the heart and soul of the

That's as it should be, because the emphasis of Optimist is on children and youth. Optimist was founded in 1919, and now numbers over 80,000 members here and in 30 countries abroad. What makes Optimists different from other service clubs is that they also bring to the world an attitude, which is spelled out in the creed, "talking health, happiness and prosperity to every person you meet."

"You can spread a positive attitude," Optimists believe, "by making all your friends feel that there is something in them." By looking at the sunny side of everything, you can make your optimism come true.

Former mayor of Downey Meredith Perkins is an example of a man who always has a smile on his face.

That smile can work wonders: Meredith once successfully acted as auctioneer for the Downey Symphonic Society, and got the bid for the Conductor's Baton up to a record high at the annual April Concert. Meredith is hard

Organizer of this event is Sam Mathis, who has been working at the Pumpkin Patch for 40 years. "It was here already when I got here," Sam said, and we used just the kitchen and the auditorium then. Now we fix 4,200 hot dogs, and use 100 pounds of sugar to make the cotton candy.

After sampling a hot dog warm and delicious – and locating an elusive Pepsi Cola among the soft drinks, we moved on to see the activity in the park. The costume parade was just starting, and for nearly an hour the stage was filled only with babies and toddlers and their parents, who walked them on stage or carried them, often dressed to match.

Soroptimist judges quickly decided the winner as each batch cab. They handed out candy of 20 or so lined up on stage.

The emcee made everyone happy by describing the costumes as contestants posed. Spider Man in his trademark crouch was a popular one, and there were robots, mermaids, princesses, and human infants in Dalmatian puppy PJ's.

One first prize ribbon went to a labor of love, a baby nestled inside a big box made to look like a reality TV show in progress. A few "Scream" masks were seen, but there was less gore and wounded this year, and more super-heroes and heroines in the line-ups.

Wonder Woman in her red, blue and gold with golden armbands came in every age and size, including grown-ups. An appropriate costume for Super-Moms, who carry the purse, family supply bag, emergency treats, the baby, somebody else's popcorn and hoodies for when it

As the sky deepened to a pinkstreaked sunset, 3-5 year olds could march unassisted on stage. There were glamorous witches, Minnie Mouses in puffy red satin skirts with big white polka dots, matching bows in their hair and little snub noses, and a scarecrow girl with straw coming out of her cuffs. Astronauts in space suits

and helmets shared the stage and posed for pictures with the with imaginative home-made outfits like twins with signs "Peanut Butter" and "Jam.

Lucky to be here in Southern California with another dry and balmy evening coming on. No one had to cover their costume with a sweater or coat, but other parts of the United States are getting flooded with rain or chilled by an early snow.

It's hard to pick a "best of all" treat, but the Downey Fire Department's tallest piece of equipment drew all eyes, a 100ft. long aerial extension ladder that pointed up to the stars. Attached to a ladder fire truck, the ladder is used to support a hose to pour water into fires in tall buildings, and also as an observation post.

Firefighter Raul Ochoa told us he had been with Downey Fire Department for 29 years. There are four personnel here with the equipment," he said, "the engineer, who drives the truck; the captain; a firefighter, and myself, the tillerman. We're on call right now. If a fire breaks

At the caricature booth, a Red Riding Hood posed with her shepherd-mix dog who was dressed very convincingly as the Big Bad Wolf, in granny glasses and a pink apron. The family pet sat patiently for the double

Costumes are an ancient part of the Halloween traditions, which go back to the bonfires early people used to light in autumn, a sort of wishful imitative magic to try to make the sun come back. Ghosts and cobwebs represent the mortality mirrored in the weakening year.

"Guising," as it was called, has become one of the most delightful aspect of a ritual that has now been taken over though dressing like good - or evil -spirits would drive away bad spirits. Today some costumes are still spooky and creepy, but there were enough super-heroes and wonder women to chase away the boogie men.




