Teachers upend school board meeting over fate of Sussman, Carpenter

Facing declining enrollment, DUSD considers closing making Sussman Middle School a magnet secondary school and Carpenter Elementary a dual immersion campus.

Teachers and parents are protesting the idea.

DOWNEY - The strike may be in Los Angeles, but that didn't mean that Downey Unified School turmoil this week.

The usually quiet and calm Grace E. Horney Board Room resembled more of a gladiator's

arena on Tuesday as a platoon of concerned teachers and parents packed into the School Board's regularly scheduled meeting.

Despite the crowd, the School Board attempted to operate as usual. However, the agenda's final two items - the potential reprogramming of Carpenter Elementary to a Dual Immersion / International Baccalaureate (IB) school and the possible change of Sussman Middle School to an IB / Early College magnet secondary school for grades six through 12 - sat like a giant elephant in the

Almost as if she anticipated District was free from its own a long and hard evening, Board Nancy President Swenson addressed the crowd before the board received presentations on the controversial agenda items.

"I want to take a moment for school year. any of the Downey Unified family members that felt disrespected with the process we have been using to roll out the information regarding the potential changes,' said Swenson. "Everything being considered has been heard during our monthly meetings, and tonight the process continues... even though more ideas and possibilities will be discussed tonight, no changes will take effect until it is approved by a vote

potential Both changes come at a time when DUSD is battling a statewide trend of declining enrollment. According to information presented at Tuesday's meeting, enrollment in DUSD has dropped from around 23,000 students in the 12/13 school year to about 22,000 in the 18/19

of the Board at a later date.'

"Enrollment is a long-term challenge; it's not going to be something that all of a sudden goes away," said Superintendent Dr. John Garcia.

Because of this trend, DUSD has scrambled to come up with ways to retain and attract students to the district, including the two controversial proposals.

More than the fate of Carpenter, most in attendance seemed disenfranchised with the idea of the seemingly impending closure of Sussman. Should the Board decided to move forward with the conversion of the middle school, they would have to decide

Bill would ban untrained teachers from low-income schools

Teacher trainees do students a disservice at Title 1 campuses, says Assembly member Cristina Garcia.

DOWNEY -Legislation that would prohibit untrained teacher trainees from teaching in low income schools was introduced by Assemblywoman Cristina Garcia (D-Bell Gardens) on Wednesday.

The bill, AB 221, seeks to prevent additional education disparities that

persist in Title 1 (low income) funded schools and are often exacerbated by poor educator training and retention seen with trainee's placed through Teach America (TFA), Garcia said.

"Title 1 funded school kids already face multiple disadvantages because of their ethnicity, zip code and socioeconomic status, that are further compounded when you have an inexperienced educator in the classroom," said Garcia, who taught math at the high school and college level prior to being elected to the Assembly.

"I've been that new teacher. I've seen how my own inabilities affected my students. And I saw how much my skillset and effectiveness changed once I had received the proper training and got a mentor.

"We must remove barriers to quality education for our most vulnerable students and not add problems that contribute to our achievement gap and create systemic inequities that follow kids their entire lives.

California's achievement gap, particularly with students of color, is well documented and historic particularly in math and science. Although the state has made attempts to closing the gap, policies and resources have struggled to close it significantly with vulnerable populations.

New standards and strategies, such as requiring better educator training and preparation, have proven effective and practical at creating a foundation that creates an equitable education system for all of California's children.

According to Garcia, Teach for America trainees lack crucial training before entering a classroom, receiving only five weeks of training before entering the classroom and do not need to have a degree in education.

traditional teacher credentialing programs, hopeful educators take two years to complete their educational training and serve as a student teacher for another year before entering the classroom as its sole instructor as a credentialed

Further, more than 50 percent of TFA trainee's leave after two years and 80 percent leave after three years creating

Filmmaker Julian Park stays humble

The Downey filmmaker is working to turn his hobby into a career.

DOWNEY - Julian Park isn't a filmmaker. At least, that's what he will tell you.

It's funny that he would say that, however, once you learn his new short film debuted recently at the InFocus Short Film Festival in Van Nuys.

The short film, called Invincible Boy, is described by Park as "all that childhood energy and imagination encapsulated in a short film." If many of the locations in the film seem familiar, that's because they are.

"I grew up here. My family moved here when I was 5," said

Park. "It's my hometown...when I did this film this year, I was like I got to pay homage to Downey. I set the film in Downey, we shot it here.'

"It's about remaining a child and holding onto that childlike wonder that you can do things, whatever you want in the world Your dreams or whatever," said

Park describes himself as a "hobbyist." While his passion is in film making, it is not his main career right now.

"For me, I was always obsessed with stories. I was a TV kid growing up," said Park. "Certain films changed my mind and really showed me that it's probably one of the highest artforms because it combines everything - acting, drama, writing, photography -

OPEN LETTER TO LEGISLATORS

By Pedro Galvez

Pedro Galvez is the brother of Downey police officer Ricky Galvez, who was shot and killed in a botched robbery attempt

Pedro wrote this open letter to legislators after one of Ricky's admitted killers was sentenced to juvenile detention, where he will serve no more than 5 years.

The letter is being published here with Pedro's permission. To Representatives of the State of California:

I am compelled to write this letter to make California residents aware of the dangerous repercussions associated with the recent passing of Senate Bill 1437 on Sept. 30, 2018 as approved by State Governor Edmund Brown. It is my intent, that it will bring forth a call to action to reverse the bill, public awareness, and provide insight into the negative impact that such a bill

would impose upon innocent

community residents and especially to victims' families like my own.

On Nov. 18, 2015 my brother Ricardo "Ricky" Galvez was murdered in the line of duty. Ricky was a dedicated Downey Police Officer, and also a United States Marine Veteran who served two separate tours of duty while serving our country. He believed in our judicial system and risked his life daily to protect the innocent and defenseless. Senate Bill 1437 now presents an opportunity for those charged

with Ricky's murder to receive no punishment for the intentional murder they were all involved in on Nov. 18. Existing law defines first

degree murder, as all murder

that is committed in the perpetration of, or the attempt to perpetrate, specified felonies, which include but are not limited to, arson, rape, carjacking, robbery, burglary, mayhem, and kidnapping. The penalty for such crime

retention problems for the most vulnerable schools and their students.

California has also struggled with a teacher shortage for decades. The answer to addressing that shortage and closing the gap in low-income schools is not placing untrained educators in them. The solution must be increased support for our teacher workforce, adequate compensation and to populate our low-income schools with trained teachers.

"We can't use our kids' classrooms as training grounds when we know it has long-lasting and detrimental effects on a child's future," added Garcia. "Experience is necessary. Proper training is necessary. That's why California mandated a year of student teaching prior to credentialing our public school teachers. This is not a profession where one can just learn on the job without significant repercussions.

"And we certainly shouldn't be allowing it with our most vulnerable students who are already dealing with systemic challenges entirely outside their

The purpose of Title I designation is to address systemic educational challenges facing high-poverty communities by providing more resources to school districts and schools with the highest concentrations of

state's goals for high quality education will be undermined if it continues to supplement an inadequate teacher supply with underprepared teachers who leave the profession at very high rates," said Garcia.

documentaries, and now I'm going more into narrative; I'm taking it more seriously as a hobby. I want to pursue it as a career, but I still have to have a day job...I kind of came at it afterwards, after I started my career. I have a day job that has nothing to do with filmmaking. "Just to get paid to do that and have a sustainable career. To make a living off of it," said Park. 'I think that's what everyone dreams of doing, to do what they love for their work so you don't have to work a day in your life."

"I don't want to be crazy successful. I just want to continue to make my work...anybody that makes art or wants to tell a story, ultimately, they want as many people to see it as possible. That's really what it is.'





whether to make the transition at a gradual or accelerated rate.

At a gradual rate, Sussman would remain open during construction between the 19/20 school year to the 21/22 school year, while simultaneously moving the current crop of students through their normal projection and phasing into the new grade format.

Under an accelerated transition, the school would close for construction during the 2019/20 school year, and reopen in 20/21 with grades six and nine before growing to grade 12 throughout the next several

In both scenarios, the new programs would officially begin in the 20/21 school year.

there Currently, approximately 1200 students at Sussman. In the case of an accelerated approach, the district would be forced to find a place for each of those students divided equally amongst Griffiths, Doty, and Stauffer schools. According to Assistant Superintendent Roger Brossmer – who was giving the presentation - that would bring in this relationship for the sake each of those schools up to around 1700 students.

of death is imprisonment in state prison for life without the possibility of parole, or imprisonment in state prison for a term of 25 years to life. Existing laws stipulates 2nd degree murder imposes the penalty of imprisonment in state prison for the terms of 15 years



The left, the wall, and the truth

Democrats and others on the left offer three reasons for their opposition to building a wall on America's southern border.

- 1. A wall is ineffective.
- 2. A wall is too expensive.
- 3. A wall is immoral.

Each one is false, so false as to constitute lies. So, the only question is: Do Democrats and others on the left believe these lies?

This question has plagued me all my life. Leftism is built on lies — and has been since Lenin. That's why he named the Communist Party's lying newspaper "Pravda" ("truth").

Did my left-wing professors at Columbia University really believe the United States and the Soviet Union were equally responsible for the Cold War? Did they really believe one of the most genocidal regimes in history — which butchered tens of millions its own people, starved as many as 4 million Ukrainians, enslaved seven Eastern European countries under totalitarian rule and created the monstrous North Korean communist regime — was no more responsible for the Cold War than the United States, the freest country in human history?

Did my left-wing professors really believe men and women are the same except for body parts? And do today's leftists really believe human beings with double X chromosomes, a vagina, a uterus, ovaries, menstrual periods and lactating breasts are not necessarily female?

Do leftists really believe American universities constitute "rape cultures"? If so, why does any left-wing parent send his or her child to college? Would you send your daughter to a place you believe is permeated by rape?

Do leftists really believe that the statement "There is only one race: the human race" is a racist statement? That is the official position of the University of California.

Do leftists really believe that virtually every criticism of former President Barack Obama emanated from racism, that all opposition to lowering college admission standards for blacks is racist, that all attacks on George Soros are anti-Semitic?

If leftists believe any of the above, let alone all of it, they are deluded people. And the existence of tens of millions of deluded people in a society can only portend catastrophe. If leftists do not believe those claims, they are not deluded; they lie for effect and, therefore, engage in evil. The existence of tens of millions of people consciously committed to lying means society has little hope.

Now to the wall.

Do leftists believe the country cannot afford \$5.7 billion? As the Democrats have approved \$1.3 billion for border security, the difference is about one-tenth of 1 percent of U.S. federal spending (\$4.5 trillion). Democrats and the rest of the left make this argument. Yet they are the very people who, for more than half a century, have successfully pushed for unprecedented expansion of government spending; the very people who are overwhelmingly responsible for local, state and federal government debts of such magnitude that they cannot be paid without massive decreases in spending and the likely social disruption they entail. It is not possible these people believe America cannot afford to pay for a wall. They are, therefore, lying when they claim the price tag is too high.

California Democrats have allocated some \$77 billion to pay for a high-speed train between San Francisco and Los Angeles that will be ready in 2033 at the earliest. It will undoubtedly rise to more than a hundred billion dollars. And, thanks to the left and the Democrats, California is spending this money despite being an estimated \$2 trillion in debt (between debt and pensions).

The left says a wall (or steel barrier) would be "ineffective" at preventing illegal immigration. We know it doesn't believe this, because just five years ago, Speaker Nancy Pelosi supported a bill that required the construction of 700 miles of border fencing. And Sen. Chuck Schumer was one among the "Gang of Eight" Republicans and Democrats who also supported 700 miles of fencing at the border. Every Senate Democrat voted for the Gang of Eight Bill, including 36 Democrats who serve in the Senate today.

Do Schumer and Pelosi and all these other Democrats regard fencing as effective but a wall as ineffective? Do Democrats deny that Israel's barrier has virtually ended Palestinian terrorism? Do they believe Turkey's just-built 500-mile wall across nearly its entire border with Syria will be ineffective? Do they know about the effective walls/barriers between the Turkish- and Greek-controlled areas in Cyprus; between Hungary and Serbia and Croatia; Morocco and Algeria; India and Pakistan; and elsewhere?

As for the Democrats and others on the left declaring a wall "immoral," it is difficult to know which is preferable: that they are living in delusion or lying. On what grounds is it "immoral"? They never say.

Is there a Democrat or leftist who regards walls or other physical barriers surrounding homes or communities as immoral? One doubts it. For one thing, many of them live behind a physical barrier. So, then, why isn't a physical barrier that protects America equally moral? The only possible answers are that these people don't really regard America as their home or they are lying about a wall being immoral.

So why all the lies?

Because lies are effective in achieving left-wing goals. There are people in every political, social and religious group who lie. And there are people within every one of those groups who are truth tellers. But — and this is a "but" whose significance cannot be overstated — while truth is a liberal value and truth is a conservative value, truth has never been a leftist value. For the left, there is always something more important. In this case, it is the humiliation of the president of the United States.

A national emergency might backfire

If you can't stop someone from doing something you dislike, you can always hope he or she will eventually overdo it. Icarus fell out of the sky not because he flew but because he disregarded a warning not to get too close to the sun.

Donald Trump may not be familiar with the lesson of that story. He has raised the real possibility that, denied funds by Congress to build his border wall, he will declare a national emergency to do it anyway. On Thursday, he said, "If this doesn't work out, probably I will do it. I would almost say definitely."

It would represent new heights of chutzpah, even for the modern presidency and even for Trump. And it might be enough to cause some Republicans on Capitol Hill to rise up in rebellion — lest this tactic become a weapon for a Democratic president pursuing liberal ends without the consent of Congress.

It would probably not be illegal, though, thanks to a 1976 statute called the National Emergencies Act. "If President Trump wishes to state that the border is in a state of disarray or exposure such that it constitutes a national emergency under the NEA, he is pretty much free to do so," writes University of Texas law professor Robert Chesney on the website Lawfare.

The "national emergency" option sounds like something to be deployed only rarely and in exceptionally dire circumstances — such as 9/11 or a huge natural disaster. In fact, it's gotten to be as unusual as corn dogs at a county fair.

In the NEA, Congress gave the president considerable authority but placed firm restrictions on it, with the intention of keeping its use to a minimum. Things didn't work out as planned. The Brennan Center for Justice reports that 58 separate emergencies have been declared, and 30 remain in effect — several of which date back to the 20th century. Congress is supposed to regularly review each use of the law, but it never has.

That's not all. There are 123 laws granting the president emergency powers. What was supposed to be a last resort in urgent crises is now rolled out whenever it suits the convenience of the White House, and what was supposed to be temporary is often permanent.

The danger to Trump is not so much that he would be blocked by the courts on the ground that using this power to build a wall would be exceeding his legal authority. It's that his declaration might

finally induce Congress to break its habit of tamely submitting to the whims of whoever occupies the Oval Office.

Congress was not supposed to be a junior partner in governing. James Madison, the chief architect of the Constitution, wrote, "In republican government, the legislative authority necessarily predominates." Under our system, "the executive magistracy is carefully limited, both in the extent and the duration of its power."

That's why the power of the purse was placed with Congress. Presidents are not supposed to be able to spend a nickel without legislative action. Madison feared that if anything, Congress would grow too powerful.

He shouldn't have worried. Lawmakers have found that with power comes responsibility, so they've chosen, repeatedly, to surrender both to the executive branch.

Partisan solidarity is one big reason. The Framers expected each branch to jealously guard its prerogatives and repel any encroachment by the others. In our time, though, members of Congress are usually more devoted to advancing the interests of their parties than of their institution.

Only when the opposition party controls one or both houses can the president expect to be rebuffed on important issues — as in the case of Trump's wall, which the Democratic House refuses to approve. Even Republicans who sometimes deplore his methods and disagree with his policies seldom vote against him.

But if Trump undertakes to spend \$5.7 billion that lawmakers have denied him, some GOP members could rebel. If a Republican president can use this trick to build a border wall, a Democratic successor might use it for some nefarious left-wing purposes. Rep. Matt Gaetz, R-Fla., said, "I don't want the next national emergency to be that some Democrat president says we have to build transgender bathrooms in every elementary school in America." And if Trump were to use it for this project, he would soon think of others.

Congress has frequently abdicated authority to presidents on the hope that it would be handled wisely. Thanks to Trump, members may finally realize that the only sure method to prevent emergency powers from being abused is to take them away.

The illogic of 'assault weapon' bans

Since 1996, Gallup has been asking Americans whether they support a ban on "assault weapons." Gallup has never explained what "assault weapons" are, and there's a good reason for that: The category is defined by politicians, so its meaning is arbitrary, mutable and illogical.

Last week, Sen. Dianne Feinstein, D-Calif., who wrote the federal "assault weapon" ban that was enacted in 1994 and expired in 2004, introduced her latest attempt to reinstate and expand it. Her bill bans "205 military-style assault weapons" by name, along with any rifle that "accepts a detachable ammunition magazine and has one or more military characteristics," such as "a pistol grip, a forward grip, a barrel shroud, a threaded barrel or a folding or telescoping stock."

The 1994 definition required two "military characteristics" instead of just one, and the list was different. Back then, Feinstein said nothing about barrel shrouds, but she was worried about bayonet mounts, which she is now willing to allow.

Now, as then, however, features that do not make a gun any more deadly in the hands of a mass shooter or an ordinary criminal, such as a folding stock or a threaded barrel, nevertheless transform it into an intolerable "assault weapon." Compounding the craziness, Feinstein's new bill also targets products that reverse this magic by removing the features that offend her.

The California company Thordsen Customs, for example, sells a kit that replaces an adjustable stock and pistol grip on a rifle that would otherwise qualify as a prohibited "assault weapon" in some states. Feinstein claims "Thordsen-type grips and stocks" are "designed to evade a ban on assault weapons," which is a bizarre way of looking at it.

"We are complying with the ban," says Alan Thordsen, the founder and CEO of Thordsen Customs. "If there's a feature that is banned, we change the feature. That's not evading. That's not skirting the law or violating the spirit of the law. We are conforming with the law and creating products that enable law-abiding people to keep their legal firearms in a

legal configuration so that they are not criminals."

By Feinstein's logic, smooth rifle barrels should be banned because they can replace threaded barrels, changing a prohibited "assault weapon" into a legal gun. The problem here is not sneaky entrepreneurs like Thordsen, but irrational legislators like Feinstein. Thordsen's real offense, one suspects, is highlighting the silliness of legislation like Feinstein's.

An "assault weapon" ban that just took effect in Boulder, Colorado, cuts Feinstein's list of "military characteristics" in half, focusing on pistol grips, adjustable stocks and "any protruding grip or other device" that "allow(s) the weapon to be stabilized with the non-trigger hand." Unlike Feinstein, it seems, Boulder's gun controllers are not afraid of barrels with shrouds or


A ballot initiative that took effect this month in Washington goes in a different direction. While the state's ban applies only to adults younger than 21, it defines "semiautomatic assault rifles" so broadly that the category includes all semiautomatic rifles.


The seven states with general bans on "assault weapons" define them more narrowly than Washington, but the criteria vary. New York, like Feinstein circa 1994, cannot abide bayonet mounts, for example, but California, which enacted the nation's first "assault weapon" ban in 1989, is OK with them.

Once you realize that "assault weapons" are in the eye of the beholder, it's hard to take seriously the extravagant promises of legislators who want to ban them. Feinstein claims her bill would "put a stop to mass shootings." Yet, even if it eliminated the millions of "assault weapons" that Americans already own (something it does not even purport to do), would-be mass shooters would still have plenty of equally lethal alternatives.

After three decades of this nonsense, Americans may be starting to wise up. According to Gallup, support for legislation like Feinstein's fell from a peak of 59 percent in 2000 to 40 percent last year.








The Downey service group held her Downey predecessor, Kevin a workshop last week, teaching parents how to fight against child predators.

ain? Nothing stops Soroptimists. At 10 a m, a poncho-clad young woman stood in the rain by the Downey Adult School driveway entrance, with a colorful sign, "Soroptimist

Another smiling volunteer waited further down, to say "Thanks for coming," making sure everyone was greeted and shepherded into the First Annual Human Trafficking Awareness Forum. What's rain? "We are Soroptimists," a sign read. "What's your superpower?"

Inside, the woman's touch was apparent in the bouquets of blue Dutch iris and yellow roses on the platform on speaker's tables, and in the festive pillars of blue and gold balloons topped with a big neon blue S. Coffee and cookies were offered by Lazy Dog and Butter Cakes, and signs adorned with "Soroptimist - Best for Women," left no question who was sponsoring this first annual event, and why.

Seen in the audience, front row, were Martha Medford Sodetani, governing member of Board of Education for the Downey Unified School District, and Gigi Perez-Saab, newest member elected to that body and former president of Downey Soroptimist. Supporters also included Dorothy Pemberton, longtime Soroptimist and presently coordinator of PTA Helps, and former Mayor of Downey Fernando Vasquez.

And the Romeo pimp turns into a Gorilla pimp, when they threaten the girls with exposure to their families, if they don't do just as they're told. These are kids who are sneaking out at night, if they haven't already run away.

Not a common crime? One in every three middle-schoolers and one in nine high-schoolers were found to have been solicited by traffickers, a Florida study found. Boys as well as girls.

And what was ironic but not funny was that now I understood a strange email I had received recently, saying "We know what you did, looking at those web sites. And we're going to tell, if you don't follow our instructions." I had ignored it, but now I see I should have copied it and the sender's address and sent it to the Hot Line. If you have a computer or a cell phone, they can get to you.

Teens are the "front line" in the war on sex trafficking. That is to say, they are the cannon fodder, as in front line troops who are consumed by the struggle for possession. Soroptimist International want to raise awareness, that this is righthere-and-now-crime.

The teen years have been romanticized for hundreds of years as a time of self- doubt, wandering and "angst." This moodiness makes teen-agers easy prey for offers of love and understanding from an invisible stranger they may first meet in a chat room on-line. Adult traffickers pose as other teens, or slightly older glamorous figures. But when the youngster, often emotionally abused at home, runs away to find "love and understanding," they are physically branded, like cattle or slaves, mutilated with facial tattoos and scars, to show they "belong" to someone else.

HOW CAN A PARENT TELL? Two major red flags are airline tickets, and second cell phone follow-up calls. Parents need to know what their kids are seeing with their cell phones. "My child doesn't have a cell phone." Oh yes they do - a stranger "gives" them one at school, and they are

The victim may look and act normal, but if you see something suspicious, such as age-inappropriate clothes on a youngster, SAY SOMETHING.

"IF YOU SEE IT, SAY IT," was the mantra of all the speakers. Susan, representing the SoCal Faith Coalition Against Human Trafficking, was followed by Detective Raymond Bercini, of the Los Angeles County Sheriff's "And these two women sitting Los Angeles Regional Human Trafficking Task Force

> Are men being supportive? Absolutely. Prominent on the wall was a poster, "Men Standing Against Human Trafficking.' Detective Raymond was proof that this fight is everyone's.

> Human trafficking deals with slavery, which is defined as one

and domestic servant slavery, but the big money is in sex. Human trafficking is a successful business model,

and people are making a lot of money out of it. It is estimated to be a \$150 billion a-year global industry, Detective Raymond said. People are making a lot of money by moving commodities - the bodies of these teens and preteens - some girls as young as 7 have been found.

The average age of sex trafficking victims is 11 to 14 years old. California has a particularly high human trafficking rate compared to the rest of the nation.

"We now have a victim-centered approach," Detective Raymond said, "and that is a new way of looking at this problem." A minor cannot be considered a prostitute legally, because a minor cannot legally consent to sex. So the perpetrator, the criminal, is the trafficker, and the youngster is the victim.

This approach was echoed by the Honorable Diane Reyes, who has presided in juvenile courts since the 1990's. "There is a judge in Compton, Judge Catherine Pratt," said Diane, "who pioneered this approach." They call it the Star Court, and all underage prostitutes who are brought before her are treated as rescued victims. "The first thing Judge Pratt says to a girl brought in to her court is 'I'm so glad you've

Alert readers of The Downey Patriot will remember this reporter's interview with Judge Pratt on April 4, 2018.

"If you see something suspicious, say something," said Judge Diane.

This was emphatically echoed by speaker Mary David, Esquire, who represents Journey Out, a private non-profit organization. She and Cherise Charleswell spoke passionately. "Come forward," said Natasha Smith of SI Downey. This is not just about poor people. Or foster children. This goes across all backgrounds.

"Not my child," A mother will say. But yes. Her child has most Department Crime Stoppers and likely been approached, maybe exposed to blandishments. And many will give in. "Many victims are loyal to their pimp," said Cherise. "Anyone can be a victim"

service by force, threat or fraud. mimicking real life to show children how they can be tricked. Providing students with awareness can minimize the success of trafficking tactics succeeding.

> In order to avert children from being exploited for labor or sex, Assembly Bill 1227 (Bonta) is proposed right now to require California public schools to offer education on human trafficking identification. Teaching teachers and administrators can help provide the tools necessary to know when a child is at risk of being trafficked.

> We need this greater awareness and education. We also need to work collaboratively with law enforcement, our schools, healthcare, houses of worship and community organizations to combat this epidemic. Human Trafficking is today's modern

> California hotels have just begun to institute Human Trafficking Awareness Training for all their employees, as mandated by a bill signed by outgoing Governor Jerry Brown. By 2020, employees who are likely to come in contact with victims will receive at least twenty minutes of training. They are told to be aware of inappropriate age pairing in clientele, or unhappy girls left alone in rooms.

> Fast food places, where the girls may be taken for a "treat" are taught to recognize symptoms. And airline personnel. And then what? "IF YOU SEE SOMETHING, CALL." Soroptimist members held up giant signs with this number: 1-888-539-2372. IF YOU SEE IT - SAY IT.

> "This is why we come together," said Cecelia in closing the session. "Women come together to work together."

> By the end of the session, the sky had cleared. Raising consciousness was the purpose of this First Annual Forum and members of the audience were ready to march north to Downey High and then back again, wearing Awareness ribbons provided by Soroptimist International of Montebello. DOWNEY - The Downey High School wrestling team defeated cross-town rival Warren at Downey last week 33-33, via criteria decision.

\$35M in tax savings still unclaimed by homeowners

LOS ANGELES - More than This is how it works: This a new water heater or installing \$35 million worth of property tax exemption reduces a property's new sprinklers. I encourage every savings go unclaimed each year by eligible homeowners in L.A. County.

In an effort to raise awareness among the estimated 435,000 homeowners who likely qualify for the savings, Los Angeles County Assessor Jeffrey Prang along with the Board of Supervisors have declared the month of January Homeowners' Exemption Awareness Month.

"It is not surprising that the savings program goes unnoticed as homeowners usually only contact the Office when they are buying or selling their property. Being that they are already inundated with paperwork, our application can easily get lost in the shuffle," said

taxable assessed value by \$7,000, resulting in a \$70 savings on the annual tax bill. Homeowners need only apply once in order to receive the savings each year or until a change in ownership is recorded. The only eligibility requirement is that the property is the owners' principal place of residence as of January 1st.

"We estimate that one in three families do not take advantage of saving \$70 each year, totaling almost \$1,000 over the average of homeownership. This savings can potentially go towards investing in easy home improvements such as, purchasing

new sprinklers. I encourage every homeowner to apply," said Prang.

In addition to County efforts, Assessor Prang is partnering with local cities to facilitate similar outreach, focusing on those with the highest percentage of unclaimed exemptions. In the City of Palmdale for example, 14,095 likely eligible homeowners have not filed, leaving just under \$1 million in unclaimed exemptions.
