### **DUSD** begins recruiting for magnet school

The Board of Education has yet to approve plans for a controversial new magnet school, but Downey Unified is already accepting applications.

District officials say an early start is necessary to avoid student poaching by neighboring school districts.

DOWNEY -While the Downey Unified Board of Education still deliberates on the fate of two schools, DUSD has already started taking applications for a dual language academic program.

A new link on DUSD's website homepage is offering information and the opportunity to apply for a new Global Language Academies of Downey (G.L.A.D.) program.

According to PR Coordinator Ashley Greaney, parents were surveyed in October 2017 in regards to Prop 58 specifically asking if they would be interested in a bilingual program in Downey Unified. Of the more than 650 parents who responded, 70 percent said that they would be interested in this type of program, with 89 percent saying they would select Spanish as the target language, Greaney

staff with a questionnaire, to which nearly after one of the accused suspects 500 staff members provided feedback which trended to an interest in dual immersion programs.

"Although no location has been finalized, these two factors in combination with the Community Meetings at the elementary level in December, solidified this interest to the point that we felt comfortable moving forward with knowing we intended to begin a Dual Immersion program with the idea of starting in August of 2019," Greaney wrote in an email.

"Since the Dual Immersion program continues to be well received, we do anticipate the Board will give final approval of a location in February and we will be able to actually begin the program in August as projected.

"Knowing we needed to act quickly before other districts started poaching our TK-K students, we began to advertise and accept applications for a projected implementation for the 2019-2020 school year.

submission period opened Jan. 7 and will continue through Feb. 15.

This comes at a time where the school district has been embroiled in controversy surrounding its potential plans for Sussman Middle School and Carpenter Elementary. While nothing has been approved as of yet, there have been discussions about the conversion of Carpenter to a dual immersion school and the possible closure, conversion, and reopening of Sussman to a six through 12 magnet school.

As it currently stands, Carpenter Elementary is the recommended location to house this program should it pass.



# Police officers speak out against new law

SB 1437, signed into law by Jerry Brown last year, is blamed for a light sentence against one of Ricky Galvez's attackers.

**DOWNEY** - Downey police officers and other officials took to City Hall on Tuesday, taking a stand against Senate Bill 1437 in the wake of a disappointing sentence to one of the Ricardo "Ricky" Galvez murder defendants.

Galvez, a Downey officer, was killed in 2015.

The wound is still extremely esh for the Galvez family and In addition, the district many of the deceased's friends, loved ones, and fellow officers in the murder case - 20-year-old Abel Diaz – was remanded back to juvenile hall where it is believed he will serve a maximum of five years for his crimes.

> disappointedly light sentence is widely believed to be the fault of Senate Bill 1437, which was signed in September of last year by then Gov. Jerry Brown. Under SB 1437, prosecutors' ability to use the "felony murder rule" to charge accomplices with homicide is now more limited.

At a recent council meeting, Mayor Rick Rodriguez asked for staff to come up with a resolution against the legislation. However, on Tuesday it was several officers and local officials who spoke up and took a stand.

The first to speak was Scott state Sen. Bob Archuleta, who said the murder of Ricky were part of a

that he had spoken with police officials earlier in the day and asked to be kept updated on any progress concerning the Ricky Galvez murder trials.

"I have spoken with the Senator about it, I did give them a copy of the letter that [Galvez's] brother submitted," said Collins.

Ralph Diaz, a police officer and president of the Downey Police Officers Association, was next, and said that there were several other associations that were "up in arms" over SB 1437

"With Senate Bill 1437, the accomplice liability for felony murder, a juvenile in Ricky's murder case is going to be released possibly by the age of 25 or even earlier," said Diaz. "I'm a police officer and I understand the consequences of putting on my uniform every day; I understand I may not return home one day. I Collins, field representative for accept that fate. gang, robbing people at gunpoint with reckless indifference. They accepted and understood the consequences of that lifestyle, and they should also accept their fate and remain behind bars for the rest of their life.'

Police Captain Mark McDaniel also spoke, representing members of the Downey Police Management Association, for which he currently serves as president.

"As law enforcement professionals, my members and took an oath to uphold the law. It's important. It's in our DNA to speak up when there's injustice, to be the voice for those who have

been victimized," said McDaniel. "We take this responsibility very seriously, and we will always protect our community and the residents that we proudly serve every day. We will always speak up for the truth, justice, and the rule of law, period.

Between 10:30 pm and 2:30 am, officers worked the downtown area. During that time, officers issued two (2) Municipal Code citations for drinking in public, and one (1) traffic citation.

At 11:15 pm, officers responded to Telegraph and Passons regarding a hit and run traffic accident. Officers discovered that an intoxicated 29-year-old male victim from Downey was standing in the street when he was struck by a black truck which was traveling eastbound Telegraph Rd. The victim was treated at a local area hospital for non-life threatening wounds. Detectives arrested the suspect in Ventura County without incident and he was booked for attempt homicide.

At 10 am, officers were dispatched to 10300 block of Lakewood Blvd. in regards to two burglaries that occurred earlier. Officers determined that the suspect(s) had pried open the rear door of a business located at 10311 1/2 Lakewood and took \$30 in coins from inside. The suspects then cut a hole in the wall and entered the business located next door.. The suspect(s) removed \$50,000 in merchandise from inside and fled the location. Detectives are investigating.

# Downey attorney charged with drug trafficking

**DOWNEY** - A Downey attorney was arrested last week on federal drug trafficking charges after she allegedly sold oxycodone pills online.

Jackie Ferrari, 36, was arrested late Friday by a federal law enforcement task force. Ferrari is a Downey resident and had recently started working at a Beverly Hills law firm, officials said.

The criminal complaint filed Jan. 15 and unsealed Tuesday specifically charges Ferrari with one count of distributing a controlled substance.

According to the complaint, an informant with a long history of purchasing narcotics from Ferrari made a buy earlier this month in which Ferrari sold the informant 50 oxycodone pills for \$1,200.

The investigation into Ferrari began after a 22-year-old woman died in August of a fentanyl overdose, and text messages on her phone initially indicated she may have purchased the drugs from Ferrari.

While investigators do not currently believe that Ferrari sold the narcotics that led to the overdose death, they have continued to investigate her "based on evidence...that she is a large-scale trafficker in opiates via the website Craigslist," according to an affidavit in support of the criminal complaint.

The affidavit also notes that two local police departments developed information about Ferrari's alleged drug trafficking activities in late 2017.

Ferrari allegedly advertised the narcotics on Craigslist using coded names such as "roxy dolls" (i.e., Roxicodone, a short-acting version of oxycodone), "black rice" (black tar heroin), and "Chinese white rice" (powdered heroin that is often mixed with fentanyl).

If convicted as charged, Ferrari faces a maximum sentence of 20 years in federal prison.

### Paging Dr. Frischer...

Roughly 32 million pounds of antibiotics are given to animals that we then consume each year.

It started back in the 1940s, when it became clear that animals given low-dose antibiotics gained weight

more quickly. But it's been in the last 20 years that antibiotic use has really skyrocketed, and recently, some 70% of all antibiotics sold in this country have been for use in food-producing animals. For these animals, low dose antibiotics promote faster growth, treat infections, reduce death rates and improve reproduction.

However, the FDA has several concerns. Does this antibiotic use contribute to the rise of resistant "superbugs?" Just as antibiotics are used to promote weight gain in food animals, might they also be contributing to obesity in humans? Do antibiotics in our food animals affect our intestinal microbiomes? Are antibiotics being overused?

chickens, and then cattle. Notable levels are also found in farmed shrimp and fish. Surprisingly, even organic vegetables may contain antibiotics, because some 75% of antibiotics fed to livestock are excreted into manure that ends up fertilizing our fields.

Do antibiotics given to animals affect our weight? Many types of bacteria in our gut help our body to absorb calories from food. If these bacteria are not in balance, and too many of them break our food down into energy, we may be absorbing more calories from the same amount of food. Interestingly, obese people do indeed have a different mix of gut bacteria than do lean people. In fact, research has shown that transplanting fecal matter of obese mice into thin mice actually does lead to weight gain among the thin mice. However, any data correlating the use of antibiotics to human obesity is very

The science is clear (and it's more than obvious!) that diet and lifestyle is a factor in obesity, but this does not fully explain our country's obesity epidemic. We do in fact consume more calories today than in the past. Today's average daily consumption of 3,900 calories can be compared to 3,400 calories in the early 1900s. Yet while obesity increased very slowly until the middle of the 1970s, it

One large change has been the ever-increasing levels of antibiotics in our food and water. Our obesity epidemic may in fact be partly due

The animals given the highest levels of antibiotics are pigs, then to "super size me" trends, partly due to consuming antibiotics that affect calorie absorption, and partly due to other factors. Clearly, more research is needed.

> What is the solution? Right now in the United States, the FDA has asked the food industry to voluntarily phase out antibiotic use. If you're concerned about this, look for organic meat from animals that have been raised without the use of antibiotics. The demand for these food products has increased drastically over the past few years. The food labels will read: "No Antibiotics", or "Raised Without Antibiotics".

> Choose restaurants that have pledged not to use meat or seafood with antibiotics. Shop at markets (like Whole Foods) that are committed to selling meat with no antibiotics. Costco has tightened its standards for the use of antibiotics in the meat and poultry it sells. You may choose to look for other sources of protein and adopt a plant-based diet.

> Until more studies are conducted, we simply cannot be certain whether eating antibiotic-treated foods are bad for us.

through twelfth grade magnet school in the 2020-2021 school year and no action will be taken on Jan. 29, 2019, and subsequently no vote will be made in February.

For the remainder of the year, staff will continue to engage stakeholders in the decision-making process through meetings, community forums and the creation of advisory groups in an effort to identify additional strategies to assist Downey Unified in combating the foreseeable decline in enrollment.

"The stakeholder feedback has been very clear that they were in favor of a revised timeline that would provide more opportunities for all stakeholders to explore additional ideas that would benefit

our district's secondary students," stated Roger Brossmer, Assistant Superintendent of Secondary Education.

"After this input, slowing things down and keeping Sussman Middle School status quo will be included in next Tuesday's presentation and no action will be

"With this revision, we will continue our research with the help of advisory groups knowing this collaborative effort will help us find the best direction to move the district forward in the coming years to help mitigate the negative impacts of our projected decline in enrollment."

Presentations were made to the Board of Education beginning in November regarding the proposed changes at the elementary level

and in December regarding the potential secondary changes. At those meetings Board members directed district staff to schedule meetings to gather stakeholder feedback and answer questions.

Monthly Regular Board of Education meetings are held at 5 p.m. in the Board Room at the district office.

A previously scheduled Special Board meeting will also be held on Tuesday, Jan. 29th, 2019, at 5:30 p.m., with an alternate location of the Downey High School Theater (11040 Brookshire Ave., Downey) to provide a larger venue.

The next Regular Board of Education meeting is scheduled on Tuesday, Feb. 19, 2019, at 5 p.m. at the district office.

"I was in court a month ago when Abel Diaz admitted to the murder of Ricky," McDaniel added. "How in the world can Mr. Diaz be released out into our community in the next few years?"

McDaniel described SB 1437 as "dangerous."

"SB 1437 eliminates murder liability for certain individuals that participate in felony acts," he continued. "In the murder of Ricky and the subsequent prosecution and guilty plea of Mr. Diaz, there is

no doubt this new law played a huge role in Mr. Diaz's criminal case in juvenile court... This new law is retroactive, and has the potential to release convicted murderers back into the community.

"This is not a partisan issue. This is not Democrat or Republican...this is what is right and what's wrong. It's about the rule of law, it's about justice. We have to get this fixed and make our community safer."

Mario Guerra - who serves as a chaplain with the Downey Police Department - rounded out the evening's speakers.

"Last month, just a few days before Christmas, we saw another injustice perpetrated upon the family of Ricky Galvez, because of the new law SB 1437," said Guerra. "As a clergy, I believe in forgiveness, but I also believe in justice. Ricky's family, our police department, his friends, our community have not received justice. It's actually the reverse because of SB 1437.

It is anticipated that city staff will present a resolution against SB 1437 to the City Council in the next couple of weeks.

# The Supreme Court just ended my military career

On Tuesday, the Supreme Court ruled, 5-4, that the Trump administration could reinstate its policy barring most transgender people from serving in the military while several cases challenging the policy are being decided. The decision was both a devastating blow to me personally, and a disturbing sign of what is to come for transgender people in the United States.

I graduated from the United States Naval Academy in 1997, and was on active duty for over a decade. When I began transitioning in 2010, I transferred from the Naval Reserves, which I had joined in 2008, to the Individual Ready Reserves, an administrative status that allows service members to deal with medical issues before returning to full duty. By spring 2012, I had resolved the "issues" at my own expense, and was ready to return to full duty — in my case, as a Navy helicopter pilot.

The problem was that at the time, the military's medical regulations prohibited transgender people from serving. I then set off on years of volunteer work on my own time researching transgender military issues. This included educational outreach, research, policy development and coordinating with the Pentagon to build an evidence-based standard for transgender service, based on the lessons learned from the other 18 countries that allow transgender people to serve.

In 2015, the Department of Defense stopped discharging people for being transgender and began the open and transparent process of researching how to institute an inclusive policy. This included an assessment of the costs, in terms of both money and readiness, of integrating transgender troops. Researchers found both impacts to be negligible.

By 2016, a policy was in place for transgender people already serving. Two years later, the military put in place a process for new recruits, officer candidates and people on inactive status like myself. The day after that, I contacted my recruiter to begin the process of rejoining the military.

Over the past year, I've had countless medical and psychological exams in my quest to return to the job I was trained to do: flying Blackhawk helicopters. This involved a lot of time off work and considerable travel, all at my own expense. At every turn, the people examining me reached the same conclusion: I was "aeromedically adapted" — fit to fly — and able to return to the service. There was, finally, a chance that I might be able finish my career after 16 good years of service.

I was hoping against hope, throughout this process, that I'd be able to join my friends who had fought alongside me for the right to serve openly. Nearly every week I would see pictures of them in Syria, Iraq and Afghanistan. It gave me a thrill in December to see a picture of four of them together at Bagram Air Base in Afghanistan. One was an airborne ranger, and one was Special Forces.

All of this makes the administration's dogged attempt to undo everything achieved over the last few years even more baffling. The ban was developed in secret, without the sort of careful study that went into the policy it reversed. It does not reflect any current medical understanding of transgender people, and it has been denounced by the American Medical Association, the American Psychological Association and the American Psychiatric Association.

No one, including the lawyers for the Trump administration, has been able to show that inclusion of transgender service members or providing care to them has had any measurable negative impact on morale, readiness or unit cohesion. The chiefs of staff of all four service branches of the military have testified to Congress that there have been no issues.

The Supreme Court decision isn't about me, though. It isn't even about the dozens of people I advised to follow a path back to service similar to mine. It is about what this means for transgender people in the United States as a whole.

While it is true that the high court's decision is not final — and that, in fact, it may have had more to do with lower court injunctions against Mr. Trump's policy, rather than the policy itself — the signal it sends is clear. The cruel pointlessness of the president's policy, which had led to the injunctions, was not pressing enough to move the court's five conservative justices.

Their decision signals a weakening of any shelter transgender people might find under the Equal Protection Clause of the 14th Amendment. The court is saying that government discrimination based not on evidence, but solely on animus against transgender people, is permissible.

trying to find a way to serve my country in uniform again. The court also rejected the administration's request for a quick hearing on the ban itself, which means at least another year of waiting. By then I will have likely aged out of my eligibility.

If this were through some failing of mine, I could accept it.

For me, however, it probably marks the end of almost 10 years of

But it speaks volumes about where we are as a country that the opportunity for many to serve should be denied by the prejudices of a few.

### More self-inflicted presidential legal woes

Last week, the investigative arm of BuzzFeed sparked a media frenzy with a report claiming that two federal law enforcement sources had informed its reporters that Michael Cohen, President Donald Trump's former lawyer and confidant, had told special counsel Robert Mueller that Trump counseled him to lie to Congress about the status of Trump's attempts to build Trump Tower Moscow.

The BuzzFeed piece also claimed that the sources revealed that Mueller's folks had received documentary evidence from Cohen to back up his allegations.

The reason for the media frenzy was the realization by House Democrats that counseling someone to lie to a tribunal constitutes the crime of subornation of perjury and, if the tribunal is engaged in a legitimate investigation, the crime of obstruction of justice — and both of those crimes are impeachable offenses.

After the BuzzFeed piece had stirred the pot of media interest and Democrats' lust for Trump's political scalp, Mueller issued a very rare one-liner stating that the references in the BuzzFeed piece to what he had received from Cohen were "not accurate."

So, did Mueller's use of "not accurate" mean that Cohen did not, in fact, tell Mueller that the president of the United States had counseled him to lie under oath, or did it mean that Cohen made the allegation that Trump had counseled him to lie but Cohen did not, in fact, give Mueller any corroborating evidence of his allegation? Here is the back story.

In addition to tax evasion and bank fraud, Michael Cohen pleaded guilty late last year to lying to Congress. Cohen lied under oath when he told congressional investigators that Trump's efforts to build Trump Tower Moscow ceased in January 2016 — because, according to Cohen, they actually ceased in June 2016. Cohen said he lied because Trump had asked him to do so and because Cohen wanted his testimony to be consistent with Trump's public campaign

narrative that he had no business dealings in Russia.

The BuzzFeed saga is not all black-and-white and has been exacerbated considerably by the president's public-facing lawyer, Rudolph Giuliani. We know that Mueller's PR person knew of the BuzzFeed piece days in advance and had numerous texts and emails with the BuzzFeed reporters. He did not discourage its publication or challenge its conclusions until 24 hours after publication. We know that neither Cohen nor his lawyers challenged the accuracy of the BuzzFeed piece.

We also know that Giuliani actually went beyond the BuzzFeed allegations. He explained to a reporter for The New Yorker that Mueller has not claimed that the Cohen allegation that President Trump counseled Cohen to lie was inaccurate; rather, the inaccurate statement in the BuzzFeed piece was its reference to the existence of texts and emails corroborating what BuzzFeed claims Trump told Cohen.

Giuliani also told the New Yorker reporter that Trump did, in fact, speak with Cohen about his testimony in advance of it. Do you think Trump told Cohen to tell the truth? That's what the New Yorker reporter asked Giuliani. Giuliani said he knows that Trump did not counsel Cohen to lie because he listened to the tapes. Tapes? What tapes? There are tapes of the Trump-Cohen conversations about Cohen's intended congressional testimony?

Then Giuliani said he misspoke. There are tapes — Cohen infamously recorded his conversations with his most famous client — but not about this. Giuliani then said he had examined emails and text messages and other documentary evidence and he had not found any that corroborated Cohen's claims; so that's what Giuliani says Mueller said was not accurate in the BuzzFeed article. "There is no corroboration that the president told him to lie."

By narrowing the application of "not accurate," by admitting Trump spoke to Cohen about his testimony in advance of it, by suggesting that there are tapes of Trump and Cohen discussing Cohen's testimony but then saying he misspoke, and by stating that the Trump Organization was negotiating with Russian officials for Trump Tower Moscow up to the date of Trump's election and then saying that that was just "a hypothetical," Giuliani has reinforced his own image and the image of his client as being unconcerned with the truth

Giuliani may be overly histrionic, but he is not stupid — though his legacy as a prosecutor and mayor is unraveling. My guess is he knows that Mueller has much evidence of a criminal conspiracy to receive something of value (the Hillary Clinton emails) between the Trump campaign and Russian intelligence and subtly is trying to tie Trump personally to it. Such a conspiracy would be a felony and produce criminal charges against all who were a part to the agreement. Giuliani also fears that Mueller will use the Trump-Cohen conversation as evidence of obstruction of justice by the president.

So why is Giuliani revealing all this to the media? Here's why. He is following an age-old trial lawyer practice. If the government has evidence harmful to your client, it is easier for the public and the jury to accept the harmful evidence if defense counsel reveals it first, drop by drop, rather than permit the government to release it all at once like an anvil falling into a pond.

Giuliani has told friends that from time to time during his negotiations with Mueller on Trump's potential interview by Mueller and his team, Mueller has shown a few of his cards. Stated differently, Giuliani probably knows some of the damning evidence Mueller has on his client and has chosen to leak it out slowly and even goofily to friendly audiences so that once Mueller unloads his findings, the shock will have been dulled.

Giuliani has also told friends that he has a client who is not paying him and who does not take his advice. Does any of this look good for Trump?







# What Downey was like in the 1860s

### Things You Didn't Know About Downey

By Bobbi Bruce **Downey Historical Society** 

hat were the people like during the 1860's? Practically every man carried a gun and hunting knife during the '60s. Hung by a strap from his shoulder were his powder-horn and bullet pouch. His feet were covered with heavy boots and he wore leggings to protect him from the brush while riding.

His principal weapon was a heavy, long, muzzle-loading rifle that, although it did not shoot far, was exceedingly accurate. Every boy learned to shoot as soon as he was able to carry a gun, and he began to contribute a large variety of game, which at times was a major part of the bill-of-fare.

The residents as a whole were a fine class of people, though there were among them some ruffians -- especially rough when fired by whiskey. Gangs of such men, disturbing the peace, often resulted in shootings, and it was necessary for the officers, who were inadequate for the occasion, to be assisted by civilians. Public whippings and hangings were resorted to, although I have found no record of the latter punishment in our vicinity.

The dress of these early settlers was of simple design, made of coarse durable material. Men tanned skins of animals and these were made into shoes and garments. Women made their own clothes and those of the children, largely without the aid of sewing

There were few articles upon which the settlers had to depend from the outside world. Of these, powder and lead were the most

#### History of early recreation

All down through the ages man has found some time to devote to pleasure. The ancients had their feasts; the Indians various dances and celebrations which lasted for days. The Spanish and Mexicans of the 60s called for contests in marksmanship and horsemanship, gaiety and color. Mexicans celebrated their independence from Spain by parades, with a chosen queen riding in a decorated wagon, guitar music, patriotic songs, speaking and dancing. The American and Mexican flags were carried side by side to the place where they were to congregate.

The Fourth of July and Christmas were occasions for fireworks and bull fights, which drew large crowds. In the gaily-painted corrals near the Plaza in Los Angeles, a bear sometimes faced el toro. Cockfights were another popular sport. Rodeos and races called for expensive outfits, some of them valued at thousands of dollars.

### **Economics**

In 1864, the year ushered in with a depression of currency resulting in hard times. The assessed valuation of Los Angeles County was \$2 million, and not one cent was collected within the city boundaries.

Summertime brought a greater scarcity of water; land prices dropped and crime and theft increased. While Los Angeles was not under military law at the time, it was dominated by military forces which were used when needed.

In 1865, 4,000 acres of the Domingues Ranch were sold to Temple and Gibson for 35 cents an acre. G. E. Compton paid Temple and Gibson \$5 an acre for the land on which he founded a Methodist colony in which liquor was prohibited. This was the first dry (no liquor sold) community in Los Angeles County, and later became the city of Compton.

That same year Don Vicente Lugo was forced to sell most of his estate which was part of the San Antonio Grant. Whole acres were sold for a few groceries, and people lived on one meal a day. A barrel of flour commanded \$15 and frijoles -- red beans -- brought 15 cents a pound.

The drought of 1865-66 caused a terrific loss of stock and forced Juan Temple to sell Rancho Los Alamitos -- this proved fatal to Don Abel Stearns, also of Rancho Los Alamitos, who eight months later sold to Michael Reese for \$31,000, approximately \$1.10 per acre. In 1881, the estate of Michael Reese sold the rancho to John Bixby who in turn conveyed one-third interest to J.W. Hellman and Jonathan Bixby. This information came from "Romance of the Ranchos" by Palmer Connor, published by Title Insurance and Trust Company, Los Angeles.

Pio Pico, whose ranch adjoined Rancho Santa Gertrudes on the north, lost heavily from the drought but was fortunate in having the San Gabriel River along its western boundary where settlement had begun. By 1866, James Shugg used the river water for irrigation purposes. On reaching the upland, his ditch continued south from the Santa Fe Railroad tracks to his home on Shugg's Lane (now Slauson Avenue in Pico Rivera).

The development problems were great, and moles, gophers,




squirrels, etc. constantly caused the loss of water. The ditch was abandoned in 1867.

Efforts toward a ditch and water company continued until the venture of the present route of the Arroyo Ditch, with two side ditches -- the Taylor Ditch on the west and the Stockton Ditch on







Moghaddam is president and chief executive officer of Financial Partners Credit Union, a banking institution that originally opened more than 80 years ago to serve the burgeoning aerospace industry in Downey and Southern California.

The credit union worked hand in hand with workers from North American Aviation and its later incarnations, including Rockwell

and Boeing, handling the financial needs of Downey's aerospace associates as they advanced the country's aviation and space endeavors

When the Rockwell plant closed in 1999, Financial Partners pivoted to become a more community-oriented credit union, re-establishing itself in the Downey community and reconnecting with the needs of its

Last year, Financial Partners made its most significant investment in its 80-plus year history in support of Downey specific initiatives, with 65% of its community resources dedicated to Downey schools and STEM education.

Among its contributions were donations to the Downey Foundation for Educational Opportunities, which provided bus transportation and funded scholarships that allowed kids to attend STEM camps, and a

Financial Partners hosted more than 50 financial literacy events last year, providing financial education curriculum to local high schools at no cost to the school district.

The credit union also provided support at events in partnership with the Downey Unified School District, including a "College Finance 101" workshop and help with FAFSA applications, along with the basics of saving for

Financial Partners also invested bolstering local economic development through its Partners at Work Program and bringing back its annual Gateway Cities Economic Forum, a free event for

"Having a passion for giving is part of our core commitment as a not-for-profit institution, said Moghaddam. "It's a cultural commitment that we've made and we stand behind it."

There are also privately owned charging stations around the city, including at the Promenade shopping mall, Stonewood Center, and at the Commons restaurant center at Lakewood Boulevard and Gallatin Road.

**NORWALK** - The Talon Marks's entire catalog of newspapers — 62 years' worth of stories chronicling life on the Cerritos College campus - is now online and available to the

Each print edition, from the very first publication in 1957 to the most recent issue, was scanned and made into a searchable PDF using OCR technology, school officials

The archives are available

online at talonmarks.com/ hourly Rosaura Montes. archives, where the editions are categorized by academic year.

The project was a collaborative effort between the college's Mass Communications Department and the Cerritos Pritchard. "I am proud of Alicia College Library after they both recognized a need to digitally archive the newspapers as historical documents.

The entire process took eight years to complete. Each newspaper had to be prepared for scanning and then digitally processed for public use.

Alicia Edquist, instructional lab technician I for the department, headed project, with assistance from former Talon Marks adviser Rich Cameron and former adult

"The Talon Marks Digital Newspaper Project is vital in preserving the history of our college," said Fine Arts and Communications Dean Gary Edquist and the tremendous effort that went into digitizing 62 years of Talon Marks. I hope everyone is as excited as I am to search the archives."

The idea for a digital archive came about in 2010, when the newspaper archives in the library were damaged by a leaky

"Being able to preserve our campus history was a priority for us when we began this project," said Edquist.

According to Edquist, the student newspaper receives multiple requests for archives each year.
