Prominent attorney killed in plane crash

Felipe Plascencia was a wellknown DUI attorney in Downey and Whittier. He and two others died in a plane crash.

DOWNEY Prominent attornev Felipe Plascencia perished in an airplane crash in the Tehachapi Mountains last week at the age of 53.

The La Habra Heights resident 21. was returning from a court

appearance San Luis Obispo when the twin engine Beechcraft he in went down. In addition Plascencia, and the pilot,

Plascencia was a well respected trial attorney and political activist. Plascencia was nationally regarded as as an expert in driving under the influence cases and he was frequently asked to lecture on the subject to both the legal community and members of law enforcement.

Plascencia was born in Tepatitlan, Jalisco, Mexico in 1965. He immigrated to Santa Ana, California at the age of seven with his parents Rafael Plascencia, Maria Guadalupe Plascencia and three brothers and a sister. Plascencia attended Los Amigos High School in Fountain Valley and while at Los Amigos he distinguished himself academically.

Plascencia matriculated California State University Fullerton where he obtained a Bachelor's degree in Psychology. While at CSUF, Plascencia actively participated in student organizations to advocate on behalf of Latino and other minority students. It was in college that Plascencia met and married his sweetheart, Yolanda Brito Plascencia who attended Santa Ana College.

In 1990 Loyola Law School admitted Plascencia and he continued to be active in politics focusing on issues that impacted the working poor and underserved immigrant communities. Upon graduation from Loyola Law School in 1993, Plascencia remained a loyal alumnus and regularly donated his time and money to the institution.

Prior to opening his own practice, Plascencia served as a Los Angeles County Deputy Public Defender, and a Deputy City Attorney for the City of Compton. A graduate of the Gerry Spence Trial Lawyer's College, Plascencia regularly lectured on trial techniques and often mentored law students and new lawyers.

In 2009 he was recognized as the Attorney of the Year by the Mexican American Bar Association, and he was introduced by then Los Angeles County District Attorney Steve Cooley.

Plascencia remained active in California politics and was President of the Mexican American Bar Association Political Action Committee from 2005 to present. During his presidency Plascencia raised the visibility of MABAPAC in Los Angeles county and Sacramento.

Plascencia, a lifelong Democrat, encouraged MABAPAC Plascencia, lifelong to endorse the candidates they felt would best serve the community regardless of political affiliation.

Plascencia is survived by his wife Yolanda, and his daughters Magali and Alena. Additionally he is survived by his father Rafael and his siblings Ramon, Rosa, Moises, Rafael, Joseph, and Erika.

Robert Cormack, former two-time Downey mayor, dies at 99

Friends and family remember Robert Cormack as a straightshooter, gentleman, and proud American.

DOWNEY - Former Downey mayor Robert Cormack has died. He was 99.

Cormack passed away on Feb

Longtime residents of Downey may remember Cormack from when he served as mayor during two separate terms, from July 1983 to July 1984, and July 1988 to June 1989. He was also a past Downey school board member and involved with the Downey Historical Society.

Former mayor David Gafin described Cormack as "a wonderful guy."

"I didn't work with him a lot because he served a few years before me," said Gafin. "He was the old school type of councilman: stalwart, a gentleman, and an upright, honest person. He always carried himself very well. The city will sorely miss him.'

Cormack carried a strong pride of Downey throughout his life, according to his daughter, Sharon

"Downey was the town he loved," she said. "He was very involved with the city, making sure the residents were taken care of right, and that they were going to keep the historical part of the city as well."

Cormack was also patriotic, having volunteered for the army in WW II. He served as a welder, and spent some time in Germany.

Leon says that he was an "All-American man."

"He loved the red, white and blue hats. He had a flag everyday flying, and it was put away by dark; if it was raining it wasn't out there," said Leon. "Every day till the end, he would put up an American flag.'

Cormack was also a faithful

"He always had a bible in his car, next to his chair," said Leon. "He read the Bible; that was his favorite book."

She also describes Cormack as "the most positive man you will

"Being a religious person,

I just think he knew what life was about,' said Leon. "He tried so desperately to keep people focused on good things in life...we were very blessed to have him as a part of our family. We were blessed beyond anything I could ever

Cormack married his first wife Louise at the age of 18, and remained married for 56 years until her passing. They had three sons - Robert, Harold, and Steven - who have all preceded him in death.

Cormack met his second wife, Faith, at the First Baptist Church of Downey, and married her after a very quick courtship. They were married 26 years.

However, upon entering this already established family, he didn't leave the warmest of impressions.

'When he became part of our family...he was kind of a stuffy man," said Leon. It was his newfound

grandchildren that softened him

"To watch him grow into a role of a grandfather was unbelievable," said Leon. "I watched him turn from this very stout man into this gentle, loving soul; and what a role model he was to our kids."

Police union sues to force destruction of records

DOWNEY - The union representing Downey police officers has filed a lawsuit asking a judge to force the city into destroying old records of officers' misdeeds, the Long Beach Post reported.

The lawsuit comes after the passage of a new state law, Senate Bill 1421, that requires police departments to release records related to The Downey campus has been

The Long Beach Post sought 10 years of police officer records but the police officers' union sued to stop their release, arguing the files would do "irreparable injury and damage" to officers.

The lawsuit is asking a judge to order the city of Downey to destroy files more than five years old in accordance with the city's own policy.

Downey city attorney Yvette Garcia told the Post that the city's policy sets a minimum standard, not a deadline, of when documents should be

"It doesn't say you have to do it within five days or 10 days after the expiration date," she told the Post.

SB 1421 mandates disclosure of police discipline records in certain situations, including when an officer was dishonest or sexually assaulted a member of the public. It also requires police to turn over records about serious uses of force.

According to the Post, the police officers' union filed the lawsuit Feb. 28 after learning the city had records of at least one officer being dishonest that it intended to release.

That disciplinary case was from May 2013, when the city's insurer agreed to pay \$4.5 million to settle a lawsuit about a man who was mistaken for a suspect and fatally shot in the back by an officer.

"We are honored to have received this recognition," said Doty's Principal Brent Shubin. "Our staff and students have worked very hard to make Doty Middle School a place where students can thrive.'

Doty Middle School joins last year's National Schools to Watch designees, Griffiths and Stauffer middle schools.



Congress and the White House are heading for a collision course. Who will win?

With the 116th Congress up and running, President Trump is facing meaningful congressional oversight for the first time. On Monday, the House Judiciary Committee embarked on a major investigative mission, sending letters to 81 witnesses seeking documents and testimony relating to possible "obstruction of justice, public corruption and other abuses of power" by Mr. Trump and his administration.

But the White House shows no signs of rolling over. It has indicated for months that it is prepared to assert the president's executive privilege to keep congressional investigators from gathering information about Mr. Trump — including his conversations with high-

Will the White House be able to use executive privilege to successfully block investigators from getting information? When executive privilege and congressional oversight collide, who wins?

This is a complex question that federal courts, and perhaps ultimately the Supreme Court, may have to answer. If congressional investigators want to prevail, it is crucial that they keep in mind the likelihood of those court battles — and that they understand the terms on which those battles will be fought — as they proceed with their

The Constitution mentions neither congressional oversight nor executive privilege. But it is now well settled that both exist. In 1927, the Supreme Court held that each house of Congress had the power "to compel a private individual to appear before it or one of its committees and give testimony needed to enable it efficiently to exercise a legislative function belonging to it under the Constitution."

And in 1974, in United States v. Nixon, the Supreme Court confirmed the existence of a constitutionally grounded executive privilege that shields, among other things, certain communications with the president. In that case, however, the court also ruled that the privilege was not absolute and did not shield Richard Nixon's White House tape recordings from being released to the special prosecutor in the Watergate investigation.

Does this mean that Mr. Trump's communications are fair game? It is hard to say. The case of the Nixon tapes involved a judicial subpoena issued in connection with a criminal trial, not a congressional investigation. Some have argued — as Attorney General Bill Barr did, during his previous stint as attorney general, in the George H.W. Bush administration — that executive privilege is at least as strong if not stronger against congressional demands for information.

One reason there is so little clarity on this question is that the courts have not had a chance to tell us. To a remarkable extent, the courts have been silent bystanders during the frequent disputes between Congress and the executive over access to information. That is because negotiation and accommodation have long led to the resolution of these disputes outside of the courts. A give-and-take between the two political branches of government usually results in congressional requests being narrowed but ultimately complied with. Each side scores some wins and suffers some losses, and a meaningful if limited investigation occurs.

Under ordinary circumstances, the process of accommodation would start now. But this process is grounded in informal norms, such as the expectation that the political branches will proceed in good faith and with mutual acceptance of their respective roles in our constitutional system.

The Trump White House, unfortunately, has shown little interest in respecting such norms. The prospect of a negotiated resolution thus seems unlikely. House committees, if faced with refusals from President Trump's advisers to testify or turn over documents, are likely to issue subpoenas and seek to enforce them in court through contempt

If that happens, the courts will have to reconcile Congress's need for information with the president's need for confidentiality in his communications with advisers and when it comes to information that might implicate national security or international relations. There is no simple formula for that. In the context of the Trump investigation, then, it will matter a great deal how congressional investigators frame and perform their oversight function. Excessively broad requests might erode congressional credibility, as might requests that duplicate or overlap those of other committees, or that seek information already public or in the hands of other congressional investigators.

As this phase of congressional scrutiny begins in earnest, investigators should not only pursue their inquiries with vigilance but also keep an eye trained on the prospect of a judicial resolution of their clashes with the executive branch. Otherwise they risk losing more than particular battles with the executive branch; they jeopardize the long-term prospects of holding the president accountable.

My brother saved my life

It was my brother who saved my life.

"Get to a hospital now," he insisted over the long-distance line. "You're having a stroke."

I had just flown to Hong Kong to run an important conference and I was tempted to dismiss this big-brother, over-the-phone diagnosis (even though my brother, Jeff, is, in fact, a doctor).

I was only 49 years old, I was healthy and had none of the conditions like high blood pressure that might predict a stroke.

I imagine this is what the actor Luke Perry thought when the paramedics first reached him. A stroke? No way. Only old people get those. Mr. Perry, famous for his role in "Beverly Hills, 90210," was just 52 when he died in the aftermath of that stroke on Monday.

I'd assumed that what was happening to me was just another of my many migraines, made only slightly weirder by a slight tingle on the side of my mouth and hand, as well as very temporary dysphasia, which made my words garbled.

That morning I'd been working on a story about yet another management crisis at Yahoo. "What a goat rodeo," I had said out loud, which came out "Grrxxxx gghrtt jjjtrws." Then, when I went to eat a strawberry, it slowly dropped from the side of my useless mouth, leaving a stain first on my shirt and then on the carpet of the luxury hotel room I had just checked into.

I stared at the stain — which was a bright and beautiful red — and instead of being concerned about my numb lip, I ran to get a towel to clean up the mess. Then, as I had often done when I had a sore throat or some other minor ailment, I texted Jeff the symptoms.

By the time I'd showered and headed to the restaurant for breakfast, the symptoms were largely gone. So when Jeff called to say I was having a stroke, I think I laughed and said, "You're a bad doctor."

Besides, I had Yahoo's Jerry Yang coming to the conference, I had

Alibaba's Jack Ma coming, I had Al Gore coming. I had no time. That much was very true. Because he was actually a very good doctor, he insisted in an increasingly urgent tone that I go to the hospital right then. That's because when it comes to strokes, time is critical. You have to get the blood flowing back to the part of the brain that is not getting it.

So I listened, for once, sidelining the obstreperous little sister, and took a car to get an emergency M.R.I.

There it was on the screen: evidence of a transient ischemic attack, often called a mini-stroke. Like the strawberry stain, it was also riveting to look at with its garish neon glow, from the angry yellow clot to the stream of red blood worming its way around it to the multicolored brain of mine full of so many ideas but also just a hunk of misfiring flesh.

As it turned out, there was a lot of that, including a small hole in my heart through which the clot traveled, as well as me having a type of blood that is more prone to clotting. All of it, combined with not hydrating or walking around enough on the long flight to Hong Kong, created what the doctor, who immediately started the treatment of anticoagulant drugs and others, called a "hole in one."

That was a good joke at a bad time. It's funny the things you remember at the critical times of your life. Like the extraordinarily bright whiteness of the surgical mask of that doctor, who also told me that had I not moved faster it would have been so much worse.

"You might have lost your abilities," he said from somewhere from behind the mask. "You might have died."

It was only then that I cried, and only because of my sons, then 6 and 9. My own father had died suddenly when I was 5. He, too, had a brain issue, but it was a more lethal one — an aneurysm that burst without warning on a sunny winter morning over 50 years ago. While he lingered for a short time, he was no longer himself. That was that and that was the rest of our lives.

And that is why the idea of death — the absolute nearness of it has been ever-present for me. Since my dad died, I have lived my life as if I had no time at all or very little, making the kinds of choices of someone who knew that tomorrow might indeed be her last.

That was the thrust of a major speech at Stanford University in 2005 by the Apple founder and tech visionary Steve Jobs:

For the past 33 years, I have looked in the mirror every morning and

asked myself: "If today were the last day of my life, would I want to do what I am about to do today?" And whenever the answer has been no for too many days in a row, I know I need to change something.

Remembering that I'll be dead soon is the most important tool I've ever encountered to help me make the big choices in life. Because almost everything — all external expectations, all pride, all fear of embarrassment or failure — these things just fall away in the face of death, leaving only what is truly important. Remembering that you are going to die is the best way I know to avoid the trap of thinking you have something to lose. You are already naked. There is no reason not to follow your heart.

It was an unusually emotional speech from someone who was widely thought to have no heart. But, actually, I have always thought that the problem with Mr. Jobs was that he had too much heart, because he seemed to always grok that the end was always nigh. Sometimes that urgency manifested itself in inspiration, sometimes in meanness, sometimes in humor, sometimes in seriousness. But it was always urgent.

When he died on Oct. 5, 2011, I read and reread that speech to keep it in my own heart, too. That was a good thing, because my own stroke came only a few days later. I had both the privilege to live more days and the awareness that those days would be limited.

If you want to analyze my motivations for being known as pretty tough on the people I cover when they inevitably mess up, it has its roots there. Basically, you all don't have the time to be so careless in what you do and I don't have the time to not ask you about it.

You get this kind of nudge again and again from death. It is, as the Buddhist teacher Frank Ostaseski noted, "a secret teacher hiding in

Luke Perry's death was yet another lesson from that teacher. Like many, I was a major fan of "90210" in its glory days and gave over so much of my precious time — every second worth it — to watching and then discussing the foibles of the kids of West Beverly Hills High. That definitely included the fantastic brooding of Mr. Perry's Dylan McKay, who was given to saying things like, "The only person you can trust in this world is yourself."

Well, I guess, but not if you are lucky enough to have a brother who saved your life.

To show that, hoaxer and mathematician James Lindsay says, "We rewrote a section of 'Mein Kampf' as intersectional feminism' and got it published in Affilia: Journal of Women and Social Work.

For another paper, they claimed to have "closely" examined genitals of 10,000 dogs in dog parks to learn about "rape culture and

queer performativity."

Boghossian had assumed, "There's no way they're gonna believe that we did this!"

But the journal Gender, Place & Culture did, calling the paper "excellent scholarship."

Seven journals accepted the absurd papers, as I show in my latest video

Hoaxers Boghossian, Lindsay and Areo Magazine editor Helen Pluckrose explain the reason for their trick.

"We think studying topics like gender, race and sexuality is worthwhile and getting it right is extremely important," says Lindsay

"Think about if you did this to civil engineers with bridge building," says Boghossian. "They would've thanked us, right? Because they're driving over the bridges with their families, so they don't want the

But the journal editors, instead of admitting that they sometimes publish nonsense, attacked the hoaxers. They accused them of doing "unethical research."

A dozen of Boghossian's colleagues at Portland State University criticized him anonymously in the school newspaper, which depicted him as a clown. He's become a pariah at his own school.

"I've been spat on ... physically threatened," he says.

Instead of applauding him for exposing nonsense, Portland State threatened him.

I called the school asking for an interview, but it declined.

How can a college criticize the hoaxers but revere ridiculous

journals that publish nonsense?

'When you live in these tight ecosystems, this stuff makes total sense," says Boghossian. For people in the tiny bubble of academic thinking, "there's a pervading rape culture; men are bad — the whole ball of wax.

It's been going on for some time. A physicist once submitted a nonsense paper claiming gravity is just a "social construct." The journal Social Text published it. That embarrassed the journal, but 20 years later, it is still going strong.

At universities, "scholarship" has gotten even crazier.

Individuals Succeed.'

The real "hoax" is on students who pay thousands of dollars for useless degrees in fields that end in "studies.' John Stossel is author of "No They Can't! Why Government Fails — But





Art and fine dining combine at Olive RestoBar

Who needs Beverly Hills art galleries when we have trendy Olive RestoBar in the Promenade in Downey!

Three local artists recently invited the art-loving community to sample an exhibition of their current work at the Olive. Every seat in the restaurant was filled, every table was taken. This time, the patrons came for the food, nibbling on starters like tomato crostinis and hot fresh pita bread

with green sauce. But next time they'll come for the art.

The night was balmy for February, and the small but tasteful exhibit was staged on the eastern edge of the Olive's outdoor patio seating area so diners could admire the art while they sipped their craft cocktails. Argentineborn Monica Pucciarelli's wildly fanciful females were placed side by side with Carolina Del Toro's unusual photographs of magnified objects and her husband Jorge's paintings. Look for the alligator – Carolina's says they are her

husband's hidden signature touch.

The sophisticated Mediterranean infusion ambiance of the Olive RestoBar starts with Sam, its Egyptian owner, said the Olive's Crystal, who greeted us at the door. The Bar is elaborately stocked with unusual items, even the most expensive tequila, Rey Sol Tequila, a bright orange intense color that is made from the blue agave and comes encased in its Bustamente-designed crystal decanter. More moderately priced drinks are The James Dean cocktail, like a whiskey sour, and the fruity and sweet Blackberry Mojito. Ťry Chapo y Kate, a tequila-based drink.

Downeyites in the know have been coming here since the Olive

opened, enjoying entrées like lamb shank with a mole-like sauce that pairs beautifully with the tender lamb and smooth mashed potatoes. If there's room, one can order the chocolate chip gelato and mascarpone tiramisu.

The Olive appeals to the taste buds of the palate, while the art stimulates the artist's palette, of colors. "As a little girl in Mexico," said Carolina, "I remember looking forward to the times the Indigenous people, Huichol, from my state of Nayarit, would come down from the Sierras to sell their arts and crafts. So beautiful, and very colorful!"

A small state in western Mexico, Nayarit lies between the forested mountains of the Sierra Madre Occidental and the Pacific Ocean. Just south are Matanchen Bay's surfing beaches, while north is Mexcaltitlán Island, considered the birthplace of Aztec civilization.

"Having a large family in a small town, most parents at that time would not usually encourage, nor support the arts," said Carolina, "because it was believed that art was not going to put food on the table. Though now, I get 100% support from everyone in my family, whether I sell or not!"

Carolina's favorite subject is "Mother Nature's 'paintings,'

from a small flower to a vast landscape. She posed beside a black and white photograph that looked like an abstraction but actually was the curve of a magnolia petal, many times magnified.

"Every time I look at Mother Nature colors, patterns, shapes through my lens," said Carolina, "that is when I find myself most at peace with it. And, whenever I exhibit my images, I always hope more than one viewer will feel the same."

I love talking about Jorge's amazing talent," said Carolina.

"He started ceramics while in elementary school," Carolina said. "He had a friend whose father had a ceramic shop and he remembers hardly waiting to get out of school to go "play" with clay. He says he started making miniature sculptures, like an inch or two in size."

"Now he has converted the garage into a studio, and owns about five different size kilns."

"His favorite subject is reptiles,' said Carolina, 'but he loves animals in general. Especially those in danger of extinction. In fact, most of his sculptures portray either an extinct animal, like the White Rhino, or one in danger of it. His intention is to create

conscientiousness about the beautiful creatures we share our planet with."

Jorge pointed out the hovering spirit faces in one of his paintings on display at the Olive. "They represent our ancestors and power," said Jorge. "The pyramid in the center is Mayan and it means strength."

A whirling figure centerfront in the painting captures the swastica-like shape that stood for creation for the Mayan. For the Incas and Aztecs it represented the four seasons due to its four arms, the center symbolizing the sun. Found in many Mesoamerican works of art, this motif must have circulated widely geographically. Persistence revealed to this viewer the alligator, embedded in one of the bent arms of the swastika, its scaly green tail making up the lower part and its open jaws covering the upper limb.

Two artists living together must be fun, but maybe challenging. Is Jorge sometimes late for dinner, because he is absorbed in making a project? "Yes!" says Carolina. "And, not just for dinner. There have been instances when I get ready to go someplace, and wait for him to come back from the studio."

"But, when he does a few hours later, it's only to apologize because he had forgotten while being absorbed by a new piece he had started. This, at times, was hard for me to understand," said Carolina, "but eventually, I got used to it. Because it's still happening!" She laughed.

But when Carolina gets absorbed in her own work, do they both go out for dinner? "Yes," she says. "This is happening more often than not. But, we also plan our outings specifically to talk about projects. Especially his, which absorb more time than mine."

"Jorge and I were invited to show today, by our friend and DAC board member, Patrizia Monica Pucciarelli,' said Carolina. And this exhibit is the brainchild of Pat Gil, President of the Downey Arts Coalition."

apitalizing on the popularity of "Hamilton" creator and star Lin Manuel Miranda, The Downey High School Theatre Department is in the home stretch of preparations for their upcoming performances of "In the Heights."

"In the Heights" first hit Broadway in 2008, with music and lyrics produced by Hamilton's Miranda and a book by Quiara Alegría Hudes. It went on to be nominated for 13 Tony Awards, walking away with four including Best Musical, Best Original Score, and Best Choreography.

The musical tells the story of the people living in the barrio of Washington Heights, New York, and how the neighborhood is turned on its head when one of its residents wins a \$96,000 lottery.

According to Theater Director Christopher Nelson, "In the Heights" suits the community of Downey.

"Lin Manuel literally wrote it because there's only one Broadway play for Puerto Ricans, and he wrote a play specifically for Latinos," said Nelson. "With the population I got across the street, I was excited to bring them this because they have a way to relate to it."

Of course, many of the students are also excited because of the show's ties to the recent smash-hit, cultural-phenomenon "Hamilton."

However, despite sharing the same writer and some of his stylings, the two plays could not be any more different.

"It's so different than
Hamilton," said Nelson.
"Hamilton is so dense with
historical information, whereas
this is just a character-driven,
pleasant story about life. It doesn't
go over your head at any point.
There's a lot of lyrics, but it's
about life. It's not about anything
other than what life is, the
experience we all know."

Nelson's 32-member cast is comprised of everything from freshmen to seniors, honors



academics to athletes, dancers, cheerleaders, singers, and band members. He even casted a Miss Downey Princess.

"It's a collection from everybody from the campus, which is really great," said Nelson. "It's the 22nd largest campus in the country, so it's nice to get a sampling of all 4,200 of them."

Senior Giovanni Ferreira, 17, will take center stage in the lead role of Usnavi, the owner of a small bodega and the narrator of the play.

"He grew up poor, and he obviously is affiliated with the culture of the urban, more rural part of New York City, but he also is very connected to his culture," said Ferreira. "He's very proud of being Latino; he thinks it's what connects his entire neighborhood together and makes them family even though they're not related and they come from different parts of the world."

One of the challenges with the Usnavi character is tackling many of the hip-hop and rap elements of his lyrics. If that's not enough pressure, Miranda himself originated the role.

"I didn't have a lot of hip-hop experience," said Ferreira. "I'm a big fan of Lin Manuel Miranda; I was even before I was casted as Usnavi. I've seen Hamilton, I've listened to the soundtrack many times. I've listened to In the Heights. I love his work. I look up to him "

"I know that I won't become a hip-hop master like he is...to be able to play a role that he played, it's a lot of pressure. There's a lot that I need to do."

"Everything needs to be very precise, because the way that he wrote the music, lyrics, and script are all very precise and I have to do it just right. It's a challenge but I welcome it."

Junior Angie Valenzuela, 17, will play Nina Rosario.

"She's the one who made it out of New York. Where they live in Washington Heights, they don't really have a lot of money, and none of them really got to go to college," said Valenzuela. "My character was the only one who was able to make it out of state and actually get a good education after high school. She goes to Stanford university, but it's expensive. She got a scholarship, but it doesn't pay for all the books, and there's still other expenses. She's working two jobs, her grades end up slipping, she loses her scholarship, and she has to figure out how to

tell her family when she comes back home for the family..."

Valenzuela's character will also struggle with a love interest that her family does not approve of.

According to Valenzuela, preparation for the show has required immense amounts of dedication and work hours from each cast member; almost every day for the last several months.

"Our director, he's great; he treats us like adults," said Valenzuela. "Every now and then, we forget ourselves that we have school, and classes and homework and tests to keep on track. A lot of it is time management. If time management isn't great then grades are going to go downhill and the play is going to be a disaster. Lunchtime, my friends and I, they always see me; I'm learning lines. It's all I'm doing right now: go home, do my homework, practice my songs, practice choreography, [and]

"In the Heights" will be performed from Thursday, March 21 to Saturday, March 23. Tickets are \$15 and available now on the Downey Theatre website.

Pat and her husband Gil soon arrived, as did Argentina-born artist Monica. "I loved to use colored pencils in high school, when I started to doodle on paper," Monica said. "The one person who truly inspired and encouraged me to create my very first painting on an actual canvas and made me believe in my gift, was a very good friend who is now my husband.

"He bought me a large canvas," said Monica, a self-taught artist. "And "brushes and paint. And he said 'You can create something awesome.' Ever since then, I never stopped loving to paint. It's longing engraved deep in my soul.'

Monica's pictures look like women in dreams or fantasies. Did she ever do "naturalistic" work, like photographic realism? "I have never felt attracted to naturalistic work," said Monica. "Why? I always seem to seek to paint that which does not exist in the real or modern world. There's something extremely fascinating in letting your subconscious guide your paintbrush to express itself in creating something which only exists in your soul.

"My artistic style developed over the years as I painted more and in a subconscious way. I seem to always be inspired by the Women Goddess and eras gone by. I believe this shows in my figures and colors and has obeame more and more recurrent in my work. In that respect, I think I began to develop a personal style which is even now, ever-changing slowly.

"When I start a new painting," Monica said, "I don't always have a pre-conceived idea of what I will create. Colors seem to choose themselves, but I always love the earth tones as they evoke a more timeless look or era." Her gorgeous mane of flame-colored hair accompanied her natural preferences.

"So many artists mean so much to me," said Monica, "but the one that come to mind is Gustav Klimt, my first inspiration. Inspiration also comes from my life, my past, an encounter, a moment, a shadow, a song, a story, the rain."

Several of Monica's paintings and collages stood on a wire mesh screen partition. Her work is contemporary figurative and mixed media is her preference both on canvas and paper. "I was born in Mendoza," Monica said, "a cosmopolitan city in Argentina. We have tree-lined streets, a sunny climate and excellent wines - over 500 wineries. I'm already missing our Fiesta Vendimia, the Grape Harvest Celebration.'

Argentina's malbec, a red wine in the merlot and cabernet tradition, grows successfully nowhere in the world but Cahors, France, and Mendoza, making that city now one of the Nine Wine

Capitals of the world. Monica's s parents live in Orange County but they thought the soft Downey evening air was still too cold for them to come out to a February

"The paintings that emerge from me reflect different aspects of my soul," said Monica, "each piece has its own history, its own past. Painting, it is an extension of who I am and each new piece of art is a new learning experience."

"I draw inspiration by listening to different types of music," Monica said. "seeing images by artists from the past. I seek to evoke mystery in my art. Rarely do I go into a painting with a preconceived idea. The first brush stroke takes me where I need to go;

the colors seem to choose themselves."

on the mattress and we loved to lay around and read our books in there. It felt like a clubhouse.

In the basement there was a wringer washing machine. We spent many hours playing bank and passing our play money through the wringer, passing it from one person to another. There was also a laundry shoot where the dirty clothing would be dropped from upstairs, down the shoot and into a large laundry basket.

Under the staircase, my younger sister and I would drape a blanket to cover the entrance and pretend that it was our house. We would sneak upstairs and take one of the kitchen drawers and slide it perfectly into place under the bottom stair. This would be our food locker. We'd fill it with slices of bread or cookies or what ever else we could pilfer without being noticed. Oh, that basement filled our imagination.

Our kitchen was a large room that taught is about working together. My brother and two sisters and I formed an assembly line each night and did the dinner dishes. Don would wash, Sharon would dry, she'd hand the dish off to Jan, and she'd hand it to me and I'd put it on the counter. Mom would then put it up where it belonged. I have fond memories of that time we spent together learning to work as a team.

In that same kitchen I remember bobbing for apples in a big galvanized tub. I mostly remember all the laughter in

Our dining room was a large room with shiny wooden floors. There were two built-in cabinets with glass doors on them, one on each side of the room. Mom kept all of her very special

dishes and crystal on display. We loved to look at all the pretty things behind glass and were taught that we were never allowed to open the doors.

There was a large wooden buffet along one wall that stored all the fancy dishes we used for holidays and special parties. A lovely white doily ran the length of the buffet. On top stood a big opened bible on a stand, surrounded by two large bunches of purple flowers from our yard. The whole middle of the room was filled with a huge table surrounded by twelve chairs. I can still see the giant turkey that sat in the middle, all golden

Grandma would come from the nursing home that she lived in and sit with us for all our holiday meals. I remember dad leading our prayers and giving thanks around that table.

Our living room had a big stone fireplace. We all loved to sit around and watch the fire burn as dad told stories. Mom would bath us after dinner and send us one by one out to dad on the sofa. We'd listen to the story as we waited for the next sibling to arrive in their pajamas.

Mom would take all the laces out of our shoes, scrub them and line them up on the window sill to dry for the next day. After that mom met us in the living room and combed our hair and tied it in rags or pin curls so we would all be nice and curly by morning. By the time she was done with all of that, the stories were about finished and it was time for bed.

This house has so many good memories. If the house itself could talk it would say that love lived here.


