# At Downey's library, it's the beginning of a new chapter

Customers say goodbye to the Downey City Library (as they know it) as the facility closes 15 months for renovations.

**DOWNEY** – Under a bright blue sky, when the trees around the Downey City Library are about to put forth green buds and leaves, a party was going on. The amazing blue ribbon library staff had invited kids and their parents, and had balloons and Spin The Wheel Games of chance with candy and books and puzzles as prizes. Finger painting on hither-to untouchable white walls.

And it almost looked like business as usual. In the Friends' Used Book Room, sales were brisk. Book lover Mitch proudly held up

his catch of the day, Marcella, one of Johnny Gruelle's Raggedy Ann's Downey with its own library. stories, Volunteer Marcia toted up his purchases while his wife Joy stood by, ready to pay.

But the Library is about to close for 15 months, and this new beginnings party was to celebrate the new phase of life for this beloved Downey institution.

In 1898, seven women residents of Downey met to found a social club - today's Women's Club Downey. One of their purposes was to establish a public library. When the Los Angeles County Library System opened a branch in Downey in September, 1915, the collection was turned over to it. Then in 1958, two years after the city of Downey was incorporated, the City Council voted to withdraw from the county library system and to

been renovated since 1979-80. But new funds were made available by Measure S, a sales tax approved by Downey voters in 2015. So far, the tax money has contributed to Parks and Recreation renovations. and street improvements. Now it's the library's turn. and a new internal configuration of the library's services is about to take place.

One of the giveaways that something was different today was in the Computer Lab. All the furniture was gone and only one row of computers stood against the wall, but each screen was glowing, still in use.

In the Cormack Room, named for former Mayor Robert Cormack who just passed away earlier this

# Police carts arrive at Downey and Warren to help campus officers

The carts will help school resource Gangs Out of Downey secured the officers react quickly to oncampus incidents and can also carry weapons and equipment, officials said.

**DOWNEY** – Downey's two comprehensive high schools are now equipped with police carts to help school resource officers navigate the campuses quickly.

The carts, which cost \$15,000 each, were delivered to Warren and Downey high schools during winter break.

"As school safety continues to be a major priority to the Board of Education, providing an additional sense of security to our students and staff is something that I firmly believe in and am proud that we now have these carts on our campuses," said school board President Nancy Swenson.

The electric carts were purchased via a financial collaboration between Gangs Out of Downey, Downey Unified, and the Downey Police Department.

funding through a sponsorship from Financial Partners Credit

"Protecting the students in our community is key to our future," said Financial Partners President and CEO Nader Moghaddam.

Officials said the carts will allow school resource officers to respond to incidents more quickly. The carts will also allow officers to leave their marked police vehicles in front of each school's administration office, making a police presence visible to all.

The police carts will also house equipment and weapons necessary for the officers to help maintain the safety of students and staff.

"Downey police officers provide a positive and impactful presence at our local high schools and added resources such as these motorized carts continue to provide a safe learning environment for students," said Mayor Rick Rodriguez.

Police Chief Dean Milligan said the police carts give school resource officers "another important tool at their disposal to assist in our efforts to ensure school safety.

"It's safe to say that our collaborative efforts with our community partners have positioned Downey Police Department and Downey Unified at the forefront of campus safety," Milligan said.

painting on the pure white walls. That had to mean that demolition was coming, and the wall was going to be torn down. What can be more fun than a party where you get to break a few rules?

Children's Librarian and Literacy Coordinator Claudia Dailey and Library Director Ben Dickow walked together to greet the arriving guests, Claudia in a flowing coral and white print long skirt and matching coral silk blouse. Ben was in a blue polo shirt with the seal of the City of Downey, and running sneakers, appropriate for a busy man who wears two hats.

Blue and coral are the colors for Downey's ubiquitous newly -branded street signs, and like them, Ben and Claudia were everywhere, Claudia making sure that each child had a balloon, even the ones in a carriage.

Later, Ben would be off to the Columbia Memorial Space Center, a few miles away by the Downey Promenade. "Juggling both the Space Center and Library has been fine," said Ben, "because I have a fantastic staff at each location. They make the job easier. We've been working to stitch both a little closer together, making managing both a little more efficient.'

The Children's Book Room was filled with busy families doing crafts. At one table sat Alice and her mother, Desiree, coloring with big crayons. Alice has been coming since she was a baby - she's now four, as she showed me by holding up four fingers.

Also at the table was another fellow volunteer of mine, Eunice, who has worked in the Friend's Book Store. Eunice was filling out a form to become a member of the Santa Fe Springs Library. We Downeyites will be temporary book-orphans, so delegates from nearby libraries staffed tables in the lobby, to make it easy to become a member. Patti, the librarian assistant from SFS, assured me, "plenty of free parking

To get there, take Florence east; about a mile after crossing the 605, turn left on Pioneer for

about half a mile, a few jogs and you're there - consult your maps or GPS. Just north of the Clarke Estate, the library is part of the beautifully landscaped SFS Civic Center complex, which fronts on Telegraph Road, and Maggi's Pub is a great place for a casual lunch, Brit style.

City of Commerce had a corresponding table, and was giving out handsome pens with "tutor.com learn better" written on them.

"That's our online tutoring program, free for any child who signs up," said Scott Gurrola, librarian at City of Commerce. The C of C bookmark listed four locations, the main one, and three

"Downey is bigger than City of Commerce," I said, "and we have only one library."

"One of the branches is for vets," said Scott. The Rosewood Neighborhood Main Library, on Jillson, is only four miles up the 710 freeway, and then one mile east, using the Washington Blvd.

The Patriot article by Eric Pierce on March 14 gave a thorough listing of where Downey Library programs will be conducted while the building is closed. All kinds of city venues and groups are lending a hand. For example, the Teen Mobile VR Unit will be stationed at Furman Park on Tuesday and Thursday, June 4- July 31, from 12

Back in the Library lobby, Rahee knelt with her daughter, Gianna, age 4. Twin sister Amaya, and their brother, Deven, who is 5, were strolling with dad Bobby, who has been coming to the library for 30 years, said Rahaa.

'We come to the Children's Story Hour. But we're not sure where it will be," she said. When informed that the City Hall had

In an exclusive interview, Ben has explained that he will still be

"I will remain as library director," Ben said, "managing the many tasks that staff will be doing during the renovation. The library will continue to offer a suite of programs at various locations around the city; staff will be retagging and re-cataloging all the 100,000+ items in the collection; we will be implementing an extensive training program to get ready for new services in the renovated library. We'll be very busy. Plus, I'll still lead the Space

"We recognize the very unique and powerful potential for

impact," Ben said, "that having these two organizations - a library and museum - working in concert can have. That keeps me, and all of us, motivated to make it all work smoothly. This tie-in will continue once the library renovation is done." A Summer Reading Camp will be held Wednesdays from June 12 to July 11, at the Space Center.

Claudia took time from her busy schedule to show us how so many Downey organizations will be proxy-hosting for the library. Literacy program tutoring, which is near and dear to Claudia's heart, is every Tuesday and Thursday from 1 to 2 pm at the First Baptist Church. Adult Communication Class will meet Mondays at 11 am at the Downey Women's Club.

The Library's book discussion club, Booked For Lunch, which has 20 or so active members, will meet Thursdays at 10:30 am at the First Baptist Church. Summer reading shows will be scheduled on Mondays in June and July at the Downey Theatre. Impressive.

The renovation gives library staff an opportunity to pause,' Ben said, "and rethink how we work and what we offer. The construction gives us time to develop these programs."

A memorial service in her honor will be at 10:00 AM Saturday March the 23rd at the First Methodist Church in Durant with the Rev. John Breon officiating.



# Kindergarten registration underway in Downey Unified

Registration packets are available at elementary schools but children must meet enrollment requirements.

**DOWNEY** – Kindergarten registration has begun for children who plan to enter a Downey Unified school for the 2019-20 school year starting in

Registration packets are available in all Downey elementary school offices. These packets will not be accepted for enrollment until all requirements for entry are met. These requirements are listed below.

To be eligible for kindergarten, children must be 5 years of age on or before Sept. 1, 2019. In addition, Downey Unified will be offering a Transitional Kindergarten (TK) program for children who will reach age 5 between Sept. 2 - Dec. 2, 2019.

TK is the first of a two-year kindergarten program. Early TK may also be available for students who will turn five after Dec. 2. Your name can be added to a contact list at your school and you will be notified if space is available for Early TK students.

Proof of age must be presented at the time of kindergarten registration. This may be done with a birth certificate, baptismal certificate or other

legal document. At the time of kindergarten registration, parents/guardians must also bring proof of residence within the Downey Unified School District.

In addition, parents/guardians must bring evidence their child has received a physical examination which must be completed after March 1, 2019. The Report of Health Examination For School Entry form, which is included in the registration packet, should be taken to your private doctor, pediatrician or usual source of medical care. The local County Health Departments also provides school entry physicals; this may be arranged by phoning the Health Department for times and locations. Please contact the school office for a list of providers if you do not have insurance or cannot afford a physical exam for your child(ren).

Lastly, parents/guardians must also bring their child's immunization record and ensure that their child is current on their immunizations which include:

Five (5) DTaP (four doses meet requirement if at least one was given on or after the fourth birthday)

Four (4) Polio (three doses meet requirement if at least one was given on or after the fourth birthday, if not, a fourth dose is

Three (3) Hepatitis B

Two (2) MMR (one dose on or after first birthday, if not, a third dose is required)

Parents/guardians must also verify that the child has received the varicella immunization or a statement from a doctor stating that the child had chicken pox. TB screening will be incorporated into existing state physical examination requirements for children entering kindergarten.

During this routine health screening, the health providers will test students for TB only if a risk factor is present. A requirement by the California Department of Education is that parents/guardians must provide proof of an Oral Health Assessment, which must be completed by a licensed dentist or other licensed or registered dental health professional.

Oral Health Assessments that have happened within the 12 months before your child enters school meet this requirement (examination must be completed after Sept.1, 2018).

For specific information about registration times and other areas of concern, please call (562) 469-6500 and ask for your local school. If you do not know which school your child will attend, call (562) 469-6553.

# We need a new Green Deal but not the one offered by AOC

Yes, of course, we need a Green New Deal to address the world's most urgent crisis, global warming.

Just, please, not the one that a flotilla of liberal politicians, including seven of the top Democratic presidential hopefuls currently in the Senate, are signing up for in droves, like children following the pied piper in the old legend.

Our modern-day pied piper, Representative Alexandria Ocasio-Cortez, is trying to lure us into a set of policies that might help save the planet but at the cost of severely damaging the global economy.

To be sure, by the time the resolution was introduced into Congress, some of its most ludicrous provisions (like the deadline of 2030 for a full transition to renewable energy and the immediate halt to any investment in fossil fuels) had been eliminated or watered down.

But as important as continuing to prune the absurd or damaging provisions would be to add what is the most effective way to attack climate change: using taxes and market forces rather than government controls to reduce harmful emissions.

That has been a problem for decades, at least since Washington got seriously into the business of improving the environment, back in 1970 with the creation of the Environmental Protection Agency — under President Nixon!

Politicians prefer that approach because using regulation hides the costs of reducing emissions. The decision, for example, to force improvements in automobile mileage by requiring each manufacturer to improve overall fleet efficiency has added thousands of dollars to the

Higher car prices have the countervailing impact of encouraging Americans to hang onto their older, less fuel-efficient cars for a longer time, offsetting at least some of the gains from newer cars. Nor have the regulations, with their many escape hatches, kept consumers from buying even more sport utility vehicles and pickup trucks as gas prices have remained historically low.

Fortunately, there is a better way to address the climate problem at far lower cost to the economy: a tax on greenhouse gas emissions. That can be imposed in any number of ways. The 18.4 cent federal gasoline

tax, for example, hasn't been increased since 1993 even as most other developed countries impose far higher levies.

A particularly thoughtful proposal has come from the Climate Leadership Council, a bipartisan organization that counts more than 3,300 economists among its signatories. Elegant in its simplicity, the key provision would be the imposition of an escalating tax on carbon. At an initial rate of \$43 per ton, the levy would be roughly equivalent to 38.2 cents per gallon of gasoline.

To prevent polluters from fleeing overseas, the tax would be imposed on imports from countries lacking a similar provision while exports to those countries would not be taxed. While difficult to implement, that component is important to work out.

The entire proceeds from the tax would be rebated to consumers. The council suggests an equal amount for each American; my view would be to exclude the wealthy (who hardly need the estimated \$2,000 a year in payments) and disproportionately favor those closer to the

Why are so many economists, even conservative ones, in favor of a massive new tax? Because markets do not always price in "externalities" like pollution. In addition to cutting consumption, raising the price of carbon would arguably do more to encourage development of alternative power sources than all the massive new government spending programs that advocates of the Green New Deal

Some technical problems would need to be addressed, such as how the higher prices would filter through inflation calculations and create unintended cost of living adjustments to wages and Social Security

But those are details; the key point is that a carbon tax has been judged by climate hawks like Resources for the Future to be far more effective in reaching the goals of the Paris agreement than the well-intended regulations put in place by President Obama and his

That's at least part of why the plan enjoys support from an armada of organizations not often on the same page, like Exxon Mobil and Conservation International.

Historically, the politics of even small increases in the gasoline

tax have been tough. A 2017 proposal in the House to increase tax by just one penny went nowhere. But recent polls suggest that perhaps sentiment is changing; a survey by the Energy Policy Institute at the University of Chicago found that 44 percent of Americans favor a carbon tax while only 29 percent oppose one.

Given how late we are to the climate battle, maintaining some sensible regulation will also be necessary. But a hefty carbon tax would go a long way toward winning the war.

# Congress grows a spine

The War Powers Resolution, which Congress passed in 1973, and the National Emergencies Act, which it approved three years later, were both intended to curb presidential power grabs. But until last week, Congress had never used them for that purpose. We can thank Donald Trump for this belated attempt to enforce the Constitution's separation

Trump is hardly the first president to use the military however he likes without bothering to ask permission from Congress, which has the constitutional power to declare war. U.S. participation in the Saudi campaign against Houthi rebels in Yemen, the target of last week's War Powers Act vote, may be appalling on humanitarian grounds, but it is less direct than the bombs and missiles that Barack Obama deployed against Muammar Gaddafi's regime in Libya.

In that case, Obama claimed the War Powers Act did not apply, because blowing up Libyan targets did not qualify as "hostilities." The argument was so laughable that the Justice Department's Office of Legal Counsel advised against it.

Obama, like Trump, launched missiles into Syria without congressional approval to punish President Bashar al-Assad for using chemical weapons in that country's civil war. The unauthorized U.S. involvement in Syria, which Trump says he wants to end, began under Obama, who as a candidate admitted "the President does not have power under the Constitution to unilaterally authorize a military attack

in a situation that does not involve stopping an actual or imminent threat to the nation.'

Trump, like Obama, was a critic of executive overreach until he had the opportunity to engage in it. "Why is @BarackObama constantly issuing executive orders that are major power grabs of authority?" he wondered on Twitter in 2012.

After declaring an emergency he admits does not exist to obtain border wall funding that Congress has repeatedly declined to appropriate, Trump probably has a better idea of why presidents do that sort of thing. But his attempt to steal the spending power from Congress did not break new ground.

During George W. Bush's last few months in office, his administration unsuccessfully urged Congress to approve a bailout of the auto industry. Undeterred by its refusal, the Bush administration swiped the money from the Troubled Asset Relief Program, which was created to shore up financial institutions. Obama expanded this illegal use of TARP money.

In 2012, a few months before Trump's tweet complaining about Obama's abuse of executive power, Andrew Rosenthal, then the editorial page editor at The New York Times, explained why Bush's record on that score was worse. While Bush overstepped his authority gratuitously, Rosenthal said, Obama did it only when Congress, controlled by Republicans bent on blocking his agenda, refused to give

Another way of looking at it, of course, is that a president is on especially shaky ground when he does something Congress has explicitly declined to authorize. That seemed to be the view of the 12 Republican senators who voted to override Trump's declaration of a

Sen. Rand Paul, R-Ky., who supported Trump's request for border wall money, nevertheless faulted him for "seeking to expand the powers of the presidency beyond their constitutional limits." Paul said he would lose his "political soul" if he "decided to treat President Trump different than President Obama."

Paul also was one of seven Republican senators who voted to end unauthorized U.S. military activity in Yemen, echoing a resolution the House passed last month with support from 18 Republicans. "I don't think you can overstate how important it is that for the first time in the history of the country, the full Congress voted to tell the president that we can't be in a war," Paul said.

Trump vetoed the border wall bill on Friday, and the same fate awaits the Yemen resolution. But at least Congress tried to draw a line on the president's war and emergency powers, which is more than it has managed to do before.

Over the last eight years, WeWork has matured from a trendy startup into a \$47 billion dollar company, according to Fast Money. But as the company has grown, they've opened themselves up to new

For starters, WeWork has a spending problem – a big one. According to Recode, last year, "[WeWork's] net loss was \$723 million in the first half of the year on about \$764 million of revenue." This wasn't a one-off; the company has a pattern of money going in and out at just about the same rate.

That's probably fine today while the economy is hot. But in the event of another downturn, such a small amount of cash-on-hand could be a real problem.

WeWork's also come into some ethical dilemmas lately that threaten their reputation as a socially-conscious 21st-century company. For instance, it's no secret that WeWork takes heavy investments from Softbank, a Japanese company that's bankrolled by the Saudi government – especially problematic given the kingdom's human rights violations.

Not to mention, WeWork's also taken heat for their poor response to sexual harassment allegations and for firing cleaning staff who asked for a pay raise.

So far, WeWork has not done much to address the problems themselves. Rather, they've embarked on a new expansion and rebranding effort. They now operate under an umbrella brand called "the we company" and are launching new business ventures in the

education and housing spaces.

Launching a new rebrand and expansion isn't a bad thing. But if this is WeWork's only solution to poor financial management and problematic ethical situations, then it's not the right move.

Not to mention, the rebrand itself has raised some eyebrows. By calling itself "we," WeWork is mirroring the name of a wellestablished Canadian charity called the WE Organization. The WE Organization has been around for over two decades, and in that time has made a mark around the world for their philanthropic efforts. Furthermore, the charity is involved in many of the same sectors as

It's one thing to change your company's name, but when you're using a similar brand as a nonprofit that is involved in the same sectors, it's certainly not the most ideal look for the millennial-driven

Bottom line: WeWork's effort to rebrand itself and grow as a business is fine. However, it is not the sole path to solving the true problems facing the company. WeWork has a lot of potential as it expands in California. If the company can solve its internal flaws, there is no doubt that WeWork will achieve even greater success.





# Things You Didn't Know About Downey

The Dec. 6, 1989 Press-Telegram had an article about a wartime "attack" that stirred Downey. This was an article by columnist Milburn Gibbs, a businessman and Downey resident.

As the story starts, Arvin MacCauley was working the graveyard shift at the South Gate Defense factory when he and his mates ran outside when the noise began. Gordon Madru was a kid and it awakened him from a sound sleep; Grace McCarthy was giving her infant son his 2 a.m. feeding when all hell broke loose.

It was Feb. 25, 1942, the day Downey thought armageddon was unfolding. Anti-aircraft guns blazed away at "unidentified flying objects" — presumably Japanese planes. Following is what really happened on the night Los Angeles became the first — and only — mainland U.S. city to be attacked in World War II.

Well, almost attacked.

The Los Angeles Daily News story of Feb. 25 read: "World War II plopped down on Los Angeles' doorstep today with a reported visit from a score of unidentified planes and a welcoming committee of dozens of

anti-aircraft guns in full

The Downey Live-Wire echoed, "Downey and a wide area of the coast area experienced its first general blackout and anti-aircraft action early Wednesday morning on orders from the Army's western defense command. No bombs were dropped and no airplanes were shot down..."

action..."

Folks around Downey were understandably nervous on that February night. Pearl Harbor was only a couple of months before, and one could not know what subterfuge the Japanese might try.

There were two batteries of anti-aircraft guns in Downey — one at Sixth Street and Paramount Boulevard, and another at Vultee Aircraft Co., at Lakewood Boulevard and Stewart & Gray Road.

The Paramount Boulevard guns were encased in a house with a retractable roof -- real high tech for the time. They were manned by Battery D, brave New York and New Jersey lads who were to defend us ably.

Jack Cook's home was only three blocks from this installation and the house rattled during the night of infamy that was to follow. The liquor store beside the gun emplacement is said to have lost much of its virgin nector to the concrete floor that night.

About 2:30 a.m., a plane or planes of unknown origin were reported sighted and guns from San Pedro to Beverly Hills began to blaze. Thousands of rounds pierced the night sky. Tracers lighted the dark and babies clear to Los Angeles cried.

Air raid wardens and block wardens swung immediately into action. They directed traffic away from the gun emplacements, causing a traffic jam of sorts at Lakewood and Firestone boulevards. They diverted traffic away from the likely target: Vultee Aircraft.

In those days, everyone cooperated. Well, most did, and few who didn't were soon sternly made aware of their patriotic stance and were contrite, the paper said.

News was very much censored during the war. News of great Allied-American victories at Corregidor and Guadalcanal were trumpeted in every paper. The War Department never did admit what really happened the day Downey went to war — one American weather balloon was mistaken for the armada of zeroes.

One other piece of evidence that came out long after the

war: there was a Japanese submarine — I-17 — operating off our coast that night, which did have the capability of launching a float plane. Later we learned that the I-17 went down in the South Pacific in 1943, her crew and logs lost for all time.

The War Department said later there were probably no enemy aircraft within 5,000 miles of Downey or her besieged neighbors that fateful night.

Around dawn, zone and post wardens were given the all clear and a much shaken group of Downeyites tried to re-group and resume their lives.

Downey in 1929: In looking over some old Downey Historical Society newsletters from 1979, there was one titled "50 Years Ago."

The Downey Live-Wire newspaper of Jan. 10, 1929 featured a front-page aerial photo of central Downey: "The Ideal Home Town of the Industrial East Side."

Shown in the photo were major landmarks: Downey High School, Downey Grammar School, Meralta Theater, Ball & Tweedy packing plant, Southern Pacific Depot, Presbyterian Church, and the Rives home.

Notable in the photo was a vast expanse of "elbow room" and unobstructed sweep of land north to the mountains.

1929 was the year James Hughan sold his 73-acre ranch to E.M. Smith for a new Emsco Aircraft Corporation. Presentday boundaries of the ranch would be Lakewood Boulevard on the west, Woodruff on the east, Imperial Highway on the south and Washburn Road on the north.

Emsco later became Vultee, North American Aviation and Rockwell International.

Also in 1929, the Los Angeles County Fire Department Band, headquartered in Downey with Caesar Mattei as director, made plans for Saturday evening summer concerts to be given in

Cane sugar sold for the tremendous price of 10 pounds for 53 cents.

Downey voters gave the go-ahead on plans to form a water district: "Extension of the system to land on which homes could be built, eliminating the necessity, as at present, of sinking wells and putting up individual systems, will aid materially in

the encouragement of home building and the growth of the community."

Front page had Downey's receipt of a new automatic rain gauge which was installed on the roof of the First National Bank building by A.L. Darby – president of the bank. He was the official keeper of rain records for this section of the county. The gauge was furnished by the County Flood Control Department and the records kept by Mr. Dary were relayed by that department to the U.S. Weather Bureau as official records.

Judge Rives' property was in the news also on Nov. 7, 1929 as it was being surveyed for subdivision. The ranch extended from 2nd Street to 7th on College, and to Rives Avenue on the west.

The entire acreage was to be included in the subdivision, except about two acres where the Rives home is. This land would be retained by the Rives family as a home.

Building restrictions in this tract would be not less than \$2,500 and up, and all construction must be of Spanish type. Lots were sold for \$1,000 to \$2,500, the latter price being for boulevard lots.

# How the Gershwin brothers revolutionzied Broadway

George and Ira Gershwin will always be remembered as the songwriting team whose voice was synonymous with the sounds and style of the Jazz Age.

**DOWNEY** – In the "Downey Doings" society colum that was in last week's issue of this newspaper, Lorine Parks very nicely wrote about the orchestral and opera compositions of George Gershwin and how they would be presented in the Downey Sympony Orchestra's "GERSHWIN!" concert that will take place on Saturday, April 6, at the Downey Theatre.

This article is focused on the songs of brothers George and Ira Gershwin that were written for a Broadway musical show or a Hollywood musical film. There were quite a few!

One of the reasons the concert on April 6th is entitled GERSHWIN! and not BY GEORGE! (for example) is that you can't do justice to the body of work of George Gershwin without also mentioning his brother, Ira. For most Gershwin songs, George wrote the music and Ira wrote the words. In the case of all song writing teams, at some point they are asked the question: "What gets written first, the music or the words?" Ira's famous reply: "The contract!"

Prior to the brothers Gershwin working together, George started as "song plugger" in Tin Pan alley in 1914 at the young age of 15. His job was to play other song writers' new works for performers who were looking for new material to put in their Vaudeville acts or producers looking to find a new song to include in their latest show.

George grew tired of the kinds of songs he was asked to play over and over on a daily basis and after three years he abondoned Tin Pan Alley to persue his growing interest in writing songs of his own for the stage. He knew he could write better material.

In 1919, it took less than half an hour for lyricist Irving Ceasar and composer George Gershwin to write a song for the great Al Jolson to include in his new show SINBAD that became an instant hit, especially after the recording of it in 1920. For all his later successes, "Swanee" became George Gershwin's greatest commercial triumph and was a milestone in Jolson's long career as well.

George and Ira actually wrote their first song together in 1918 - "The Real American Folk Song [Is A Rag]" - and their first complete score together in 1921 - A DANGEROUS MAID. The song writing team kept busy in the early 1920's primarily with Broadway shows. However, it was the premiere performance of George's first major "classical" composition "Rhapsody In Blue" on February 12, 1924 with Paul Whiteman's orchestra (George himself playing the piano) that made George a musical celebrity. This writer can not wait to hear "Rhapsody In Blue" performed by the Downey Symphony Orchestra, featuring piano soloist Bernadene Blaha, at the concert on April 6th. It will be a fantsatic ending to a great evening of music!

Our GERSHWIN! evening


begins with "Strike Up The Band" from the score of the show of the same name that the brothers wrote in 1927. A satire concerning a war between the USA and Switzerland that erupts over a tariff on imported Swiss cheese, the show was a quick flop and closed during try-outs in Philadelphia. Although performed by the Downey Symphony Orchestra without the lyrics, Ira did write some which he later customized for, and the brothers gifted the song to UCLA after moving to Hollywood in the mid 1930's.

In 1926, George and Ira brought the show OH, KAY! to Broadway with a score that includes one of their most romantic songs, "Someone to Watch Over Me." It was introduced by star Gertrude Lawrence, singing it alone onstage to a rag doll she was holding.

Composer George originally wrote the melody as an up-tempo tune but later decided it was much better slowed down to a ballad. A Broadway critic, writing about the show and this song, confessed that the Gershwins had "wrung the withers of even the most hardhearted of those present."

Downey-raised singer Rachael Lorenzetti performs this song in the concert on April 6 and commented, "I love the Geshwin songs and was thrilled to be asked to sing some of them. Sharon Lavery, the artistic rirector, Lars Clutterham, my accompniant on piano, and I had to really make some tough decessions to pick what I will be singing, taking in to consideration my soprano vocal range but also wanting to have some variety with the three songs.

Mom always had tables set hours before company would arrive, always had the food prepped and ready to go way before the actual time to cook.

While in London, we were having breakfast. We were to meet up with our group in the bus out front of the hotel at 7:30 a.m.

We were eating and everyone was enjoying discussing our day's plan. Mom was getting so anxious about the time, you could just about see her quiver. She was chomping at the bit to get out to that bus, and couldn't sit another minute. She had to get out there and save our seats.

We were only about half way done eating when she got up and said she'd meet us on the bus. About 10 minutes later we went to the bus and found mom was not there. We couldn't imagine what could have happened. We piled off the bus and looked around and saw another bus down the drive way.

We ran to that bus laughing

and thinking, "Oh great, we lost mom." We boarded the other bus and our eyes scanned every seat. Imagine our surprise when we saw about 70 African American women and our one little mother. One of the palest white women in the world, completely surrounded by an entire bus filled with a beautiful Baptist church group. I could be wrong, but I think I'd notice.


The funniest part was that Mom was so proud of being on "Bette time" and being in her seat early and ready to go that it never dawned on her that she might be on the wrong bus.

Ella Fitzgerald's recording of it my whole life."

1928 saw George traveling to Europe where he was honored by several musicians there. Quite the celebrity at this point in his life, he was condsidered a "double threat" - equally respected in the separate worlds of the Broadway stage and the concert hall. In France he was in great demand by fellow composers such as Sergei Prokofiev and Maurice Ravel. While staying in Paris at the luxurious Majestic Hotel, George worked on the classical composition "An American in Paris" - another selection to be performd by the Downey Symphony Orchestra on April 6.

GIRL CRAZY arrived successfully on Broadway on October 14, 1930 with Ginger Rogers and newcomer, Ethel Merman, in the cast. Many memorable songs that are considered "standards" today were written for GIRL CRAZY. The show was jam-packed with great moments like Ginger Rogers singing "Embraceable"

You" and "But Not For Me" to audiences hearing these songs for the first time. Ira won high praise for his fine lyrics.

However, magic took place in the Alvin Theatre on opening night, as the first act came to an end a legendary Broadway career began. Newcomer to Broadway audiences, Ethel Merman, backed by a stage full of chorus girls, stepped downstage to the foot lights and belted out the Gershwin brothers' compelling announcement "I Got Rhythm." Merman made history when, on the second chorus, she just held the 'I' ...one long note...for 16 bars while the orchestra played the tune. The audience just kept clapping and going wild. They shouted for several encores and Merman just kept right on going. To quote her - "It was like electricity!"

and retained many of the same songs, plot devices, and main characters from GIRL CRAZY. The first act still ends with "I Got Rhythm" and , in a tribute to Merman, the "I" is held several times during the song as the note gets higher and higher and the high-stepping rhythmic dancing gets more frenzied.

Rachel Lorenzetti will open the second half of the Downey Symphony Orchestra concert singing this up-beat wellknown song.

Summoned to Hollywood in 1931, the brothers Gershwin wrote the score for the undistinguished movie musical DELICIOUS which stared Janet Gaynor and Charles Farrell. Despite some very attractive melodies, the film was hardly a hit. The brothers promptly returned to Broadway and the theatre, a territory they knew better and where they were better appreciated.

Upon their return, George and Ira immediately created the score for OF THE I SING, another political satire, which became their longest-running show (441 performances) and became the first musical to win the Pulizer Prize. However, the prize was only awarded "for the written word' to lyricist Ira and librettists George F. Kaufman and Morrie Ryskind - not to George who had contributed the music. In fact, the score was equally important to the show's success. George called it "the one show that I am more proud of than any I have written."

George jumped back to classical compositions with 'Second Rhapsody' also in 1931 and in 1932 he composed 'Cuban Overture' and completed transcriptions for solo piano of 18 songs, published as "George Gershwins Song Book." scores for two commercial and critical failures, LET 'EM EAT CAKE and PARDON MY ENGLISH, which, in Ira's words, was "a headache from start to finish."

1934 saw George and Ira both begin working with author DuBose Heyward on what many view as the greatest opera of the 20th Century: PORGY AND BESS. George's involvement actually began in 1925 after being inspired by Heyward's novel PORGY. The opera was finished on August 23, 1935 and premiered on October 10, 1935 at the Alvin Theatre on Broadway rather than the Metropolitan Opera for which it had initially been intended.

The collaborators feared a full-scale operatic production would limit its appeal to the regular theatre going public. PORGY AND BESS received a mixed critcal reaction and only lasted for a meager 124 performances. However, in the years since its initial Broadway run, the artistic merits have been recognized. Fifty years after its creation, the "folk opera" finally played at the Met. Downey Symphony Orchestra will be performing "Catfish Row: Symphonic Suite from PORGY AND BESS" to end the first half of the concert.

George felt that PORGY AND BESS was his most impressive achievement and that the brothers Gershwin had reached their zenith; it was their final theatrical collaboration. In 1936 they made the move back to Hollywood to work again in films. In 1937 they worked closely with Fred Astaire on two film musicals, SHALL WE DANCE and A DAMSEL IN DISTRESS.

Also in 1937, working on the film THE GOLDWYN FOLLIES, George and Ira completed five songs despite the fact that George began to complain about frequent migraine headaches. The last song they worked on together was "Our Love Is Here To Stay" before George died of an inoperable brain tumor on July 11, 1937.

Appropriately, Rachael Lorenzetti's final song she will be performing during the concert will be "Our Love Is Here To Stay" in tribute to the Gershwins' everlasting brotherly love.

Although only 38 years old, George's impressive musical legacy captured the American spirit and is still popular today. "George Gershwin has a place in music history," said Lars Clutterham, a composer and fellow Downey Symphonic Society board member. "In an extremely short time frame he was able to bridge the gap from popular music to classical music, from Tin Pan Alley to Broadway and Hollywood, with stops along his journey

through this world in a few

concert halls.'

Ira was almost two years older than his brother, George. Together they created dozen of standards but Ira was also proud of his collaborations with other composers including Harold Arlen, Venon Duke, Kurt Weill, Harry Warren, Arthur Schwartz, Burton Lane, and Jerome Kern with whom he created his greatest song hit of any one year, "Long Ago And Far Away." However, in his later years, Ira was somewhat astonished at the durability of the songs that he and his brother wrote. In Ira's words "They are here to stay."


Even though he was officially retired in the early 1980's, Ira ocassionally dabbled


in his favorite occupation, even producing new material for the 1983 "New Gershwin Broadway Musical" MY ONE AND ONLY that starred Twiggy and Tommy Tune. Explaining this spurt of activity so late in his life, Ira simply said, "Once a lyric writer, always a lyric writer." Ira died on August 17, 1983, in Beverly Hills.

# A proposal to help Downey's returning veterans and aging residents

By Dennis Billings

A new nonprofit is launching in Downey over the next several weeks specifically to provide services for returning veterans, senior citizens on fixed incomes, disabled seniors or those seniors experiencing daily life as a shut-

Assistance is in the form of services and limited funding as described below and is provided by prequalified homeless program participants and returning vets, both of which are looking to stabilize their environment before deciding on a permanent service career or other career option.

Simply stated the project functions as follows: Without using any funding from any governmental source, donated funds are used to rent 3- or 4-bedroom homes in the community. A qualified homeless individual or returning veteran that we refer to as a "house and home captain" is selected to supervise the maintenance of the property as well as the qualified residents.

All residents, including the house and home captain, are paid a weekly salary based on their individual qualifications ranging from a service trainee, service specialist or house and home captain.

The name of the non-profit is Homeless & Senior Hero's, Inc. The reason "senior" is in the name is because some seniors may wish to rent their property to the non-profit for rental income and become house and home captains to also earn a salary. Professional social workers will provide guidance for all of the house and home captains.

As of the 2010 census, Downey has 2.211 households with a person age 65 or older living alone. For the seniors who avail themselves of our services, the non-profit will provide up to \$50 a month to offset the cost of meds and food. All Homeless Hero's services are free to seniors.

The financial model for Homeless Hero's is very similar to the Public Broadcasting Service's (PBS) financial model

whereby donations and grants drive financial support to struggling seniors and those homeless and returning vets looking to gain a new foothold on life as grants and donations drive content for PBS stations.

Once our business model is perfected in Downey it will be expanded on a county by county basis as funds become available. Donations are not limited to the residents of Downey and are accepted from all states, the District of Columbia and all possessions.

We clearly understand not all of the homeless are capable or interested in supporting our rapidly growing senior population nor will all seniors be interested in our services and/ or financial assistance. That said, all of our Homeless Hero's and returning vets are eager to provide assistance and have had a background check and are

Our immediate and focused goal is to demonstrate proof of concept here in Downey so that all of our nation's citizens can clearly see and provide the help to begin to solve three rapidly growing social issues (homélessness, aging seniors in need of assistance and returning vets needing a stable environment to establish or reestablish themselves)

Fifty-five point seven per cent (55.7%) of the US population are over the age 18 and under the age of 65 per the census bureau as of 2018. That leaves about 183 million adults of which about fifty one per cent (51%) or about 92 million (according to the Pew Research Center) are in the middle to upper middle income brackets. If ten percent (10%) would be willing to donate \$10 a month,

we could have the potential to raise \$1.1 billion which of course is not likely in the near term. But we come to this project with a long term view and will set goals based on our performance

We have begun to accept donations via the internet and the GoFundMe app. Utilizing the app on your smart phone or gofundme.com on your computer. Simply look for the search window and type in zip code 90242 once on the Downey scroll down until you find "see more" and click on that title and then scroll down until you find the Homeless & Senior Hero's title with a picture of a man standing beside a light pole at Apollo Park.

That man is long time Downey resident William (Bill or Billy) Hayes who grew up in Downey and graduated from Warren High School in 1980. After graduation Bill became interested in the tool and die business where he worked his way up to supervising a small group of workers. During grammar and high school, Bill lived in a house directly adjacent to Apollo Park allowing him to play basketball daily after school and make many friends over the years. Bill has been homeless for a number of years now and

has been providing handyman services to all who ask including seniors who have come to know him. Bill is extremely well respected and liked by the homeless and non-homeless. Bill will be our first house and home captain once adequate funds are available.

Each month we'll produce an announcement of a new member joining the team. Next month you'll be introduced to Jeremy Ferguson, a 28-year-old from Downey. We believe his story will be quite inspiring to many.

The following are the initial services we'll be providing: house cleaning, laundry service, fluff and fold, dry cleaning, carpet cleaning, trash removal, lawn care, Meals On Wheels delivery as volunteers, transportation, home maintenance (i.e. installation and maintenance of smoke and carbon monoxide alarms, leaky faucets, changing light bulbs, etc.), referrals to other social services, to name a few of our
