# Mayor talks candidly of health troubles

A cancer scare followed by a herniated disc have sidelined Downey Mayor Rick Rodriguez.

owney Mayor Rick Rodriguez sat straight up in his backyard patio chair and reflected.

His face was noticeably thinner, the result of a 30-lb. weight loss in barely a month. His arms and shoulders -skinny also - disappeared underneath a black t-shirt emblazoned with his favorite slogan, "Always Forward."

It was a rough summer for the Downey mayor, who endured multiple health scares that resulted in him being pricked, prodded and probed over the course of several hospitalizations and one

But Rodriguez's health scares were more than just uncomfortable — they were legitimately life-threatening.

"I planned my own funeral," admitted Rodriguez, who is 59. "I called [Risher Mortuary owner] Greg Welch and he gave me a workbook. I told my oldest son, 'The workbook's in my top desk drawer. If something happens, don't burden Mom or your brothers and sisters. You take charge of this. Everything's done, everything's paid for. Just go forthright.'

Rodriguez has chosen to go public with his health battles for two reasons: to encourage other people, particularly men, not to ignore warning signs that something is wrong with their health; and to publicly thank the doctors and staff of Kaiser Permanente Downey Medical Center, who he credits with saving his life.

For Rodriguez, the first sign that something was wrong emerged earlier this year.

"I was going to the restroom four to five times an hour, sometimes 10 times an hour," Rodriguez said. "I brushed it off. I felt like, 'I'm getting older. I guess this is reality.'

"Six months go by and then one morning, I got up and I noticed I urinated blood. I took a shower and it happened again. That was an eye-opening experience."

Rodriguez visited a urologist and then an oncologist. Each visit came with biopsies, MRIs, scopes and cameras.

# Owner of Rives Mansion gets OK to build coffee shop

A split City Council on Tuesday gave final approval to a proposed coffee shop and juice bar in the front yard of the Rives Mansion.

**DOWNEY** - A controversial renovation project for the Rives Mansion cleared a major hurdle on Tuesday, surviving an appeal to the city council over a retail café set to be built on the property.

Downey's Planning Commission initially approved plans to refurbish and convert the historic residential home into nine commercial office spaces and construct a 1,200 square foot coffee shop and juice bar early last month.

Almost immediately the of the proposed coffee shop. conservation groups supporters have voiced concerns that the café's placement may be obstructive, therefore damaging the site's historic value.

Concha and Erika De La Teja looked visibly frustrated and exasperated, with the appeal bump in what has already proved to be a long and tedious process.

Concha said that the process has been "uphill" for his family, adding that the coffee shop is needed in order to make the project feasible.

"It's been really a struggle," said Concha. "We purchased the property in December of 2017... we've been working on this project for almost two years now. Ve've approached the city with different concepts...financially, we've put so much money it's put a hardship, even on us.

"The city has asked for everything in the book in this property. We came out of Planning Commission thinking we won with 101 conditions. With 101 conditions we won? It was horrific for us."

"I understand the historical project garnered pushback, value of the property; we are okay specifically over the location with meeting all the historical components of the property. to our business use was very harmful to us."

Resident feedback proved to be a mixed bag at the meeting, several community Mansion owners Arturo members coming out in support and opposition. However, with Mayor Rick Rodriguez still on medical absence and Alex Saab abstaining due to the proximity

coming as the most recent speed of his law office to the mansion, the difficult decision would ultimately fall on the remaining three council members. What's more, if they were to overturn the Commission's decision, they would need to do it unanimously.

> Councilman Sean Ashton who called for the review of the plans initially - came out in opposition.

"It's not a personal thing for me to do this; it's just something that I felt that there was enough of an issue with the Planning Commission's decision where this needed to be brought forth here," said Ashton.

"There is no perfect situation. I guess the perfect situation for me would have been if code enforcement would have taken care of the issues that were happening with the Rives Mansion before [the Concha family] even got involved with all this mess.

"I personally don't know if I Many of Downey's historical but to add another 50 conditions could ever be happy with having a coffee shop there, I'm going to be honest with you. I do feel there is an issue with having that in that site...I just know that having it up front is not anything I can support."

# Downey's Flora Cheng hosting album release concert

**DOWNEY** - As a performance venue, the fabled Epic Lounge in Downey is known for hosting rock concerts of all genres, movie festivals, and special events.

Cheng's score for "Blue Skies on Mars" earned her Best Original Score from the International Independent Film Awards 2018, New York Film Awards, and American Tracks Music Awards.

Cheng says her album "Icarus" grew from a desire to compose something original that was not for film.

"This is my first album created from my heart, so it's enrolled at Warren High. Having my baby," she explains. She describes her inspiration coming Music since a young age, Cheng from the story of Icarus and his struggle to escape the labyrinth of the Minotaur with his father.

# Rick Rodriguez recovering from hospitalizations

Doctors discovered Rodriguez had elevated prostate-specific antigen (PSA) levels, which is oftentimes an early indicator of prostate cancer.

"It's not until they say, 'Hey look, I think you have a 60-65 percent chance of having cancer, we have to get in there,' that you take it serious," he said.

"At first when they say that to you, you say, 'Holy smokes, I'm going to die.' When there's a crack in the armor, you think, 'Holy smokes, what happens now? What happens to my family?

"But then you say, 'Time out. In order for me to die, I have to quit. I have to give up.'"

As this was playing out in private, Rodriguez continued to fulfill his obligations as mayor.

"I didn't want the city to know I had any issue with cancer, so I just put a smile on my face and said, 'Let's go.' I attended every meeting regardless of whether I had a biopsy two days prior. Being mayor was actually the best therapy for me."

Surgery was scheduled for Sept. 6, where surgeons removed 100 grams from Rodriguez's prostate, along with samples of his kidney and bladder. The surgery was a success – no cancer – but came at a cost: severe internal bleeding.

"I never expected the pain in the abdomen that I had," said Rodriguez, who had back surgery in 2012. "The comparison would be to doing a thousand push-ups a day for 30 days. I couldn't sit up straight, I was consistently in the fetal position, I couldn't walk very well. "And then lo and behold, what happens next, I herniated a disc. The disc slides out of my spine like a melted candle, and I couldn't move."

The Downey Fire Department transported Rodriguez back to Kaiser, where he was injected with morphine and spent four days in the hospital. Doctors wanted to operate on the mayor's back, but he declined, opting for physical therapy.

On Oct. 6, exactly one month after his prostate surgery, Rodriguez found himself at home debilitated from back pain and again urinating blood.

"I didn't want my wife (Lupe) to know what was going on," Rodriguez said. "But my Apple watch told me my heart was going into AFIB."

Firefighters again took Rodriguez to Kaiser's emergency room, where technicians performed an emergency ultrasound on his bladder.

"They came to find out my bladder was covered with blood clots, preventing me from making my own blood," he said. "They had to go into my body, get rid of those blood clots, get them all out of me - by this time I lost two pints of blood and was approaching cardiac arrest."

Over the next 24 hours, Rodriguez underwent two blood transfusions. A nurse called Rodriguez's survival "a miracle." He would spend an additional seven days hospitalized.

Today, Rodriguez is back home and on the mend but under strict orders to rest. He has more doctors' appointments this week and begins physical therapy this month. His goal is to recover well enough to return to City Hall in November and finish out his term as mayor.

"As timing would have it, we have two grand openings planned for our city parks next month, which gives me an opportunity to start on my health goals," Rodriguez said.

In his time away, Rodriguez has stayed on top of local news and regularly watches video of City Council meetings, which Mayor Pro Tem Blanca Pacheco has led in Rodriguez's absence. He's aware of the criticism leveled by a small group of protesters who questioned Rodriguez's commitment to the city.

"The first reaction is kind of hurt," Rodriguez said. "I was in the hospital when I first read that. I had tubes everywhere...

"I read that thing in my hospital bed, and it really broke my heart. I said, 'Man, is that what the residents really think of me?' If that's the case, then I'm OK with stepping down. Let somebody better than me have this job. Somebody smarter, younger, healthier, let them have this job.

"And then I started to receive emails and text messages and letters and cards, flowers, baskets that were sent by people saying, 'Don't listen to the naysayers. We want you back. We need you back.' And that caused me to dig my heels in and say, 'I'm doing this. I'm getting back to my health, I'm getting back in my office.'

"That's the long answer. At first, it was fear and hurt, and then it went to anger and persistence."

Rodriguez credits his ongoing recovery to his urologist, Dr. William Chu, the Downey Fire Department, and "the men and women of Kaiser Downey."

"They not only cheerfully cared for me during my recovery, which included two separate


occasions in the Kaiser ER, but the compassion that they demonstrated to all Kaiser patients was amazing to witness first hand," Rodriguez said.

"We are so fortunate to have these servants in our city. Words cannot express my gratitude for these special people that have answered the call to save the lives of others.

"Going through this has served as a reminder of just how important regular health check-ups are. Health truly is wealth. It's easy to take your health for granted until you have something go wrong."

# Not your father's masculinity

John Wayne, that repository of testosterone — now considered an illicit substance in many states — once played a character who said, "You have to be a man first, before you're a gentleman." Who knows what, exactly, he meant by it? It sounded like a fine thing to say, back when men were unabashed "men." Now, we have #MeToo, and toxic males, and even such a once man-friendly rag as Gentlemen's Quarterly (i.e., GQ), which has historically celebrated men, seems to be just sick about them, eager to atone for their Y chromosome.

As a subscriber for decades — and as a biological male eagerly delved into GQ's "New Masculinity" issue. I've historically read the magazine that "meets millions of modern men where they live" for high-grade long-form journalism, or to settle existential quandaries such as, "What the hell is face serum and do I need to use it?" Still, one generally doesn't turn to men's magazine editors with soft hands who fret about conquering "your complex pant-shoe relationship" for instruction on the meaning of manhood. Not to pick on GQ, which, after all, helps us perform vital functions, such as how to "salute the celebrity mustache."

But after years of #MeToo scandals, which have revealed weirdos and perverts and sex criminals (and that's just R. Kelly), "toxic masculinity" is now regarded as tautology in some quarters. In more than a few tellings today, just to be a man is to be toxic.

So GQ's newish editor in chief, Will Welch, is taking a crack at overhauling our benighted gender, presenting an issue in which, as he puts it, "traditional notions of masculinity are being challenged" and "overturned." In doing so, he holds, we can be more generous, empathetic humans, even to ourselves, since "toxicity simply cannot thrive in the golden presence of genuine self-love." Tell that to Harvey Weinstein, who allegedly "self-loved" into a potted plant in front of one of his trapped victims.

For those curious to see just how much American masculinity is shifting — at least at Condé Nast headquarters in Manhattan — the trouble starts on the cover, in which the singer Pharrell Williams sports a canary-yellow, high-fashion Moncler sleeping-bag-asgown, looking like Cinderella going to the Dick's Sporting Goods ball. From there, "The Glorious Now of Men in Makeup" spread is little surprise, with lacquered-up boy-banders, models and influencers dispensing invaluable beauty pointers, such as Gen Z trans model Casil McArthur, who advises going with "mascara and lip tint. If I want to be extra, I'll incorporate intense sparkles.

It's difficult to envision the guys down at the tackle shop or Tractor Supply going in for sleeping-bag couture and hot makeup tips. But then, they're the Old Man, the kind of man the new masculinity seeks to leave behind. Maybe they haven't paraded around female job applicants with open kimono, à la Charlie Rose, or haven't traumatized female colleagues by subjecting them to pelvic pinball, à la Mark Halperin. But in GQ's eyes they're guilty of a more universal sin: They're still living as men undefined by non-men.

The bulk of GQ's conversation starter is a package in which "18 powerful voices" have their say on the new masculinity. You'd think this would make for an interesting cross-section of representative men, but there, you'd largely be wrong, since traditional men seem afterthoughts in their own discussion. As the writer Rod Dreher has noted in his own analysis of the GQ spread, scratching out some backof-the-envelope calculations, of these 18 purportedly definitive figures, "there are perhaps four who are heterosexual [cis] men about 20 percent." (Even though 95 percent of all males identify as Matt Labash was a national correspondent at The Weekly Standard.

Aside from the views of men like the filmmaker John Waters

("men are the ones who have penis envy"), or Magic Johnson's son, who has chosen a life "embracing traditionally feminine clothing and cosmetics," GQ seems primarily interested in soliciting women's opinions of what being a man means. Imagine Ms. or Jezebel doing the mirror version of this, with men mansplaining what women should be. Then run for your life.

You do get transgender men, like the boxer Thomas Page McBee, celebrating his "newly weaponized body," which might sound like a threat to women if he hadn't been originally gender-assigned to womanhood. There's the rapper Killer Mike, who, along with his wife, Shana Render, is interviewed in one of Atlanta's iconic strip clubs. But don't strip clubs demean women? No bother. Killer Mike is otherwise woke enough to pass muster (he is, after all, a Bernie Sanders supporter), and Ms. Render informs that they do dispense investment tips to strippers. "Catering, massage companies, real estate," Killer Mike adds.

Otherwise, there are a lot of women, all kinds of women. There's the comedian Hannah Gadsby, who suggests men scale back their confidence, refrain from sharing their opinions, while looking "to traditional feminine traits" and then "incorporating them into your masculinity." And there's Al Freeman, whose soft-sculpture work is an effort to examine hypermasculine spaces, "a mirror of the things that I wish would be softer, or more benign, or less threatening somehow." Think pillow versions of male genitalia or frat-house Jagermeister bottles. "I guess it's castrating humor, to some degree," Ms. Freeman says.

In an interview with Gayle King on "CBS This Morning," Mr. Welch reported that in GQ's survey of attitudes on masculinity, 97 percent said they felt masculinity was changing, and "30 percent of men said that they were confused by the changes.

Wonder how that could've happened.

As for me, I might be tempted to answer Vox's Liz Plank, one of GQ's 18 voices, who recently published a book, "For the Love of Men." While writing it, she went to Washington Square in Manhattan, thoughtfully asking men, "What's hard about being a man?

"Having to listen to people who aren't men, or who are ashamed of manhood, constantly telling me how to be one," would be my short answer, after I stopped, dropped and rolled for cover.

But for actual guidance — more sage than anything I read in GQ's masculinity symposium — I'd turn to Edward Abbey, the ornery liberal who enjoyed baiting those on his own team. By most lights, he was a more reliable environmentalist than he was a feminist. "The feminists have a legitimate grievance," he said. "But so does everyone else.") But Mr. Abbey, a former park ranger, did spend a lot of time observing nature up close, and not just the flora and fauna. Of man/woman relations, he wrote, "It is the difference between men and women, not the sameness, that creates the tension and the

Why keep fuzzing distinctions that for millenniums have resisted fuzzing? Punish the sex criminals and pelvic pinball wizards. Good riddance to them all. But otherwise, let men and women be men and women, however that appropriately breaks, without laboring so hard to fuse them. Maybe our opposites attracting, which the furtherance of our species has depended on, isn't a design flaw, but its very essence. And maybe the wokerati ought to take their own most oftrepeated cliché to heart: Our diversity is our strength.

For everyone's information, not all people looking for a puppy want to go to the pound. Purebred puppies are hardly ever at a pound. Bless all the people that go there and save a life but AKC puppies are what a lot of people want. There are two very different types of

I have saved hundreds of dogs and cats from going to the pounds for the last 45 years. How many dogs has Mr. Rodriguez saved lately? I have worked with veterinarians my whole life. Every week clients come in with horror stories about Craigslist scammers. I was trying to save people from getting caught up in all the sociopaths out there waiting for sweet, unknowing people to answer their ads. So if it sounds fishy, beware.

Let's make Mr. Rodriguez happy: they answer the phone and want to meet you on a corner. They tell you to send money via Western Union (so you can't get a refund). "Send us money!" They don't have any dogs, their pictures are fake.

Never send anyone money. Never meet on a corner or the street.

And in case you haven't heard, Mr. Rodriguez, the law says pet stores in California can't sell dogs or cats unless they're from the pound. I am not a pet store. I am a very experienced, knowledgeable pet professional. Sounds to me like Mr. Rodriguez thinks he knows more than any real pro.

He may be concerned about the pet scam problem, so let me correct his inaccuracies. If the seller sounds intelligent, go to their home. Is it clean? Do the puppies look well-fed and playful? If so, get a receipt with the seller's name, address, phone number and price. California law says you have two weeks to return the puppy with a receipt from a veterinarian stating the problem. Or you may keep the dog and still get money back from the seller for the vet bill. If the dog dies, you must present to the seller a death certificate from the vet.

You also have a year guarantee for any congenital problem. You may choose to keep the dog and get the money back for the vet bill. You have five days from the time you learned about the sickness to call the seller and state your intentions. I tell this to clients all the

Also, a new law just passed in California that is heaven sent. Emotional support animal law. Go online and certify your dog or cat as an ESA. No landlord can tell you you can't have your pet, and you can't be charged a fee to have the pet. Also, your pet flies for free. You must show documentation to the airline when booking your flight. Always get info from whatever airline you are flying.

Using Franz Waxman's masterful orchestration, Shi did things with the violin that I didn't even have words for, but it didn't matter. in his hands the violin became the gypsy Carmen, sharp and demanding in her Habañera theme song. His instrument evoked the tender Don Jose and Michaela love duet, then the crazed crowd cheering the Toreador.

How to top that? The intensity remained, but with Tchaikovsky's Valse-Sherzo it became feverish. Shi's tiny precise movements on the fingerboard were performed at hummingbird speed; double stops and cadenzas stunned the listeners. As always Maestro Lavery displayed an extraordinary sympathy to the needs of the visiting soloist.

On his second curtain call Shi received a bouquet of white roses across the footlights from a young admirer. He gave the bouquet to Maestro Sharon, whom he knows from USC's Thornton School of Music where as a young virtuoso Shi is studying, and Musical Director Maesto Sharon teaches.



However, it soon became clear that the council would not get the unanimous vote it needed, with Frometa commenting that the project was "not the best solution, but it is the best-case scenario."

"We want to make decisions that are reasonable," Frometa. "Collectively, we have watched this property go from decay to despair, to being an eyesore in this community. We all want to preserve it; we all want to preserve the historical presence of this particular building...We are not in a position to buy this property and restore it; the city is not in that position."

"We either let it go, and it

will continue to fall into disrepair and at some point, it will be bulldozed, or we are here to decide 'do we affirm the Planning Commission's decision."

Pacheco also came out in support of the project.

"It is a tough decision," said Pacheco. "I also want to maintain the Rives Mansion and the beauty of the Rives Mansion. I know that the Planning Commission spent many long hours trying to figure out the location of this juice bar/ coffee bar, and many different alternatives as to what can be

Jean, a lively school teacher from Minnesota, and Bob got married in 1957, and settled in Downey, eventually raising six children and 12 grandchildren and staying active in the community. Bob had an impressive career as an attorney, and now practices business and estate planning law from his home.

Bob chaired the committee that drafted the Downey City Charter.

Downey calls Bob "Mr.
Mayor," and he served from 199394. Jim Derry called him "the
most impressive man I know." He
received the Exceptional Service
Award, the highest award given
by the Downey Family YMCA.

But the lovingly bestowed soubriquet "Bean Head," that's the name everyone called him today.

# City approves plan for 540 trees

**DOWNEY** - The City Council unanimously approved a \$192,796 contract with the Los Angeles Conservation Corps on Tuesday for the planting of 540 trees.

City staff submitted a grant proposal for the development of an Urban Forest Management Plan to CALFIRE, of which the planting of the 540 trees was a requirement.

In May of 2017, the city was notified that it's grant application was selected for funding in the amount of \$379,750.

Total cost of the project – including preparation of the UFMP, planting, and grant administration services totals to \$305,351.96.

City staff is currently in the process of compiling a list of residents and property owners who wish to have a tree planted in front of their property, which will be accommodated on a "first come, first served basis"

It is anticipated that planting will begin in December and be completed by the end of March 2020.

The newly approved trees are not a part of the controversial Tree People project, in which the non-profit is set to plant 3,000 trees in the city to offset the impact of recent freeway projects.

# Downey contracts for homeless outreach

**DOWNEY** – In a continued effort to address the growing homeless epidemic, the city of Downey approved a \$60,000 professional services agreement with the non–profit Coast to Coast Foundation on Tuesday.

Coast to Coast will continue to work with Downey Police Department in their homeless outreach, assist in cleanup efforts, and will help to organize supplemental assistance for those outreach efforts, including coordinating community volunteers and donations to help homeless individuals.

A portion of the funds in the agreement are also specifically dedicated for emergency housing, mental health or drug treatment services, and transportation services for individuals who need immediate help before there is space available in the publicly-funded programs.

The agreement will be funded through the fiscal year 2019-20 budget.


# Gracie Munguia finishes basic training

# At Rotary Club's 10K Winner's Night, Downey is the real winner

buzz of excitement - the odds are good, at 1 chance in 250, that someone in this room will win big.

It's the Rotary Club of Downey's 10K Winner's Night. "10K" meaning someone is guaranteed to win the \$10,000 prize. It's "Winner's Night" because the evening specifically benefits all the club's local Downey projects. The money raised at the 10K Winner's Night stays in Downey.

The first sight on entering the banquet room at the Embassy Suites was Rotarian Jenette Lopez sitting cross-legged on the floor, her auburn hair done up on top of her head and a look of intense concentration on her face.

Jenette had the key job of being sure all the numbers called were entered and projected on the big TV screen. The 10K is a game of reverse selection: every number of the 250 sold is called, and the winner is not the first, but the one with the very last number remaining at the end of the evening.

Consequently, it's a party where everyone stays interested till the end, when the climax of calling numbers arrives.

Jenette's husband, Past President Alex Lopez, was making sure each numbered chance sold was present and accounted for in the hopper, before the drawing began. The task of announcing each number as it was eliminated went to Ray Brown.

Ray had 250 numbers to call in

an hour and a half, so that's 250 names in 90 minutes. Silvertongued Ray had to speak above the din of the crowd to do it, and Ray was up to the task.

Maurice Casaus, manager of the Embassy Suites and president-elect of the Rotary Club, was our host. We were treated to a delicious Italian-themed buffet of lasagna, Italian sausage with red and green peppers, and chicken parmesan. Dessert was cheesecake and also chocolate layer cake with a creamy chocolate bavaroise

Everyone was equipped with a scorecard, and guests kept track of the progress of each number as the evening went on. "Are you still in" was a frequent question, often answered with a smile but sometimes with a rueful grin - no translation needed.

Rotarian Raul Lopez and Soroptimist Arlene, Alex's parents, were on hand early. Arlene loves to give the casino a flutter, and there were several tables for her to try her luck, with donated merchandise for prizes.

Larry McGrew, who graciously hosts the Texas Hold 'em Poker Night for Rotary several times a year, was asked if he planned to win at the gaming tables.

"Nope," said Larry. "I'm sticking with the 10K opportunity and I'm going to win the big one."

Someone was certain to have lucky night, but the real winner was the community of Downey. Rotary dedicates the proceeds of this yearly event to its local causes and charities, and it took a long page in the program to

list them, from the Arc Fishing Derby and Buddy Benches for the Downey Unified School District's anti-bullying campaign, to children's books for the Downey City Library Children's Room, and a donation to the Downey Symphonic Society with its Music in the Schools program. Rotarians work all year to strengthen local organizations.

Newest Rotary project will be Fiesta de la Calaveras on October 26, to be held at the Stonewood Mall. The event will replace the Dias de los Muertes, an event that the City of Downey had to cancel because of construction at the Civic Center and the Downey Theatre Plaza. Rotary is eager to pick up the slack, and will work on this together with Courage Forward, the association to help veterans with PTSD.

Other events during the Rotary year are specially designated: the golf tournament in November donates all its proceeds to The Arc. The pancake breakfast at Warren High, enjoyed by the community for so many years, and planned for springtime 2020, is an all-out effort to make a meaningful gift to the Downey

Family YMCA. Greg Welch, immediate past president of Rotary, is the new chair of the Board of Managers of the Downey Family YMCA.

These big fundraisers have always been dedicated to the Arc and the Downey YMCA. But the loK Night enriches the club's treasury so it can contribute to home town projects like TLC, or True Lasting Connections, which is affiliated with the DUSD and helps needy families of students at the Downey schools.

Rotarian Jesse Vargas is on the board of the foundation of Rancho Los Amigos Rehabilitation Center, where many Downeyites join to raise money to provide special equipment for the patients. Rotary has also co-hosted the annual luncheon event to honor the Downey Police and Fire Founda-

Speaking of the DUSD, one of the delightful surprise guests was Dr. Ed Potter, former assistant superintendent of the DUSD. Dr. Ed was president of the Rotary Club of Downey in 1993-94, the year it met at the Embassy Suites while the Rio Hondo Country Club was re-landscaped and our beautiful new event center was being built, with its wrap-around glass walls looking out over the terrace and the fairways.

Dr. Ed said he had recently taken a motor trip with Raul and Arlene Lopez, starting in Boston, "where the credit union conference was," said Dr. Ed. "We ended up 1,700 miles later in Miami. We saw everything along the way, and I heard quite a lot about Cuba."

# The Old Plank Road

This is another one of those "popping up" and pulling me in to pursue the subject further.

Growing up in the days of yore, I recall mom talking about "The Old Plank Road." It made such a lasting impression on her that she mentioned it often over

Granddad and Grandma White, along with Mom and her brother, George, migrated from the State of Texas to Imperial Valley, and they used the plank road to get to their final destination. Mom had to have been a nine-year-old passenger when the family drove over it in 1923.

The road was built in 1915 to

assist cars to get across the Imperial Sand Dunes, as back then it was looked upon as a seamless ocean of sand. Even then, during nigh winds, sand blew onto parts of the roadway, preventing our early automobiles from traveling any further until the sand could be removed.

Composed of pre-assembled thin pine planks in 8 ft. wide by 12 ft. long sections, they were then loaded on mule drawn wagons and lowered into place with crude cranes and bolted into place. In total, it was only six and one-half miles long.

Located within one-half mile of the Mexican border, the road was an east-west route over the Imperial Sand Dunes. It then connected the extreme lower section of Southern California to Arizona and provided the last

link in a commercial route between San Diego and Yuma.

In following years, after splintered board and drifting sand provided endless maintenance headaches, the road was replaced by an asphalt road and today's four-lane highway. A surviving section (with its own historical sign) and parallel to the plank road can still be seen at Gray's Well exit of the I-8 freeway.

The "Old Plank Road" is now a landmark; it is a surviving remnant of Americana and an off-the-beaten-path travel destination known now as an unusual U.S. highway artifact.

From my newly chosen seat in the balcony, the whole orchestra is exposed, from the back row French horn player seated on the riser, to the far side front principal bass player. I could make out the difference between soft tufted heads of the drum sticks for the bass drum and the set of mallets for the timpani.

"To play, or to be part of the percussion section," advises

the Oregon Crusader Cymbal Technique Packet, "you must be able to push yourself mentally to approach every count, every time, all of the time, with clarity and confidence. You will own your cymbals like they are an extension of your body. You will be pushed to exhaustive lengths every time you put on your cymbals, thus you must be trained to endure." The big symphonic piece of the evening was about to test that resolve.

Maestro Lavery's baton signaled the call for horns and bassoons to open Tchaikovsky's Fourth Concerto in F minor. The same summons occurs in Beethoven's famous Fifth, but Tchaikovsky responds in a different manner, with a personal melancholy that says he is at first unwilling to take on the heroics. Little sighs on the flute echo that.

The long first movement also features strings that sing lyrically, suggesting his Serenade for Strings melodies, that he wrote just two years later. The first movement is written in part "in movimento

di Valse," and the temptation to sway with Tchaikovsky is hard to resist. But the call to conscience becomes more insistent.

The Symphony becomes personal and intimate with the melancholy melody of the oboe. Strings play pizzicato throughout the third movement and one almost expects the Sugar Plum Fairy to appear, so remarkably does Tchaikovsky suggest themes he will later expand and borrow from himself

In the vigorous finale, Tchaikovsky incorporates a Russian folk song, and peasant vigor takes over, until the Fate theme sounds again on the horns. Folk music and Fate finally harmonize as Tchaikovsky seems to have come to an uneasy balance. Lightning bolts come from the percussion section, constant drumming on the three timpani as well as beating on the big bass drum, with cymbals clashing and crashing, a vigorous and triumphant end. Still, all cannot be well. Too much still unsaid.

# Paging Dr. Frischer...

I am always reminding my patients to drink more water. While there are a few disease

conditions where people must watch their fluid intake, most people simply do not drink enough. Dehydration can have serious physical consequences.



When dehydrated, the body lacks enough water to function properly. We have water inside our cells, within blood vessels, and between cells; in fact, water makes up approximately 75% of the human body. A sophisticated water management system keeps water levels balanced, and our thirst mechanism usually tells us when we need more fluid.

Water loss is natural. We lose water from sweating, breathing, urinating, bowel movements, tears and saliva. Dehydration is caused either by losing too much fluid, by not drinking enough to replace what is lost, or both. Additional fluid is lost from a fever, diarrhea, vomiting, excessive sweating, excess urination as a result of diabetes, diuretic medicine, or to some extent by consuming diuretics like alcohol or caffeine.

Outdoor work or exercise, especially in heat, increases the risk of dehydration, and when the air is humid, sweat doesn't evaporate and cool the body as quickly as usual. This leads to an increased body temperature and the need for more fluids.

Many people choose not to drink in order to avoid having to get up to urinate. The elderly often make this conscious choice,

as do those whose jobs make it difficult to take bathroom

Older adults are at greater risk for dehydration. They have smaller body fluid reserves. The ability to conserve water is reduced and the thirst sense becomes less acute. Compounding the problem, the elderly may suffer from chronic diseases like diabetes or dementia. They could be on medications that cause fluid loss. They may have chronic kidney disease or heart failure, which would require that they consume less fluid. Older adults also may have mobility problems that limit their ability to get water to drink, or to reach a bathroom.

Signs of dehydration include thirst, dry or sticky mouth, decreased urination and dark yellow urine, dry, cool skin, headache, and muscle cramps. Signs of severe dehydration include infrequent and dark urine, very dry skin, dizziness, rapid heartbeat, rapid breathing, sunken eyes, sleepiness, lack of energy, confusion or irritability, and even fainting. Severe dehydration is a medical emergency that requires immediate attention.

Dehydration can lead to urinary and kidney problems which include urinary tract infections, kidney stones and kidney failure. It can cause electrolyte imbalances; electrolytes carry electrical signals from cell to cell, and an imbalance can lead to involuntary muscle contractions and even seizures. Low blood volume from dehydration can cause a drop in blood pressure, a drop

in oxygen in the cells, and most severely, hypovolemic shock.

Always drink plenty of fluids, and eat foods with high water content, like fruits and vegetables. Most healthy people can let thirst be their guide. Note the frequency, quantity and color of your urine. Pay extra attention to hydration if you are strenuously exercising, or are experiencing vomiting, diarrhea, or other illness.

If you have had diarrhea for more than 24 hours, can't keep fluids down, or show any of the signs of serious dehydration, call your doctor immediately.

# Townhome project in Norwalk moves forward

NORWALK - A major potential housing development passed its first hurdle on Wednesday, but will still need the approval of the city council to move forward.

Located on the west side of San Antonio Drive between Sproul Street and Olive Street, the potential development would see the construction of 27 townhomes, 11 of which being "live-work."

The live-work townhomes would enable its residents to live and work within their space.

If all is successful and this project is seen through to its completion, it will include six three-story buildings containing between three and six units each. Each unit will include two-car private garages, as well as private front entries.
