**DOWNEY** Downey students will not be returning to school campuses before the end of the current academic year.

Downey Board of Tuesday Education voted to accept state and county keep recommendations to campuses closed through May 31, the last day of school in the Downey Unified School District.

"Our Downey Unified family's health and safety is our greatest concern," said superintendent Dr. John Garcia. "Even so, this is a difficult day, especially for our high school seniors who have been looking forward to important school milestones."

Garcia said he will meet with senior class representatives this week to formulate a plan regarding graduation ceremonies, summer school, scholarships, and other end-ofvear matters.

"We want to emphasize, this does not mean the 2019-2020 academic year is finished," school board president Donald LaPlante and superintendent Dr. John Garcia said in a letter to parents. "While we will continue to stay physically apart, our educators will continue to provide distance learning instruction and our students will stay engaged in their learning until the very last day of school...'

The letter sent out by Downey Unified is below in its entirety:

Downey Dear Unified Families:

As promised last week, we're reaching out to you this evening to provide you with an update following our recently concluded Special Board of Education meeting. In a public address on April 1, Governor Newsom emphasized that it is incumbent upon all of us to comply with the "safer-at-home" orders to help save lives. The Governor, along with State Schools Thurmond Superintendent and the Los Angeles County Superintendent of Schools, Dr. Duardo, also recommended that California schools should remain physically closed for the rest of this academic year.

City OK's help for renters

Residential and commercial tenants get additional time to pay rent if they were impacted financially by the Covid-19 pandemic.

**DOWNEY** — The Downey City Council has voted to provide extra breathing room to commercial tenants affected by Covid-19, while also setting an expiration date for residential rent flexibility.

In response to concerns over the spread of coronavirus, council members had previously given direction to the city attorney to draft an emergency ordinance placing a temporary moratorium on evictions of residential tenants. The City Council was scheduled to vote on the moratorium April 14.

That point became mute, however, when Gov. Gavin Newsom issued his statewide moratorium three days after the City Council

Yet the governor's order came without a specific timetable for when renters would be held responsible for their unpaid rent

At their special meeting last Thursday, the council decided to allow renters up to three months after the termination of the local emergency to satisfy any outstanding rent.

The subject of commercial property renters - many of which are facing declines in business and closures due to the coronavirus pandemic – was also left unchecked by Newsom's order, which Downey's latest action also addressed.

Commercial tenants will have several conditions to meet before falling under the safety net of the new moratorium.

Tenants must their landlords in writing that they are unable to pay the rent due to the effects of Covid-19, meaning they have suffered "financial impact" resulting from being ill with coronavirus, income reduction resulting from closure, curtailment of business operations or other economic or employer impacts of Covid-19, layoff or furlough of employees of the business, compliance with a recommendation from a government health authority to stay home, self-quarantine, or avoid congregating with others during the state of emergency, extraordinary out-of-pocket business or medical expenses, or child care needs arising from school closures.

Commercial renters are also eligible if the financial impact is a result of compliance with local, state or federal health guidelines.

### Paging Dr. Frischer...

Guess what the #1 concern of my patients has been lately... now guess again.

Anxiety. The world has changed so dramatically in such a short period of time that it

makes our heads spin. It isn't only our health that is threatened today; it's the economy, our jobs, and our savings. Add to that the physi-



cal isolation from our friends and

loved ones, and yes, anxiety is running rampant.

Anxiety manifests in a number of ways. Many people develop persistent worrying; overthinking plans and solutions and dwelling on worst-case outcomes. They have difficulty handling uncertainty, and show indecisiveness and fear of making the wrong decision. They have an inability to relax, feeling restless; keyed up; on edge. They have difficulty concentrating. Physical signs include fatigue, trouble sleeping, muscle tension or muscle aches, trembling,

nervousness or being easily startled, sweating, nausea, diarrhea, flare-ups of irritable bowel syndrome, and irritability.

Clearly, anxiety is not merely a mental disorder. It affects both our minds and our bodies, so we need to pay attention to both our physical and our mental health. Let's look at some coping mechanisms to help manage our lives during this unprecedented and challenging time:

· Take care of your body with exercise, hydration, nutrition, and sleep. Your body will handle stress far more easily when it is fit and healthy.

· Limit your alcohol, caffeine, tobacco, and sugar consumption.

· Take a multivitamin if you are unable to consume a healthy, balanced diet.

· Take time for yourself every day. Just 20 minutes of relaxation or doing something pleasurable can be restorative and decrease your overall anxiety level.

· Practice relaxation techniques including meditation, yoga, tai chi, breathing exercises, massage, music, and walks.

· Don't neglect hobbies and personal interests.

· Keep a positive attitude as best you can.

· Be assertive rather than aggressive. State your feelings, opinions, or beliefs instead of becoming angry, defensive, or

· Work on managing your time. Where possible, avoid activities that you find stressful. Set personal limits.

 Keep an anxiety journal. Rank your anxiety on a 1 to 10 scale. Note the events that make you feel anxious (such as watching TV news), and the thoughts going through your mind before and during the anxiety. Note the things that make you feel less


· Be aware of hyperventilation. If you begin to breathe rapidly, exhale into a paper bag and inhale the air within the bag. This increases the amount of carbon dioxide inhaled, which can reduce the urge to hyperventilate. It also helps to reduce dizziness or tingling.

Seek out social support from your community of family, friends, religious organization, etc. Spend time with those you love, over the phone or online.

We can all use a reminder to reconsider our lifestyle; incorporating relaxation techniques, physical activity, nutrition, better control of alcohol, caffeine and drug use, and more effective time management. If these measures don't seem to help, seek treatment with your personal physician, therapist, or other mental health professional. It is very likely that they will be able to "see" you via your computer or phone. Remember that while we don't know how long this crisis will last, we do know that it is temporary.

## Julian Gutierrez January 14, 1992 - March 30, 2020



Julian Gutierrez was born at Cedars Sinai on January 14, 1992 and was raised in Downey. He received the Sacred Sacrament of Baptism at St. Raymond's Church. He built a solid foundation of Christian character during the years he studied at the Kirkwood Christian School. He was a member of Troop 2, initially participating in

the Cub Scout program, then in the following years, with the mentoring of many caring adults, he advanced to the level of Life Scout.

Instilled early on with the passion to serve others, he enlisted with The Few, The Proud, The United States Marine Corps. He was the recipient of the National Defense Service Medal, the Global War on Terrorism Service Medal, the Sea Service Deployment Ribbon, the Expert Rifle Qualification Badge, and the USMC Good Conduct Medal. He was honorably discharged after serving four years during Operation Enduring Freedom. He continued his service to our country by serving in the Ready Reserves.

A generous and caring individual to those less fortunate, Julian traveled to a shelter in Tijuana housing deported US Veterans to deliver hope and needed supplies.

Julian attended Junior College, obtained a certificate as an EMT, and was working toward a dual degree in Nutrition and Kinesiology. He took great care to live a healthy life and encouraged his friends and family members to do the same, often buying them supplements and vitamins, and putting together personalized diet and exercise plans.

His love of reading was encouraged at an early age. He astonished many with his photographic memory, his capacity to recite facts, and to prepare cogent arguments. He had a special sense of humor and great timing.

Julian was an only child and is survived by his mother, stepfather, grandmother, aunts, uncles, cousins, and a large extended family, as well as a handful of special friends who have brought so much comfort to the family. He is preceded in death by his father and grandparents. The love we shared with Julian will always be connected in our hearts.

Tragically, while on a day trip to Rosarito, on the night of March 30, he became one of the many victims of the senseless violence sweeping across Mexico.

On 3/30/2020 at approximately 9:30 a.m., officers responded to the railroad tracks behind Penske Toyota regarding transients on railroad tracks. Officers contacted two subjects, 1 female and 1 male, who were both cited for trespassing on railroad property.

On 3/31/2020 at approximately 7:45 p.m., officers responded to the 8000 block of Firestone Blvd. regarding reports of a shooting.

The suspect and victim were in a verbal argument. The suspect subsequently shot the victim in the lower abdomen. The suspect fled the scene and was last seen traveling eastbound. Officers checked the area and were unable to locate the suspect. The victim was transported to a nearby hospital and treated for non-life threatening injuries. Detectives responded in from home, identified the suspect, and later arrested him for attempted murder.

The victims were in the park when they were approached by 3 males and 1 female suspect. Multiple suspects produced knives and threatened the victims while demanding their property. The suspects removed the victim's wallet, iPhone, and keys to a vehicle from his pockets.

The suspects fled on foot, eastbound through the park toward Dunrobin. The suspects' faces were all covered with bandanas.

## How to end the shutdown

President Donald Trump is hinting at a second task force responsible for getting Americans back to work. Appoint it now, Mr. President. Don't wait until the virus peaks. This second task force bureaucratic, risk-averse and slow drug approval process. He's should prepare the country to reopen, with new tools to fight the

The president's top epidemiologist, the esteemed Anthony Fauci, insists "the best tool we have" is "physical separation." But mandating that people stay home is costing Americans their jobs and will force businesses into bankruptcy. The nation needs an alternative strategy.

A chorus of government health officials and academics, like Harvard's Marc Lipsitch, want the shutdown continued until the virus is gone or a vaccine is developed. They're well-meaning but out of touch. No wonder. Their paychecks continue to roll in, even during a shutdown.

Meanwhile, blue-collar workers and business owners are hammered. It's possible the virus will stay with us, and become seasonal, Fauci warns. And a vaccine will take at least 18 months.

This second task force needs to cut red tape and speed approvals for new drugs, making coronavirus a treatable disease by summer. That's a real possibility, not wishful thinking.

Several drugs are already being tested on patients, including antiviral medicines. As former Food and Drug Administration Commissioner Scott Gottlieb explains, the key is getting the FDA to

review how patients are responding in real time, rather than waiting for the trials to end.

Since taking office, Trump has worked to speed up the FDA's pushing even harder now.

Trump's under attack for pressuring the FDA to allow doctors to try hydroxychloroquine combined with the antibiotic azithromycin, although both drugs are already in use for other maladies. In a French clinical trial, the combo worked on coronavirus, but critics object that study wasn't large enough. That's a legitimate concern in ordinary

"The president is short-circuiting the process," protests Jeffrey Flier, former Harvard Medical School dean. The process? In a pandemic, patients can't wait.

State Rep. Tavia Galonski, D-Ohio, wants to charge Trump with "crimes against humanity" for pushing a drug that hasn't been tested for coronavirus patients. Patients think he deserves a medal.

A second task force also needs to ramp up production and distribution of rapid tests. It's key to reopening workplaces, including assembly lines and office settings. Walmart is taking employees temperatures, but that is hit or miss because many infected people have no fever. Broad distribution of the Abbott five-minute test could be a game changer. So could the new Ortho Clinical Diagnostics blood test, already in mass production, which will tell people if they have antibodies to the virus and are probably immune.

The new task force's third job is to shrink the shutdown to where it's actually needed. Not every part of America is enduring the medical carnage of New York. But shutdown pain is everywhere. On Friday, first-time unemployment benefit applications hit an alltime high nationwide.

University of Texas professor Lauren Ancel Meyers is urging all counties in the nation to shutdown. Meyers' approach is typical, ignoring the human cost of closing the economy. She warns that in counties with no reported cases, there's still a 9% chance of an outbreak. Maybe so, but shutting down comes with a 100% chance of destroying Main Street and costing people their livelihoods, and some even their lives.

Likewise, Fauci is urging Americans to stick with the shutdown. "It's inconvenient," he says, but it's "the answer to our problems." "Inconvenient" is the wrong word. The shutdown is a killer.

In Sweden, government leaders have avoided shutting the economy down, instead letting individuals decide what precautions to take. A major rationale for that approach, explains Anders Tegnell, Sweden's chief epidemiologist, is that "unemployed people are a great threat to public health.

Trump's Task Force deserves enormous thanks for marshaling resources to equip our hospitals and man the front lines. Now it's time for a second task force to rescue America from the shutdown.

## Social distancing guidelines are confusing

This week in Colorado, our statewide stay-at-home order was extended until April 26. Gov. Jared Polis urged everyone to wear a mask of any kind while outdoors. Local groceries are limiting customers to one every 120 square feet of the store. For the first time, my neighborhood playground on Tuesday was wrapped in bright yellow "CAUTION" tape. And in Brighton, Colorado, a father was handcuffed in an empty park by three police officers for playing T-ball with his 6-year-old daughter and wife.

We are not a serious country. America's "social distancing" campaign has gone both too far and not far enough. The restrictions and guidelines are arbitrary, irrational and unevenly applied.

While children's swings and slides are now crime scenes, golf courses and pickleball courts in my city are wide open.

Weed and booze stores are considered "essential." Ice cream, dessert joints and fast-food outlets with takeout and delivery services are still operating. But family-owned, sit-down restaurants that have been staples in our community have been forced to shut their doors after decades in business.

Barbershops and hair salons here were ordered to close three weeks ago, but government employees on landscaping crews who cut grass — like the ones I've seen all crammed together in a city truck - are still earning paychecks subsidized by the taxpayers sidelined from their jobs in the name of safety and public health.

In my state, and across the country, private gyms have been forbidden spaces for the masses for weeks. But if you're a celebrity or Beltway elitist, you can still stay in shape while sanctimoniously taping public service announcements telling everyone else to stay at

Jennifer Lopez and Alex Rodriguez have been racking up social media clicks by sharing cozy family quarantine videos and coping tips from their multi-million-dollar Florida mansion. "We all need to take care of ourselves, mentally and physically, and also be respectful of the health and well-being of others. At a time when people need

to stay apart, we can still find other ways to feel togetherness. Stay connected, and most importantly, stay safe," Rodriguez tweeted to his 1.2 million fans. Yet, last week, the power couple was caught by paparazzi exiting a Miami gym whose front-door sign read: "This gym is not open. Stay home stay safe."

Actors Mario Lopez and Mark Wahlberg have also become quarantine time favorites, sharing dance routines, home workouts and homeschool scenes to show their commitment to self-isolation. But last week, the buff Hollywood bros ventured out to a posh Los Angeles F45 Training facility to tape a partner workout together (with a two-person film crew) that they told their viewers to replicate in their apartments or backyards.

Supreme Court Justice Ruth Bader Ginsburg's personal trainer bragged that until last week, she was working out at the private Supreme Court gym. "Everybody's been shut down," trainer Bryant Johnson told Law360, a legal news and analysis website. "The only reason why I didn't shut the justice down is because, hey, she ain't MichelleMalkinInvestigates@protonmail.com. having it," Johnson said.

Translation: We are not "all in this together," like the cliched hashtag saying goes. The privileged among us get VIP gym access during lockdown, while ordinary Americans are cooped up inside doing pushups in the living room, lunges through the bedroom, makeshift treadmill runs in slippery socks across the kitchen floor, and bicep curls with their jugs of laundry detergent.

Wealthy LA denizens were still flocking to trendy farmers markets last week — until they were shamed on Nextdoor and other social media outlets. Throngs descended on the D.C. Maine Avenue Fish Market last weekend in defiance of stay-at-home orders. Mardi Gras partiers and spring break students formed contagion-friendly mobs while authorities sat on their hands. Philadelphia hoodlums are still holding tailgate parties with carloads of boozers. New York subways remain stuffed to the gills with commuters on trains and platforms. But cops in Florida did crack down on a pastor in Tampa for holding services at his megachurch, and police in New Jersey arrested 15 attendees at an Orthodox Jewish rabbi's funeral.

# Early failures by the CDC and FDA has lasting consequences

Public officials across the United States are flying blind against the COVID-19 epidemic. Because of a government-engineered testing fiasco, they do not know how fast the virus is spreading, how many people have been infected by it, how many will die as a result or how many have developed immunity to it.

The failure to implement early and wide testing, which was caused by a combination of short-sightedness, ineptitude and bureaucratic intransigence, left politicians scrambling to avoid a hospital crisis by imposing broad business closures and stay-at-home orders. It foreclosed the possibility of a more proactive and targeted approach, focused on identifying carriers, tracing their contacts and protecting the public through isolation and quarantines.

The initial outbreak of COVID-19 in Wuhan, China, was reported at the end of December. The first confirmed case in the United States was reported on Jan. 20, by which time it seems likely that many other Americans were already infected.

At first, the U.S. Centers for Disease Control and Prevention

monopolized COVID-19 tests. When the CDC began shipping test kits to state laboratories in early February, they turned out to be defective.

The CDC and the Food and Drug Administration initially blocked efforts by universities and businesses to develop and conduct tests before relaxing the restrictions that made it impossible to assess the progress of the epidemic. Making a false virtue of necessity, the CDC set irrationally narrow criteria for testing, which meant that carriers without severe symptoms or obvious risk factors escaped detection.

The CDC still insists that "not everyone needs to be tested for COVID-19." But without testing everyone — or at least representative little better than guess its prevalence, its lethality and the extent of immunity among the general public.

Even now, months after the Wuhan outbreak and the first reported case in the U.S., we have managed to test less than 1% of the population, and those tests have been limited mainly to people with symptoms severe enough for them to seek treatment. Since people infected by the COVID-19 virus typically experience mild symptoms or no symptoms at all, that's a real problem.

Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases, estimates that "somewhere between 25 percent and 50 percent" of COVID-19 carriers are asymptomatic. But he cautions that "right now we are just guessing," saying the issue would be clarified by wide antibody testing, which would identify people who had the virus and recovered, many of whom may never have realized they were infected.

Iceland — which has tested more than 8% of its population for the virus, 14 times the U.S. rate — has been screening the general public as well as people who think they might have COVID-19. About 1% of those volunteers have tested positive and half of them reported no

Iceland's response to COVID-19, which features aggressive testing, contact tracing and quarantines of infected people but no general lockdown, seems to be working. Its crude case fatality rate known deaths as a share of confirmed cases — is much lower than the rates in other developed countries, including places where the disease emerged around the same time.

Other countries that are doing mass testing, including South Korea, Singapore, Austria and Germany, also seem to have a better handle on their epidemics, whether measured by their crude CFRs or by the number of new cases. Because of the ongoing test shortage, the United States has been unable to mount a similar response.

Our ignorance about COVID-19 will have profound consequences, potentially leading to an overreaction that wrecks the economy while saving relatively few lives or (less likely, given the current political climate) an underreaction that costs many lives and allows hospitals to be overwhelmed by COVID-19 cases. You can thank the same agencies on which we are relying to guide us through this crisis.

Of course, this is a matter of semantics, but we Downeyites demand perfection from our Patriot editor.





## Downey food banks see record numbers

With job losses mounting, Downey's food banks are seeing a surge in new families tring to obtain groceries.

**DOWNEY** — With gritty focus and determination, FoodHelp, a local food bank sponsored by Downey First Christian Church, swiftly reorganized its procedures to serve the increasing number of people facing food uncertainty during the COVID-19 crisis.

Marty Fehn, director of the weekly Saturday distribution, said they experienced an immediate rush on the food bank after the stay-at-home order was issued last month. The panic buying and empty shelves at regular grocery stores prompted many people to show up at the

Fehn estimates that 30 families showed up that first weekend "who came in and told me, 'I just can't find anything, so I'm just desperate.'" Some people shared that they saw posts on Facebook saying the church was giving away food.

"That was concerning," said Fehn, "because we're not situated to handle the primary food market. You know, we're the secondary food market for those in need, so we looked at several conditions and we talked all week." One major problem was the ensuing disorder as the operation struggled to have people comply with safe social distancing.

"We made some procedural changes," Fehn recounts, "we

would still have food. We made a medical services, etc. decision Thursday that we would be open again that Saturday and we broke our all-time record, which was about 153 families, and shot up to 178. That didn't hold long, because the following week we broke it again when we went up to 180."

Fehn describes most of their "neighbors," the people they serve, as the working poor and the elderly with limited resources. Only a small percentage of those they serve are part of the homeless population.

As business contracted and layoffs began, an increasing number of people sought help. Last Saturday FoodHelp recorded 242 families receiving food assistance from this 16-year-old recipient's car.







## Food banks meet challenges in days of Covid-19

Food arrives at FoodHelp by various means. Volunteers in a bright yellow truck make daily trips to pick up donations from certain contributors. Another truck makes weekly trips to the LA Regional Food Bank. FoodHelp also receives a weekly delivery from a non-profit, Food Finders, that collects and distributes donated perishable

"Our suppliers have been wonderful, they really have," affirms Fehn. "There's a real mobilization around this." Safe operation during the health crisis has created an unexpected need—additional cash.

"The thing we're struggling with the most now," says Fehn, "are some actual hard costs that are increasing, but we don't get any relief from." These include masks and gloves for the volunteers, and cleaners and disinfectants. "With some of them being unavailable, they're more expensive."

Gas is also a problem, he ntinues. "Our fuel costs continues. are up a little, although fuel price is down. We've had to do more pickups at various places, and when you have a delivery style truck, it's not your most fuel-efficient vehicle on the market." There is also increased maintenance with greater use.

little hand carts which help so much with social distancing during the distribution are also a source of increased costs.

"Those little carts are getting a lot more wear than they normally would," Fehn reports "We're putting several hundred pounds on them all day long, back and forth, down the sidewalks and the blacktop, over to people's cars. They only last a few months." Fehn counts replacement carts at about \$70 each. In light of these increasing expenditures, Fehn everyone who can to make a cash donation. FoodHelp uses Breeze, a church management software, for donations. Their website is https://downeyfirst.breezechms. com/give/online. A menu allows the donor to designate FoodHelp as the recipient.

#### PTA H.E.L.P.S.

Downey's other food bank, PTA H.E.L.P.S., has had to shut its doors for a while. The two food banks often work collaboratively on food drives and providing full Thanksgiving and Christmas dinners for needy families during the holidays.

A food packaging event sponsored by Downey Federal Credit Union for the past five

due to the threat of Covid-19. Gathering at the Warren High School gym, several hundred volunteers would work in assembly lines to combine lentils, beans, rice, and spices into packages that became a nutritious meals for a family of four when water was added. The dry meals, with their long shelf life, were distributed among the various food banks. The event cancellation this year represents over 50,000 family meals no longer available for distribution.

Despite their limitations, the PTA and the Downey Unified School District still offer support for those most in need.

Cheryl Juarez, President of PTA H.E.L.P.S., says they are still supplying food to families "on an as-needed basis."



The proposed Action Plan includes a recommended distribution of the federal funds, the required application for the HUD grants, and a discussion of actions the City will undertake during the program year regarding homelessness and anti-poverty initiatives. The Analysis of Impediments to Fair Housing Choice focuses on actions, omissions and decisions made because of race, color, religion, sex, disability, familial status or national origin, which restrict, or have the effect of restricting, housing choices or the availability of housing choices in the City. And finally, The Citizen Participation Plan sets forth the City's policies and procedures for providing citizens and other interested parties with opportunities to participate in an advisory role in the planning, implementation, and evaluation of the Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) programs.

During the next program year, the City of Downey will receive \$1,094,600 of CDBG funds and \$457,821 of HOME funds. When combines with \$170,575 in HOME program income generated during the current program year, the combined total of new federal Grants and estimated program income is proposed to be distributed as follows:



#### Q: Hi Jared! Can you tell us a little about yourself?

A: I'm an aerospace engineer living in Downey. Work at Griffith Observatory and the hometown Columbia Memorial Space Center, both consider me some kind of walking spaceflight encyclopedia. I appear on TMRO, the longest running spaceflight web show [12 years now!], and host TMRO:Space News. In my spare time I like to build rockets in my garage, take my Jeep out and explore the desert, and grab my backpacking gear and climb mountains.

#### Q: How's your quarantine going?

**A:** Going very well! Preparation is everything, and that's what made the difference. The dogs are loving having us home. Did have a scare of getting somewhat ill a week ago, but it went away quickly. Both jobs and TMRO are keeping me busy: Space doesn't care if we're having a pandemic down on Earth. I haven't eaten all of the quarantine snacks and ice cream...yet...

#### 0: One thing astronauts are very good at is social distancing. Are there any tips the general public can take from astronauts in relation to social distancing and staying in quarantine?

**A:** Astronauts are actually taught what are called "expeditionary skills", which they do exactly what they sound like: make expeditions to space easier. Frequent, clear, and honest communication is critical to making sure everyone is on the same page, and so that tempers don't flare, or worse, boil over. Remembering that what we're doing right now is

sing the first verse at you for the time you should be rinsing.

Another for me has been "Sabotage" by Beastie Boys. The hook is a few seconds short of 20, so just give it a two count, but that first verse ends at the perfect time for you to be wrapping up the rinse.

#### Q: The skies look very clear right now. What's the best way to stargaze from my backyard?

A: Because Downey is right in the middle of the LA Basin, and we've got millions of our best friend's outdoor lights spilling into the sky, light pollution is horrendous - but even with that, a good pair of binoculars is a good place to start, look for 15x70 as the size, that'll get you amazing views of the Moon's surface and even Saturn's rings. Brands like Celestron make good stuff. Grab an app or two as well! I use Sky Safari, and it can help you learn what stars and constellations you can see. I highly recommend learning the sky first before you get a telescope.

Right now in the evening sky you've got a very bright point of light, and that's the planet Venus! In the coming weeks, as Venus catches up to the Earth in its own orbit around the Sun, in a good pair of binoculars you can see that Venus has phases, just like the Moon.

The only bad time to look at the Moon is when it's full, as there's no shadows being cast relative to our viewing here on Earth, so you lose surface detail.

In the morning, you've got Jupiter, Mars, and Saturn greeting you before sunrise. Sometimes I'll step out and share a coffee with them. But as the Earth continues in its own orbit around the Sun, we'll catch up and pass all three, so their positions will change so that prime viewing for Jupiter and Saturn will be July into August, and Mars' best will be around September.

#### Q: Do I need an expensive

A: You don't! Eyes work! As mentioned before, binoculars too! But if you want a telescope, start small, make sure you want to do astronomy as a hobby. I know folks who have entry-level telescopes that cost them \$60 new, I know folks who moved to the desert, built a house around

their own private observatory, then dropped a million dollars on equipment for it. Like any hobby, it's limited only by how much you're willing to spend. I always recommend start with a reflector telescope, and look for something in the 4" range.

#### Q: Our newspaper has a couple of readers who insist that the Moon Landings were staged. Can you address this once and for all?

**A:** The ability to stage the Moon Landing was just not possible in the late-1960s. The Soviet Union and China both had the motivation to embarrass the United States on as big a stage as possible, and they certainly had the technology to know Apollo was actually happening. You're telling me all of that machinery that was made is perfectly hidden somewhere? In addition, you're telling me the 400,000 people who worked on Apollo have maintained over half a century of silence on the matter? Get real, they were real. Watch 2001: A Space Odyssey, that was Stanley Kubrick's perfection of the best special effects of the time Apollo happened, and it just doesn't cut the mustard. As the joke about Stanley Kubrick faking the Moon landing goes: When hired to fake the Moon

landings, Kubrick was such a perfectionist that he shot on-

#### Q: Not to get too political, but what are your thoughts on the Space Force?

**A:** I think the Space Force is an okay thing actually. It's really been in the works since 2001 when the US DoD had a panel on US-aerospace challenges, and one of those recommendations was to have a space-specific set of operations and capabilities. It's just been a matter of moving the right bureaucracy to make the newer, shinier bureaucracy. I feel like in addition to its role of being a standalone version of the Air Force Space Command, it should also track and mitigate space debris from rockets and satellites in orbit around the Earth, and should also hunt for and track asteroids, because preventing your extinction is important, especially if you have the technology to do so.

#### Q: Do you believe there is life out in the universe besides Earth?

A: Absolutely. From my point-of-view, knowing just how many planets are in the Milky Way by itself [about 1 trillion, yeah, 1,000,000,000,000 planets - then think about how

many galaxies there are in the Universe and multiply those two numbers...], it's almost arrogant to think that Earth is alone in having life.

I would be very surprised if we didn't find other life or evidence for past life in our own Solar System. Mars at one time had all of the right ingredients to be habitable. We know several moons in our Solar System, like Europa orbiting Jupiter, or Enceladus orbiting Saturn, have multiple parts of what it takes for life to occur, and may have that complete set that makes the survival of life possible.

I would be surprised if it was anything beyond bacteria though, and I would also be surprised if it had the same kind of genetic makeup we do. For all we know, life on Earth could be the weird ones in the Universe.




