Downey votes to no longer fly Pride flags

DOWNEY – A three-year-old decision to fly the Pride flag each June came to an abrupt end on Tuesday, when Downey City Council voted to revert back to its previous flag policy, effective immediately.

City Council voted 3-2, with Mayor Mario Trujillo and Councilman Horacio Ortiz in opposition.

Downey flies The United States, California, city, and Prisoners of War/Missing in Action (POW/MIA) flags year-round. In June 2021, the city council voted to raise the Pride flag each Pride month.

Sometimes known as a "neutral flag policy," the city council's most recent action will bar the display of any flag other than the federal, state, local and POW/MIA on city facilities and flag poles.

The issue drew a mix of community members, who spoke both for and against the policy. Both LA County Representative Janice Hahn and Assemblywoman Blanca Pacheco – who as mayor pro tem at the time voted in favor of raising the Pride flag for Pride month – sent representatives to speak in opposition.

Mayor Pro Tem Hector Sosa, who requested the discussion, said that it was "by no means an attempt to silence or spite anyone."

"I don't think it's our role as elected officials to pick and choose which groups get to fly their flags. Our role is to simply govern, and govern for the residents of Downey," said Sosa. "It is my opinion that the only flags that should be displayed are the American flag, the state flag, the city flag, and the POW/MIA flags."

Ortiz and Trujillo described it as "a step back."

"The previous flag policy that we have, implemented and voted on in the past by a past administration, is one that represents a new front of acceptance for our city. Their actions paved a way for Downey's united sense of community," said Ortiz. "The reaction to change or alter this new progress feels as though we're making a bigger statement. As it stands, the flag policy has become a symbol for this change; to move back to a time without it feels as though we're taking two steps back instead of two steps forward."

Trujillo said the motion was "a direct attack on the Pride flag," specifically calling out the conservative Massachusetts-based group MassResistance.

"This motion came about because of a group called MassResistance...MassResistance has been deemed as a hate group by the Southern California Poverty Law Center. Their two goals are basically anti-immigration and anti-Pride flag, let's be clear," said Trujillo. "It's unfortunate that it was brought about through this hate group, who hides behind religious, you have religious people coming forward talking about the Bible, and these are the same families and parents that are prone to kicking out their child who comes out to them."

Responding to a previous comment made by Sosa, who had said that he had family and friends in the LGBTQ community who he "cared deeply for," Trujillo said "after tonight, they will not consider you an ally."

"I just want everyone to be clear, this is an eradication of the Pride Flag. If you're carving out an exception for the POW flag, this is a direct attack on the Pride flag," said Trujillo. "It is an unfortunate message that we will send to the community, that at least here in Downey, don't look to us as allies for your community, at least not the current composition of this council."

Councilwoman Claudia M. Frometa pushed back on the mayor's comments, calling them "untrue."

"This is not an attack on any one community," said Frometa. "We stand united under the flag of this country that flies, whether it's war or the Olympics; it unites all of us regardless of race, color, or religion."

In response to the decision, Supervisor Hahn released a statement, saying:

"I am disappointed in the Downey City Council's decision, and I worry about the message it sends to LGBTQ+ residents in Downey. Thankfully, the Pride Flag will still fly over Downey this June. My colleagues and I put in place a new policy last year to fly the Pride flag at all County facilities every June – including our eight county facilities in Downey." Park Chung-Hee took over the government machinery, dissolved the National Assembly, and imposed a strict ban on political activity.


Authentic Hawaiian music returns to Downey Theatre

More probation officers placed on leave

■ 14 probation officers at Los Padrinos Juvenile Hall have been discplined for conduct issues.

DOWNEY - Two more Los Angeles County probation officers were placed on leave following an investigation that detected additional cases of "youth-on-youth violence" at Los Padrinos Juvenile Hall in Downey, the Probation Department announced Monday.

The 14 Los Padrinos officers -- two more than previously announced -- are among a total of 66 probation officers who have been placed on leave since the beginning of the year for various issues relating to conduct on and off duty.

Eight other officers were placed on leave in January following an incident that

"We are releasing this information in the spirit of greater transparency and to assure our stakeholders -especially the families of youths in our juvenile facilities -- that we will not tolerate anything that impedes our mission to provide a safe, nurturing and structured environment for those entrusted to our care," Los Angeles County Probation Chief Guillermo Viera Rosa said in a statement.

Those placed on leave were assigned to both the department's adult and juvenile operations, Viera Rosa said.

Viera Rosa said all the officers placed on leave since the first of the year represent a small minority of the department's nearly 2,800 sworn personnel.

"It is out of respect for the majority of our officers, who perform their duties each day with integrity, that we moved quickly on these cases," he said. "It's not right that the majority should be tarnished by the misconduct of a few. We will According to the department, not tolerate anything that is we do."

The earlier instance that at Los Padrinos, according to law enforcement agency for

probation officers occurred on Dec. 22, 2023. Surveillance officers standing by in a dining room at the hall while a series individually detainees approached a 17-year-old boy and began punching and kicking him in what appeared to be coordinated attacks.

At least five probation officers can be seen in the room at the time. One occasionally steps in to break up the fights, but she appears to be smiling or laughing as she does so. By the end of the six-minute video, the teen victim walks to one of the tables and sits down with other youth.

The video was shown in a Sylmar courtroom in April, when the 17-year-old victim's attorney asked that her client be released due to unsafe conditions

The Times.

The attorney, Sherrie Albin, said the teen suffered a broken Board of State and Community nose in the attack, but was not taken for medical treatment by probation officers for several Secure Youth Treatment Facility days after the beatings.

During the court hearing, Albin said one of the probation officers seen in the video "instigated" the attacks, saying the officer told other youths the 17-year-old was a racist based on his gang affiliation and where he lived, the Times reported. finding in April, determining According to the paper, all of the assailants were Black, and had been made to address the the 17-year-old is Latino.

judge ultimately The declined to release the teen, noting he has been transferred out of the unit at Los Padrinos where the attacks occurred, the Times reported.

Viera Rosa said the incidents have been referred to an outside investigation.

In February, the California Corrections declared Los Padrinos and the Barry J. Nidorf in Sylmar unsuitable to house youths. The state board cited violations ranging from poor staffing levels to inadequate training, education programs, safety plans and disciplinary procedures.



Downey goes backwards by banning Pride flag

Tuesday's decision by the Downey City Council to rescind its policy allowing the Pride flag to fly each June is not just a step backward; it's a puzzling act of divisiveness at a time when Downey is still healing from several years of instability.

The move sends a message of exclusion and discrimination, and it's especially insulting that it comes during the mayoral term of Mario Trujillo, Downey's first openly gay mayor.

With its 3-2 vote (Trujillo and Councilman Horacio

Ortiz voted no), Downey city facilities are restricted from flying the Pride flag, something Downey began doing only three years ago.

Tuesday's vote was the Downey City Council's conservative majority flexing its muscle. Instead of fostering inclusivity and celebrating diversity, they're choosing to sow seeds of division. Instead of promoting unity and acceptance, they're widening the gap between different groups within the city.

As a symbol of pride and progress, the Pride flag represents the struggles and achievements of the LGBTQ+ community. Banning it during the leadership of a mayor who represents a milestone in Downey's

history — and two weeks before the start of Pride Month — is a direct affront to the values of equality and respect.

In a time when many cities and institutions are embracing diversity and actively working towards creating more inclusive environments, Downey's step backward is disappointing and disheartening.

It's my hope the City Council will reconsider their decision and either carve out an exception for the Pride flag or rescind their neutral flag policy entirely.

Is this a tipping point for pageant culture?

t's been a manicured-brow-raising week in the world of beauty pageants, as Miss USA and Miss Teen USA have both resigned from their roles, fueling speculation about both pageants' management and treatment of their talent.

Both pageant winners — Miss USA 2023 Noelia Voigt and Miss Teen USA 2023 UmaSofia Srivastava — posted explanations for their departures, Voigt citing her mental health and Srivastava citing misalignment of the organization's values with her own. And both are bound by strict non-disclosure agreements, radically limiting what they can say.

The Miss Teen USA and Miss USA pageants fall under the broader umbrella of the Miss Universe Organization, a global network of pageants. In a statement following Voigt's announcement to step down, the Miss USA pageant said, "We respect and support Noelia's decision to step down from her duties," noting that, "The well-being of our titleholders is a top priority, and we understand her need to prioritize herself at this time." Miss Teen USA made a similar statement after Srivastava's resignation.

There seems to be much intrigue in pageant world over these resignations. And there is a deeper question that needs to be raised: In 2024, why in the world are we still doing beauty pageants?

I know, I know: "It is not a beauty pageant, it is a scholarship program." According to Miss USA, the pageant is about celebrating "beauty, intelligence, and empowerment." It just so happens that all of the contestants fit into a very narrow definition of female attractiveness, intelligence doesn't usually seem to count

It is arguably progress that beauty pageants now have to pretend that they aren't just beauty pageants, but something related to talent, character and empowerment. The problem, though, is that a world in which women were fully empowered, treated with the same dignity as men, and judged according to their characters and not their sexual attractiveness to men is a world in which beauty pageants would not exist.

No matter how you spin it or how much language about "empowerment" you slap on a website, pageants are pageants: venues to judge women dressed up like Barbies and declare one the most beautiful of them all.

That an interview portion determines if a woman can string a few words together doesn't actually solve the fundamental flaw of pageants, especially since interviews are used to judge "personality," which seems to be shorthand for how sweet and feminine a contestant is. These competitions, no matter how much you massage the language around them, are condescending and sexist.

That isn't to insult the many women and girls who



Joel Antonio Villegas, 35, pleaded guilty to one count of conspiracy to distribute and possess with intent to distribute controlled substances, according to the U.S. Attorney's Office. He faces a life prison sentence when he is sentenced Aug. 30.



UC Irvine faculty arrested at encampment

 Protestors demanding UC Irvine divest from Israel clashed with police Wednesday.

IRVINE – UC Irvine students and staff were informed classes would meet remotely Thursday and "unless specifically noted, all employees should work remotely" following what Chancellor Howard Gillman called "a sad day for our university."

Police took multiple people into custody, including at least two who identified themselves UCI faculty members, as and cleared a Gaza Solidarity Encampment at the university Wednesday evening, more than two weeks after it was established.

Protesters surrounded the



about 2:30 p.m. Wednesday, prompting campus police to request aid from Orange County sheriff's deputies and Irvine police, among other neighboring agencies, said Tom Vasich, a university spokesman.

Protesters were led in chants of "We won't move" and "shame" and some wore scarves or face masks and had goggles and hard hats, according to The Orange County Register.

The university sent a message to students at 5:57 p.m. declaring, Anyone currently in buildings in the vicinity of the protest are advised to exit buildings & leave area at this time. ... If able, please leave immediately & continue to avoid the protest area until further notice."

A large contingent of police and sheriff's deputies descended on the campus and began arresting protesters and dismantling the encampment by early evening after declaring an unlawful assembly and ordering the crowd to disperse.

Some shoving between police and protesters was spotted as officers moved further into the encampment area and eventually started to remove some protesters. At least two people who were taken into custody identified themselves as UCI faculty members, The Register reported.

Approximately 300 protesters remained at 7 p.m. By 8 p.m. protesters has been funneled by advancing police to Aldrich Park, a large green lawn area nearby. An announcement was made about 8:10 to disperse within five minutes. Many in the remaining crowd left at that

Physical Sciences Lecture Hall point, according to The Register.

By 8:33 p.m., police had cleared Aldrich Park and only a few lingering people remained on campus. Police remained in a line formation in various spots and asked anyone coming by to leave, The Register reported.

The protest had been largely peaceful as the students have been negotiating with university officials.

The situation intensified over the past week, particularly after some protesting students received suspension notices from the university, including some who were involved in negotiations with UCI administrators.

In a statement posted on social media Wednesday, the UCI Divest protest group said it is "reclaiming the university for Palestine and for the people."

"Exactly one week ago to the day, UC Irvine issued temporary suspensions to many students in the encampment, including the majority of the student negotiation team," according to the group.

"Students barred from returning to their own campus residence halls, cannot come to campus at the peak of midterms and finals, and are already facing the emotional toll of seeing the university militarize itself before it even accepts ending the genocide and killings of the students' family members and friends."

Numerous tents were erected around the physical sciences building, and banners were hung from the building's balcony listing the groups demands for divestment. Some small
